BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.5

- Section 1. Minnesota Statutes 2014, section 352.113, subdivision 2, is amended to read: 1.6 Subd. 2. Application; accrual of benefits. (a) An employee making claim for a total 1.7 and permanent disability benefit, or someone acting on behalf of the employee upon proof 1.8 of authority satisfactory to the director, shall file a written application for benefits in the 1.9 office of the system on or before the deadline specified in subdivision 4, paragraph (f) or (g). 1.10 (b) The application must be in a form and manner prescribed by the executive director. 1.11 (c) The benefit shall begin to accrue the day following the start of disability or the 1.12 day following the last day paid, whichever is later, but not earlier than 180 days before the 1.13 date the application is filed with the director. 1.14

and totally disabled within the meaning of section 352.01, subdivision 17, and that the
disability arose before the employee was placed on any paid or unpaid leave of absence or
terminated public service.

(c) If there is medical evidence that supports the expectation that at some point 2.4 the person applying for the disability benefit will no longer be disabled, the decision 2.5 granting the disability benefit may provide for a termination date upon which the total and 2.6 permanent disability can be expected to no longer exist. When a termination date is part 2.7 of the decision granting benefits, prior to the benefit termination the executive director 28 shall review any evidence provided by the disabled employee to show that the disabling 2.9 condition for which benefits were initially granted continues. If the benefits cease, the 2.10 disabled employee may follow the appeal procedures described in section 356.96 or may 2.11 reapply for disability benefits using the process described in this subdivision. 2.12

(d) Any claim to disability must be supported by a report from the employer
indicating that there is no available work that the employee can perform with the disabling
condition and that all reasonable accommodations have been considered. Upon request of
the executive director, an employer shall provide evidence of the steps the employer has
taken to attempt to provide reasonable accommodations and continued employment to
the claimant.

(e) The director shall also obtain written certification from the employer stating
whether the employment has ceased or whether the employee is on sick leave of absence
because of a disability that will prevent further service to the employer and that the
employee is not entitled to compensation from the employer.

2.23 (f) The medical adviser shall consider the reports of the physicians, physician assistants, psychologists, and chiropractors and any other evidence supplied by the 2.24 employee or other interested parties. If the medical adviser finds the employee totally and 2 25 permanently disabled, the adviser shall make appropriate recommendation to the director 2.26 in writing together with the date from which the employee has been totally disabled. The 2.27 director shall then determine if the disability occurred within 18 months of filing the 2.28 application, if the disability occurred while still in the employment of the state, and the 2.29 propriety of authorizing payment of a disability benefit as provided in this section. 2.30

(g) A terminated employee may apply for a disability benefit within 18 months of
termination as long as the disability occurred while in the employment of the state. The
fact that an employee is placed on leave of absence without compensation because of
disability does not bar that employee from receiving a disability benefit.
