1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. Minnesota Statutes 2012, section 290.0681, subdivision 1, is amended to read:
1.7	Subdivision 1. Definitions. (a) For purposes of this section, the following terms
1.8	have the meanings given.
1.9	(b) "Account" means the historic credit administration account in the special
1.10	revenue fund.
1.11	(c) "Office" means the State Historic Preservation Office of the Minnesota Historical
1.12	Society.
1.13	(d) "Project" means rehabilitation of a certified historic structure, as defined in
1.14	section 47(c)(3)(A) of the Internal Revenue Code, that is located in Minnesota and is
1.15	allowed a federal credit under section 47(a)(2) of the Internal Revenue Code.
1.16	(e) "Society" means the Minnesota Historical Society.
1.17	(f) "Federal credit" means the credit allowed under section 47(a)(2) of the Internal
1.18	Revenue Code.
1.19	(g) "Placed in service" has the meaning used in section 47 of the Internal Revenue
1.20	Code.
1.21	(h) "Qualified rehabilitation expenditures" has the meaning given in section 47 of
1.22	the Internal Revenue Code.
1.23	<b>EFFECTIVE DATE.</b> This section is effective the day following final enactment.

Sec. 2. Minnesota Statutes 2012, section 290.0681, subdivision 3, is amended to read: 2.1 Subd. 3. Applications; allocations. (a) To qualify for a credit or grant under this 2.2 section, the developer of a project must apply to the office before the rehabilitation 2.3 begins. The application must contain the information and be in the form prescribed by 2.4 the office. The office may collect a fee for application of <del>up to \$5,000</del> \$....., based on 2.5 estimated qualified rehabilitation expenses expenditures, to offset costs associated with 2.6 personnel and administrative expenses related to administering the credit and preparing 2.7 the economic impact report in subdivision 9. Application fees are deposited in the 2.8 account. The application must indicate if the application is for a credit or a grant in lieu 2.9 of the credit or a combination of the two and designate the taxpayer qualifying for the 2.10 credit or the recipient of the grant. 2.11 (b) Upon approving an application for credit, the office shall issue allocation 2.12 certificates that: 2.13 (1) verify eligibility for the credit or grant; 2.14 (2) state the amount of credit or grant anticipated with the project, with the credit 2.15 amount equal to 100 percent and the grant amount equal to 90 percent of the federal 2.16 credit anticipated in the application; 2.17 (3) state that the credit or grant allowed may increase or decrease if the federal 2.18 credit the project receives at the time it is placed in service is different than the amount 2.19 anticipated at the time the allocation certificate is issued; and 2.20 (4) state the fiscal year in which the credit or grant is allocated, and that the taxpayer 2.21 or grant recipient is entitled to receive the credit or grant at the time the project is placed 2.22

2.23 in service, provided that date is within three calendar years following the issuance of2.24 the allocation certificate.

(c) The office, in consultation with the commissioner of revenue, shall determine
if the project is eligible for a credit or a grant under this section <u>and must notify the</u>
<u>developer in writing of its determination</u>. Eligibility for the credit is subject to review
and audit by the commissioner of revenue.

(d) The federal credit recapture and repayment requirements under section 50 of theInternal Revenue Code do not apply to the credit allowed under this section.

(e) Any decision of the office under paragraph (c) may be challenged as a contested
 case under chapter 14. The contested case proceeding must be initiated within 45 days of
 the date of written notification by the office.

3.1	Subd. 4. Credit certificates: grants. (a)(1) The developer of a project for which the
3.2	office has issued an allocation certificate must notify the office when the project is placed
3.3	in service. Upon verifying that the project has been placed in service, and was allowed a
3.4	federal credit, the office must issue a credit certificate to the taxpayer designated in the
3.5	application or must issue a grant to the recipient designated in the application. The credit
3.6	certificate must state the amount of the credit.
3.7	(2) The credit amount equals the federal credit allowed for the project.
3.8	(3) The grant amount equals 90 percent of the federal credit allowed for the project.
3.9	(b) The recipient of a credit certificate may assign the certificate to another taxpayer,
3.10	which is then allowed the credit under this section or section 297I.20, subdivision 3. <u>An</u>
3.11	assignment is not valid unless the assignee notifies the commissioner within 30 days of the
3.12	date that the assignment is made. The commissioner shall prescribe the forms necessary
