1.2 relating to taxation; motor vehicle sales; expanding an exemption for certain
1.3 motor vehicle purchases by local governments; amending Minnesota Statutes
1.4 2014, section 297B.03.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2014, section 297B.03, is amended to read:

1.7 **297B.03 EXEMPTIONS.**

1.8 Subdivision 1. **Scope.** ~~There is~~ The purchases or acquisitions of a motor vehicle
1.9 listed in this section are specifically exempted from the provisions of this chapter and from
1.10 computation of the amount of tax imposed by it the following:

1.11 Subd. 2. **Federal government.** ~~(1)~~ The purchase or use, including use under a
1.12 lease purchase agreement or installment sales contract made pursuant to section 465.71,
1.13 of any motor vehicle by the United States and its agencies and instrumentalities and
1.14 by any person described in and subject to the conditions provided in section 297A.67,
1.15 subdivision 11; is exempt.

1.16 Subd. 3. **Purchased while a resident of another state.** ~~(2)~~ The purchase or use
1.17 of any motor vehicle by any person who was a resident of another state or country at the
1.18 time of the purchase and who subsequently becomes a resident of Minnesota, provided
1.19 the purchase occurred more than 60 days prior to the date such person began residing in
1.20 the state of Minnesota and the motor vehicle was registered in the person's name in the
1.21 other state or country; is exempt.

1.22 Subd. 4. **Interstate motor carriers.** ~~(3)~~ The purchase or use of any motor vehicle
1.23 by any person making a valid election to be taxed under the provisions of section 297A.90;
1.24 is exempt.

2.1 Subd. 5. **Sale of a business.** (4) The purchase or use of any motor vehicle previously
2.2 registered in the state of Minnesota when such transfer constitutes a transfer within the
2.3 meaning of section 118, 331, 332, 336, 337, 338, 351, 355, 368, 721, 731, 1031, 1033, or
2.4 1563(a) of the Internal Revenue Code; is exempt.

2.5 Subd. 6. **Leased vehicles for interstate commerce.** (5) The purchase or use of any
2.6 vehicle owned by a resident of another state and leased to a Minnesota-based private or
2.7 for-hire carrier for regular use in the transportation of persons or property in interstate
2.8 commerce provided the vehicle is titled in the state of the owner or secured party, and
2.9 that state does not impose a sales tax or sales tax on motor vehicles used in interstate
2.10 commerce; is exempt.

2.11 Subd. 7. **Use in automotive training programs.** (6) The purchase or use of a motor
2.12 vehicle by a private nonprofit or public educational institution for use as an instructional
2.13 aid in automotive training programs operated by the institution. "Automotive training
2.14 programs" includes motor vehicle body and mechanical repair courses but does not
2.15 include driver education programs; is exempt.

2.16 Subd. 8. **Ambulance and emergency response.** (7) The purchase of a motor
2.17 vehicle by an ambulance service licensed under section 144E.10 when that vehicle is
2.18 equipped and specifically intended for emergency response or for providing ambulance
2.19 service; is exempt.

2.20 Subd. 9. **Library use.** (8) The purchase of a motor vehicle by or for a public
2.21 library, as defined in section 134.001, subdivision 2, as a bookmobile or library delivery
2.22 vehicle; is exempt.

2.23 Subd. 10. **Ready-mix concrete truck.** (9) The purchase of a ~~ready-mixed~~
2.24 ~~ready-mix~~ concrete truck; is exempt.

2.25 Subd. 11. **Local government road maintenance.** (10) The purchase or use of a
2.26 motor vehicle by a ~~town~~ local government for use exclusively for road maintenance,
2.27 including ~~snowplows and dump trucks~~ a snowplow or dump truck, but not including
2.28 ~~automobiles, vans, or pickup trucks~~; an automobile, van, or pickup truck is exempt. For
2.29 purposes of this subdivision "local government" means:

2.30 (1) a home rule charter or statutory city;

2.31 (2) a county;

2.32 (3) a town; or

2.33 (4) an instrumentality of a home rule charter or statutory city, county, or town.

2.34 An instrumentality may be a special district under section 6.465, or a special district
2.35 organized under a joint powers agreement under section 471.59, if the special district was

established by the county, city, or town, or the majority of the special district's governing board is made up of:

(i) elected officials of the city, county, or town; or

(ii) the special district's members are appointed by the governing body of the city, county, or town.

Subd. 12. Charitable use. ~~(11)~~ The purchase or use of a motor vehicle by a corporation, society, association, foundation, or institution organized and operated exclusively for charitable, religious, or educational purposes, except a public school, university, or library is exempt, but only if the vehicle is:

~~(i)~~ (1) a truck, as defined in section 168.002, a bus, as defined in section 168.002, or a passenger automobile, as defined in section 168.002, if the automobile is designed and used for carrying more than nine persons including the driver; and

~~(ii)~~ (2) intended to be used primarily to transport tangible personal property or individuals, other than employees, to whom the organization provides service in performing its charitable, religious, or educational purpose; is exempt.

Subd. 13. Transit use. ~~(12)~~ The purchase of a motor vehicle for use by a transit provider exclusively to provide transit service is exempt if the transit provider is either (i) receiving financial assistance or reimbursement under section 174.24 or 473.384, or (ii) operating under section 174.29, 473.388, or 473.405; is exempt.

Subd. 14. Job opportunity building zone. ~~(13)~~ The purchase or use of a motor vehicle by a qualified business, as defined in section 469.310, located in a job opportunity building zone, if the motor vehicle is principally garaged in the job opportunity building zone and is primarily used as part of or in direct support of the person's operations carried on in the job opportunity building zone. The exemption under this clause applies to sales, if the purchase was made and delivery received during the duration of the job opportunity building zone. The exemption under this clause also applies to any local sales and use tax; is exempt.

Subd. 15. Certain purchases from a nonprofit. ~~(14)~~ The purchase of a leased vehicle by the lessee who was a participant in a lease-to-own program is exempt if the purchase is from a charitable organization that is:

~~(i)~~ (1) described in section 501(c)(3) of the Internal Revenue Code; and

~~(ii)~~ (2) licensed as a motor vehicle lessor under section 168.27, subdivision 4; and.

Subd. 16. Mobile medical unit. ~~(15)~~ The purchase of a motor vehicle used exclusively as a mobile medical unit for the provision of medical or dental services by a federally qualified health center, as defined under title 19 of the Social Security Act, as amended by Section 4161 of the Omnibus Budget Reconciliation Act of 1990 is exempt.
