.8	(1) "qualifying employee" means a person who performs services for hire in
.9	Minnesota and who has been subject to isolation or quarantine for a communicable disease

(a) An employer shall not discharge, discipline, threaten, or penalize a qualifying employee, or otherwise discriminate in the work terms, conditions, 2.2 location, or privileges of the employee, because the employee has been in isolation or 2.3 quarantine. A person quarantined under subdivision 1, clause (3), may ask the commissioners of health and commerce for documentation setting forth the person's conditions of isolation or quarantine to assist the person in their efforts to obtain the protections specified in subdivision 2. The request may be made by telephone, in writing, or through a third party.
