1.2	relating to commerce; modifying unclaimed property requirements; modifying
1.3	the commissioner's duties; requiring reports; amending Minnesota Statutes 2014,
1.4	section 345.42, subdivision 1, by adding a subdivision.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6	Section 1. Minnesota Statutes 2014, section 345.42, subdivision 1, is amended to read:
1.7	Subdivision 1. Commissioner's duty. Within the calendar year next following
1.8	the year in which abandoned property has been paid or delivered to the commissioner,
1.9	the commissioner shall provide public notice of the abandoned property in the manner
1.10	described in subdivision 1a and frequency otherwise as the commissioner determines to be
1.11	most effective and efficient in communicating to the persons appearing to be owners of
1.12	this property. Public notice may include the use of print, broadcast, or electronic media.
1.13	The commissioner shall, at a minimum, expend 15 percent of the funds allocated by
1.14	the legislature to the operations of the unclaimed property division, to comply with the
1.15	public notice requirements of this subdivision section and shall report to the legislature
1.16	annually on how those funds are expended.
1.17	EFFECTIVE DATE. This section is effective the day following final enactment.

1.20	Subd. 1a. Public notice. (a) Public notice provided by the commissioner shall
1.21	include the following:
1.22	(1) posting on the Department of Commerce Web site a list of all persons appearing

2.2	updated at least three times per year and must remain on the Department of Commerce
2.3	Web site at all times;
2.4	(2) publication in a qualified newspaper of a list of persons appearing to be owners
2.5	of abandoned property having a value of \$500 or more. The list must be published in the
2.6	largest circulation qualified newspaper in each county, and must include the names of all
2.7	persons whose last known address is within the county. The list must be published at least
2.8	once per year. The commissioner may stagger publication of the entire list of owners by
2.9	publishing a partial list at least twice, but no more than three times per year. Each qualified
2.10	newspaper that publishes the list shall, at no additional charge to the commissioner, also
2.11	post the list on its Web site or on a central Web site that can be accessed directly from the
2.12	qualified newspaper's Web site. The list must be accessible on the Web site for not less
2.13	than 180 days and at no cost to the public. The qualified newspaper must include in its
2.14	publication of the list a reference to its Web site or a central Web site; and
2.15	(3) dissemination of information to persons appearing to be owners of abandoned
2.16	property through other means and media, including broadcast media, the Internet, and
2.17	social media.
2.18	(b) Beginning July 1, 2016, and annually thereafter, the commissioner shall
2.19	provide to each member of the legislature a list of all persons appearing to be owners of
2.20	abandoned property whose last known address is located in the legislator's respective
2.21	legislative district.
2.22	EFFECTIVE DATE. This section is effective the day following final enactment.
2.23	Sec. 3. REPORT ON UNCLAIMED PROPERTY.
2.24	The commissioner shall report to the house of representatives and senate committees
2.25	with jurisdiction over commerce issues by January 1, 2016, regarding the process owners
2.26	of abandoned property must comply with in order to file an allowed claim under chapter
2.27	345 and the methods the commissioner uses to return abandoned property to owners.
2.28	The report shall include:
2.29	(1) information regarding the documentation and identification necessary for owners
2.30	of each type of abandoned property under chapter 345 to file an allowed claim; and
2.31	(2) a comparison of the effectiveness of the methods the commissioner uses to return
2.32	abandoned property under chapter 345 to the owner.

2.33 **EFFECTIVE DATE.** This section is effective the day following final enactment.
