BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. [62Q.679] PRIMARY CARE PAYMENT RATES.

- Subdivision 1. Payment rate equalization. (a) A health plan company offering a group health plan or individual health plan shall reimburse all in-network primary care providers located within the same geographic rating area at the same payment rate for each primary care service covered by the health plan. The payment rate may be different for in-network primary care providers located in a different geographic rating area, but must be the same for providers located within each geographic rating area.
 - (b) The health plan company may negotiate payment rates with each primary care provider, but is prohibited from paying any provider a rate that is different than the highest negotiated rate.
- (c) The health plan company may require the primary care provider to meet reasonable 1.17 data, utilization review, referral criteria, and quality reassurance requirements on the same 1.18 basis as other in-network providers. 1.19
- Subd. 2. **Definitions.** (a) For purposes of this section, the following terms have the 1.20 meanings given. 1.21
