

## Minnesota Rules: Amendments and Additions =

#### NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1997 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Provisions exist for the Commissioners of some state agencies to adopt emergency expedited rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Emergency expedited rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions. Emergency expedited rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these emergency expedited rules detail the agency's rulemaking authority.

## Adopted Expedited Emergency Game and Fish Rules; Deer Hunting Regulations; Youth Waterfowl Hunting

**NOTICE IS HEREBY GIVEN** that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of these rules is *Minnesota Statutes*, sections 97A.465, 97A.535, 97B.111, 97B.301, 97B.305, 97B.311, 97B.731, and 97B.803.

#### 6232.0300 GENERAL RESTRICTIONS FOR TAKING DEER.

Subpart 1. **Zone and date options.** A firearm deer hunter may purchase a firearm license valid for the regular firearms deer season or muzzleloader season, a license to take antlered deer in more than one zone, or a resident youth license. A hunter purchasing a resident youth license or a regular firearm license, including a hunter choosing a muzzleloader option, must select only one of the zone and date options listed on the license. For the regular firearm season, this choice will be indicated by a punched hole at the time of purchase, except that for licenses issued through an electronic point-of-sale system, the choice will be printed on the license. A person may only hunt deer by firearms within the zone and date options indicated on the person's regular firearm license.

Subp. 5. **Tagging.** The seal or the tag of the license valid for the taking of the deer must be affixed around the tendon or bone of a hind leg, around the base of an antler, or through a slit cut in either ear so that the seal cannot be readily removed, except that for licenses issued through an electronic point-of-sale system, the adhesive tag must be sealed over both ends of a looped string or wire, attached in any of these same locations, in such a manner that the tag cannot be removed without cutting the string or wire.

- Subp. 8. **Bag limit.** A person may not tag more than one deer during a license year by any method, except as authorized in items A to D.
  - A. Archery and firearms deer management permits may be used to tag a second deer as provided in this chapter.
- B. In Marshall, Kittson, Roseau, Lake of the Woods, and Pennington counties, a person may tag one deer with a regular archery license and another with a regular firearms license, including the muzzleloader option or multizone buck license. Both deer must be taken and registered in this five-county area.
- C. A person may tag a third, fourth, or fifth deer by archery or firearms with an intensive harvest permit in specified areas as prescribed in this chapter.
  - D. C. In no case may a person tag more than five deer per year by firearms, archery, or both methods combined.

#### 6232.0500 DEER LICENSES FOR MILITARY PERSONNEL.

Military personnel and disabled veterans may obtain a license to hunt deer as authorized by *Minnesota Statutes*, sections 97A.441 and 97A.465, under the conditions in this part.

- A. The free license, antlerless permit, and tag must be obtained from the county auditor or purchased through an electronic point-of-sale system.
- B. The auditor must punch the zone and the date option selected by the applicant, except that for licenses issued through an electronic point-of-sale system, the zone and date option will be printed on the license.

#### 6232.0600 SEASONS AND ZONES FOR TAKING DEER BY ARCHERY.

[For text of subpart 1, see M.R.]

- Subp. 2. Northeast Border Zone. The following provisions apply to the taking of deer by archery in the Northeast Border Zone:
  - A. The open area consists of: Deer Registration Blocks 415, 116, 117, 118, and 127, 130, and 194.
  - B. Open dates are from the Saturday nearest September 16 through the last day of the regular Zone 1 firearms deer season.

#### 6232.0700 LEGAL DEER BY ARCHERY.

Antlerless deer and legal bucks may be taken by archery, except that in 1999, archery hunters may not take antlerless deer in those permit areas that have no antlerless permit quota or in those permit areas that have a quota of youth antlerless permits for firearms deer hunters under part 6232.1800, subpart 9.

#### 6232.0800 ARCHERY SPECIAL HUNT AREAS AND PROCEDURES.

[For text of subpart 1, see M.R.]

- Subp. 2. **Areas.** Special bow and arrow permits are valid in areas designated by the commissioner and published in the annual hunting regulations booklet. The following archery special hunt areas are established for the 1999 season:
- A. Crow-Hassan Park Reserve in Hennepin county is open November 12 to November 14 for taking antlerless deer and legal bucks. No more than 135 permits shall be issued. Management permits are available and up to three intensive harvest permits may be used by permittees to take deer. Applications must be sent to Hennepin Parks Bow Hunt, 3800 County Road 24, Maple Plain, MN 55359.
- B. Murphy-Hanrehan Park Reserve in Scott county is open November 12 to November 14 for taking antlerless deer and legal bucks. No more than 180 permits shall be issued. Management permits are available and up to three intensive harvest permits may be used by permittees to take deer. Applications must be sent to Hennepin Parks Bow Hunt, 3800 County Road 24, Maple Plain, MN 55359.
- C. Cleary Lake Regional Park in Scott county is open November 12 to November 14 for taking antlerless deer and legal bucks. No more than 55 permits shall be issued. Management permits are available and up to three intensive harvest permits may be used by permittees to take deer. Applications must be sent to Hennepin Parks Bow Hunt, 3800 County Road 24, Maple Plain, MN 55359.
- D. Portions of the city of New Ulm as shown on maps available from the city are open October 16 to December 31 for taking antlerless deer and legal bucks. No more than 50 permits shall be issued by the city of New Ulm. A regular archery license and an archery deer management permit must be purchased to qualify for the hunt. One intensive harvest permit may be used by permittees to take deer. Applications must be sent to New Ulm City Deer Hunt, City Manager's Office, 100 N. Broadway, New Ulm, MN 56073. The application deadline is August 28.
- E. Portions of the city of Red Wing as shown on maps available from the city are open September 18 to December 31 for taking antlerless deer. A proficiency test is required and hunters must wear back tags during the hunt. A regular archery license and an archery deer management permit must be purchased to qualify for the hunt. Up to three intensive harvest permits may be used by permittees to take deer. Applications must be submitted to City of Red Wing Deer Hunt, 315 West 4th Street, Red Wing, MN 55066.

#### 6232.1200 ARCHERY DEER MANAGEMENT PERMITS.

The purchase of an archery deer management permit is authorized for any person who has purchased and presents a valid archery deer license from the current year. Archery deer management permits may be purchased from county auditors' offices, the license bureau, and other authorized agents. The archery deer management permit authorizes taking an antierless deer in the following areas:

- A. special hunt areas by permittees where deer management permits are valid. In 1999, antlerless deer may be taken under an archery deer management permit in the Crow-Hassan Park Reserve, Murphy-Hanrehan Park Reserve, Cleary Lake Regional Park, City of New Ulm, and City of Red Wing archery special hunt areas; and
- B. designated antlerless permit areas, which consist of antlerless permit areas that the commissioner anticipates will be undersubscribed. In 1999, antlerless deer may be taken under an archery deer management permit in the following antlerless permit areas: 204, 209, 210, 223, 225, 227, 228, 236, 337, 339, 341, 342, 343, 345, 346, 347, 348, 349, 401, 402, 403, 404, 405, 406, 409, 410, 411, 412, 413, 414, 415, 416, 419, 421, 422, 423, 429, 431, 452, 461, 462, 465, and 466.

#### 6232.1250 TAKING DEER BY ARCHERY UNDER INTENSIVE HARVEST PERMITS.

[For text of subpart 1, see M.R.]

Subp. 2. **Restrictions.** Intensive harvest permits may be used to take antlerless deer only or antlerless deer and adult bucks in antlerless permit areas and special hunt areas prescribed by the commissioner.

#### Subp. 3. 1999 archery intensive harvest permit areas.

- A. Intensive harvest permits may be used to take up to three antlerless deer by archery in the following areas in 1999:
  - (1) antlerless permit areas 228 and 337; and
- (2) the Crow-Hassan Park Reserve, Murphy-Hanrehan Park Reserve, Cleary Lake Regional Park, and City of Red Wing archery special hunt areas.
  - B. Intensive harvest permits may be used to take one antlerless deer by archery in the City of New Ulm archery special hunt area.
- C. Intensive harvest permits may be used to take up to three legal bucks or antlerless deer in the Twin Cities Army ammunition plant.

#### 6232.1600 SPECIAL HUNT PROCEDURES.

[For text of subps 1 to 5, see M.R.]

- Subp. 6. 1999 special firearms hunt areas. The following firearms special hunt areas are authorized for the 1999 season:
- A. Rice Lake National Wildlife Refuge in Aitkin county is open November 13 to November 21 for taking antlerless deer and legal bucks. No more than 20 permits shall be issued to Zone 1 licensees. This is special hunt area 901.
- B. Saint Croix State Park in Pine county is open November 13 to November 14 for taking antlerless deer and legal bucks. No more than 650 permits shall be issued to Zone 1 licensees. Management permits may be available. This is special hunt area 902.
- C. Gooseberry Falls State Park in Lake county is open November 6 to November 21 for taking legal bucks. No more than 15 permits shall be issued to Zone 1 licensees. This is special hunt area 903.
- D. Split Rock Lighthouse State Park in Lake county is open November 6 to November 21 for taking legal bucks. No more than 15 permits shall be issued to Zone 1 licensees. This is special hunt area 904.
- E. Tettegouche State Park in Lake county is open November 6 to November 21 for taking antlerless deer and legal bucks. No more than 75 permits shall be issued to Zone 1 licensees. This is special hunt area 905.
- F. Afton State Park in Washington county is open November 13 to November 14 for taking antlerless deer and legal bucks. No more than 40 permits shall be issued to Zone 2 licensees. Management permits are available and up to three intensive harvest permits may be used to take a third, fourth, and fifth deer. This is special hunt area 906.

The accompanying adult may not hunt. No hunting license or waterfowl stamps are required.</u>

Subp. 2. Shooting hours. Shooting hours are one-half hour before sunrise to 4:00 p.m.

Subp. 3. Bag limits. The daily bag limit for ducks is six ducks, and may not include more than four mallards, of which not more than two may be female mallards; three greater or lesser scaup combined; one pintail; two wood ducks; two redheads; one black duck; and one canvasback. The daily bag limit for mergansers is five mergansers, of which no more than one may be a hooded merganser. The daily bag limit for coots and moorhens is 15 in combination. The daily bag limit for geese is one Canada goose, except in the West Zone, where the daily bag limit is five Canada geese.

#### 6240.0200 GENERAL RESTRICTIONS FOR TAKING AND POSSESSION OF MIGRATORY GAME BIRDS.

Subpart 1. Shooting hours. Shooting hours for migratory game birds are one-half hour before sunrise to sunset, except as follows:

A. on the opening day of the duck season October 2, shooting hours for all migratory game birds, except woodcock, are 12:00 noon to 4:00 p.m.; and

B. from the opening day of the migratory waterfowl season October 3 to the Friday nearest October 49 9, shooting hours end at 4:00 p.m.

#### 6240.0600 TAKING DUCKS, COOTS, AND MOORHENS.

Subpart 1. Open season. Ducks, coots, and moorhens may be taken statewide during the 60-day period from October 2 to November 30, 1999.

Subp. 2. Daily limits. A person may not in any one day take more than six ducks other than mergansers, five mergansers, and a total of 15 coots and moorhens. The daily limit of ducks other than mergansers may not include more than four mallards, of which not more than two may be female mallards; one black duck; one canvasback; two redheads; one pintail; three lesser or greater scaup; and two wood ducks. The daily limit of mergansers may not include more than one hooded merganser.

## <u>6240.0950</u> TAKING GEESE AND BRANT IN WEST, WEST CENTRAL, LAC QUI PARLE, AND NORTHWEST GOOSE ZONES.

<u>Subpart 1.</u> **Open season in West Goose Zone.** <u>Canada geese may be taken during the 40-day period from October 2 to November 10, 1999, except in the West Central Goose Zone and in the Lac qui Parle Goose Zone as provided in subparts 2 and 3.</u>

Subp. 2. Open season in West Central Goose Zone. Canada geese may be taken during the 30-day period from October 9 to November 7, 1999, except that the season may close earlier in the Lac qui Parle Goose Zone as provided in subpart 3.

- Subp. 3. Open season in Lac qui Parle Goose Zone. Geese and brant may be taken during the 30-day period from October 9 to November 7, 1999, except that the season on geese and brant shall be closed earlier than November 7, 1999, if and when the Canada goose harvest index reaches 16,000. The commissioner shall provide public notice of the closing no less than 48 hours prior to the effective time of closing by:
  - A. issuing a news release specifying the time of closing and describing the zone; and
- B. posting written notices of the closing at the headquarters of the Lac qui Parle Wildlife Management Area and at four other points around the perimeter of the zone.
- Subp. 4. Open season in Northwest Goose Zone. Canada geese may be taken during the 40-day period from October 2 to November 10, 1999.
- Subp. 5. Daily limit. A person may not take more than one Canada goose in the West, West Central, Lac qui Parle, and Northwest Goose Zones.

#### 6240.1000 TAKING GEESE IN SOUTHEAST GOOSE ZONE.

- Subpart 1. **Zone.** The Southeast Goose Zone is comprised of Isanti, Chisago, Washington, Anoka, Hennepin, Carver, Scott, Ramsey, Dakota, Rice, Goodhue, Wabasha, Winona, Olmsted, Dodge, Steele, Freeborn, Mower, Fillmore, and Houston counties: that part of the state within the following described boundaries: beginning at the intersection of U.S. Highway 52 and the south boundary of the Twin Cities Metro Canada Goose Zone; thence along U.S. Highway 52 to State Trunk Highway (STH) 57; thence along STH 57 to the municipal boundary of Kasson; thence along the municipal boundary of Kasson to County State Aid Highway (CSAH) 13, Dodge county; thence along CSAH 13 to STH 30; thence along STH 30 to U.S. Highway 63; thence along U.S. Highway 63 to the south boundary of the state; thence along the south and east boundaries of the state to the south boundary of the Twin Cities Metro Canada goose zone; thence along said boundary to the point of beginning.
- Subp. 2. Seasons. Canada and white fronted geese and brant may be taken during the 70-day period beginning the Saturday on or nearest October 1. In Olmsted County and in the Twin Cities Metropolitan Goose Zone, Canada geese may also be taken in the late season as provided in part 6240.1900, subpart 3.

#### 6240.1100 TAKING GEESE IN REMAINDER OF STATE.

- <u>Subpart 1.</u> **Zone and season.** The remainder of the state consists of all areas not within the <del>Southeast,</del> Northwest, and West Goose Zones. Canada <del>and white fronted</del> geese <del>and brant</del> may be taken during the 70-day period beginning the Saturday on or nearest October 1.
  - Subp. 2. Daily limit. A person may not take more than two Canada geese.

#### 6240.1150 TAKING SNOW, BLUE, AND ROSS', AND WHITE-FRONTED GEESE AND BRANT.

- <u>Subpart 1.</u> **Seasons.** Snow, blue, and Ross', and white-fronted geese and brant may be taken statewide during the 80-day period beginning the Saturday on or nearest October 1, except that the season in the Lac qui Parle Goose Zone will be closed when the season for Canada and white fronted geese is closed.
- <u>Subp. 2.</u> **Daily limit.** A person may not take more than ten snow, blue, and Ross' geese in combination; two white-fronted geese; and one brant.

#### 6240.1900 LATE SEASON FOR TAKING GEESE.

- Subpart 1. **Daily limit.** A person may not take more than two five Canada geese per day during the late season, except that no more than two Canada geese per day may be taken in the Southeast Goose Zone.
- Subp. 2. **Public roads.** Taking Canada geese from public roads and their rights-of-way is prohibited in the Twin Cities Metropolitan Metro Canada Goose Zone during the late season established by this part.
- Subp. 3. Seasons. Canada geese may be taken in the Twin Cities Metropolitan Canada Goose Zone and in Olmsted County from December 15 through December 24. Canada geese may be taken in the Fergus Falls/Alexandria Goose Zone during the ten-day period beginning the second Saturday in December statewide except in the West Central Goose Zone and the Lac qui Parle Goose Zone from December 11 to December 20, 1999. Taking Canada geese on or within 100 yards of all surface waters, excluding ice, is prohibited in the Twin Cities Metropolitan Metro Canada Goose Zone during the late season.
- <u>Subp. 4.</u> **Special Canada goose license required.** A special Canada goose season license is required for participation in the late season established in this part, as provided in *Minnesota Statutes*, section 97B.802.
- EFFECTIVE PERIOD. The emergency amendments to Minnesota Rules, parts 6240.0200, 6240.1000, 6240.1100, 6240.1150, and 6240.1900 expire December 31, 1999. After the emergency amendments expire, the permanent rules as they read prior to those amendments again take effect, except as they may be amended by permanent rule. Minnesota Rules, parts 6240.0600 and 6240.0950 expire December 31, 1999.

#### PROCEDURAL HISTORY

On July 20, 1999, Great River Energy (Great River) filed an application for a certificate of need to build a large electric generating facility, as defined in *Minnesota Statutes* § 216B.2421, subd. 2(a). The proposed project will include three gas-fired, simple cycle combustion turbines for Great River's peaking needs. The plant will be located in Pleasant Valley Township in Mower County, Minnesota.

Great River supplemented the application on August 5, 1999.

On August 6, 1999, the Commission issued an ORDER VARYING TIME DEADLINE. In that Order, the Commission explained that the 30-day review period provided in *Minnesota Rules*, part 7849.0200, subp. 5, would not allow sufficient time in this case to determine the adequacy of the filing. The Commission therefore varied *Minnesota Rules*, part 7849.0200, subp. 5, to extend the period for Commission action on the completeness of the application.

On August 19, 1999, the Commission met to consider this matter.<sup>1</sup>

#### FINDINGS AND CONCLUSIONS

#### I. JURISDICTION

The Commission has jurisdiction over applications for certificates of need for large energy facilities under *Minnesota Statutes* § 216B.243. The statute requires the Commission to hold at least one public hearing under the Administrative Procedure Act before acting on this or any other application for a certificate of need. *Minnesota Statutes* § 216B.243, subd. 4.

#### II. REFERRAL FOR CONTESTED CASE PROCEEDINGS

The Commission finds that it cannot satisfactorily resolve all issues raised by the Company's application on the basis of its filing and the single public hearing required under the statute. The Commission will therefore refer the matter to the Office of Administrative Hearings for contested case proceedings.

#### III. ISSUES TO BE ADDRESSED

*Minnesota Statutes* § 216B.243 and *Minnesota Rules*, parts 7849.0010-7849.0400, set forth criteria which must be met to establish need for proposed large energy facilities. Parties to this proceeding shall address whether the proposed facility meets these criteria.

#### IV. PUBLIC PARTICIPATION

*Minnesota Statutes* § 216B.243, subd. 4, encourages public participation in certificate of need proceedings. The statute requires at least one hearing to obtain public opinion on the application and requires the Commission to designate an employee to facilitate citizen participation in the hearing process.

#### Commissioner's Orders

Members of the public need not become formal parties to participate in the hearing process. They are encouraged to attend the public hearing(s) and to submit testimony and exhibits. Persons who cannot attend the public hearing(s) and wish to comment may submit written comments to the Administrative Law Judge. The Commission will require the Company to publish notice of the public and evidentiary hearings, in the form of visible display ads, in relevant newspapers of general circulation at least ten days prior to the start of the hearings. The applicant shall obtain proofs of publication of such ads from the newspapers selected, and shall consult with Commission Staff on the timing, text, and distribution of such ads prior to the publication.

#### V. PROCEDURAL OUTLINE

#### A. Administrative Law Judge

#### **B.** Hearing Procedure

Hearings in this matter will be conducted in accordance with the Administrative Procedure Act, *Minnesota Statutes* §§ 14.57-14.62; the rules of the Office of Administrative Hearings, *Minnesota Rules*, parts 1400.5100 to 1400.8400; and, to the extent that they are not superseded by those rules, the Commission's Rules of Practice and Procedure, *Minnesota Rules*, parts 7829.0100 to 7829.3200. Copies of these rules and statutes may be purchased from the Print Communications Division of the Department of Administration, 117 University Avenue, St. Paul, Minnesota 55155, 651-297-3000.

Under these rules parties may be represented by counsel, may appear on their own behalf, or may be represented by another person of their choice, unless otherwise prohibited as the unauthorized practice of law. They have the right to present evidence, conduct cross-examination, and make written and oral argument. Under *Minnesota Rules*, part 1400.7000, they may obtain subpoenas to compel the attendance of witnesses and the production of documents.

Any party intending to appear at the hearing must file a notice of appearance (Attachment A) with the Administrative Law Judge within 20 days of the date of this Notice and Order for Hearing. Failure to appear at the hearing may result in facts and issues being resolved against the party who fails to appear.

Parties should bring to the hearing all documents, records, and witnesses necessary to support their positions. They should take note that any material introduced into evidence may become public data unless a party objects and requests relief under *Minnesota Statutes* § 14.60, subd. 2.

Other persons wishing to become formal parties to this proceeding shall promptly file petitions to intervene with the Administrative Law Judge. They shall serve copies of such petitions on all current parties and on the Commission. *Minnesota Rules*, part 1400.6200.

#### **D.** Prehearing Conference

A prehearing conference will be held in this matter on Wednesday, September 22, 1999, at 9:30 A.M. in the Small Hearing Room at the Commission offices, 121 Seventh Place East, Suite 350, St. Paul, Minnesota 55101-2147.

Persons intending to intervene in the matter should attend the conference, prepared to discuss time frames and scheduling. Other matters which may be discussed include the locations and dates of public hearings, discovery procedures, and similar issues.

#### E. Time Constraints

Under *Minnesota Statutes* § 216B.243, subd. 5, the Commission is required to act on the Company's application within six months of receipt of a substantially complete filing. The Commission asks the Administrative Law Judge to conduct contested case proceedings in light of these time constraints. Parties should note the six-month statutory time frames at the outset and be prepared for the expedited hearing schedule that time frame requires.

#### F. Application of Lobbying Provisions

The lobbying provisions of the Ethics in Government Act, *Minnesota Statutes* §§ 10A.01 *et seq.*, apply to certificate of need proceedings. Persons appearing in this proceeding may be subject to registration, reporting, and other requirements set forth in that Act. All persons appearing in this case are urged to refer to the Act and to contact the Minnesota Ethical Practices Board, 651-296-1720, with any questions.

#### G. Ex Parte Communications

Restrictions on *ex parte* communications with Commissioners and reporting requirements regarding such communications with Commission staff apply to this proceeding from the date of this Order. - 3. The Department of Public Service shall initiate an investigation to determine the reasonableness of granting a certificate of need to the applicant. Great River shall facilitate the Department's investigation in every reasonable way.
- 4. At least one public hearing shall be held in this matter at a time and place determined by the Administrative Law Judge after consultation with the Commission.
- 5. All parties to this proceeding may serve information requests on any other party. Information requests shall be answered within ten days of receipt.
- 6. Great River shall publish notice of the public and evidentiary hearings, in the form of visible display ads, in relevant newspapers of general circulation at least ten days prior to the start of the hearings. The applicant shall obtain proofs of publication of such ads from the newspapers selected, and shall consult with Commission Staff on the timing, text, and distribution of such ads prior to publication.
- 7. This Order shall become effective immediately.

## REQUEST FOR COMMENTS on Planned Rules Governing Health Risk Values for Air Pollutants

**Subject of Rules.** The Minnesota Department of Health requests comments on its planned rules governing health risk values (HRVs) for air pollutants. The Department is considering rules that will provide uniform, science-based guidelines applicable to the general public exposed routinely to hazardous substances released into the environment. HRVs are concentrations of chemicals in air that are considered to produce no significant risk of harmful effects to humans when exposed to those concentrations over a specified time. The planned Health Risk Value rule originated from a need to have health-based concentrations of chemicals and substances which could be used for comparison with concentrations of contaminants emitted to air.

This notice supplements the Department of Health's previous "Notice of Solicitation of Outside Information" published in the *State Register* on September 5, 1995 (20 S.R. 443). The Notice is republished in order to meet the requirements of *Minnesota Statutes*, section 14.101.

**Persons Affected.** All persons living in Minnesota could potentially benefit from the planned rule but particularly individuals living in areas where there is already an air pollution concern or problem. The proposed rule may indirectly effect permitting of facilities or operations which could emit pollutants into the air. This effect is indirect because the planned rule does not include provisions to apply the HRVs to any public programs, public services or public parties. The application of the HRVs is undetermined at this time and will not be included in this rulemaking.

**Statutory Authority.** *Minnesota Statutes*, section 144.12, subdivision 1, item 14, authorizes the Department to adopt rules for developing health risk values for air contaminants:

Subdivision 1. Rules. The commissioner may adopt reasonable rules pursuant to chapter 14 for the preservation of the public health. The rules shall not conflict with the charter or ordinance of a city of the first class upon the same subject. The commissioner may control, by rule, by requiring the taking out of licenses or permits, or by other appropriate means, any of the following matters:

(14) Atmospheric pollution which may be injurious or detrimental to public health;

**Public Comment.** Interested persons or groups may submit comments or information on these planned rules in writing until further notice is published in the *State Register* that the Department intends to adopt or to withdraw the rules.

**Advisory Committee.** The Department developed the draft health risk value rule in consultation with a technical advisory committee convened specifically for this purpose. ## Public Hearing on Revised 2000-2005 Metropolitan Regional Parks Capital Improvement Program

The Metropolitan Council will hold a public hearing on October 4, 1999, on the Revised 2000-2005 Metropolitan Regional Parks Capital Improvement Program (CIP) as an amendment to the *Recreation Open Space Development Guide/Policy Plan*.

The revision to the CIP, contained in publication no. 78-99-034, is needed for the following reasons:

- 1. The Ventura administration will be proposing a bonding bill to the 2000 legislative session that recommends \$5 million for Metropolitan Regional Parks. The revised CIP proposes that amount in Part 1 of the 2000-2001 CIP to comply with the governor's bonding recommendation. This is matched with \$3.3 million of Metropolitan Council bonds. Part 2 of the 2000-2001 CIP proposes an additional \$6.2 million in state bonds beyond what is proposed in Part 1 to allow the legislature and the governor to consider appropriating more than \$5 million. The \$6.2 million would be matched with \$4.13 million of Metropolitan Council bonds. Finally, Part 3 proposes \$5 million of Environmental Trust Funds to be appropriated in 2001 and matched with \$3.3 million of Metropolitan Council bonds.
- The 1999 Legislature enacted a law that prohibits any more payments on a loan from the Minneapolis Community
  Development Agency to the Minneapolis Park and Recreation Board for acquisition and development of Central
  Mississippi Riverfront Regional Park. The revised CIP proposes that alternative Minneapolis Park and Recreation Board

projects be funded with the money initially proposed for the loan payments.

The revised CIP also includes the following information:

- 1. Prioritized lists of land acquisition, recreation facility redevelopment and recreation facility development capital improvements for the Metropolitan Regional Park System for the period 2000 to 2005. Policies from the *Recreation Open Space Development Guide/Policy Plan* that were used to evaluate and prioritize the capital improvements are included as well.
- 2. Proposed revenue sources to finance each capital improvement project including state bonds, Environmental Trust Fund appropriations and Metropolitan Council bonds.
- Policy statements used to determine what land acquisition costs will be financed with state and Council regional park acquisition funds.

The public hearing will be held *Monday, October 4, 1999, at 3:30 p.m.* in Conference Room 1-A at the Metropolitan Council offices, Mears Park Centre, 230 E. Fifth St., St. Paul. The proposed amendment may affect the standards for determining projects of metropolitan significance in the Metropolitan Significance Rules.
