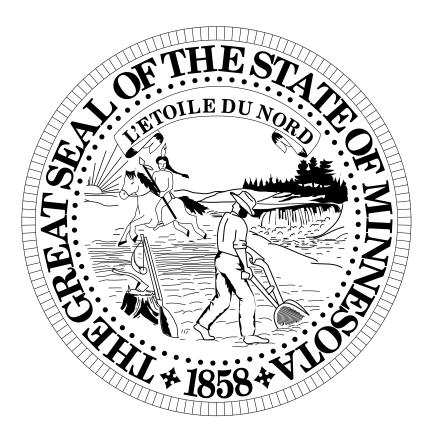

Minnesota Rules: Amendments and Additions =

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Revenue Notices

The Department of Revenue began issuing revenue notices in July of 1991. Revenue notices are statements of policy made by the department that provide interpretation, detail, or supplementary information concerning a particular statute, rule, or departmental practice. The authority to issue revenue notices is found in *Minnesota Statutes* § 270.0604.

Department of Revenue

Revenue Notice # 02-19: Solid Waste Management Tax - Waste Generated by Campus School Housing

This revenue notice deals with the solid waste management taxes under *Minnesota Statutes* chapter 297H and whether waste generated by school housing units, including dormitories and apartments, should be considered waste generated by a commercial generator or a residential generator.

The department's position is that waste generated by school housing units is commercially generated waste. This position is based upon the reference to "school" in the definition of commercial generator set forth in *Minnesota Statutes*, section 297H.01, subdivision 2.

The State of Minnesota announces the publication of the draft of the *Consolidated Annual Performance and Evaluation Report* (CAPER). The state will make this draft available for public review and will accept comments from the public beginning 8:00 a.m. on Monday, November 18, 2002, until 4:30 p.m., on Friday, December 6, 2002.

The state submits its CAPER to the U.S. Department of Housing and Urban Development as one of the conditions of receiving federal funds under these programs: Community Development Block Grants, HOME Investment Partnerships, Emergency Shelter Grants, and Housing Opportunities for Persons with AIDS. The CAPER provides information to measure the state's progress during the past year in meeting assistance goals and priorities identified in the *Consolidated Housing and Community Development*

Plan. The CAPER includes a summary and analysis of updates to the state's *Analysis of Impediments to Fair Housing*, identifying actions that state agencies have taken to affirmatively further fair housing and overcome impediments to fair housing. (The complete step-by-step updates are available in the 2002 Statewide Analysis of Impediments to Fair Housing Choice, available at the MHFA website address listed.)

REQUEST FOR COMMENTS on Possible Amendment to Rules Governing Payment Limitation for Hospitalization for Mental Health, *Minnesota Rules*, Part 9505.0323, Subpart 1, Item U and Subpart 14

Subject of Rules. The Minnesota Department of Human Services requests comments on its possible amendments to rules governing payment limitations for partial hospitalization for mental health. The Department is considering amending subpart 1, item U and repealing subpart 14. The proposed amendments will increase the number of available providers of partial hospitalization and eliminate the payment limitations in subpart 14.

Persons Affected. The rule amendments would affect such individuals and groups as programs governed by the rules and program participants; counties; and health plan and health insurance companies. The proposed amendments ameliorate disparities between private pay patients and Medicaid recipients and makes these medically necessary services immediately accessible to Medicaid recipients and expands the available providers to Medicare certified community mental health centers. Partial hospitalization providers will have incentive to provide appropriate services and will no longer be faced with either absorbing the cost of admitting Medicaid recipients or denying admission and referring Medicaid recipients to less appropriate services such as day treatment programs. By expanding the available providers to include Medicare certified community mental health centers, counties currently paying for partial hospitalization services to those entities will experience a reduction in costs and will make partial hospitalization services more locally available to individuals who would otherwise need to travel extensive distances to receive these services.

Statutory Authority. *Minnesota Statutes*, section 256E.05, subdivision 1a permits the commissioner to review requirements of social services rules and adopt amendments that would simplify or streamline administering the rules. *Minnesota Statutes*, section 256B.04, subdivision 2 authorizes the department to adopt rules to carry out and enforce the provisions of that chapter.

Public Comment. Interested persons or groups may submit comments or information on these possible rules in writing or orally until further notice is published in the *State Register* that the Department intends to adopt or to withdraw the rules. While the Department does not contemplate appointing an advisory committee to comment on the possible rules, it has informed providers about the proposed amendments and will continue to communicate with them and other interested parties throughout the rulemaking process.

Rules Drafts. The Department has prepared a draft of the possible rule amendments.

1995 Laws of Minnesota, Chapter 207, Article 7, Section 32 (hereinafter Minnesota Statutes Section 256B.434) authorized the Commissioner of the Department of Human Services to establish a contractual alternative payment system as an alternative way to pay for nursing facility services under the Medical Assistance (MA) Program. In order to implement this legislation, the Department established the "Nursing Home Contract Project." The purpose of the Project was to explore a contract-based reimbursement system as an alternative to the current cost-based system for reimbursement of nursing facility services under Minnesota Statutes Section 256B.431.

The 2000 Laws of Minnesota, Chapter 245, Article 3, Section 25 established the authority for the Commissioner to implement a performance-based contracting system to replace the current method of setting operating cost payment rates under sections 256B.431 and 256B.434 and Minnesota Rules, parts 9549.0010 to 9549.0080 to be effective July 1, 2001. 2001 First Special Session, Article 5, Section 35(d) states, Notwithstanding Minnesota Statutes, section 256B.435, the commissioner must not implement a performance-based contracting system for nursing facilities prior to July 1, 2003. The commissioner shall continue to reimburse nursing facilities under Minnesota Statutes, section 256B.431 or 256B.434, until otherwise directed by law. The commissioner will consider proposals from all nursing facilities that have payment rates established under section 256B.431. The commissioner may develop reasonable requirements which, in the judgment of the commissioner, are necessary to protect residents or ensure that the performance-based contracting system furthers the interests of the state of Minnesota. The nursing facility may be required to negotiate with the State any modifications to the proposal as required by the State to make the terms of the proposal more favorable to the State.

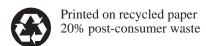
