# Minnesota Rules: Amendments and Additions =

#### NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the *Rulesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. # **Proposed Rules**

#### **Comments on Planned Rules or Amendments**

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rules Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* § § 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

#### Rules to be Adopted After a Hearing

After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rules. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record is then closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the report before taking any action.

#### Rules to be Adopted Without a Hearing

Pursuant to *Minnesota Statutes* § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rules** Amendments from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

#### Notice of Intent to Repeal Obsolete Rules

Proposed Repeal of Rules Governing County Agriculture Inspectors; Nursery Stock; Seed Containers; Organic Standards and Certifications; and Data Privacy; *Minnesota Rules*, 1505.0760, 1505.0770, 1505.0790, 1505.0800, 1510.0110, 1510.0130 - 1510.0150, 1555.0005 - 1555.0012, 1556.0200 - 1556.0227, and 1558.0040, subd. 5

**Introduction.** The Department of Agriculture intends to repeal obsolete rules following the procedures set forth in the Administrative Procedure Act, *Minnesota Statutes*, section 14.3895.

**Subject of Rules and Statutory Authority.** The proposed repeal is of obsolete rules that set standards for county agriculture inspectors, rose bushes, and care of nursery stock, set labeling requirements for seed, set standards for organic food and requirements for organic certification and set privacy requirements for data submitted in release permit applications for genetically engineered organisms. The statutory authority to repeal the rules is *Minnesota Statutes*, sections 18.48, subd. 2; 21.85, subd. 11; 31.94; 31.95; and 18F.12. A copy of the proposed repeal is published in the *State Register* and attached to this notice as mailed.

**Comments.** You have until 4:30 p.m. on May 2, 2003 to submit written comment in support of or in opposition to the proposed repeal or any part or subpart of the repeal. Your comment must be in writing and received by the agency contact person by the due date. Comment is encouraged. Your comment should identify the portion of the rule proposed for repeal involved and the reason for the comment. You are encouraged to propose that any part or subpart not be repealed. Any comments that you would like to make on the legality of the proposed repeal must also be made during this comment period

**Request for an Alternative Process.** If 25 or more people submit a written request, the agency will have to meet the requirements of sections 14.131 to 14.20 for rules adopted after a public hearing or the requirements of sections 14.22 to 14.28 for rules adopted without a public hearing, including preparation of a statement of need and reasonableness and the opportunity for a hearing. Your request must be in writing and be received by the agency contact person by 4:30 p.m. on, May 2, 2003. Your written request for an alternative process must include your name and address. You must identify the rule which you feel should not be repealed or state that you oppose the entire repeal. Any request that does not comply with these requirements is not valid and cannot be counted by the agency for determining whether an alternative process is necessary. You are also encouraged to state the reason for the request.

**Modifications.** The proposed repeal may be modified as a result of public comment. The modifications must be supported by comments and information submitted to the agency, but modifications can only alter which rules or parts are repealed. If the proposed repeal affects you in any way, you are encouraged to participate in the process.

# **Proposed Rules**=

Adoption and Review of Rules. If no alternative process is required, the agency may repeal the rules after the end of the comment period. The repealed rules and supporting documents will then be submitted to the Office of Administrative Hearings for review for legality. You may ask to be notified of the date the repeal is submitted to the office. If you want to be so notified, or want to receive a copy of the repealer, or want to register with the agency to receive notice of future rule proceedings, submit your request to the agency contact person listed above.

# **Expedited Emergency Rules**

Provisions exist for the Commissioners of some state agencies to adopt emergency expedited rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Emergency expedited rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions. Emergency expedited rules are effective for the period stated or up to 18 months. Specific *Minnesota Statutes* citations accompanying these emergency expedited rules detail the agency's rulemaking authority.

Subp. 5. Areas closed to hunting and trapping. The Boerner Wildlife Management Area in Sibley county, the Buelow Wildlife Management Area in Steele county, the Bryson Wildlife Management Area in Freeborn county, the Chapa Kay-Say-Za Wildlife Management Area in Steele county, and the Hutchinson Wildlife Management Area in McLeod county, and are closed to the hunting and trapping of all species. #### Health Care Purchasing and Delivery Systems Division, Health Care Administration Public Notice of the Maximum Allowable Costs of Medical Assistance Outpatient Prescribed Drugs

**NOTICE IS HEREBY GIVEN** to recipients, providers of services, and to the public of changes to the state Medical Assistance maximum allowable cost (state MAC) list for certain outpatient prescribed drugs.

At least once each calendar year, the United States Department of Health and Human Services, Centers for Medicare & Medicaid Services, publishes a federal upper limit (FUL) payment schedule for many commonly prescribed multiple-source drugs. The federal upper limit is set at a rate equal to 150 percent of the published price for the least costly therapeutic equivalent that can be purchased by pharmacists. This FUL payment schedule constitutes the federal MAC list. For many multiple-source drugs that are not on the federal MAC list, the Department establishes a state MAC list.

The Department requires Medical Assistance pharmacy providers to submit their usual and customary costs. Pharmacy providers are reimbursed at the lower of: the federal or state MAC, plus a dispensing fee; the submitted usual and customary charge to the general public; or a discount off of average wholesale price, plus a dispensing fee.

On February 7, 2003, pursuant to *Minnesota Statutes*, §16A.152, subdivision 4, the Governor balanced the State Fiscal Year 2003 budget. The Governor's action permits the Department to will impose a state MAC for many multiple-source drugs that are on the federal MAC list, as long as the savings are at least as much as the savings would be using the federal MAC list.

On January 13, 2003 at 27 SR 1117-1130, the Department published the MAC list, listing the federal and state MACs. On February 18, 2003 at 27 SR 1331-1334, the Department published changes to the state MAC list.

Effective March 4, 2003, the Department will implement changes to the state MAC list. The first table lists additions to this list and the second lists deletions. The tables should be read in conjunction with the two prior *State Register* notices.

The pharmacy unit also provides educational outreach, along with support for providers and agency staff.

There are two rebate programs administered by the Pharmacy Program staff: Federally mandated rebates from the manufacturers of drugs dispensed to Medicaid recipients and State mandated rebates from the manufacturers of drugs dispensed to Prescription Drug Program enrollees.

# Amended Request for Comments on Planned Rule Amendments to Minnesota Rules Chapters 7001 and 7035 Governing Solid Waste Management

In response to comments received from the October 29, 2001 Request for Comments Notice published in the *State Register* (CITE 26 SR 572), the Minnesota Pollution Control Agency (MPCA) has determined that additional rule amendments are needed than previously noticed. This notice is meant to clarify the proposed amendments the MPCA is considering and to request additional comment.

**Subject of Rules:** The MPCA is planning to amend parts of *Minnesota Rules* Chapters 7001 and 7035 that govern management of solid waste to address "beneficial use" of solid waste and demonstration/research projects. In addition, the MPCA will amend portions of Chapters 7001 and 7035 to eliminate inappropriate cross-references, clarify permitting requirements during site remediation and emergencies, establish protocols for characterization of waste, and make other miscellaneous changes necessary to update certain sections of existing rule.

The information that follows describes the areas of proposed rule modification the MPCA is considering during this rule revision and describes how you can provide input to the MPCA.

# Official Notices=

**Beneficial Use of Solid Waste:** The present rule is ambiguous in regard to the regulatory status of projects that involve utilization of solid wastes. The proposal being discussed would establish standards for storage prior to use, a list of beneficial uses that need no agency contact, and a procedure for obtaining MPCA approval for non-listed uses of solid wastes.

**Demonstration/Research Projects:** Present rules require persons who seek to demonstrate or test innovative solid waste management techniques to obtain variances or permit amendments. The MPCA is considering amending rules to allow demonstration and research of new technologies for solid waste management under enforceable agreements. The proposed rule will allow temporary non-compliance with rule standards for research/demonstration plans with commissioner approval of the research/demonstration plan and the signing of the enforceable agreement. Commissioner approval would be dependent on evidence that human health and the environment would be protected during the project and that federal standards would be met.

**General Changes:** The MPCA is considering using this rulemaking to make the following changes: amend rule citation error corrections; remove conflicts with new standards of demonstration/research projects and beneficial use of solid waste; create an exemption from solid waste permitting for remediation sites where waste would be managed under the auspices of MPCA cleanup programs; grant increased authority of the commissioner to suspend rule requirements during emergencies where large amounts of solid waste must be managed on an expedited basis (floods, tornadoes, etc.); and modify the provisions that allow sewage containing wastes to be disposed of in a land disposal facility.

**Persons Affected:** The rule amendments would primarily affect individuals and generators of solid wastes who are interested in beneficially using solid wastes. The rule would also affect parties such as owners and operators of land disposal facilities, and generators of solid wastes that are interested in conducting research or demonstration projects on so alternatives for solid waste management that are not currently being used. The rule may also affect local units of government that regulate management of solid wastes in some situations.

**Statutory Authority:** *Minnesota Statutes*, section 116.07 authorizes the MPCA to adopt standards for the control of the collection, transportation, storage, processing, and disposal of solid waste.

**Rule Revision Timeline:** At this time, the MPCA intends to publish the proposed rule amendments in April of 2003. The planned completion date for the rule is July 2003. The MPCA has been working with stakeholders to obtain input prior to drafting the rule. Information on how stakeholders have been involved and minutes from meetings of the solid waste utilization advisory group can be found on the web site cited below or by contacting the MPCA.

**Public Comment:** Affected, interested persons or groups may submit comments or information on this planned rulemaking in writing or orally until 4:30 p.m. on May 2nd 2003.

Rules Drafts: The MPCA has not yet prepared a draft of the possible rule amendments.

If you submitted comments during the development of the rules and you want to ensure that the Administrative Law Judge reviews the comments, you should resubmit the comments after the rules are formally proposed.
