Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Executive Orders

The governor has the authority to issue written statements or orders, called Executive Orders. as well as Emergency Executive Orders. The governor's authority is specified in the *Constitution of the State of Minnesota*, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

Office of the Governor

Emergency Executive Order # 08-07: Providing for Relief from Regulations to Certain Motor Carriers and Drivers Operating in Minnesota

I, TIM PAWLENTY, GOVERNOR OF THE STATE OF MINNESOTA, by virtue of the authority vested in me by the Constitution and applicable laws do hereby issue this emergency executive order:

WHEREAS, the seasonal load restrictions as described in *Minnesota Statutes* 2006, Section 169.87, Subdivision 2 are in effect in the South, Southeast, Metro, Central, North Central and North frost zones of the state; and

WHEREAS, many vehicles used to transport heating fuel exceed the weight permitted under the seasonal load restrictions even when empty; and

WHEREAS, the winter and spring season have been colder than in recent years; and

WHEREAS, temperatures continue to require heating and, without the ability to receive timely and efficient delivery of heating fuels, businesses and homeowners are in danger of running out of necessary heating fuels; and

WHEREAS, current statute recognizes permanent exemptions from the seasonal load restrictions for school buses, milk carriers, utility vehicles, garbage and recycling vehicles.

NOW, THEREFORE, I hereby order that an emergency condition exists and order that:

- 1. Vehicles used to transport fuels commonly used for heating are exempted from the seasonal load restrictions on local and state highways and streets imposed under *Minnesota Statutes* 2006, Section 169.87.
- 2. Motor carriers must abide by all other posted road restrictions or laws governing gross weight including, but not limited to, the gross weight limits set forth in *Minnesota Statutes* 2006, Sections 169.823 and 169.824.

Pursuant to *Minnesota Statutes* 2006, Section 4.035, Subdivision 2, this Order is effective immediately and shall remain in effect until June 1, 2008, or the Commissioner of Transportation's removal of spring load restrictions, whichever is earlier.

Commissioner's Scientific and Natural Area Order # 187: Cottonwood River Prairie Scientific and Natural Area; Superseding Scientific and Natural Area Order # 165

WHEREAS, certain lands in Brown County, Minnesota, described as:

The Northwest Quarter (NW 1/4) of Section 31, Township 109 North, Range 35)West, EXCEPTING THEREFROM the existing right-of-way of the Dakota, Minnesota and Eastern Railroad Corporation (formerly the Winona and St. Peter Railroad Company right-of-way) as the same is now located across said premises; and EXCEPTING also Lot 1 of said Northwest Quarter, Section 31, more particularly described as follows:

Beginning at the northwest corner of Section 31, Township 109, Range 35; thence East along the north line of said Section a distance of 907.0 feet; thence South parallel with west line of said Section a distance of 212.3 feet to the North right-of-way of the C. & N.W.R.R.; thence in a northwesterly direction along the said right-of-way line a distance of 912.3 feet to the west line of said Section, thence North 93.1 feet to the place of beginning.

ALSO, all that part of the Northeast Quarter (NE 1/4) of Section 31, Township 109 North, Range 35 West, which lies south of the right-of-way of the Dakota, Minnesota and Eastern Railroad Corporation (formerly the Winona and St. Peter Railroad Co. right-of-way) and northerly of the line drawn parallel with and 100 feet distant southerly from the center line of the Dakota, Minnesota and Eastern Railroad Corporation (formerly the Minnesota and Iowa Railway Co. right-of-way).

ALSO, a strip, belt or piece of land 200 feet wide, being 100 feet wide on each side of the center line of the Dakota, Minnesota and Eastern Railroad Corporation (formerly the Minnesota and Iowa Railway Co. right-of-way) as the same is located over and across the Northwest Quarter (NW 1/4) and the Northeast Quarter of the Southwest Quarter (NE 1/4-SW 1/4) of Section 32, Township 109 North, Range 35 West.

ALSO, a strip, belt or piece of land 100 feet wide, being 50 feet wide on each side of the center line of the Dakota, Minnesota and Eastern Railroad Corporation (formerly the Winona and St. Peter Railroad Company right-of-way) extending across the following described tract of land:

The Southeast Quarter (SE 1/4) of Section 32, Township109 North, Range 35 West, the center line of which said strip intersects the west line of said Southwest Quarter of said Section 32 at a point 3123 feet South of the northwest corner of the Northeast Quarter of said Section 32 and intersects the east line of said Section 32 at a point 312.5 feet North of the southeast corner of said Section 32.

ALSO, two additional strips of land 50 feet in width of each side of and adjoining said original 100-foot strip on said Southeast Quarter of said Section 32. The East ends of which said additional strip of land is bounded by a straight line which intersects the center line of said original strip of land at a point 1200 feet in a southeasterly direction distant from the point where the center line of said 100 foot strip intersects the west line of said Southeast Quarter of Section 32, said additional 50 foot strip extending along on each side of the adjoining said 100 foot strip of said Southeast Quarter of Section 32.

ALSO, that part of the Southwest Quarter (SW 1/4) and the Southwest Quarter of the Southeast Quarter (SW 1/4 SE 1/4) of Section 33, Township 109 North, Range 35 West, described as follows:

Beginning at the southwest corner of said Southwest Quarter, thence on a bearing based on the Brown County Coordinate System of 1983, of North 00° 50′ 02″ East along the west line of said Southwest Quarter 2057.49 feet; thence South 89° 59′ 04″ East 2586.98 feet; thence South 00° 00′ 56″ West 1526.57 feet; thence South 89° 59′ 04″ East 334.16 feet; thence South 00° 00′ 56″ West 536.42 feet to the south line of said Southwest Quarter of the Southeast Quarter; thence North 89° 52′ 53″ West along said south line 310.42 feet to the southwest corner thereof; thence North 89° 52′ 22″ West along the south line of said Southwest Quarter 2640.11 feet to the point of beginning; EXCEPTING THEREFROM the right-of-way line of the Dakota, Minnesota and Eastern Railroad.

ALSO, that part of the Northeast Quarter of the Northeast Quarter (NE 1/4 NE 1/4) of Section 5, 108 North, Range 35 West lying north of the center of Mound Creek.

ALSO that part of the Northwest Quarter of the Northwest Quarter (NW 1/4 NW 1/4) of Section 4, Township 108 North, Range 35 West lying north of the center of Mound Creek and northerly and westerly of the centerline of County State Aid Highway #2 as it currently exists as shown on Brown County Highway Department Project No. S.A.P. 09-602-12, April 2002.

Containing 332.6 acres, more or less, is under the control and possession of the Department of Natural Resources; and

WHEREAS, such lands contain high quality dry hill prairie and the threatened plant species *Lespedeza leptostachya* (prairie bush clover); and

WHEREAS, the most effective means by which such lands can be protected and perpetuated in their natural state and used for educational and research purposes in such a manner as will leave them conserved for future generations is by designation as a Scientific and Natural Area;

NOW THEREFORE, I, Mark Holsten, Commissioner of Natural Resources, pursuant to authority vested in me by *Minnesota Statutes* §§ 84.033, 86A.05, subd. 5, 97A.093 and other applicable laws, do hereby designate the above-described lands as the Cottonwood River Prairie Scientific and Natural Area.

FURTHERMORE, the Cottonwood River Prairie Scientific and Natural Area is designated as a Public Use unit, open to the public for nature observation and general educational and research activities.

IT IS FURTHER ORDERED that Scientific and Natural Area Order no. 165 is hereby superseded.

IT IS FURTHER ORDERED that the provisions of *Minnesota Rules* 6136.0100 through 6136.0600 shall apply to the above-designated area.

A copy of this order shall be filed with the Secretary of State.

Classification of the Crow Wing State Forest, Emily State Forest, and Other State Forest Lands in Crow Wing County, Minnesota with Respect to Motor Vehicle Use

NOTICE IS HEREBY GIVEN that the Commissioner of Natural Resources orders the classification of the Crow Wing State Forest and the Emily State Forest in Crow Wing County as 'limited' with respect to motor vehicle use. The commissioner also orders classification of other parcels of state forest land described in this order as either "limited" or "closed" with respect to motor vehicle use. These classifications of state forest lands with respect to motor vehicle use are pursuant to Minnesota Laws 2003, Chapter 128, Article 1, Section 167, (as amended in 2005 and 2007) and Minnesota Rules Chapter 6100.1950.

WHEREAS

- 1. *Minnesota Laws 2003*, Chapter 128, Article 1, Section 167, (as amended in 2005 and 2007) and *Minnesota Rules* Chapter 6100.1950 require the Commissioner of Natural Resources to classify all state forest lands with respect to motor vehicle use.
- 2. The Department of Natural Resources published its proposed motor vehicle use classification and forest road and trail designations for state forest lands in Crow Wing County in a draft plan in April 2007.
 - 3. All notice and procedural requirements in *Minnesota Statutes*, and other applicable laws and rules have been met.


NOW THEREFORE, IT IS ORDERED that approximately 23,005 acres of state forest land including the Crow Wing State Forest, the Emily State Forest, and other state forest lands under the authority of the commissioner in Crow Wing County be classified as 'limited' with respect to motor vehicle use, pursuant to authority vested in me by Minnesota law. These state forest lands are depicted as 'limited' on the map in *Exhibit A*, attached hereto and incorporated herein.

IT IS FURTHER ORDERED that approximately 877 acres of state forest lands lands under the authority of the commissioner in Crow Wing County be classified as "*closed*" with respect to motor vehicle use, pursuant to authority vested in me by Minnesota law. These state forest lands are depicted as '*closed*' on the map in *Exhibit A*, attached hereto and incorporated herein.

IT IS FURTHER ORDERED that the above motor vehicle use classifications shall become effective December 31, 2008.





NOW THEREFORE, IT IS ORDERED that the forest trails described below are hereby designated pursuant to authority vested in me by Minnesota law:



IT IS FURTHER ORDERED that these trail designations shall become effective December 31, 2008.




