

Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Expedited Emergency Rules

Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the State Register, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

Minnesota Department of Natural Resources (DNR) Adopted Expedited Emergency Game and Fish Rules: Fall Wild Turkey Hunting; Prairie Chicken Hunting

NOTICE IS HEREBY GIVEN that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rule is *Minnesota Statutes*, sections 97A.434, 97A.435, 97B.711 and 97B.716.

The conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are that population and harvest data needed for setting quotas and areas are only available on an annual basis. Rule changes related to the elimination of the lottery for fall turkey licenses are in response to consistently undersubscribed permit areas. Permit area boundary changes for both fall turkey and prairie chicken are intended to provide additional hunting opportunities and to better reflect hunter preference.

6236.0300 TURKEY HUNT DRAWING.

Subpart 1. Spring license application drawings.

A. Applications for ~~all~~ spring hunts must be made according to this part and according to application instructions provided by the commissioner. Each person must apply at an electronic license system agent or the Department of Natural Resources License Center. Drawings will be conducted by the department to determine persons who will be eligible to purchase licenses for each season. The drawings will be subject to the quotas established by the commissioner. Preference in the respective drawings is given to applicants based upon the number of times they have correctly applied for a license for that hunt but have been unsuccessful. A person selected by the drawings is eligible to purchase a license to hunt turkey. Upon issuance of a turkey license for the spring ~~or fall~~ season, all accumulated preference for that season is lost, except as provided in subpart 6.

B. No application is needed to purchase a fall turkey license.

Subp. 2. **Participation in application drawings.** Applicants ~~may complete an application for either the spring or fall turkey hunt or both.~~ A person may not apply more than once for a hunt, whether as an individual or as a member of a group. Qualifying individuals may apply for the resident landowner-tenant turkey drawing. All of the information in items A to H must be supplied on the application forms.

(1) ~~deadline for the spring season: the second is the first Friday in January; and~~

(2) ~~fall season: the last Friday in July~~ December.

Expedited Emergency Rules

6236.0400 OBTAINING LICENSE.

A. The following provisions apply to persons who have applied for a turkey license:

A:

(1) Only successful applicants will be notified.

B:

(2) Successful applicants will receive a license application with instructions for obtaining their licenses. Persons who do not return the license application and the fee according to the provisions specified on the license application or who do not provide all the requested information will be disqualified.

B. Persons may purchase fall turkey licenses without an application. A turkey permit area must be selected.

6236.0700 FALL TURKEY SEASON.

Subp. 4. **Open areas.** Wild turkey permit areas are open for the fall turkey season as prescribed by the commissioner. Turkey licenses are valid for taking turkeys only in the wild turkey permit area specified on the license. The following wild turkey permit areas are open for the 2013 fall season: 501, 502, 503, 504, 505, 506, 507, 508, 509, 510, 511, and 512.

6236.0810 WILD TURKEY PERMIT AREA DESCRIPTIONS.

Subpart 1. Designations. Wild turkey permit areas are ~~comprised of registration blocks with the same numbers, as established in part 6232.4700, except as follows: designated and described by the permit area numbers and boundary descriptions in this part.~~

A: ~~wild turkey permit area 425 consists of registration blocks 425 and 435;~~

B: ~~wild turkey permit area 451 consists of registration blocks 451, 452, and 453; and~~

C: ~~wild turkey permit area 454 consists of registration blocks 454 and 455.~~

Subp. 2. Permit area 501. Wild turkey permit area 501 consists of that portion of the state lying within the following described boundary:

Only one legal buck may be taken during this hunt and in the state per year. An adult mentor age 18 or older authorized by the youth's parent or guardian must accompany the youth hunter at all times during the hunt. The accompanying adult may not hunt. Party hunting is not allowed. The blaze orange requirements in *Minnesota Statutes*, section 97B.071, paragraph (a), apply to all hunters and trappers, and all adult mentors of youth hunters, in the areas open to firearms deer hunting during the youth special seasons established in this part.

For 2013, permit areas 101, 105, 111, 114, 201, 203, 208, 209, 256, 257, 260, 263, 264, 267, 268, 338, 339, 341, 343, 344, 345, 346, 347, 348, 349, 601, and 602 are open October 17 to 20 for taking either sex deer by firearms for youth who are at least age ten and under age 16 at the time of the hunt. Whitewater Game Refuge is open for taking either sex deer by eligible youth. One bonus permit may be used, but a hunter may not take more than one deer. Only one legal buck may be taken during this hunt.

Subp. 3. Special archery season. Sand Prairie Wildlife Management Area in Stearns County is open during the regular archery season for youth ages ten to 17. The bag limit is one. The youth archery season is closed from November 9 to 17, when a special deer hunt for disabled individuals will be held on the wildlife management area. The bag limit is one deer.

EFFECTIVE PERIOD. The emergency amendments to *Minnesota Rules*, parts 6232.0900, 6232.2550, and 6232.2560, expire December 31, 2013. After the emergency amendments expire, the permanent rules as they read prior to those amendments again take effect, except as they may be amended by permanent rule.

Executive Orders

The governor has the authority to issue written statements or orders, called Executive Orders, as well as Emergency Executive Orders. The governor's authority is specified in the *Constitution of the State of Minnesota*, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

Office of the Governor

Emergency Executive Order 13-08: Declaring an Emergency and Providing for Relief from Regulations to Motor Carriers and Drivers Operating in the State of Minnesota

I, **MARK DAYTON, GOVERNOR OF THE STATE OF MINNESOTA**, by virtue of the authority vested in me by the Constitution and applicable statutes, do hereby issue this Executive Order:

WHEREAS, the recent severe storms in Minnesota has resulted in widespread power outages which threaten life and property within the state; and

WHEREAS, emergency assistance of motor carriers and drivers is needed to provide utility support, and to transport utility service vehicles and materials from other states; and

WHEREAS, to further relief efforts and to recover from the storms, carriers and drivers or commercial motor vehicles require waivers of federal and state regulations; and

NOW, THEREFORE, I hereby declare that:

1. An emergency exists in Minnesota that requires relief from regulations incorporated in *Minnesota Statutes*, section 221.0314, subdivision 9, pertaining to hours of service for carriers and drivers of commercial motor vehicles providing direct assistance in emergency relief efforts.
2. Nothing in this order relieves motor carriers and drivers from regulations pertaining to driver qualifications; driving of commercial motor vehicles; commercial drivers' licenses; drug and alcohol testing for drivers; or equipment, parts, and accessories necessary for the safe operation of vehicles.
3. No motor carrier operating under terms of this emergency order shall require or allow an ill or fatigued driver to operate a commercial motor vehicle. Any driver who informs a carrier that he or she needs immediate rest shall be given at least ten consecutive off-duty hours before the driver is required to return to service.
4. Upon the expiration of this emergency order, or when a driver or carrier ceases to provide direct assistance to the emergency relief effort, a driver that has had at least thirty-four consecutive hours off-duty must be permitted to start his or her on-duty status hours and 60/70-hour clock at zero.

Pursuant to *Minnesota Statutes*, section 4.035, subdivision 2, this Emergency Executive Order is effective immediately and must be filed with the Secretary of State and published in the *State Register* as soon as possible after its issuance. This order providing emergency relief from regulations for motor carriers and drivers providing direct assistance to emergency relief efforts shall remain in effect for the duration of the motor carrier or driver's direct assistance in providing emergency relief or 30 days, whichever is less.

Minnesota Pollution Control Agency (MPCA) Remediation Division Notice of Proposed Update of the State Superfund Priority List (Superfund List) (also known as the Permanent List of Priorities (PLP)) Among Releases or Threatened Releases of Hazardous Substances or Pollutants or Contaminants

NOTICE IS HEREBY GIVEN that the Minnesota Pollution Control Agency (MPCA) is publishing for public comment proposed additions to and deletions from the State Superfund List which lists releases or threatened releases of hazardous substances, pollutants, or contaminants for which the MPCA may take removal or remedial actions under the Minnesota Environmental Response and Liability Act (MERLA), *Minnesota Statutes* §§ 115B01-115B.20.

Pursuant to *Minnesota Statutes* § 115B.17 (2012) and *Minnesota Rules* 7044.0950 (2010), the MPCA is proposing the following changes to the Superfund List.

The MPCA is proposing to delete the following two sites (Sites) from the State Superfund List: Former Northwest Refinery, New Brighton, Anoka County; and Kennedy Building Site, Minneapolis, Hennepin County.

The MPCA has determined that either all MERLA Response Actions have been completed at these Sites; or that the sites do not pose a threat to public health or welfare or the environment. If necessary, appropriate institutional controls as determined by the MPCA will be in place prior to final deletion from the PLP. In both cases, all appropriate MERLA response actions have been completed and/or long term monitoring indicates that each Site does not pose a threat to public health or welfare or the environment.

The Northwest Refinery Site was listed on the State Superfund List in 1986. The approximately 20-acre site is currently owned by the city of New Brighton. From 1941 until the early 1960s, Northwest Refinery and other companies leased the land and operated a refinery on the site. In 1964 the refinery was shut down and in 1967, it was demolished. In 1970 Ashland acquired the Northwest Refinery Company and their refinery in St. Paul Park, along with other various assets.

Ashland never operated the refinery on the New Brighton Site. Numerous environmental investigations (1998 - 2007) have been conducted on the 20-acre Northwest Refinery property and the nature and extent of the soil and groundwater impacts have been determined. The Site was found to be contaminated with petroleum. The petroleum impacts are related to releases associated with the former refinery. MPCA staff determined that petroleum impacts should be remediated under *Minnesota Statutes* 115C (Petroleum Remediation Program). On April 15, 2011, Ashland and the MPCA entered into a Compliance Agreement which includes provisions for detailed work plans to remediate the Site. The Compliance Agreement provided the terms and conditions for the MPCA's Petroleum Remediation Program to oversee remediation and enforcement for petroleum releases to water and soil at the Site.

A Superfund Consent Order, which was first signed in May 2000, was terminated on April 15, 2011. The termination was granted as all required work under the Superfund Consent Order was complete and additional remediation of the Site would be completed under the Compliance Agreement signed by Ashland and the MPCA on April 15, 2011. Ashland began remediation of the 20 acre parcel on November 7, 2011 and finished the excavation on February 2, 2012. The following amounts of soil and material were part of Site excavation and remediation activities:

- 1,627.73 tons of refinery waste and debris (piping, tanks, and various metals) were removed and sent to an approved disposal facility.
- 66,631 cubic yards of soil excavated, of which 37,475 cubic yards were sent to an approved disposal facility. The remaining-29,156 cubic yards were used onsite as approved backfill after being assessed using MPCA screening criteria.
- 51,812 tons of clean soil was imported to the Site for backfill purposes.
- Soil excavation occurred at various depths throughout the Site ranging to approximately 12 feet below the ground surface.

Soil volume excavated at the Site exceeded expectations in part due to low groundwater levels at the time of excavation. This allowed for a deeper excavation than expected under normal groundwater level conditions. MERLA contaminants were removed by the extensive excavation. Remaining impacts beneath the groundwater table will be subject to natural attenuation. A groundwater monitoring program was implemented during the spring of 2013 by Ashland. The MPCA's Petroleum Remediation Program will oversee the monitoring.

The Kennedy Building Site is located within an industrial and commercial area in northeast Minneapolis, Minnesota. The Site consists of a five-story building, plus a basement, and occupies approximately 65,200 square feet on a 0.9 acre parcel. The portion of the Site not occupied by the building consists of asphalt-paved parking and driving areas.

Westinghouse Electric Corporation (WEC) owned and operated the property known as the KBA Site from approximately 1925 to 1980. During the period in which it owned the property, WEC operated its business at the KBA Site. Among the operations conducted by WEC upon portions of the KBA Site were construction of switchboard motors and generators, the repair of electrical transformers, including transformers with fluids containing Polychlorinated Biphenyls (PCBs). On February 1, 1980, WEC conveyed the KBA Site to Hillcrest Development, Incorporated. Kennedy Building Associates is the current owner of the property and has subdivided the building for multi-tenant leasing purposes. Investigations showed contaminants of concern found in the soil and groundwater at the Site included PCBs, volatile organic compounds and dioxins.

A Minnesota Decision Document (MDD) was signed on April 20, 2005 by the MPCA Commissioner which called for removal of PCB impacted soil to a depth of 12 feet below grade located outside the KBA building footprint. Impacted soil was not remediated below the building slab. Groundwater was required to be monitored to ascertain plume stability for a period of five years.

While the MDD did not specifically address remediation of contaminated soils under the KBA building, if the KBA building is demolished at some future time, or future building maintenance, repair, or improvement require removal of a portion of the floor, which exposes soil that is currently classified as "remotely accessible," the Responsible Party (RP) will be required to remediate the exposed soil

in accordance with an MPCA-approved Response Action Plan (RAP). The RP acknowledges and contemplates future additional remedial action in the RAP and states it will remediate soils to Tier 1 soil reference values to 12 feet below ground surface.

Soil response actions were completed in December 2006, with required groundwater monitoring activities completed in September 2011. Kennedy Building Associates has filed an Affidavit Concerning Real Property Contaminated with Hazardous Substances. Pursuant to the Affidavit, any person who is planning any use or activity that may disturb soil and groundwater at the Property is required to contact the MPCA prior to commencement of the planned activities.

The MPCA is proposing to add the following two sites to the State Superfund List (Hazard Ranking Score assigned pursuant to *Minnesota Rules* 7044.0350 follows the Site): Poplar Hill Solvent Plume Site, Hibbing, St. Louis County (6) and Main Street Solvent Plume Site, Biwabik, St. Louis County (2). These two sites are being proposed for addition to the State Superfund List as in each case, State Superfund resources will likely be necessary to complete appropriate response actions. Each site has been assigned to Response Action Classes C and D (see *Minnesota Rules* 7044.0450). The four response action classes are defined as follows: Class A - Declared Emergency; Class B - Response Actions Completed and Operation and Maintenance/Long-Term Monitoring Ongoing; Class C - Response Actions Necessary or in Progress or First Year Operation and Maintenance at a Site; and Class D - Remedial Investigations and Feasibility Studies Necessary or in Progress.

The MPCA invite members of the public to submit written comments on the proposed additions to and/or deletions from the State Superfund List. All written comments with regard to these proposed changes to the Superfund List must be received no later than 4:30 p.m. on July 31, 2013.
