

Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Expedited Emergency Rules

Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the State Register, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

Minnesota Department of Natural Resources (DNR) Adopted Expedited Emergency Game and Fish Rules: 2015 Beaver Season Extension

NOTICE IS HEREBY GIVEN that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rule is *Minnesota Statutes*, sections 97B.605.

The conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are that the beaver season is being extended in the northern region at the request of county officials seeking to reduce the cost of problem beaver control.

6234.1900 TAKING BEAVER.

[For text of subps 1 and 2, see 39 SR 172]

Subp. 3. **Beaver season extension in North Zone.** Beaver may be taken and possessed without limit from May 1 to May 15 under the following conditions in that portion of the state described in part 6234.1000, subpart 3:

A. foothold traps must be set in at least eight inches of water;

B. body-gripping traps must be completely submerged as described in part 6234.0900, subpart 5. Body-gripping traps with a jaw opening greater than 7.5 inches must be set with the trigger wires moved all the way to one side of the trap; and

C. snares must be set with stops affixed to the cable to ensure that the portion of the snare that makes up the noose loop may not be less than four inches in diameter when fully closed.

EFFECTIVE PERIOD. *Minnesota Rules*, part 6234.1900, subpart 3, expires December 31, 2015.

Minnesota Department of Natural Resources (DNR)

Adopted Expedited Emergency Game and Fish Rules: Lynx Management Zone

NOTICE IS HEREBY GIVEN that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rule is *Minnesota Statutes*, sections 97A.045, 97B.605. The emergency conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are as follows: Rule changes are made to comply with a federal court order that directs the Minnesota DNR to implement regulatory and programmatic changes to restrict, modify, or eliminate the incidental taking of Canada Lynx through trapping activities in the core Canada Lynx ranges.

The federal court order remains in effect until the U.S. Fish and Wildlife Service issues an incidental take permit, which could require further changes to lynx rules. The 18-month effective time of rules under *Minnesota Statutes* 84.027 subdivision 13(b) best accommodates the incidental take permit process. Once the incidental take permit is finalized, the DNR will begin a permanent rulemaking process.

6234.1000 DESCRIPTION OF FURBEARER ZONES.

[For text of subps 1 to 4, see M.R.]

Subp. 5. **Lynx Management Zone.** That portion of the state lying north and east of a line beginning at U.S. Highway 53 at the east boundary of the state, thence along U.S. Highway 53 to the north boundary of the state, is known as the Lynx Management Zone.

6234.2200 USE OF TRAPS.

[For text of subps 1 to 5, see M.R.]

Subp. 5a. **Body-gripping traps; Lynx Management Zone.** In the Lynx Management Zone, a person may not set, place, or operate, except as a waterset, any body-gripping trap that has a maximum jaw opening, when set, of greater than five inches and less than 7-1/2 inches measured from the inside edges of the body-gripping portions of the jaws, unless the trap is set:

A. at least three feet above the ground or snow level in a tree;

B. at least three feet above the ground or snow level on a leaning pole six inches or less in diameter; or

C. in a cubby box recessed at least seven inches from the box opening, which must be less than 50 square inches in opening size. A cubby box may be constructed of any material, but must be constructed and set in a manner that allows an animal to enter only through the cubby box opening.

[For text of subps 6 to 12, see M.R.]

Subp. 13. **Trap staking and tethering; Lynx Management Zone.** In the Lynx Management Zone, except for watersets, all traps must be staked or otherwise secured by tethering chains or cables not more than 18 inches long, in a manner that prevents captured animals from removing the trap from the trap site.

Subp. 14. **Trap tether swivels; Lynx Management Zone.** In the Lynx Management Zone, except for watersets, all leghold traps must have two or more swivels in the tethering chain or cable.

Subp. 15. **Bait restrictions; Lynx Management Zone.** In the Lynx Management Zone, the use of fresh meat, rabbits or hares, or parts of rabbits or hares is prohibited. Other meat may be used as bait if it has been unfrozen and exposed to air for at least 24 hours before being placed in a trap.

Subp. 16. **Sight attractant restrictions; Lynx Management Zone.** In the Lynx Management Zone, the use of suspended flags or other sight attractants within 20 feet of a trap is prohibited.

Expedited Emergency Rules

6234.2400 SPECIAL RESTRICTIONS ON USE OF SNARES.

[For text of subps 1 to 7, see M.R.]

Subp. 8. **Snare loop diameter.** The diameter of a snare loop may not exceed ten inches. In the Lynx Management Zone, the diameter of a snare loop must be at least eight inches when set on land.

Subp. 9. **Snare cable diameter.** Snare cable or wire may not exceed one-eighth inch in diameter. In the Lynx Management Zone, snare cable or wire must be at least 5/64 inch in diameter when set on land.

EFFECTIVE PERIOD. The expedited emergency amendments to *Minnesota Rules*, parts 6234.1000; 6234.2200; and 6234.2400, are effective May 26, 2015.

Minnesota Department of Natural Resources (DNR) Adopted Expedited Emergency Game and Fish Rules: Mille Lacs Lake Fishing Regulations

NOTICE IS HEREBY GIVEN that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subd. 13 (b). The statutory authority for the contents of the rule is *Minnesota Statutes*, sections 97A.045, subd. 2; 97C.005; and 97C.401.

The emergency conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are that under the terms of the Federal District Court the Mille Lacs Band, Fond Du Lac Band, and six Wisconsin Bands of Chippewa are not required to declare their harvest intentions on inland waters until mid-March. The Mille Lacs proposed regulations are based on a safe harvest level determined for 2015. Final harvest threshold levels to be included in the proposed rules were not available until March. These new threshold levels and regulations need to be put in place as soon as possible to ensure that angler harvest does not exceed state angler harvest thresholds for the 2015 open water fishing season.

6264.0400 DESIGNATED SPECIAL MANAGEMENT WATERS.

[For text of subps 1 to 3, see M.R.]

Subp. 4. **Mille Lacs Lake and associated tributaries special management regulations.**

A. While a person is on or fishing in Mille Lacs Lake or its associated tributaries to the posted boundaries, ~~all northern pike in possession must be less than 24 inches in length or greater than 36 inches in length. All northern pike that are 24 to 36 inches in length, inclusive, must be immediately returned to the water. A person's possession limit may not include more than one northern pike over 36 inches in length. the possession limit for northern pike is ten. Only one northern pike in possession may be greater than or equal to 30 inches in length. At least two northern pike less than 30 inches in length taken the same day from Mille Lacs Lake must be in immediate possession prior to possessing a northern pike equal to or greater than 30 inches in length. The angling season for northern pike is the Saturday two weeks prior to the Saturday of Memorial Day weekend to the last Sunday in March.~~

B. ~~While a person is on or fishing in Mille Lacs Lake or its associated tributaries, the possession limit for largemouth and smallmouth bass in aggregate is one-six, with only one smallmouth bass greater than 18 inches in length. While a person is on or fishing in Mille Lacs Lake or its associated tributaries to the posted boundaries, all smallmouth bass in possession must be 21 inches or greater in length. All smallmouth bass less than 21 inches in length must be immediately returned to the water. The season for taking largemouth and smallmouth bass is the Saturday two weeks prior to the Saturday of Memorial Day weekend to the last Sunday in February. Notwithstanding part 6262.0200, subpart 1, item A, subitem (2), the catch and release season does not apply to Mille Lacs Lake or its associated tributaries to the posted boundaries.~~

Expedited Emergency Rules

C. Mille Lacs Lake is closed to the taking of fish between the hours of 10 p.m. and 6 a.m. daily during the period commencing at 10 p.m. on the Monday following the Saturday two weeks prior to the Saturday of Memorial Day weekend and ending at 12:01 a.m. on Monday, four weeks after the date of commencement December 1. During the closure, no person shall be on the waters of Mille Lacs Lake while having in possession any equipment whereby fish may be taken. ~~Spearing is prohibited from December 1 through April 30. A person may not have a spear in possession while on or fishing in Mille Lacs Lake during this period, with the following exceptions:~~

(1) beginning June 8, fishing for muskellunge is allowed between the hours of 10 p.m. and 6 a.m. Only artificial muskellunge lures greater than eight inches in length, measured from the front of the eye of the lure to the end of the trailing hook, or sucker minnows greater than eight inches in length may be used or in possession. While fishing for muskellunge under this subitem, no person may have in possession tackle or bait other than that specifically used for muskellunge. Angling for, harvest of, and possession of species other than muskellunge are prohibited; and

(2) beginning June 8, bowfishing for rough fish is allowed between the hours of 10 p.m. and 6 a.m. No person shall have in possession any angling equipment while bowfishing under this subitem. Angling for, harvest of, and possession of species other than rough fish while bowfishing are prohibited.

E. While a person is on or fishing in Mille Lacs Lake or its associated tributaries to the posted boundaries:

(1) the possession limit for walleye is one;

(2) all walleye in possession must be:

(a) equal to or greater than 19 inches in length and equal to or less than 21 inches in length; or

(b) equal to or greater than 28 inches in length; and

(3) all walleye that are:

(a) less than 19 inches in length; or

(b) greater than 21 inches and less than 28 inches in length must be immediately returned to the water.

E.F. While a person is on or fishing in Mille Lacs Lake or its associated tributaries to the posted boundaries, the possession and daily limit for Northern cisco (tullibee) is ten fish.

F.G. Fish that are taken by angling and not immediately released into the water after capture are considered to be in possession and part of the bag limit. Once a fish has been reduced to possession, culling or live-well sorting (the act of exchanging one fish for another) is not allowed.

Executive Orders

The governor has the authority to issue written statements or orders, called Executive Orders, as well as Emergency Executive Orders. The governor's authority is specified in the *Constitution of the State of Minnesota*, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

Office of the Governor

Emergency Executive Order 15-09: Declaring a State of Peacetime Emergency in the State of Minnesota

I, MARK DAYTON, GOVERNOR OF THE STATE OF MINNESOTA, by virtue of the authority vested in me by the Constitution and applicable statutes, do hereby issue this Executive Order:

WHEREAS, on March 5, 2015, the United States Department of Agriculture's (USDA) Animal and Plant Health Inspection Service and the Minnesota Board of Animal Health confirmed the presence of highly pathogenic H5N2 avian influenza (HPAI) in a commercial turkey flock in Minnesota, and since then the disease has been identified in forty six different locations across the state impacting sixteen counties;

WHEREAS, it is urgent that continuous action be taken to prevent further economic hardship in the state's poultry industry;

WHEREAS, farms need support to maintain healthy flocks;

WHEREAS, emergency operations equipment and personnel are needed to support the response to and recovery from the H5N2 avian influenza incident statewide;

WHEREAS, emergency assets and personnel from state agencies and local governments are needed; and

WHEREAS, the USDA has identified that increased support from state and local government is needed to respond to the incident.

NOW, THEREFORE, I hereby order that:

1. A state of peacetime emergency exists pursuant to Minnesota Statutes, section 12.31.
2. The Minnesota Board of Animal Health is the lead technical agency for developing, implementing, and coordinating measures to protect the health of Minnesota domestic animals.
3. The Minnesota Department of Agriculture is the lead support agency to the Board of Animal Health for implementing measures to protect the health of Minnesota domestic animals.
4. The Minnesota Department of Natural Resources is the lead technical agency for developing, implementing, and coordinating measures to protect the health of wildlife in Minnesota.
5. The Departments of Agriculture, Public Safety, Health, Natural Resources, and Transportation, the Minnesota Pollution Agency, and the Board of Animal Health shall continue to coordinate and integrate the state response and recovery resources and coordinate with the USDA Incident Management Team.
6. The Department of Public Safety, Division of Homeland Security and Emergency Management is to continue to implement the Minnesota Emergency Operations Plan and continue the activation of the State Emergency Operations Center (SEOC) for the duration of the incident.

Executive Orders

7. All state agencies are directed to provide the assistance necessary to help agricultural agencies and local units of government respond to and recover from this incident as coordinated through the State Emergency Operations Center.
8. Joseph Kelly, the Director of the Division of Homeland Security and Emergency Management, be appointed as the Governor's Authorized Representative (GAR) for coordination of the state agency and local government support to the Department of Agriculture and the Board of Animal Health HPAI operations and response in Minnesota.
9. Joseph Kelly, the Director of the Division of Homeland Security and Emergency Management, acting as the GAR is authorized to make purchases, and coordinate and deploy state resources as necessary to support the response and recovery efforts as requested by the Board of Animal Health and the Department of, and request assistance from and coordinate with the federal government to enhance the emergency response activity in Minnesota.
10. The Adjutant General of Minnesota order to state active duty on or about April 23, 2015, in the service of the state, coordination staff for the SEOC and such personnel and equipment of the military forces of the state as required, and for such period of time as necessary to protect the lives and property of the citizens of Minnesota when requested by the GAR.
11. The Adjutant General is authorized to purchase, lease, or contract goods or services necessary to accomplish the mission. The cost of subsistence, transportation, fuel, pay, and allowances of said individuals shall be defrayed from the general fund of the state, as provided for in *Minnesota Statutes* 2014, Sections 192.49, 192.52 and 192.54.
12. This state of emergency also requires relief from certain federal regulations incorporated in *Minnesota Statutes*, section 221.0314, subdivision 9, pertaining to hours of service for motor carriers and drivers providing direct assistance in emergency relief efforts.
13. Motor carriers and drivers, as identified in Executive Order 15-06, traveling to affected areas of the state and providing direct assistance for emergency relief efforts, are exempted from paragraphs (b), (c), and (d) under the *Code of Federal Regulations*, title 49, part 395.3 which are incorporated in Minnesota Statutes, section 221.0314, subdivision 9, pertaining to hours of service.
14. Nothing in this order shall be construed to relieve motor carriers and drivers transporting supplies and materials and providing direct assistance for emergency relief efforts from the requirements under paragraph (a) of the *Code of Federal Regulations*, title 49, part 395.3 which states, in part, a driver may drive only during a period of 14 consecutive hours after coming on duty following 10 consecutive hours off duty.
15. Nothing in this order shall be construed to relieve motor carriers and drivers transporting supplies and materials and providing direct assistance for emergency relief efforts from regulations pertaining to driver qualifications; driving of commercial motor vehicles; commercial drivers' licenses; drug and alcohol testing for drivers; or equipment, parts, and accessories necessary for the safe operation of vehicles.
16. No motor carrier or driver operating under the terms of this order shall require or allow an ill or fatigued driver to operate a motor vehicle. Any driver who informs a carrier that he or she needs immediate rest shall be given at least ten consecutive off-duty hours before the driver is required to return to service.
17. Upon the expiration of this order, or when a motor carrier or driver ceases to provide direct assistance to the emergency relief effort, a driver that has had at least thirty-four consecutive hours off-duty must be permitted to start his or her on-duty status hours and 60/70-hour clock at zero.

Pursuant to *Minnesota Statutes* 4.035, subdivision 2, this emergency executive order shall be effective immediately and must be filed with the Secretary of State and published in the *State Register* as soon as possible after its issuance. This peacetime emergency shall remain in effect for five days, unless extended in accordance with *Minnesota Statutes*, section 12.31, subdivision 2. The portion of this order activating the National Guard is not subject to any time limitation contained in *Minnesota Statutes* Chapter 12. Emergency relief from regulations for motor carriers and drivers, as identified in Executive Order 15-06, traveling to affected areas of the state, shall remain in effect until May 22, 2015, or until the motor carrier or driver ceases direct assistance in providing emergency relief, whichever occurs first. For purposes of this Emergency Executive Order, direct assistance is defined in *Minnesota Statutes*, section 221.0269, subdivision 3,

paragraph (c). The hours of service exemption granted in this Emergency Executive Order may be extended in accordance with *Minnesota Statutes*, section 221.0269, subdivision 2.

Executive Order 15-10: Directing the Minnesota Department of Natural Resources to Discontinue Placing Radio Collars on Moose

I, MARK DAYTON, GOVERNOR OF THE STATE OF MINNESOTA, by virtue of the authority vested in me by the Constitution and applicable statutes, do hereby issue this Executive Order:

WHEREAS, the State of Minnesota has a diverse and rich natural heritage;

WHEREAS, moose are an iconic part of Minnesota's natural heritage;

WHEREAS, the moose population in northeast Minnesota has been in decline since 2006, the causes of which are poorly understood;

WHEREAS, the Department of Natural Resources initiated research, which included placing radio collars on moose, to identify and understand the causes of the moose decline; and

WHEREAS, unintended and unanticipated mortality of moose occurred during the collaring process.

NOW, THEREFORE, I hereby order that:

1. The Minnesota Department of Natural Resources discontinue placing any additional radio collars on moose.
2. The Minnesota Department of Natural Resources discontinue issuing permits for placing any additional radio collars on moose.
3. No additional collars shall be placed on moose under existing Department of Natural Resources permits.

Pursuant to *Minnesota Statutes*, section 4.035, subdivision 2, this executive order will be effective fifteen (15) days after publication in the *State Register* and filing with the Secretary of State and will remain in effect, in accordance with *Minnesota Statutes*, section 4.035, subdivision 3.
