BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. **SUMMARY OF APPROPRIATIONS.**

The amounts shown in this section summarize direct appropriations, by fund, made in sections 1 to 3.

"The first year" is fiscal year 2008. "The second year" is fiscal year 2009. "The biennium" is fiscal years 2008 and 2009.

3.10 The commissioner may provide incentives
3.11 to encourage, and may give priority to
3.12 proposals that foster, regional collaboration
3.13 for service delivery. The grants may be for a
3.14 term of up to two years. The commissioner
3.15 shall ensure that grants are made throughout
3.16 all regions of the state and shall develop a
3.17 description of best practices for the use of
3.18 these grants. A county may not reduce its
3.19 county veterans service officer budget by any
3.20 amount received as a grant under this section.

3.21 Grants made under this section are in addition
3.22 to and not subject to the requirements for
3.23 grants made under Minnesota Statutes,
3.24 section 197.608. The Minnesota Association
3.25 of County Veterans Service Officers may
3.26 apply for grants under this section beginning
3.27 July 1, 2007. Any balance remaining after
3.28 the first year does not cancel and is available
3.29 in the second year. This appropriation must
3.30 be included in the appropriation base through
3.31 fiscal year 2011.

3.32 (h) \$250,000 each year is added to the base
3.33 for grants to Disabled American Veterans,
