

A bill for an act

relating to capital improvements; appropriating money for asset preservation at Anoka-Ramsey Community College; authorizing the sale and issuance of state bonds.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. **APPROPRIATION; ANOKA-RAMSEY COMMUNITY COLLEGE.**

Subdivision 1. **Appropriation.** \$3,499,000 is appropriated from the bond proceeds fund to the Board of Trustees of the Minnesota State Colleges and Universities for higher education asset preservation and replacement at Anoka-Ramsey Community College to be spent in accordance with Minnesota Statutes, section 135A.046, to replace air handling units in the humanities, library, and college services buildings on the Coon Rapids campus.

Subd. 2. **Bond sale.** To provide the money appropriated in subdivision 1 from the bond proceeds fund, the commissioner of finance shall sell and issue bonds of the state in an amount up to \$3,499,000 in the manner, upon the terms, and with the effect prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota Constitution, article XI, sections 4 to 7.

EFFECTIVE DATE. This section is effective the day following final enactment.
