

A bill for an act

relating to vulnerable adults; authorizing disclosure of financial records in connection with financial exploitation investigations; modifying procedures and duties for reporting and investigating maltreatment; specifying duties of financial institutions in cases alleging financial exploitation; modifying the crime of financial exploitation; imposing criminal and civil penalties; amending Minnesota Statutes 2008, sections 13A.02, subdivisions 1, 2; 13A.04, subdivision 1; 256B.0595, subdivisions 4, 9; 299A.61, subdivision 1; 388.23, subdivision 1; 609.2335; 609.52, subdivision 3; 611A.033; 626.557, subdivisions 4, 5, 9, 9a, 9b, 9e, by adding subdivisions; 626.5572, subdivisions 5, 21; 628.26.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 2008, section 13A.02, subdivision 1, is amended to read:

Subdivision 1. **Access by government.** Except as authorized by this chapter, no government authority may have access to, or obtain copies of, or the information contained in, the financial records of any customer from a financial institution unless the financial records are reasonably described and:

(1) the customer has authorized the disclosure;

(2) the financial records are disclosed in response to a search warrant;

~~(3) the financial records are disclosed in response to a judicial or administrative subpoena; or~~

(3) the financial records are disclosed to law enforcement, a lead agency as defined in section 626.5572, subdivision 13, or prosecuting authority that is investigating financial exploitation of a vulnerable adult in response to a judicial subpoena or administrative subpoena under section 388.23; or

(4) the financial records are disclosed pursuant to section 609.535 or other statute or rule.

Sec. 2. Minnesota Statutes 2008, section 13A.02, subdivision 2, is amended to read:

Subd. 2. **Release prohibited.** No financial institution, or officer, employee, or agent of a financial institution, may provide to any government authority access to, or copies of, or the information contained in, the financial records of any customer except in accordance with the provisions of this chapter.

Nothing in this chapter shall require a financial institution to inquire or determine that those seeking disclosure have duly complied with the requirements of this chapter, provided only that the customer authorization, search warrant, subpoena, or written certification pursuant to section 609.535, subdivision 6; 626.557; or other statute or rule, served on or delivered to a financial institution shows compliance on its face.

Sec. 3. Minnesota Statutes 2008, section 13A.04, subdivision 1, is amended to read:

Subdivision 1. **Statutory violations; financial exploitation.** Nothing in this chapter precludes any financial institution, or any officer, employee, or agent of a financial institution, from notifying a government authority that the institution, or officer, employee, or agent has information which may be relevant to a possible violation of any statute or rule or the financial exploitation of a vulnerable adult and providing access to financial records relevant to the possible violation or financial exploitation.

Sec. 4. Minnesota Statutes 2008, section 256B.0595, subdivision 4, is amended to read:

Subd. 4. **Other exceptions to transfer prohibition.** (a) An institutionalized person who has made, or whose spouse has made a transfer prohibited by subdivision 1, is not ineligible for long-term care services if one of the following conditions applies:

(1) the assets were transferred to the individual's spouse or to another for the sole benefit of the spouse; or

(2) the institutionalized spouse, prior to being institutionalized, transferred assets to a spouse, provided that the spouse to whom the assets were transferred does not then transfer those assets to another person for less than fair market value. (At the time when one spouse is institutionalized, assets must be allocated between the spouses as provided under section 256B.059); or

(3) the assets were transferred to the individual's child who is blind or permanently and totally disabled as determined in the supplemental security income program; or

(4) a satisfactory showing is made that the individual intended to dispose of the assets either at fair market value or for other valuable consideration; or

(5) the local agency determines that denial of eligibility for long-term care services would work an undue hardship and grants a waiver of a penalty period of ineligibility

3.1 resulting from a transfer for less than fair market value based on an imminent threat to
3.2 the individual's health and well-being. Imminent threat to the individual's health and
3.3 well-being means that imposing a period of ineligibility would endanger the individual's
3.4 health or life or cause serious deprivation of food, clothing, or shelter. Whenever an
3.5 applicant or recipient is denied eligibility because of a transfer for less than fair market
3.6 value, the local agency shall notify the applicant or recipient that the applicant or recipient
3.7 may request a waiver of the ~~penalty~~ period of ineligibility if the denial of eligibility
3.8 will cause undue hardship. With the written consent of the individual or the personal
3.9 representative of the individual, a long-term care facility in which an individual is
3.10 residing may file an undue hardship waiver request, on behalf of the individual who is
3.11 denied eligibility for long-term care services on or after July 1, 2006, due to a period
3.12 of ineligibility resulting from a transfer on or after February 8, 2006. ~~In evaluating a~~
3.13 ~~waiver, the local agency shall take into account whether the individual was the victim of~~
3.14 ~~financial exploitation, whether the individual has made reasonable efforts to recover the~~
3.15 ~~transferred property or resource, whether the individual has taken any action to prevent~~
3.16 ~~the designation of the department as a remainder beneficiary on an annuity as described in~~
3.17 ~~section 256B.056, subdivision 11, and other factors relevant to a determination of hardship.~~

3.18 (b) Subject to paragraph (c), when evaluating a hardship waiver, the local agency
3.19 shall take into account whether the individual was the victim of financial exploitation,
3.20 whether the individual has made reasonable efforts to recover the transferred property or
3.21 resource, whether the individual has taken any action to prevent the designation of the
3.22 department as a remainder beneficiary on an annuity as described in section 256B.056,
3.23 subdivision 11, and other factors relevant to a determination of hardship.

3.24 (c) In the case of an imminent threat to the individual's health and well-being, the
3.25 local agency shall approve a hardship waiver of the portion of an individual's period of
3.26 ineligibility resulting from a transfer of assets for less than fair market value by or to
3.27 a person:

3.28 (1) convicted of financial exploitation, fraud, or theft upon the individual for such
3.29 transfer of assets; or

3.30 (2) against whom a report of financial exploitation upon the individual has been
3.31 substantiated. For purposes of this paragraph, "financial exploitation" and "substantiated"
3.32 have the meanings given in section 626.5572.

3.33 (d) The local agency shall make a determination within 30 days of the receipt of all
3.34 necessary information needed to make such a determination. If the local agency does not
3.35 approve a hardship waiver, the local agency shall issue a written notice to the individual
3.36 stating the reasons for the denial and the process for appealing the local agency's decision.

When a waiver is granted, a cause of action exists against the person to whom the assets were transferred for that portion of long-term care services provided within:

- ~~(i)~~ (1) 30 months of a transfer made on or before August 10, 1993;
- ~~(ii)~~ (2) 60 months of a transfer if the assets were transferred after August 30, 1993, to a trust or portion of a trust that is considered a transfer of assets under federal law;
- ~~(iii)~~ (3) 36 months of a transfer if transferred in any other manner after August 10, 1993, but prior to February 8, 2006; ~~or~~

~~(iv)~~ (4) 60 months of any transfer made on or after February 8, 2006, or the amount of the uncompensated transfer, whichever is less, together with the costs incurred due to the action; or

~~(6)~~ (5) for transfers occurring after August 10, 1993, the assets were transferred by the person or person's spouse: (i) into a trust established for the sole benefit of a son or daughter of any age who is blind or disabled as defined by the Supplemental Security Income program; or (ii) into a trust established for the sole benefit of an individual who is under 65 years of age who is disabled as defined by the Supplemental Security Income program.

"For the sole benefit of" has the meaning found in section 256B.059, subdivision 1.

Sec. 5. Minnesota Statutes 2008, section 256B.0595, subdivision 9, is amended to read:

Subd. 9. **Filing cause of action; limitation.** (a) The county of financial responsibility under chapter 256G may bring a cause of action under any or all of the following:

- (1) subdivision 1, paragraph (f);
- (2) subdivision 2, paragraphs (a) and (b);
- (3) subdivision 3, paragraph (b);
- (4) subdivision 4, ~~clause (5)~~ paragraph (d); and
- (5) subdivision 8

on behalf of the claimant who must be the commissioner.

(b) Notwithstanding any other law to the contrary, a cause of action under subdivision 2, paragraph (a) or (b), or 8, must be commenced within six years of the date the local agency determines that a transfer was made for less than fair market value. Notwithstanding any other law to the contrary, a cause of action under subdivision 3, paragraph (b), or 4, ~~clause (5)~~, must be commenced within six years of the date of approval of a waiver of the penalty period for a transfer for less than fair market value based on undue hardship.

5.1 Sec. 6. Minnesota Statutes 2008, section 299A.61, subdivision 1, is amended to read:

5.2 Subdivision 1. **Establishment.** The commissioner of public safety, in cooperation
5.3 with the commissioner of administration, shall develop and maintain an integrated
5.4 criminal alert network to facilitate the communication of crime prevention information
5.5 by electronic means among state agencies, law enforcement officials, and the private
5.6 sector. The network shall disseminate data regarding the commission of crimes, including
5.7 information on missing and endangered children or vulnerable adults, and attempt
5.8 to reduce theft and other crime by the use of electronic transmission of information.
5.9 In addition, the commissioner shall evaluate the feasibility of using the network to
5.10 disseminate data regarding the use of fraudulent checks and the coordination of security
5.11 and antiterrorism efforts with the Federal Bureau of Investigation. If the commissioner
5.12 determines that one or both of these uses are feasible, the commissioner shall ensure that
5.13 the network disseminates data in the area or areas determined to be feasible.

5.15 Subdivision 1. **Authority.** The county attorney, or any deputy or assistant county
5.16 attorney whom the county attorney authorizes in writing, has the authority to subpoena
5.17 and require the production of any records of telephone companies, cellular phone
5.18 companies, paging companies, subscribers of private computer networks including
5.19 Internet service providers or computer bulletin board systems, electric companies, gas
5.20 companies, water utilities, chemical suppliers, hotels and motels, pawn shops, airlines,
5.21 buses, taxis, and other entities engaged in the business of transporting people, and freight
5.22 companies, warehousing companies, self-service storage facilities, package delivery
5.23 companies, and other entities engaged in the businesses of transport, storage, or delivery,
5.24 and records of the existence of safe deposit box account numbers and customer savings
5.25 and checking account numbers maintained by financial institutions and safe deposit
5.26 companies, insurance records relating to the monetary payment or settlement of claims,
5.27 the banking, credit card, and financial records of a vulnerable adult, whether held in the
5.28 name of the vulnerable adult or a third party, including but not limited to safe deposit, loan
5.29 and account applications and agreements, signature cards, statements, check, transfers,
5.30 account authorizations, safe deposit access records and documentation of fraud, and
5.31 wage and employment records of an applicant or recipient of public assistance who is
5.32 the subject of a welfare fraud investigation relating to eligibility information for public
5.33 assistance programs. Subpoenas may only be issued for records that are relevant to an
5.34 ongoing legitimate law enforcement investigation. Administrative subpoenas may only
5.35 be issued in welfare fraud cases if there is probable cause to believe a crime has been

committed. This provision applies only to the records of business entities and does not extend to private individuals or their dwellings.

Sec. 8. Minnesota Statutes 2008, section 609.2335, is amended to read:

609.2335 FINANCIAL EXPLOITATION OF VULNERABLE ADULT.

Subdivision 1. **Crime.** Whoever does any of the following acts commits the crime of financial exploitation:

(1) in breach of a fiduciary obligation recognized elsewhere in law, including pertinent regulations, contractual obligations, documented consent by a competent person, or the obligations of a responsible party under section 144.6501 intentionally:

(i) fails to use the real or personal property or other financial resources of the vulnerable adult to provide food, clothing, shelter, health care, therapeutic conduct, or supervision for the vulnerable adult; ~~or~~

(ii) uses, manages, or takes either temporarily or permanently the real or personal property or other financial resources of the vulnerable adult, whether held in the name of the vulnerable adult or a third party, for the benefit of someone other than the vulnerable adult; or

(iii) deprives either temporarily or permanently a vulnerable adult of the vulnerable adult's real or personal property or other financial resources, whether held in the name of the vulnerable adult or a third party, for the benefit of someone other than the vulnerable adult; or

(2) in the absence of legal authority:

(i) acquires possession or control of an interest in ~~funds or~~ real or personal property or other financial resources of a vulnerable adult, whether held in the name of the vulnerable adult or a third party, through the use of undue influence, harassment, or duress; ~~or~~

(ii) forces, compels, coerces, or entices a vulnerable adult against the vulnerable adult's will to perform services for the profit or advantage of another; or

(iii) establishes a relationship with a fiduciary obligation to a vulnerable adult by use of undue influence, harassment, duress, force, compulsion, coercion, or other enticement.

Subd. 2. **Defenses.** (a) Nothing in this section requires a facility or caregiver to provide financial management or supervise financial management for a vulnerable adult except as otherwise required by law.

(b) If the actor knew or had reason to know that the vulnerable adult lacked capacity to consent, consent is not a defense to a violation of this section.

Subd. 3. **Criminal penalties.** A person who violates subdivision 1, clause (1) or (2), item (i), may be sentenced as provided in section 609.52, subdivision 3. A person who

violates subdivision 1, clause (2), item (ii) or (iii), may be sentenced to imprisonment for not more than one year or to payment of a fine of not more than \$3,000, or both.

EFFECTIVE DATE. This section is effective August 1, 2009, and applies to crimes committed on or after that date.

Sec. 9. Minnesota Statutes 2008, section 609.52, subdivision 3, is amended to read:

Subd. 3. **Sentence.** Whoever commits theft may be sentenced as follows:

(1) to imprisonment for not more than 20 years or to payment of a fine of not more than \$100,000, or both, if the property is a firearm, or the value of the property or services stolen is more than \$35,000 and the conviction is for a violation of subdivision 2, clause (3), (4), (15), or (16), or section 609.2335, subdivision 1, clause (1) or (2), item (i); or

(2) to imprisonment for not more than ten years or to payment of a fine of not more than \$20,000, or both, if the value of the property or services stolen exceeds \$5,000, or if the property stolen was an article representing a trade secret, an explosive or incendiary device, or a controlled substance listed in schedule I or II pursuant to section 152.02 with the exception of marijuana; or

(3) to imprisonment for not more than five years or to payment of a fine of not more than \$10,000, or both, if any of the following circumstances exist:

(a) the value of the property or services stolen is more than \$1,000 but not more than \$5,000; or

(b) the property stolen was a controlled substance listed in schedule III, IV, or V pursuant to section 152.02; or

(c) the value of the property or services stolen is more than \$500 but not more than \$1,000 and the person has been convicted within the preceding five years for an offense under this section, section 256.98; 268.182; 609.24; 609.245; 609.53; 609.582, subdivision 1, 2, or 3; 609.625; 609.63; 609.631; or 609.821, or a statute from another state, the United States, or a foreign jurisdiction, in conformity with any of those sections, and the person received a felony or gross misdemeanor sentence for the offense, or a sentence that was stayed under section 609.135 if the offense to which a plea was entered would allow imposition of a felony or gross misdemeanor sentence; or

(d) the value of the property or services stolen is not more than \$1,000, and any of the following circumstances exist:

(i) the property is taken from the person of another or from a corpse, or grave or coffin containing a corpse; or

(ii) the property is a record of a court or officer, or a writing, instrument or record kept, filed or deposited according to law with or in the keeping of any public officer or office; or

(iii) the property is taken from a burning, abandoned, or vacant building or upon its removal therefrom, or from an area of destruction caused by civil disaster, riot, bombing, or the proximity of battle; or

(iv) the property consists of public funds belonging to the state or to any political subdivision or agency thereof; or

(v) the property stolen is a motor vehicle; or

(4) to imprisonment for not more than one year or to payment of a fine of not more than \$3,000, or both, if the value of the property or services stolen is more than \$500 but not more than \$1,000; or

(5) in all other cases where the value of the property or services stolen is \$500 or less, to imprisonment for not more than 90 days or to payment of a fine of not more than \$1,000, or both, provided, however, in any prosecution under subdivision 2, clauses (1), (2), (3), (4), and (13), the value of the money or property or services received by the defendant in violation of any one or more of the above provisions within any six-month period may be aggregated and the defendant charged accordingly in applying the provisions of this subdivision; provided that when two or more offenses are committed by the same person in two or more counties, the accused may be prosecuted in any county in which one of the offenses was committed for all of the offenses aggregated under this paragraph.

EFFECTIVE DATE. This section is effective August 1, 2009, and applies to crimes committed on or after that date.

Sec. 10. Minnesota Statutes 2008, section 611A.033, is amended to read:

611A.033 SPEEDY TRIAL; NOTICE OF SCHEDULE CHANGE.

(a) A victim has the right to request that the prosecutor make a demand under rule 11.10 of the Rules of Criminal Procedure that the trial be commenced within 60 days of the demand. The prosecutor shall make reasonable efforts to comply with the victim's request.

(b) A prosecutor shall make reasonable efforts to provide advance notice of any change in the schedule of the court proceedings to a victim who has been subpoenaed or requested to testify.

(c) In a criminal proceeding in which a vulnerable adult, as defined in section 609.232, subdivision 11, is a victim, the state may move the court for a speedy trial. The court, after consideration of the age and health of the victim, may grant a speedy trial.

9.1 The motion may be filed and served with the complaint or any time after the complaint
9.2 is filed and served.

9.3 Sec. 11. Minnesota Statutes 2008, section 626.557, subdivision 4, is amended to read:

9.4 Subd. 4. **Reporting.** (a) Except as provided in paragraph (b), a mandated
9.5 reporter shall immediately make an oral report to the common entry point. Use of a
9.6 telecommunications device for the deaf or other similar device shall be considered an oral
9.7 report. The common entry point may not require written reports. To the extent possible,
9.8 the report must be of sufficient content to identify the vulnerable adult, the caregiver, the
9.9 nature and extent of the suspected maltreatment, any evidence of previous maltreatment,
9.10 the name and address of the reporter, the time, date, and location of the incident, and any
9.11 other information that the reporter believes might be helpful in investigating the suspected
9.12 maltreatment. A mandated reporter may disclose not public data, as defined in section
9.13 13.02, and medical records under sections 144.291 to 144.298, to the extent necessary
9.14 to comply with this subdivision.

9.15 (b) A boarding care home that is licensed under sections 144.50 to 144.58 and
9.16 certified under Title 19 of the Social Security Act, a nursing home that is licensed under
9.17 section 144A.02 and certified under Title 18 or Title 19 of the Social Security Act, or a
9.18 hospital that is licensed under sections 144.50 to 144.58 and has swing beds certified under
9.19 Code of Federal Regulations, title 42, section 482.66, may submit a report electronically
9.20 to the common entry point instead of submitting an oral report. The report may be a
9.21 duplicate of the initial report the facility submits electronically to the commissioner of
9.22 health to comply with the reporting requirements under Code of Federal Regulations, title

9.24 to include items required under paragraph (a) that are not currently included in the
9.25 electronic reporting form.

9.27 Subd. 5. **Immunity; protection for reporters.** (a) A person who makes a good
9.28 faith report is immune from any civil or criminal liability that might otherwise result from
9.29 making the report, or from participating in the investigation, or for failure to comply fully
9.30 with the reporting obligation under section 609.234 or 626.557, subdivision 7.

9.31 (b) A person employed by a lead agency or a state licensing agency who is
9.32 conducting or supervising an investigation or enforcing the law in compliance with this
9.33 section or any related rule or provision of law is immune from any civil or criminal

liability that might otherwise result from the person's actions, if the person is acting in good faith and exercising due care.

(c) A person who knows or has reason to know a report has been made to a common entry point and who in good faith participates in an investigation of alleged maltreatment is immune from civil or criminal liability that otherwise might result from making the report, or from failure to comply with the reporting obligation or from participating in the investigation.

(d) The identity of any reporter may not be disclosed, except as provided in subdivision 12b.

(e) For purposes of this subdivision, "person" includes a natural person or any form of a business or legal entity.

Sec. 13. Minnesota Statutes 2008, section 626.557, is amended by adding a subdivision to read:

Subd. 5a. **Financial institution cooperation.** Financial institutions shall cooperate with a lead agency, law enforcement, or prosecuting authority that is investigating maltreatment of a vulnerable adult and comply with reasonable requests for the production of financial records as authorized under section 13A.02, subdivision 1. Financial institutions are immune from any civil or criminal liability that might otherwise result from complying with this subdivision.

Sec. 14. Minnesota Statutes 2008, section 626.557, subdivision 9, is amended to read:

~~Subd. 9. **Common entry point designation.** (a) Each county board The commissioner of human services shall designate establish and maintain a common entry point for reports of suspected maltreatment made pursuant to section 626.557 through a single statewide toll-free telephone number, and the Web-based system. Two or more county boards may jointly designate a single common entry point.~~ The common entry point is the unit responsible for receiving the report of suspected maltreatment under this section.

(b) Any person may use the statewide toll-free telephone number or Web-based system to report known or suspected abuse, neglect, or exploitation of a vulnerable adult at any hour of the day or night, any day of the week. The common entry point must be available 24 hours per day to take calls from reporters of suspected maltreatment. The common entry point shall use a standard intake form that includes:

(1) the time and date of the report;

(2) the name, address, and telephone number of the person reporting;

- 11.1 (3) the time, date, and location of the incident;
- 11.2 (4) the names of the persons involved, including but not limited to, perpetrators,
- 11.3 alleged victims, and witnesses;
- 11.4 (5) whether there was a risk of imminent danger to the alleged victim;
- 11.5 (6) a description of the suspected maltreatment;
- 11.6 (7) the disability, if any, of the alleged victim;
- 11.7 (8) the relationship of the alleged perpetrator to the alleged victim;
- 11.8 (9) whether a facility was involved and, if so, which agency licenses the facility;
- 11.9 (10) any action taken by the common entry point;
- 11.10 (11) whether law enforcement has been notified;
- 11.11 (12) whether the reporter wishes to receive notification of the initial and final
- 11.12 reports; and
- 11.13 (13) if the report is from a facility with an internal reporting procedure, the name,
- 11.14 mailing address, and telephone number of the person who initiated the report internally.
- 11.15 (c) The common entry point is not required to complete each item on the form prior
- 11.16 to dispatching the report to the appropriate investigative agency.
- 11.17 (d) The common entry point shall immediately report to a law enforcement agency
- 11.18 any incident in which there is reason to believe a crime has been committed.
- 11.19 (e) If a report is initially made to a law enforcement agency or a lead agency, those
- 11.20 agencies shall take the report on the appropriate common entry point intake forms and
- 11.21 immediately forward a copy to the common entry point.
- 11.22 (f) The common entry point staff must receive training on how to screen and
- 11.23 dispatch reports efficiently and in accordance with this section.
- 11.24 (g) ~~When a centralized database is available, The common entry point has access to~~
- 11.25 ~~the centralized database and~~ must log the reports ~~in on~~ into the central database.

11.26 **EFFECTIVE DATE.** This section is effective January 1, 2011.

11.27 Sec. 15. Minnesota Statutes 2008, section 626.557, subdivision 9a, is amended to read:

11.28 Subd. 9a. **Evaluation and referral of reports made to common entry point unit.**

11.29 (a) The common entry point must be operated in such a manner as to enable the common

11.30 entry point staff to:

11.31 (1) when appropriate, refer calls that do not allege the abuse, neglect, or exploitation

11.32 of a vulnerable adult to other organizations that might better resolve the reporter's

11.33 concerns; and

11.34 (2) immediately identify and locate prior reports of abuse, neglect, or exploitation.

(b) The common entry point must screen the reports of alleged or suspected maltreatment for immediate risk and make all necessary referrals as follows:

(1) if the common entry point determines that there is an immediate need for adult protective services, the common entry point agency shall immediately notify the appropriate county agency;

(2) if the report contains suspected criminal activity against a vulnerable adult, the common entry point shall immediately notify the appropriate law enforcement agency;

(3) if the report references alleged or suspected maltreatment and there is no immediate need for adult protective services, the common entry point shall notify the appropriate lead agency as soon as possible, but in any event no longer than two working days;

(4) if the report does not reference alleged or suspected maltreatment, the common entry point may determine whether the information will be referred; and

(5) if the report contains information about a suspicious death, the common entry point shall immediately notify the appropriate law enforcement agencies, the local medical examiner, and the ombudsman established under section 245.92. Law enforcement agencies shall coordinate with the local medical examiner and the ombudsman as provided by law.

(c) The common entry point must be operated in such a manner as to enable the commissioner of human services to:

(1) track critical steps in the investigative process to ensure compliance with all requirements for all reports;

(2) maintain data to facilitate the production of aggregate statistical reports for monitoring patterns of abuse, neglect, or exploitation;
