BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

3.8 This appropriation is to investigate (1)

3.10 liabilities from individuals and businesses
3.11 that currently do not pay all taxes owed; and
3.12 (2) illegal or improper activity related to sale,
3.13 transfer, titling, and registration of motor
3.14 vehicles. This initiative is expected to result
3.15 in new revenues for the biennium as follows:

3.16 (1) \$454,000 for the highway user tax
3.17 distribution fund;

3.18 (2) \$303,000 for the transit assistance fund;
3.19 and

3.20 (3) \$50,000 for the general fund.

3.21 The base for this program is \$693,000 in
3.22 fiscal year 2012 and \$693,000 in fiscal year
3.23 2013.
