- (c) Calculation of nursing hours per standardized resident day is performed by dividing total hours of nursing personnel for a given period by the total of standardized resident days for that same period. Certified nursing homes shall prepare annual reports showing the nursing home's calculation of nursing personnel staffing and compliance with the minimum staffing standards in this subdivision.
- (d) The annual reports required in paragraph (c) must be filed with the Department of Health. The filed reports are public documents and must be posted in a prominent location at each nursing home site for review by patients, visitors, and staff. Copies must also be provided to pertinent collective bargaining representatives of nursing home staff upon request.
- (d) (e) A nursing home that is issued a notice of noncompliance under section 144A.10, subdivision 5, for a violation of this subdivision, shall be assessed a civil fine of \$300 for each day of noncompliance, subject to section 144A.10, subdivisions 7 and 8.
