Members of the advisory committee serve without compensation but may be reimbursed for their reasonable expenses as determined by the Metropolitan Council. The advisory committee expires December 31, 2012 2016.
- (c) The council must consider the work and recommendations of the advisory committee when the council is preparing its regional development framework.
