1.36 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

ARTICLE 1

ABSENTEE VOTING

Section 1. Minnesota Statutes 2012, section 5B.06, is amended to read:

5B.06 VOTING BY PROGRAM PARTICIPANT; ABSENTEE BALLOT.

A program participant who is otherwise eligible to vote may register with the secretary of state as ~~an ongoing~~ a permanent absentee voter. Notwithstanding section 203B.04, subdivision 5, the secretary of state is not required to send an absentee ballot application prior to each election to a program participant registered as a permanent absentee voter under this section. As soon as practicable before each election, the secretary of state shall determine the precinct in which the residential address of the program participant is located and shall request from and receive from the county auditor or other election official the ballot for that precinct and shall forward the absentee ballot to the program participant with the other materials for absentee balloting as required by Minnesota law. The program participant shall complete the ballot and return it to the secretary of state, who shall review the ballot in the manner provided by section 203B.24. If the ballot and ballot materials comply with the requirements of that section, the ballot must be certified by the secretary of state as the ballot of a program participant, and must be forwarded to the appropriate electoral jurisdiction for tabulation along with all other ballots. The name and address of a program participant must not be listed in the statewide voter registration system.

Sec. 2. Minnesota Statutes 2012, section 203B.02, subdivision 1, is amended to read:

Subdivision 1. ~~Unable to go to polling place~~ **Absentee voting; eligibility.** (a) Any eligible voter ~~who reasonably expects to be unable to go to the polling place on election day in the precinct where the individual maintains residence because of absence from the precinct; illness, including isolation or quarantine under sections 144.419 to 144.4196 or United States Code, title 42, sections 264 to 272; disability; religious discipline; observance of a religious holiday; or service as an election judge in another precinct~~ may vote by absentee ballot as provided in sections 203B.04 to 203B.15.

~~(b) If the governor has declared an emergency and filed the declaration with the secretary of state under section 12.31, and the declaration states that the emergency has made it difficult for voters to go to the polling place on election day, any voter in a precinct covered by the declaration may vote by absentee ballot as provided in sections 203B.04 to 203B.15.~~

Sec. 3. Minnesota Statutes 2012, section 203B.04, subdivision 1, is amended to read:

3.1 Subdivision 1. **Application procedures.** (a) Except as otherwise allowed by
3.2 subdivision 2 or by section 203B.11, subdivision 4, an application for absentee ballots for
3.3 any election may be submitted at any time not less than one day before the day of that
3.4 election. The county auditor shall prepare absentee ballot application forms in the format
3.5 provided by the secretary of state and shall furnish them to any person on request. By
3.6 January 1 of each even-numbered year, the secretary of state shall make the forms to be
3.7 used available to auditors through electronic means. An application submitted pursuant to
3.8 this subdivision shall be in writing and shall be submitted to:

3.9 (1) the county auditor of the county where the applicant maintains residence; or

3.10 (2) the municipal clerk of the municipality, or school district if applicable, where
3.11 the applicant maintains residence.

3.12 (b) An application shall be approved if it is timely received, signed and dated by
3.13 the applicant, contains the applicant's name and residence and mailing addresses, date
3.14 of birth, and at least one of the following:

3.15 (1) the applicant's Minnesota driver's license number;

3.16 (2) Minnesota state identification card number;

3.17 (3) the last four digits of the applicant's Social Security number; or

3.18 (4) a statement that the applicant does not have any of these numbers.

3.19 (c) To be approved, the application ~~must state that the applicant is eligible to vote by~~
3.20 ~~absentee ballot for one of the reasons specified in section 203B.02,~~ and must contain an oath
3.21 that the information contained on the form is accurate, that the applicant is applying on the
3.22 applicant's own behalf, and that the applicant is signing the form under penalty of perjury.

3.23 (d) An applicant's full date of birth, Minnesota driver's license or state identification
3.24 number, and the last four digits of the applicant's Social Security number must not be
3.25 made available for public inspection. An application may be submitted to the county
3.26 auditor or municipal clerk by an electronic facsimile device. An application mailed or
3.27 returned in person to the county auditor or municipal clerk on behalf of a voter by a
3.28 person other than the voter must be deposited in the mail or returned in person to the
3.29 county auditor or municipal clerk within ten days after it has been dated by the voter and
3.30 no later than six days before the election. The absentee ballot applications or a list of
3.31 persons applying for an absentee ballot may not be made available for public inspection
3.32 until the close of voting on election day.

3.33 (e) An application under this subdivision may contain an application under
3.34 subdivision 5 to automatically receive an absentee ballot application.

3.35 Sec. 4. Minnesota Statutes 2012, section 203B.04, subdivision 5, is amended to read:

4.1 Subd. 5. **Permanent illness or disability absentee voter status.** (a) An eligible
 4.2 voter ~~who reasonably expects to be permanently unable to go to the polling place on~~
 4.3 ~~election day because of illness or disability~~ may apply to a county auditor or municipal
 4.4 clerk ~~under this section~~ to automatically receive an absentee ballot application before each
 4.5 election, other than an election by mail conducted under section 204B.45, and to have
 4.6 the status as a permanent absentee voter indicated on the voter's registration record. An
 4.7 eligible voter listed as an ongoing absentee voter as of July 31, 2013, pursuant to laws
 4.8 in effect on that date, shall be treated as if the voter applied for status as a permanent
 4.9 absentee voter pursuant to this subdivision.

4.10 (b) A voter who applies under paragraph (a) must automatically be provided an
 4.11 absentee ballot application for each eligible election. A voter's permanent absentee status
 4.12 ends and automatic ballot application delivery must be terminated on:

4.13 (1) the voter's written request;

4.14 (2) the voter's death;

4.15 (3) return of an absentee ballot as undeliverable; or

4.16 (4) a change in the voter's status to "challenged" or "inactive" in the statewide voter
 4.17 registration system.

4.18 ~~(b)~~ (c) The secretary of state shall adopt rules governing procedures under this
 4.19 subdivision.

4.20 Sec. 5. Minnesota Statutes 2012, section 203B.06, subdivision 1, is amended to read:

4.21 Subdivision 1. **Printing and delivery of forms.** Each county auditor and municipal
 4.22 clerk shall prepare and print a sufficient number of blank application forms for absentee
 4.23 ballots. The county auditor or municipal clerk shall deliver a blank application form to
 4.24 any voter who requests one pursuant to section 203B.04. Blank application forms must be
 4.25 mailed to eligible voters who have requested an application pursuant to section 203B.04,
 4.26 subdivision 5 ~~or 6~~, at least 60 days before:

4.27 (1) each regularly scheduled primary for federal, state, county, city, or school board
 4.28 office;

4.29 (2) each regularly scheduled general election for city or school board office for
 4.30 which a primary is not held; and

5.1 Sec. 6. Minnesota Statutes 2012, section 203B.121, subdivision 2, is amended to read:

5.2 Subd. 2. **Duties of ballot board; absentee ballots.** (a) The members of the ballot
5.3 board shall take possession of all return envelopes delivered to them in accordance with
5.4 section 203B.08. Upon receipt from the county auditor, municipal clerk, or school district
5.5 clerk, two or more members of the ballot board shall examine each return envelope and
5.6 shall mark it accepted or rejected in the manner provided in this subdivision. Election
5.7 judges performing the duties in this section must be of different major political parties,
5.8 unless they are exempt from that requirement under section 205.075, subdivision 4, or
5.9 section 205A.10, subdivision 2.

5.10 (b) The members of the ballot board shall mark the return envelope "Accepted" and
5.11 initial or sign the return envelope below the word "Accepted" if a majority of the members
5.12 of the ballot board examining the envelope are satisfied that:

5.13 (1) the voter's name and address on the return envelope are the same as the
5.14 information provided on the absentee ballot application;

5.15 (2) the voter signed the certification on the envelope;

5.16 (3) the voter's Minnesota driver's license, state identification number, or the last four
5.17 digits of the voter's Social Security number are the same as the number provided on the
5.18 voter's application for ballots. If the number does not match the number as submitted on
5.19 the application, or if a number was not submitted on the application, the election judges
5.20 must compare the signature provided by the applicant to determine whether the ballots
5.21 were returned by the same person to whom they were transmitted;

5.22 (4) the voter is registered and eligible to vote in the precinct or has included a
5.23 properly completed voter registration application in the return envelope;

5.24 (5) the certificate has been completed as prescribed in the directions for casting an
5.25 absentee ballot; and

5.26 (6) the voter has not already voted at that election, either in person or, if it is after the
5.27 close of business on the ~~fourth~~ seventh day before the election, by absentee ballot.

5.28 The return envelope from accepted ballots must be preserved and returned to the
5.29 county auditor.

5.30 (c)(1) If a majority of the members of the ballot board examining a return envelope
5.31 find that an absentee voter has failed to meet one of the requirements provided in
5.32 paragraph (b), they shall mark the return envelope "Rejected," initial or sign it below the
5.33 word "Rejected," list the reason for the rejection on the envelope, and return it to the
5.34 county auditor. There is no other reason for rejecting an absentee ballot beyond those
5.35 permitted by this section. Failure to place the ballot within the security envelope before
5.36 placing it in the outer white envelope is not a reason to reject an absentee ballot.

6.1 (2) If an envelope has been rejected at least five days before the election, the
6.2 envelope must remain sealed and the official in charge of the ballot board shall provide the
6.3 voter with a replacement absentee ballot and return envelope in place of the rejected ballot.

6.4 (3) If an envelope is rejected within five days of the election, the envelope must
6.5 remain sealed and the official in charge of the ballot board must attempt to contact the
6.6 voter by telephone or e-mail to notify the voter that the voter's ballot has been rejected.
6.7 The official must document the attempts made to contact the voter.

6.8 (d) The official in charge of the absentee ballot board must mail the voter a written
6.9 notice of absentee ballot rejection between six and ten weeks following the election. If the
6.10 official determines that the voter has otherwise cast a ballot in the election, no notice is
6.11 required. If an absentee ballot arrives after the deadline for submission provided by this
6.12 chapter, the notice must be provided between six to ten weeks after receipt of the ballot. A
6.13 notice of absentee ballot rejection must contain the following information:

6.14 (1) the date on which the absentee ballot was rejected or, if the ballot was received
6.15 after the required deadline for submission, the date on which the ballot was received;

6.16 (2) the reason for rejection; and

6.17 (3) the name of the appropriate election official to whom the voter may direct further
6.18 questions, along with appropriate contact information.

6.19 (e) An absentee ballot return envelope marked "Rejected" may not be opened or
6.20 subject to further review except in an election contest filed pursuant to chapter 209.

6.21 Sec. 7. Minnesota Statutes 2012, section 203B.121, subdivision 3, is amended to read:

6.22 Subd. 3. **Record of voting.** (a) When applicable, the county auditor or municipal
6.23 clerk must immediately record that a voter's absentee ballot has been accepted. After the
6.24 close of business on the ~~fourth~~ seventh day before the election, a voter whose record
6.25 indicates that an absentee ballot has been accepted must not be permitted to cast another
6.26 ballot at that election. In a state primary, general, or state special election for federal or
6.27 state office, the auditor or clerk must also record this information in the statewide voter
6.28 registration system.

6.29 (b) The roster must be marked, and a supplemental report of absentee voters who
6.30 submitted a voter registration application with their ballot must be created, no later than
6.31 the start of voting on election day to indicate the voters that have already cast a ballot at
6.32 the election. The roster may be marked either:

6.33 (1) by the county auditor or municipal clerk before election day;

6.34 (2) by the ballot board before election day; or

6.35 (3) by the election judges at the polling place on election day.

7.1 The record of a voter whose absentee ballot was received after the close of business
7.2 on the ~~fourth~~ seventh day before the election is not required to be marked on the roster or
7.3 contained in a supplemental report as required by this paragraph.

7.4 Sec. 8. Minnesota Statutes 2012, section 203B.121, subdivision 4, is amended to read:

7.5 Subd. 4. **Opening of envelopes.** After the close of business on the ~~fourth~~ seventh
7.6 day before the election, the ballots from return envelopes marked "Accepted" may be
7.7 opened, duplicated as needed in the manner provided in section 206.86, subdivision 5,
7.8 initialed by the members of the ballot board, and deposited in the appropriate ballot box. If
7.9 more than one ballot is enclosed in the ballot envelope, the ballots must be returned in the
7.10 manner provided by section 204C.25 for return of spoiled ballots, and may not be counted.

7.11 Sec. 9. **REPEALER.**

7.12 Minnesota Statutes 2012, section 203B.04, subdivision 6, is repealed.

7.13 Sec. 10. **EFFECTIVE DATE; APPLICABILITY.**

7.14 This article is effective January 1, 2014, and applies to voting at elections conducted
7.15 on the date of the state primary in 2014 and thereafter.

7.18 Section 1. **[2.495] FORTY-NINTH DISTRICT.**

7.19 Subdivision 1. **Senate district.** Senate District 49 consists of that district as
7.20 described in the order of the Minnesota Special Redistricting Panel in Hippert v. Ritchie,
7.21 No. A11-152 (February 21, 2012).

7.22 Subd. 2. **House of representatives districts.** Notwithstanding the order of the
7.23 Minnesota Special Redistricting Panel in Hippert v. Ritchie, No. A11-152 (February 21,
7.24 2012), Senate District 49 is divided into two house of representatives districts as follows:

7.25 (a) House of Representatives District 49A consists of the district as described in
7.26 that order, with the modification contained in file L49A-2, on file with the Geographic
7.27 Information Systems Office of the Legislative Coordinating Commission and published on
7.28 its Web site on March 28, 2012.

7.29 (b) House of Representatives District 49B consists of the district as described in
7.30 that order, with the modification contained in file L49B-2, on file with the Geographic
7.31 Information Systems Office of the Legislative Coordinating Commission and published on
7.32 its Web site on March 28, 2012.

8.1 **EFFECTIVE DATE.** This section is effective the day following final enactment.

8.2 Sec. 2. Minnesota Statutes 2012, section 103C.225, subdivision 3, is amended to read:

8.3 Subd. 3. **Referendum.** (a) ~~Within 60 days after the petition is received by the state~~
8.4 ~~board, it shall give due notice of the holding of a referendum, schedule the referendum at~~
8.5 ~~the next general election, and cooperate with county election officials to accomplish the~~
8.6 ~~election in the most expedient manner. Upon receipt of a petition, the state board shall~~
8.7 ~~provide written notice to the secretary of state and the county auditor of each county in~~
8.8 ~~which the district is located no later than 74 days before the state general election. The~~
8.9 ~~notice must include the date of the election and the title and text of the question to be~~
8.10 ~~placed on the ballot. Prior to the referendum, the state board shall facilitate the preparation~~

8.19 (c) Only eligible voters in the district may vote in the referendum.

8.20 (d) Informalities in the conduct of the referendum or matters relating to the
8.21 referendum do not invalidate the referendum, or result of the referendum, if due notice has
8.22 been given and the referendum has been fairly conducted.

8.23 (e) The state board shall publish the result of the referendum.

8.24 Sec. 3. Minnesota Statutes 2012, section 103C.305, subdivision 3, is amended to read:

8.25 Subd. 3. **Ballots.** Ballots shall be prepared by the county auditor. The names of
8.26 candidates shall be placed on the ~~"canary ballot" described in section 204D.11, subdivision~~
8.27 ~~3 state general election ballot.~~ The office title printed on the ballot must be either "Soil
8.28 and Water Conservation District Supervisor" or "Conservation District Supervisor," based
8.29 upon the district from which the supervisor is to be elected.

8.30 Sec. 4. Minnesota Statutes 2012, section 201.061, subdivision 3, is amended to read:

8.31 Subd. 3. **Election day registration.** (a) An individual who is eligible to vote may
8.32 register on election day by appearing in person at the polling place for the precinct in
8.33 which the individual maintains residence, by completing a registration application, making

9.1 an oath in the form prescribed by the secretary of state and providing proof of residence.

9.2 An individual may prove residence for purposes of registering by:

9.3 (1) presenting a driver's license or Minnesota identification card issued pursuant
9.4 to section 171.07;

9.5 (2) presenting any document approved by the secretary of state as proper
9.6 identification;

9.7 (3) presenting one of the following:

9.8 (i) a current valid student identification card from a postsecondary educational
9.9 institution in Minnesota, if a list of students from that institution has been prepared under
9.10 section 135A.17 and certified to the county auditor in the manner provided in rules of
9.11 the secretary of state; or

9.12 (ii) a current student fee statement that contains the student's valid address in the
9.13 precinct together with a picture identification card; or

9.14 (4) having a voter who is registered to vote in the precinct, or who is an employee
9.15 employed by and working in a residential facility in the precinct and vouching for a resident
9.16 in the facility, sign an oath in the presence of the election judge vouching that the voter or
9.17 employee personally knows that the individual is a resident of the precinct. A voter who
9.18 has been vouched for on election day may not sign a proof of residence oath vouching for
9.19 any other individual on that election day. A voter who is registered to vote in the precinct
9.20 may sign up to ~~15~~ eight proof-of-residence oaths on any election day. This limitation
9.21 does not apply to an employee of a residential facility described in this clause. The
9.22 secretary of state shall provide a form for election judges to use in recording the number
9.23 of individuals for whom a voter signs proof-of-residence oaths on election day. The
9.24 form must include space for the maximum number of individuals for whom a voter may
9.25 sign proof-of-residence oaths. For each proof-of-residence oath, the form must include
9.26 a statement that the voter is registered to vote in the precinct, personally knows that the
9.27 individual is a resident of the precinct, and is making the statement on oath. The form must
9.28 include a space for the voter's printed name, signature, telephone number, and address.

9.29 The oath required by this subdivision and Minnesota Rules, part 8200.9939, must be
9.30 attached to the voter registration application.

9.31 (b) The operator of a residential facility shall prepare a list of the names of its
9.32 employees currently working in the residential facility and the address of the residential
9.33 facility. The operator shall certify the list and provide it to the appropriate county auditor
9.34 no less than 20 days before each election for use in election day registration.

9.35 (c) "Residential facility" means transitional housing as defined in section 256E.33,
9.36 subdivision 1; a supervised living facility licensed by the commissioner of health under

10.1 section 144.50, subdivision 6; a nursing home as defined in section 144A.01, subdivision
10.2 5; a residence registered with the commissioner of health as a housing with services
10.3 establishment as defined in section 144D.01, subdivision 4; a veterans home operated by

10.5 licensed by the commissioner of human services to provide a residential program as

10.22 responsible for election day registration initial each completed registration application.

10.23 Sec. 5. Minnesota Statutes 2012, section 201.071, subdivision 2, is amended to read:

10.24 Subd. 2. **Instructions.** A registration application shall be accompanied by
10.25 instructions specifying the manner and method of registration, the qualifications for
10.26 voting, the penalties for false registration, and the availability of registration and voting

65.32 Article II - Right of the People in Member States to

66.1 Each member state shall conduct a statewide popular election for president and

66.3 Article III - Manner of Appointing Presidential Electors in Member States

66.4 Prior to the time set by law for the meeting and voting by the presidential electors,
66.5 the chief election official of each member state shall determine the number of votes for
66.6 each presidential slate in each state of the United States and in the District of Columbia
66.7 in which votes have been cast in a statewide popular election and shall add such votes
66.8 together to produce a "national popular vote total" for each presidential slate. The chief
66.9 election official of each member state shall designate the presidential slate with the largest
66.10 national popular vote total as the "national popular vote winner." The presidential elector
66.11 certifying official of each member state shall certify the appointment in that official's own
66.12 state of the elector slate nominated in that state in association with the national popular
66.13 vote winner. At least six days before the day fixed by law for the meeting and voting by the
66.14 presidential electors, each member state shall make a final determination of the number of
66.15 popular votes cast in the state for each presidential slate and shall communicate an official
66.16 statement of such determination within 24 hours to the chief election official of each other
66.17 member state. The chief election official of each member state shall treat as conclusive an
66.18 official statement containing the number of popular votes in a state for each presidential
66.19 slate made by the day established by federal law for making a state's final determination
66.20 conclusive as to the counting of electoral votes by Congress. In event of a tie for the
66.21 national popular vote winner, the presidential elector certifying official of each member
66.22 state shall certify the appointment of the elector slate nominated in association with the
66.23 presidential slate receiving the largest number of popular votes within that official's own
66.24 state. If, for any reason, the number of presidential electors nominated in a member state
66.25 in association with the national popular vote winner is less than or greater than that state's
66.26 number of electoral votes, the presidential candidate on the presidential slate that has been
66.27 designated as the national popular vote winner shall have the power to nominate the
66.28 presidential electors for that state and that state's presidential elector certifying official
66.29 shall certify the appointment of such nominees. The chief election official of each member
66.30 state shall immediately release to the public all vote counts or statements of votes as they
66.31 are determined or obtained. This article shall govern the appointment of presidential
66.32 electors in each member state in any year in which this agreement is, on July 20, in effect
66.33 in states cumulatively possessing a majority of the electoral votes.

66.34 Article IV - Other Provisions

66.35 This agreement shall take effect when states cumulatively possessing a majority of
66.36 the electoral votes have enacted this agreement in substantially the same form and the

67.1 enactments by such states have taken effect in each state. Any member state may withdraw
67.2 from this agreement, except that a withdrawal occurring six months or less before the end
67.3 of a president's term shall not become effective until a president or vice president shall
67.4 have been qualified to serve the next term. The chief executive of each member state shall
67.5 promptly notify the chief executive of all other states of when this agreement has been
67.6 enacted and has taken effect in that official's state, when the state has withdrawn from this

67.9 remaining provisions shall not be affected.

67.10 Article V - Definitions

67.11 For purposes of this agreement,

67.12 "chief executive" means the governor of a state of the United States or the mayor of
67.13 the District of Columbia;

67.14 "elector slate" means a slate of candidates who have been nominated in a state for
67.15 the position of presidential elector in association with a presidential slate;

67.16 "chief election official" means the state official or body that is authorized to certify
67.17 the total number of popular votes for each presidential slate;

67.18 "presidential elector" means an elector for president and vice president of the
67.19 United States;

67.20 "presidential elector certifying official" means the state official or body that is
67.21 authorized to certify the appointment of the state's presidential electors;

67.22 "presidential slate" means a slate of two persons, the first of whom has been
67.23 nominated as a candidate for president of the United States and the second of whom
67.24 has been nominated as a candidate for vice president of the United States, or any legal
67.25 successors to such persons, regardless of whether both names appear on the ballot
67.26 presented to the voter in a particular state;

67.27 "state" means a state of the United States and the District of Columbia; and

67.28 "statewide popular election" means a general election in which votes are cast for
67.29 presidential slates by individual voters and counted on a statewide basis.

2.484 FORTY-FIFTH DISTRICT.

Subdivision 1. **Senate district.** Senate District 45 consists of that district as described in the order of the Minnesota Special Redistricting Panel in *Zachman v. Kiffmeyer*, No. C0-01-160 (March 19, 2002).

Subd. 2. **House of representatives districts.** Notwithstanding the order of the Minnesota Special Redistricting Panel in *Zachman v. Kiffmeyer*, No. C0-01-160 (March 19, 2002), Senate District 45, as described in that order, is divided into two house of representatives districts as follows:

(a) House of Representatives District 45A consists of House of Representatives District 45A as described in that order, except for the portion of that House of Representatives District 45A described as follows:

Beginning at the intersection of the center lines of 35th Avenue North and Nevada Avenue North, then south along the center line of Nevada Avenue North to the center line of 34th Avenue North, then west along the center line of 34th Avenue North to the center line of Winpark Drive, then north along the center line of Winpark Drive to the center line of 35th Avenue North, then west along the center line of 35th Avenue North to the center line of Winnetka Avenue North, then north along the center line of Winnetka Avenue North to the north municipal boundary line of Crystal, then west along that municipal boundary line to the west municipal boundary line of Crystal, then south along that municipal boundary line to the center line of 33rd Avenue North, then east along the center line of 33rd Avenue North to the center line of Wisconsin Avenue North, then north along the center line of Wisconsin Avenue North to the center line of 35th Avenue North, then east along the center line of 35th Avenue North to the center line of Utah Avenue North, then south along the center line of Utah Avenue North to the center line of 33rd Place North, then east along the center line of 33rd Place North to the center line of Winnetka Avenue North, then south along the center line of Winnetka Avenue North to the center line of 32nd Avenue North, then east along the center line of 32nd Avenue North to the center line of Nevada Avenue, then north along the center line of Nevada Avenue to the center line of Valley Place, then east along the center line of Valley Place to the center line of Louisiana Avenue North, then north along the center line of Louisiana Avenue North to the center line of 35th Avenue North, then west along the center line of 35th Avenue North to the center line of Nevada Avenue North, which was the place of beginning.

(b) House of Representatives District 45B consists of that portion of Senate District 45 not included in House of Representatives District 45A.

203B.04 APPLICATION FOR BALLOTS.

Subd. 6. **Ongoing absentee status; termination.** (a) An eligible voter may apply to a county auditor or municipal clerk for status as an ongoing absentee voter who reasonably expects to meet the requirements of section 203B.02, subdivision 1. Each applicant must automatically be provided with an absentee ballot application for each ensuing election other than an election by mail conducted under section 204B.45, and must have the status of ongoing absentee voter indicated on the voter's registration record.

(b) Ongoing absentee voter status ends on:

- (1) the voter's written request;
- (2) the voter's death;
- (3) return of an ongoing absentee ballot as undeliverable;
- (4) a change in the voter's status so that the voter is not eligible to vote under section 201.15 or 201.155; or
- (5) placement of the voter's registration on inactive status under section 201.171.

204B.12 WITHDRAWAL OF CANDIDATES.

Subd. 2a. **After primary; candidates for constitutional office.** (a) A candidate for a constitutional office may withdraw from the general election ballot by filing an affidavit of withdrawal with the same official who received the affidavit of candidacy. The affidavit must request that official to withdraw that candidate's name from the ballot and must be filed no later than 16 days before the general election.

(b) A candidate for a constitutional office may withdraw after the deadline in paragraph (a) if:

- (1) the candidate withdraws because of a catastrophic illness that was diagnosed after the deadline for withdrawal;

(2) the candidate's illness will permanently and continuously incapacitate the candidate and prevent the candidate from performing the duties of the office sought; and

(3) the candidate or the candidate's legal guardian files with the affidavit of withdrawal a certificate verifying that the candidate's illness meets the requirements of clauses (1) and (2), signed by at least two licensed physicians.

204B.13 VACANCY IN NOMINATION.

Subd. 4. **Nonpartisan office; filling vacancy.** A vacancy in nomination in a nonpartisan office may be filled by filing an affidavit of candidacy and paying a filing fee or by filing an affidavit of candidacy and filing a petition in place of a filing fee in the manner provided in sections 204B.06, 204B.09, and 204B.11. All documents and fees required by this subdivision must be filed within five days after the vacancy in nomination occurs. There must be a two-day period for withdrawal of candidates after the last day for filing.

If the vacancy in nomination resulted from a withdrawal during the withdrawal period held on the 68th to 69th day before the primary, and if, at the end of the withdrawal period to fill the vacancy in nomination, there are more than two candidates, the candidates' names must appear on the primary ballot.

In all other cases, the candidates' names must appear on the general election ballot.

Subd. 6. **Vacancy after deadline.** If a candidate withdraws after the 16th day before the general election but before four days before the general election, the secretary of state shall instruct the election judges to strike the name of the withdrawn candidate from the general election ballot and shall substitute no other candidate's name. Filing officers may not accept a nomination certificate for filing to fill a vacancy in nomination resulting from the filing of an affidavit of withdrawal by a candidate after the 14th day before the general election.

204B.42 PAPER COLOR FOR SAMPLE BALLOTS; PENALTY.

No sample ballot shall be printed on paper of the same color as any official ballots except when printed in black ink on white paper and appearing in a newspaper as news matter. A violation of this section is a misdemeanor.

204D.11 STATE GENERAL ELECTION BALLOTS; CANDIDATES; OFFICIAL IN CHARGE; RULES; REIMBURSEMENT.

Subd. 2. **Pink ballots.** Amendments to the state Constitution shall be placed on a ballot printed on pink paper which shall be known as the "pink ballot." The pink ballot shall be prepared by the county auditor, in the manner provided in the rules of the secretary of state.

Subd. 3. **Canary ballot.** All questions and the names of all candidates for offices to be voted on at the state general election which are not placed on the white ballot shall be placed on a single ballot printed on canary paper which shall be known as the "canary ballot." The canary ballot shall be prepared by the county auditor in the manner provided in the rules of the secretary of state.

205.17 BALLOTS.

Subd. 2. **First class cities.** In all cities of the first class, for the municipal general election, the city clerk shall have printed in blocks of 50 a partisan ballot upon which the names of all candidates for the office of mayor and for the city council are printed, and a nonpartisan ballot upon which the names of all candidates for all other city offices are printed. The partisan ballot shall be printed on light orange paper and shall be headed "City Partisan General Ballot." The nonpartisan ballot shall be printed on light green paper and shall be headed "City Nonpartisan General Ballot." Both ballots shall state the name of the city and the date of the election and conform in all other respects to the white ballot used at the state general election. The names of the candidates on the nonpartisan ballot shall be rotated in the manner prescribed for the rotation of names on nonpartisan ballots in state general elections.

On the partisan ballot the names of the candidates for mayor shall be placed first. The order of the names of the candidates shall be in the manner prescribed for state general elections in section 204D.13.

Subd. 4. **Blue ballots; questions.** All questions relating to the adoption of a city charter or charter amendments, a proposition for the issuance of bonds, and all other questions relating to city or town affairs submitted at an election to the voters of the municipality shall be printed on one separate blue ballot and shall be prepared, printed, and distributed under the direction of the municipal clerk at the same time and in the same manner as other municipal ballots. The ballots,

when voted, shall be deposited in a separate blue ballot box provided by the local authorities for each voting precinct. The ballots shall be canvassed, counted, and returned in the same manner as other municipal ballots. The returns shall provide appropriate blank spaces for the counting, canvassing, and returning of the results of the questions submitted on the blue ballot.

205A.08 BALLOTS.

Subd. 4. **Goldenrod ballots; questions.** All questions relating to a proposition for the issuance of bonds, and all other questions relating to school district affairs submitted at an election to the voters of the school district, shall be printed on one separate goldenrod ballot and shall be prepared, printed, and distributed under the direction of the school district clerk at the same time and in the same manner as other school district ballots. The ballots, when voted, shall be deposited in a separate goldenrod ballot box provided by the local authorities for each voting precinct. The ballots shall be canvassed, counted, and returned in the same manner as other school district ballots. The returns shall provide appropriate blank spaces for the counting, canvassing, and return of the results of the questions submitted on the goldenrod ballot.
