1.6	Section 1. [256B.86] PRESCRIPTION DRUG PURCHASING PROGRAM.
1.7	Subdivision 1. Establishment of program. (a) The commissioner of human services
1.8	shall administer and oversee a Minnesota prescription drug purchasing program for
1.9	prescription drugs provided to program participants.
1.10	(b) For purposes of this section, "program participants" means medical assistance and
1.11	MinnesotaCare enrollees served under the fee-for-service and managed care delivery systems.
1.12	Subd. 2. Duties of commissioner. The commissioner, through the Minnesota prescription
1.13	drug purchasing program, shall:
1.14	(1) make prescription drugs available at the lowest possible cost to program participants;
1.15	(2) promote health through the purchase and provision of discounted prescription drugs
1.16	and coordination of comprehensive prescription benefit services for program participants;
1.17	(3) maintain a list of prescription drugs recommended as the most effective prescription
1.18	drugs available at the best possible prices;
1.19	(4) administer prescription drug benefits for medical assistance and MinnesotaCare; and

drug p	archasing program, the commissioner, in consultation with the Formulary Committee
establi	shed under section 256B.0625, subdivision 13c, has the authority to:

<u>(2)</u>	engage in price negotiations with prescription drug manufacturers, wholesalers, or
group	ourchasing organizations to obtain price discounts and rebates for prescription drugs
for pro	gram participants; and
<u>(3)</u>	develop and manage a drug formulary for the program.
<u>(b)</u>	The commissioner may contract with one or more entities to perform any of the
function	ons described in paragraph (a).

to part	cipate in the program. All pharmacies participating as medical assistance providers,
and an	y other pharmacy licensed under chapter 151 willing to accept the terms and

Sub	od. 5. Federal approval. The commissioner shall seek any necessary federal approvals
to imp	lement this section.
<u>EF</u>	FECTIVE DATE. This section is effective January 1, 2023, or upon federal approval,

The	e commissioner of human services, in consultation with the commissioners of

enrolle	es of health plan companies that have contracted with the commissioner to participate
in the 1	program. The recommendations must address the process and terms by which the
commi	ssioner would contract with health plan companies to administer prescription drug
benefit	s and develop and manage a drug formulary. The commissioner shall present
recomi	mendations to the chairs and ranking minority members of the legislative committees
with ju	risdiction over commerce and health and human services policy and finance by
Decem	ber 15, 2023.
