2.1 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

2.2 **ARTICLE 1**
2.3 **HEALTH CARE**

2.4 Section 1. Minnesota Statutes 2018, section 256B.04, subdivision 21, is amended to read:

2.5 Subd. 21. **Provider enrollment.** (a) If the commissioner or the Centers for Medicare
2.6 and Medicaid Services determines that a provider is designated "high-risk," the commissioner
2.7 may withhold payment from providers within that category upon initial enrollment for a
2.8 90-day period. The withholding for each provider must begin on the date of the first
2.9 submission of a claim.

2.10 (b) An enrolled provider that is also licensed by the commissioner under chapter 245A,
2.11 or is licensed as a home care provider by the Department of Health under chapter 144A and
2.12 has a home and community-based services designation on the home care license under
2.13 section 144A.484, must designate an individual as the entity's compliance officer. The
2.14 compliance officer must:

2.15 (1) develop policies and procedures to assure adherence to medical assistance laws and
2.16 regulations and to prevent inappropriate claims submissions;

2.17 (2) train the employees of the provider entity, and any agents or subcontractors of the
2.18 provider entity including billers, on the policies and procedures under clause (1);

2.19 (3) respond to allegations of improper conduct related to the provision or billing of
2.20 medical assistance services, and implement action to remediate any resulting problems;

2.21 (4) use evaluation techniques to monitor compliance with medical assistance laws and
2.22 regulations;

2.23 (5) promptly report to the commissioner any identified violations of medical assistance
2.24 laws or regulations; and

2.25 (6) within 60 days of discovery by the provider of a medical assistance reimbursement
2.26 overpayment, report the overpayment to the commissioner and make arrangements with
2.27 the commissioner for the commissioner's recovery of the overpayment.

2.28 The commissioner may require, as a condition of enrollment in medical assistance, that a
2.29 provider within a particular industry sector or category establish a compliance program that
2.30 contains the core elements established by the Centers for Medicare and Medicaid Services.

3.1 (c) The commissioner may revoke the enrollment of an ordering or rendering provider
3.2 for a period of not more than one year, if the provider fails to maintain and, upon request
3.3 from the commissioner, provide access to documentation relating to written orders or requests
3.4 for payment for durable medical equipment, certifications for home health services, or
3.5 referrals for other items or services written or ordered by such provider, when the
3.6 commissioner has identified a pattern of a lack of documentation. A pattern means a failure
3.7 to maintain documentation or provide access to documentation on more than one occasion.
3.8 Nothing in this paragraph limits the authority of the commissioner to sanction a provider
3.9 under the provisions of section 256B.064.

3.10 (d) The commissioner shall terminate or deny the enrollment of any individual or entity
3.11 if the individual or entity has been terminated from participation in Medicare or under the
3.12 Medicaid program or Children's Health Insurance Program of any other state. The
3.13 commissioner may exempt a rehabilitation agency from termination or denial that would
3.14 otherwise be required under this paragraph, if the agency:

3.15 (1) is unable to retain Medicare certification and enrollment solely due to a lack of billing
3.16 to the Medicare program;

3.17 (2) meets all other applicable Medicare certification requirements based on an on-site
3.18 review completed by the commissioner of health; and

3.19 (3) serves primarily a pediatric population.

3.20 (e) As a condition of enrollment in medical assistance, the commissioner shall require
3.21 that a provider designated "moderate" or "high-risk" by the Centers for Medicare and
3.22 Medicaid Services or the commissioner permit the Centers for Medicare and Medicaid
3.23 Services, its agents, or its designated contractors and the state agency, its agents, or its
3.24 designated contractors to conduct unannounced on-site inspections of any provider location.
3.25 The commissioner shall publish in the Minnesota Health Care Program Provider Manual a
3.26 list of provider types designated "limited," "moderate," or "high-risk," based on the criteria
3.27 and standards used to designate Medicare providers in Code of Federal Regulations, title
3.28 42, section 424.518. The list and criteria are not subject to the requirements of chapter 14.
3.29 The commissioner's designations are not subject to administrative appeal.

3.30 (f) As a condition of enrollment in medical assistance, the commissioner shall require
3.31 that a high-risk provider, or a person with a direct or indirect ownership interest in the
3.32 provider of five percent or higher, consent to criminal background checks, including
3.33 fingerprinting, when required to do so under state law or by a determination by the

4.1 commissioner or the Centers for Medicare and Medicaid Services that a provider is designated
4.2 high-risk for fraud, waste, or abuse.

4.3 (g)(1) Upon initial enrollment, reenrollment, and notification of revalidation, all durable
4.4 medical equipment, prosthetics, orthotics, and supplies (DMEPOS) medical suppliers
4.5 meeting the durable medical equipment provider and supplier definition in clause (3),
4.6 operating in Minnesota and receiving Medicaid funds must purchase a surety bond that is
4.7 annually renewed and designates the Minnesota Department of Human Services as the
4.8 obligee, and must be submitted in a form approved by the commissioner. For purposes of
4.9 this clause, the following medical suppliers are not required to obtain a surety bond: a
4.10 federally qualified health center, a home health agency, the Indian Health Service, a
4.11 pharmacy, and a rural health clinic.

4.12 (2) At the time of initial enrollment or reenrollment, durable medical equipment providers
4.13 and suppliers defined in clause (3) must purchase a surety bond of \$50,000. If a revalidating
4.14 provider's Medicaid revenue in the previous calendar year is up to and including \$300,000,
4.15 the provider agency must purchase a surety bond of \$50,000. If a revalidating provider's
4.16 Medicaid revenue in the previous calendar year is over \$300,000, the provider agency must
4.17 purchase a surety bond of \$100,000. The surety bond must allow for recovery of costs and
4.18 fees in pursuing a claim on the bond.

4.19 (3) "Durable medical equipment provider or supplier" means a medical supplier that can
4.20 purchase medical equipment or supplies for sale or rental to the general public and is able
4.21 to perform or arrange for necessary repairs to and maintenance of equipment offered for
4.22 sale or rental.

4.23 (h) The Department of Human Services may require a provider to purchase a surety
4.24 bond as a condition of initial enrollment, reenrollment, reinstatement, or continued enrollment
4.25 if: (1) the provider fails to demonstrate financial viability, (2) the department determines
4.26 there is significant evidence of or potential for fraud and abuse by the provider, or (3) the
4.27 provider or category of providers is designated high-risk pursuant to paragraph (a) and as
4.28 per Code of Federal Regulations, title 42, section 455.450. The surety bond must be in an
4.29 amount of \$100,000 or ten percent of the provider's payments from Medicaid during the
4.30 immediately preceding 12 months, whichever is greater. The surety bond must name the
4.31 Department of Human Services as an obligee and must allow for recovery of costs and fees
4.32 in pursuing a claim on the bond. This paragraph does not apply if the provider currently
4.33 maintains a surety bond under the requirements in section 256B.0659 or 256B.85.

5.1 Sec. 2. **PAIN MANAGEMENT.**

5.2 (a) The Health Services Policy Committee established under Minnesota Statutes, section
5.3 256B.0625, subdivision 3c, shall evaluate and make recommendations on the integration
5.4 of nonpharmacologic pain management that are clinically viable and sustainable; reduce or
5.5 eliminate chronic pain conditions; improve functional status; and prevent addiction and
5.6 reduce dependence on opiates or other pain medications. The recommendations must be
5.7 based on best practices for the effective treatment of musculoskeletal pain provided by
5.8 health practitioners identified in paragraph (b), and covered under medical assistance. Each
5.9 health practitioner represented under paragraph (b) shall present the minimum best integrated
5.10 practice recommendations, policies, and scientific evidence for nonpharmacologic treatment
5.11 options for eliminating pain and improving functional status within their full professional
5.12 scope. Recommendations for integration of services may include guidance regarding
5.13 screening for co-occurring behavioral health diagnoses; protocols for communication between
5.14 all providers treating a unique individual, including protocols for follow-up; and universal
5.15 mechanisms to assess improvements in functional status.

5.16 (b) In evaluating and making recommendations, the Health Services Policy Committee
5.17 shall consult and collaborate with the following health practitioners: acupuncture practitioners
5.18 licensed under Minnesota Statutes, chapter 147B; chiropractors licensed under Minnesota
5.19 Statutes, sections 148.01 to 148.10; physical therapists licensed under Minnesota Statutes,
5.20 sections 148.68 to 148.78; medical and osteopathic physicians licensed under Minnesota
5.21 Statutes, chapter 147, and advanced practice registered nurses licensed under Minnesota
5.22 Statutes, sections 148.171 to 148.285, with experience in providing primary care
5.23 collaboratively within a multidisciplinary team of health care practitioners who employ
5.24 nonpharmacologic pain therapies; and psychologists licensed under Minnesota Statutes,
5.25 section 148.907.

5.26 (c) The commissioner shall submit a progress report to the chairs and ranking minority
5.27 members of the legislative committees with jurisdiction over health and human services
5.28 policy and finance by January 15, 2020, and shall report final recommendations by August
5.29 1, 2020. The final report may also contain recommendations for developing and implementing
5.30 a pilot program to assess the clinical viability, sustainability, and effectiveness of integrated
5.31 nonpharmacologic, multidisciplinary treatments for managing musculoskeletal pain and
5.32 improving functional status.

6.2 **HOME CARE LICENSING**

6.3 Section 1. Minnesota Statutes 2018, section 144A.43, subdivision 11, is amended to read:

6.4 Subd. 11. **Medication administration.** "Medication administration" means performing
6.5 a set of tasks ~~to ensure a client takes medications, and includes~~ that include the following:

6.6 (1) checking the client's medication record;

6.7 (2) preparing the medication as necessary;

6.8 (3) administering the medication to the client;

6.9 (4) documenting the administration or reason for not administering the medication; and

6.10 (5) reporting to a registered nurse or appropriate licensed health professional any concerns
6.11 about the medication, the client, or the client's refusal to take the medication.

6.12 Sec. 2. Minnesota Statutes 2018, section 144A.43, is amended by adding a subdivision to
6.13 read:

6.14 Subd. 12a. **Medication reconciliation.** "Medication reconciliation" means the process
6.15 of identifying the most accurate list of all medications the client is taking, including the
6.16 name, dosage, frequency, and route by comparing the client record to an external list of
6.17 medications obtained from the client, hospital, prescriber, or other provider.

6.18 Sec. 3. Minnesota Statutes 2018, section 144A.43, subdivision 27, is amended to read:

6.19 Subd. 27. **Service ~~plan~~ agreement.** "Service ~~plan~~ agreement" means the written ~~plan~~
6.20 agreement between the client or client's representative and the temporary licensee or licensee
6.21 about the services that will be provided to the client.

6.22 Sec. 4. Minnesota Statutes 2018, section 144A.43, subdivision 30, is amended to read:

6.23 Subd. 30. **Standby assistance.** "Standby assistance" means the presence of another
6.24 person ~~within arm's reach to minimize the risk of injury while performing daily activities~~
6.25 ~~through physical intervention or cueing~~ to assist a client with an assistive task by providing
6.26 cues, oversight, and minimal physical assistance.

6.27 Sec. 5. Minnesota Statutes 2018, section 144A.472, subdivision 5, is amended to read:

6.28 Subd. 5. **Transfers prohibited; Changes in ownership.** ~~Any~~ (a) A home care license
6.29 issued by the commissioner may not be transferred to another party. Before acquiring

7.1 ownership of or a controlling interest in a home care provider business, a prospective
 7.2 ~~applicant~~ owner must apply for a new ~~temporary~~ license. A change of ownership is a transfer
 7.3 of operational control ~~to a different business entity~~ of the home care provider business and
 7.4 includes:

7.5 (1) transfer of the business to a different or new corporation;

7.6 (2) in the case of a partnership, the dissolution or termination of the partnership under
 7.7 chapter 323A, with the business continuing by a successor partnership or other entity;

7.8 (3) relinquishment of control of the provider to another party, including to a contract
 7.9 management firm that is not under the control of the owner of the business' assets;

7.10 (4) transfer of the business by a sole proprietor to another party or entity; or

7.11 (5) ~~in the case of a privately held corporation, the change in~~ transfer of ownership or
 7.12 control of 50 percent or more of the ~~outstanding voting stock~~ controlling interest of a home
 7.13 care provider business not covered by clauses (1) to (4).

7.14 (b) An employee who was employed by the previous owner of the home care provider
 7.15 business prior to the effective date of a change in ownership under paragraph (a), and who
 7.16 will be employed by the new owner in the same or a similar capacity, shall be treated as if
 7.17 no change in employer occurred, with respect to orientation, training, tuberculosis testing,
 7.18 background studies, and competency testing and training on the policies identified in
 7.19 subdivisions 1, clause (14), and 2, if applicable.

7.20 (c) Notwithstanding paragraph (b), a new owner of a home care provider business must
 7.21 ensure that employees of the provider receive and complete training and testing on any
 7.22 provisions of policies that differ from those of the previous owner, within 90 days after the
 7.23 date of the change in ownership.

7.24 Sec. 6. Minnesota Statutes 2018, section 144A.472, subdivision 7, is amended to read:

7.25 Subd. 7. **Fees; application, change of ownership, ~~and~~ renewal, and failure to**
 7.26 **notify.** (a) An initial applicant seeking temporary home care licensure must submit the
 7.27 following application fee to the commissioner along with a completed application:

7.28 (1) for a basic home care provider, \$2,100; or

7.29 (2) for a comprehensive home care provider, \$4,200.

7.30 (b) A home care provider who is filing a change of ownership as required under
 7.31 subdivision 5 must submit the following application fee to the commissioner, along with
 7.32 the documentation required for the change of ownership:

8.1 (1) for a basic home care provider, \$2,100; or

8.2 (2) for a comprehensive home care provider, \$4,200.

8.3 (c) For the period ending June 30, 2018, a home care provider who is seeking to renew
8.4 the provider's license shall pay a fee to the commissioner based on revenues derived from
8.5 the provision of home care services during the calendar year prior to the year in which the
8.6 application is submitted, according to the following schedule:

8.30 fee shall be based on revenues derived from the provision of home care services during the
8.31 calendar year prior to the year in which the application is submitted.

8.32 (e) Beginning July 1, 2020, a home care provider who is seeking to renew the provider's
8.33 license shall pay a fee to the commissioner based on revenues derived from the provision
8.34 of home care services during the calendar year prior to the year in which the application is
8.35 submitted, according to the following schedule:

9.20 (f) If requested, the home care provider shall provide the commissioner information to
 9.21 verify the provider's annual revenues or other information as needed, including copies of
 9.22 documents submitted to the Department of Revenue.

9.23 (g) At each annual renewal, a home care provider may elect to pay the highest renewal
 9.24 fee for its license category, and not provide annual revenue information to the commissioner.

9.25 (h) A temporary license or license applicant, or temporary licensee or licensee that
 9.26 knowingly provides the commissioner incorrect revenue amounts for the purpose of paying
 9.27 a lower license fee, shall be subject to a civil penalty in the amount of double the fee the
 9.28 provider should have paid.

9.29 (i) The fee for failure to comply with the notification requirements of section 144A.473,
 9.30 subdivision 2, paragraph (c), is \$1,000.

9.31 (j) Fees and penalties collected under this section shall be deposited in the state treasury
 9.32 and credited to the state government special revenue fund. All fees are nonrefundable. Fees
 9.33 collected under paragraphs (c), (d), and (e) are nonrefundable even if received before July
 9.34 1, 2017, for temporary licenses or licenses being issued effective July 1, 2017, or later.

10.1 Sec. 7. Minnesota Statutes 2018, section 144A.473, is amended to read:

10.2 **144A.473 ISSUANCE OF TEMPORARY LICENSE AND LICENSE RENEWAL.**

10.3 Subdivision 1. **Temporary license and renewal of license.** (a) The department shall
10.4 review each application to determine the applicant's knowledge of and compliance with
10.5 Minnesota home care regulations. Before granting a temporary license or renewing a license,
10.6 the commissioner may further evaluate the applicant or licensee by requesting additional
10.7 information or documentation or by conducting an on-site survey of the applicant to
10.8 determine compliance with sections 144A.43 to 144A.482.

10.9 (b) Within 14 calendar days after receiving an application for a license, the commissioner
10.10 shall acknowledge receipt of the application in writing. The acknowledgment must indicate
10.11 whether the application appears to be complete or whether additional information is required
10.12 before the application will be considered complete.

10.13 (c) Within 90 days after receiving a complete application, the commissioner shall issue
10.14 a temporary license, renew the license, or deny the license.

10.15 (d) The commissioner shall issue a license that contains the home care provider's name,
10.16 address, license level, expiration date of the license, and unique license number. All licenses,
10.17 except for temporary licenses issued under subdivision 2, are valid for up to one year from
10.18 the date of issuance.

10.19 Subd. 2. **Temporary license.** (a) For new license applicants, the commissioner shall
10.20 issue a temporary license for either the basic or comprehensive home care level. A temporary
10.21 license is effective for up to one year from the date of issuance, except that a temporary
10.22 license may be extended according to subdivision 3. Temporary licensees must comply with
10.23 sections 144A.43 to 144A.482.

10.24 (b) During the temporary license year period, the commissioner shall survey the temporary
10.25 licensee within 90 calendar days after the commissioner is notified or has evidence that the
10.26 temporary licensee is providing home care services.

10.27 (c) Within five days of beginning the provision of services, the temporary licensee must
10.28 notify the commissioner that it is serving clients. The notification to the commissioner may
10.29 be mailed or e-mailed to the commissioner at the address provided by the commissioner. If
10.30 the temporary licensee does not provide home care services during the temporary license
10.31 year period, then the temporary license expires at the end of the year period and the applicant
10.32 must reapply for a temporary home care license. A temporary licensee who fails to comply

11.1 with the notification requirements of this paragraph is subject to the fee described in section
11.2 144A.472, subdivision 7, paragraph (i).

11.3 (d) A temporary licensee may request a change in the level of licensure prior to being
11.4 surveyed and granted a license by notifying the commissioner in writing and providing
11.5 additional documentation or materials required to update or complete the changed temporary
11.6 license application. The applicant must pay the difference between the application fees
11.7 when changing from the basic level to the comprehensive level of licensure. No refund will
11.8 be made if the provider chooses to change the license application to the basic level.

11.9 (e) If the temporary licensee notifies the commissioner that the licensee has clients within
11.10 45 days prior to the temporary license expiration, the commissioner may extend the temporary
11.11 license for up to 60 days in order to allow the commissioner to complete the on-site survey
11.12 required under this section and follow-up survey visits.

11.13 **Subd. 3. Temporary licensee survey.** (a) If the temporary licensee is in substantial
11.14 compliance with the survey, the commissioner shall issue either a basic or comprehensive
11.15 home care license. If the temporary licensee is not in substantial compliance with the survey,
11.16 the commissioner shall either: (1) not issue a basic or comprehensive license and there will
11.17 be no contested hearing right under chapter 14 terminate the temporary license; or (2) extend
11.18 the temporary license for a period not to exceed 90 days and apply conditions, as permitted

144A.45 REGULATION OF HOME CARE SERVICES.

Subd. 6. **Home care providers; tuberculosis prevention and control.** (a) A home care provider must establish and maintain a comprehensive tuberculosis infection control program according to the most current tuberculosis infection control guidelines issued by the United States Centers for Disease Control and Prevention (CDC), Division of Tuberculosis Elimination, as published in CDC's Morbidity and Mortality Weekly Report (MMWR). This program must include a tuberculosis infection control plan that covers all paid and unpaid employees, contractors, students, and volunteers. The Department of Health shall provide technical assistance regarding implementation of the guidelines.

(b) Written compliance with this subdivision must be maintained by the home care provider.

144A.481 HOME CARE LICENSING IMPLEMENTATION FOR NEW LICENSEES AND TRANSITION PERIOD FOR CURRENT LICENSEES.

Subdivision 1. **Temporary home care licenses and changes of ownership.** (a) Beginning January 1, 2014, all temporary license applicants must apply for either a temporary basic or comprehensive home care license.

(b) Temporary home care licenses issued beginning January 1, 2014, shall be issued according to sections 144A.43 to 144A.4798, and the fees in section 144A.472. Temporary licensees must comply with the requirements of this chapter.

(c) No temporary license applications will be accepted nor temporary licenses issued between December 1, 2013, and December 31, 2013.

(d) Beginning October 1, 2013, changes in ownership applications will require payment of the new fees listed in section 144A.472. Providers who are providing nursing, delegated nursing, or professional health care services, must submit the fee for comprehensive home care providers, and all other providers must submit the fee for basic home care providers as provided in section 144A.472. Change of ownership applicants will be issued a new home care license based on the licensure law in effect on June 30, 2013.

Subd. 2. **Current home care licensees with licenses as of December 31, 2013.** (a) Beginning July 1, 2014, department licensed home care providers must apply for either the basic or comprehensive home care license on their regularly scheduled renewal date.

(b) By June 30, 2015, all home care providers must either have a basic or comprehensive home care license or temporary license.

Subd. 3. **Renewal application of home care licensure during transition period.** (a) Renewal and change of ownership applications of home care licenses issued beginning July 1, 2014, will be issued according to sections 144A.43 to 144A.4798 and, upon license renewal or issuance of a new license for a change of ownership, providers must comply with sections 144A.43 to 144A.4798. Prior to renewal, providers must comply with the home care licensure law in effect on June 30, 2013.

(b) The fees charged for licenses renewed between July 1, 2014, and June 30, 2016, shall be the lesser of 200 percent or \$1,000, except where the 200 percent or \$1,000 increase exceeds the actual renewal fee charged, with a maximum renewal fee of \$6,625.

(c) For fiscal year 2014 only, the fees for providers with revenues greater than \$25,000 and no more than \$100,000 will be \$313 and for providers with revenues no more than \$25,000 the fee will be \$125.

256I.05 MONTHLY RATES.

Subd. 3. **Limits on rates.** When a room and board rate is used to pay for an individual's room and board, the rate payable to the residence must not exceed the rate paid by an individual not receiving a room and board rate under this chapter.

9530.6800 ASSESSMENT OF NEED FOR TREATMENT PROGRAMS.

Subpart 1. **Assessment of need required for licensure.** Before a license or a provisional license may be issued, the need for the chemical dependency treatment or rehabilitation program must be determined by the commissioner. Need for an additional or expanded chemical dependency treatment program must be determined, in part, based on the recommendation of the county board of commissioners of the county in which the program will be located and the documentation submitted by the applicant at the time of application.

If the county board fails to submit a statement to the commissioner within 60 days of the county board's receipt of the written request from an applicant, as required under part 9530.6810, the commissioner shall determine the need for the applicant's proposed chemical dependency treatment program based on the documentation submitted by the applicant at the time of application.

Subp. 2. **Documentation of need requirements.** An applicant for licensure under parts 9530.2500 to 9530.4000 and Minnesota Statutes, chapter 245G, must submit the documentation in items A and B to the commissioner with the application for licensure:

A. The applicant must submit documentation that it has requested the county board of commissioners of the county in which the chemical dependency treatment program will be located to submit to the commissioner both a written statement that supports or does not support the need for the program and documentation of the rationale used by the county board to make its determination.

B. The applicant must submit a plan for attracting an adequate number of clients to maintain its proposed program capacity, including:

- (1) a description of the geographic area to be served;
- (2) a description of the target population to be served;
- (3) documentation that the capacity or program designs of existing programs are not sufficient to meet the service needs of the chemically abusing or chemically dependent target population if that information is available to the applicant;
- (4) a list of referral sources, with an estimation as to the number of clients the referral source will refer to the applicant's program in the first year of operation; and
- (5) any other information available to the applicant that supports the need for new or expanded chemical dependency treatment capacity.

9530.6810 COUNTY BOARD RESPONSIBILITY TO REVIEW PROGRAM NEED.

When an applicant for licensure under parts 9530.2500 to 9530.4000 or Minnesota Statutes, chapter 245G, requests a written statement of support for a proposed chemical dependency treatment program from the county board of commissioners of the county in which the proposed program is to be located, the county board, or the county board's designated representative, shall submit a statement to the commissioner that either supports or does not support the need for the applicant's program. The county board's statement must be submitted in accordance with items A and B:

A. the statement must be submitted within 60 days of the county board's receipt of a written request from the applicant for licensure; and

B. the statement must include the rationale used by the county board to make its determination.
