1.21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.22 **ARTICLE 1**

1.23 **VOTER ID**

1.24 Section 1. Minnesota Statutes 2018, section 5B.06, is amended to read:

1.25 **5B.06 VOTING BY PROGRAM PARTICIPANT; ABSENTEE BALLOT.**

1.26 Notwithstanding any law to the contrary, a program participant who is otherwise eligible

1.27 to vote may vote pursuant to this section and may register with the secretary of state as a

1.28 permanent absentee voter. Notwithstanding section 203B.04, subdivision 5, the secretary

1.29 of state is not required to send an absentee ballot application prior to each election to a

2.1 program participant registered as a permanent absentee voter under this section. As soon  
2.2 as practicable before each election, the secretary of state shall determine the precinct in  
2.3 which the residential address of the program participant is located and shall request from  
2.4 and receive from the county auditor or other election official the ballot for that precinct and  
2.5 shall forward the absentee ballot to the program participant with the other materials for  
2.6 absentee balloting as required by Minnesota law. The program participant shall complete  
2.7 the ballot and return it to the secretary of state, who shall review the ballot in the manner  
2.8 provided by section 203B.121, subdivision 2. If the ballot and ballot materials comply with  
2.9 the requirements of that section, the ballot must be certified by the secretary of state as the  
2.10 ballot of a program participant, and must be forwarded to the appropriate electoral jurisdiction  
2.11 for tabulation along with all other ballots. The name and address of a program participant  
2.12 must not be listed in the statewide voter registration system.

2.13 Sec. 2. Minnesota Statutes 2018, section 13.6905, is amended by adding a subdivision to  
2.14 read:

2.15 Subd. 36. **Voter identification card.** Applicant data related to a voter identification  
2.16 card is governed by section 171.06, subdivision 3c.

2.17 **EFFECTIVE DATE.** This section is effective June 1, 2021.

2.18 Sec. 3. Minnesota Statutes 2018, section 144.226, is amended by adding a subdivision to  
2.19 read:

2.20 Subd. 7. **Documents required for voter identification card.** (a) Notwithstanding  
2.21 provisions to the contrary in this section, no fee or surcharge shall be charged by the state  
2.22 registrar or local issuance office for a certified vital record if the applicant attests that the  
2.23 record is needed to obtain a voter identification card issued pursuant to section 171.07,  
2.24 subdivision 3b.

2.25 (b) The state registrar and local issuance offices shall report each year to the commissioner  
2.26 of management and budget the number of records obtained under this subdivision for which  
2.27 no fee or surcharge was charged.

2.28 **EFFECTIVE DATE.** This section is effective June 1, 2021.

2.29 Sec. 4. Minnesota Statutes 2018, section 144.226, is amended by adding a subdivision to  
2.30 read:

2.31 Subd. 8. **Appropriations and transfers.** (a) Each year, an amount equal to the total  
2.32 number of records reported to the commissioner of management and budget under subdivision

3.1 7, paragraph (b), for that year times the amount of the surcharge under section 144.226,  
3.2 subdivision 3, paragraph (b), is appropriated from the general fund to the commissioner of  
3.3 health for the administration of this section.

3.4 (b) Each year, an amount equal to the total number of records reported to the  
3.5 commissioner of management and budget under subdivision 7, paragraph (b), for that year  
3.6 times the amount of the surcharge under subdivision 4, is transferred from the general fund  
3.7 to the state government special revenue fund. This amount is appropriated annually from  
3.8 the state government special revenue fund to the commissioner of health for the  
3.9 administration of this section.

3.10 (c) Each year, an amount equal to the total number of records reported to the  
3.11 commissioner of management and budget under subdivision 7, paragraph (b), for that year  
3.12 times the amount of the surcharge under subdivision 3, paragraph (a), is transferred from  
3.13 the general fund to the account for the children's trust fund for the prevention of child abuse  
3.14 established under section 256E.22.

3.15 (d) Each year an amount equal to the number of records reported to the commissioner  
3.16 of management and budget by the state registrar under subdivision 7, paragraph (b), for that  
3.17 year times the amount of the fee under subdivision 1, paragraph (b), is transferred from the  
3.18 general fund to the state government special revenue fund. This amount is appropriated  
3.19 annually from the state government special revenue fund to the commissioner of health for  
3.20 the administration of this section.

3.21 (e) The commissioner of health must transmit payment of \$9 to a local issuance office  
3.22 for each certified vital record issued for no charge under subdivision 7, paragraph (a). Each  
3.23 year, an amount equal to the number of records reported to the commissioner of management  
3.24 and budget by local issuance offices under subdivision 7, paragraph (b), for that year times  
3.25 the amount of the fee under subdivision 1, paragraph (b), is appropriated from the general  
3.26 fund to the commissioner of health to make payments under this paragraph.

3.27 **EFFECTIVE DATE.** This section is effective June 1, 2021.

3.28 Sec. 5. Minnesota Statutes 2018, section 171.06, subdivision 1, is amended to read:

3.29 Subdivision 1. **Application format and requirements.** Every application for a Minnesota  
3.30 identification card, including an enhanced identification card, or for a driver's license,  
3.31 including an instruction permit, a provisional license, ~~and~~ an enhanced driver's license, or  
3.32 voter identification card, must be made in a format approved by the department. Every  
3.33 application must be accompanied by payment of the proper fee except for an application

4.1 for a voter identification card issued pursuant to section 171.07, subdivision 3b. All applicants  
 4.2 must sign the application and declare, under penalty of perjury, that the information and  
 4.3 documentation presented in the application is true and correct. All applications requiring  
 4.4 evidence of legal presence in the United States or United States citizenship must be signed  
 4.5 in the presence of the person authorized to accept the application, or the signature on the  
 4.6 application may be verified by a notary public.

4.7 **EFFECTIVE DATE.** This section is effective June 1, 2021.

5.13 From August 1, 2019, to June 30, 2022, the fee is increased by \$0.75 for REAL ID compliant  
 5.14 or noncompliant classified driver's licenses, REAL ID compliant or noncompliant classified  
 5.15 under-21 driver's licenses, and enhanced driver's licenses.

5.16 (b) In addition to each fee required in paragraph (a), the commissioner shall collect a  
 5.17 surcharge of \$2.25. Surcharges collected under this paragraph must be credited to the driver  
 5.18 and vehicle services technology account under section 299A.705.

5.19 (c) Notwithstanding paragraph (a), an individual who holds a provisional license and  
 5.20 has a driving record free of (1) convictions for a violation of section 169A.20, 169A.33,  
 5.21 169A.35, sections 169A.50 to 169A.53, or section 171.177, (2) convictions for crash-related  
 5.22 moving violations, and (3) convictions for moving violations that are not crash related, shall  
 5.23 have a \$3.50 credit toward the fee for any classified under-21 driver's license. "Moving  
 5.24 violation" has the meaning given it in section 171.04, subdivision 1.

5.25 (d) In addition to the driver's license fee required under paragraph (a), the commissioner  
 5.26 shall collect an additional \$4 processing fee from each new applicant or individual renewing  
 5.27 a license with a school bus endorsement to cover the costs for processing an applicant's  
 5.28 initial and biennial physical examination certificate. The department shall not charge these  
 5.29 applicants any other fee to receive or renew the endorsement.

5.30 (e) In addition to the fee required under paragraph (a), a driver's license agent may charge  
 5.31 and retain a filing fee as provided under section 171.061, subdivision 4.

5.32 (f) In addition to the fee required under paragraph (a), the commissioner shall charge a  
 5.33 filing fee at the same amount as a driver's license agent under section 171.061, subdivision  
 5.34 4. Revenue collected under this paragraph must be deposited in the driver services operating  
 5.35 account under section 299A.705.

5.36 (g) An application for a Minnesota identification card, instruction permit, provisional  
 5.37 license, or driver's license, including an application for renewal, must contain a provision

6.1 that allows the applicant to add to the fee under paragraph (a), a \$2 donation for the purposes  
6.2 of public information and education on anatomical gifts under section 171.075.

6.3 (h) The commissioner or driver's license agent must not collect any fee or surcharge for  
6.4 a voter identification card issued pursuant to section 171.07, subdivision 3b.

6.5 **EFFECTIVE DATE.** This section is effective June 1, 2021.

6.6 Sec. 7. Minnesota Statutes 2018, section 171.06, is amended by adding a subdivision to  
6.7 read:

6.8 Subd. 3c. **Application for voter identification card.** (a) An application for a voter  
6.9 identification card, including a renewal or duplicate card, must:

6.10 (1) state the applicant's full legal name, date of birth, sex, residence address, and (i) last  
6.11 four digits of the applicant's Social Security number, or (ii) certification that the applicant  
6.12 has not been assigned a Social Security number;

6.13 (2) provide a description of the applicant in the same manner as required on an application  
6.14 for a Minnesota driver's license;

6.15 (3) provide proof of the applicant's United States citizenship by presenting a document  
6.16 included in Minnesota Rules, part 7410.0400, subpart 1, item D;

6.17 (4) state the length of residence at the applicant's current address; and

6.18 (5) present a photographic identity document described in section 200.035 or affirm  
6.19 under penalty of perjury that the applicant has a religious objection to the use of a  
6.20 photographic image.

6.21 (b) Applicant data, submitted pursuant to this subdivision, is private data on individuals,  
6.22 as defined in section 13.02, subdivision 12.

6.23 **EFFECTIVE DATE.** This section is effective June 1, 2021.

6.24 Sec. 8. Minnesota Statutes 2018, section 171.061, subdivision 4, is amended to read:

6.25 Subd. 4. **Fee; equipment.** (a) The agent may charge and retain a filing fee of \$8 for each  
6.26 application, except for an application for a voter identification card issued pursuant to section  
6.27 171.07, subdivision 3b, for which no filing fee may be charged. Except as provided in  
6.28 paragraph (c), the fee shall cover all expenses involved in receiving, accepting, or forwarding  
6.29 to the department the applications and fees required under sections 171.02, subdivision 3;  
6.30 171.06, subdivisions 2 and 2a; and 171.07, subdivisions 3 and 3a.

7.1 (b) The statutory fees and the filing fees imposed under paragraph (a) may be paid by  
7.2 credit card or debit card. The driver's license agent may collect a convenience fee on the  
7.3 statutory fees and filing fees not greater than the cost of processing a credit card or debit  
7.4 card transaction. The convenience fee must be used to pay the cost of processing credit card  
7.5 and debit card transactions. The commissioner shall adopt rules to administer this paragraph  
7.6 using the exempt procedures of section 14.386, except that section 14.386, paragraph (b),  
7.7 does not apply.

7.8 (c) The department shall maintain the photo identification equipment for all agents  
7.9 appointed as of January 1, 2000. Upon the retirement, resignation, death, or discontinuance  
7.10 of an existing agent, and if a new agent is appointed in an existing office pursuant to  
7.11 Minnesota Rules, chapter 7404, and notwithstanding the above or Minnesota Rules, part  
7.12 7404.0400, the department shall provide and maintain photo identification equipment without  
7.13 additional cost to a newly appointed agent in that office if the office was provided the  
7.14 equipment by the department before January 1, 2000. All photo identification equipment  
7.15 must be compatible with standards established by the department.

7.16 (d) A filing fee retained by the agent employed by a county board must be paid into the  
7.17 county treasury and credited to the general revenue fund of the county. An agent who is not  
7.18 an employee of the county shall retain the filing fee in lieu of county employment or salary  
7.19 and is considered an independent contractor for pension purposes, coverage under the  
7.20 Minnesota State Retirement System, or membership in the Public Employees Retirement  
7.21 Association.

7.22 (e) Before the end of the first working day following the final day of the reporting period  
7.23 established by the department, the agent must forward to the department all applications  
7.24 and fees collected during the reporting period except as provided in paragraph (d).

7.25 (f) The commissioner must transmit payment to the agent of \$8 for each application for  
7.26 a voter identification card issued pursuant to section 171.07, subdivision 3b. An agent  
7.27 employed by a county board must remit the payments to the county under paragraph (d).  
7.28 All other agents may retain the payments.

7.29 **EFFECTIVE DATE.** This section is effective June 1, 2021.

7.30 Sec. 9. Minnesota Statutes 2018, section 171.07, is amended by adding a subdivision to  
7.31 read:

7.32 Subd. 3b. **Voter identification cards.** (a) A voter identification card must be issued to  
7.33 a qualifying applicant who, on the election day next occurring after the date of issuance,

8.1 will meet the voter eligibility requirements of the Minnesota Constitution and Minnesota  
 8.2 Statutes, and who does not possess a current Minnesota driver's license or Minnesota  
 8.3 identification card.

8.4 (b) A voter identification card must bear a distinguishing number assigned to the  
 8.5 applicant, the applicant's full name and date of birth, the applicant's address of residence,  
 8.6 a description of the applicant in the same manner as provided on a Minnesota driver's license,  
 8.7 the date of the card's expiration, and the usual signature of the applicant. The card must bear  
 8.8 a colored photograph or an electronically produced image of the applicant, or, for an applicant  
 8.9 who has affirmed a religious objection under section 171.06, subdivision 3b, clause (5), the  
 8.10 card must bear the words "Valid without photograph."

8.11 (c) A voter identification card is not valid identification for any purpose other than  
 8.12 proving identity and residence for voting purposes.

8.13 (d) A voter identification card must be of a different color scheme than a Minnesota  
 8.14 driver's license or state identification card, but must incorporate the same information and  
 8.15 security features as provided in subdivision 9.

8.16 (e) Each voter identification card must be plainly marked: "Voter Identification Card.  
 8.17 Valid Identification Only for Voting."

8.18 **EFFECTIVE DATE.** This section is effective June 1, 2021.

8.19 Sec. 10. Minnesota Statutes 2018, section 171.07, subdivision 4, is amended to read:

8.20 Subd. 4. **Identification card expiration.** (a) Except as otherwise provided in this  
 8.21 subdivision, the expiration date of a Minnesota identification card or voter identification  
 8.22 card is the birthday of the applicant in the fourth year following the date of issuance of the  
 8.23 card.

8.24 (b) For an applicant age 65 or older:

8.25 (1) the expiration date of a Minnesota identification card or voter identification card is  
 8.26 the birthday of the applicant in the eighth year following the date of issuance of the card;  
 8.27 or

8.28 (2) a noncompliant identification card is valid for the lifetime of the applicant.

8.29 (c) For the purposes of paragraph (b), "Minnesota identification card" does not include  
 8.30 an enhanced identification card issued to an applicant age 65 or older.

8.31 (d) The expiration date for an Under-21 identification card is the cardholder's 21st  
 8.32 birthday. The commissioner shall issue an identification card to a holder of an Under-21



9.1 identification card who applies for the card, pays the required fee, and presents proof of  
 9.2 identity and age, unless the commissioner determines that the applicant is not qualified for  
 9.3 the identification card.

9.4 (e) Notwithstanding paragraphs (a) to (d), the expiration date for an identification card  
 9.5 issued to a person with temporary lawful status is the last day of the person's legal stay in  
 9.6 the United States, or one year after issuance if the last day of the person's legal stay is not  
 9.7 identified.

9.8 (f) Notwithstanding paragraphs (a) to (d), a voter identification card issued pursuant to  
 9.9 section 171.07, subdivision 3b, to a person then or subsequently serving outside Minnesota  
 9.10 in active military service, as defined in section 190.05, subdivision 5, in any branch or unit  
 9.11 of the armed forces of the United States, or the person's spouse, continues in full force and  
 9.12 effect without requirement for renewal until the date one year following the service member's  
 9.13 separation or discharge from active military service, or until the cardholder's birthday in  
 9.14 the fourth full year following the person's most recent card renewal or until the person's  
 9.15 birthday in the third full year following the renewal.

9.16 **EFFECTIVE DATE.** This section is effective June 1, 2021.

9.17 Sec. 11. Minnesota Statutes 2018, section 171.11, is amended to read:

9.18 **171.11 DUPLICATE LICENSE; CHANGE OF DOMICILE OR NAME.**

9.19 Subdivision 1. Duplicate driver's license. When any person, after applying for or  
 9.20 receiving a driver's license, shall change permanent domicile from the address named in  
 9.21 such application or in the license issued to the person, or shall change a name by marriage  
 9.22 or otherwise, such person shall, within 30 days thereafter, apply for a duplicate driver's  
 9.23 license upon a form furnished by the department and pay the required fee. The application  
 9.24 or duplicate license shall show both the licensee's old address and new address or the former  
 9.25 name and new name as the case may be.

9.26 Subd. 2. Duplicate voter identification card. A voter identification cardholder who  
 9.27 changes residence address or name from the address or name stated on the card shall not  
 9.28 present the card for voting purposes, but must apply for a duplicate voter identification card  
 9.29 upon a form furnished by the department. The application for a duplicate voter identification  
 9.30 card must show the cardholder's former address and current address, along with length of  
 9.31 residence at the current address, and the cardholder's former name and current name, as  
 9.32 applicable.

9.33 **EFFECTIVE DATE.** This section is effective June 1, 2021.

10.1 Sec. 12. Minnesota Statutes 2018, section 171.14, is amended to read:

10.2 **171.14 CANCELLATION.**

10.3 Subdivision 1. Cancellation of driver's license. (a) The commissioner may cancel any  
 10.4 driver's license upon determination that (1) the licensee was not entitled to the issuance of  
 10.5 the license, (2) the licensee failed to give the required or correct information in the  
 10.6 application, (3) the licensee committed any fraud or deceit in making the application, or (4)  
 10.7 the person, at the time of the cancellation, would not have been entitled to receive a license  
 10.8 under section 171.04.

10.9 (b) The commissioner shall cancel the driver's license of a person described in paragraph  
 10.10 (a), clause (3), for 60 days or until the required or correct information has been provided,  
 10.11 whichever is longer.

10.12 Subd. 2. Cancellation of voter identification card. (a) The commissioner must cancel  
 10.13 any voter identification card issued pursuant to section 171.07, subdivision 3b, upon  
 10.14 determination that (1) the cardholder was not entitled to the issuance of the card, (2) the  
 10.15 cardholder failed to give the required or correct information in the application, (3) the  
 10.16 cardholder committed any fraud or deceit in making the application, or (4) the cardholder,  
 10.17 at the time of the cancellation, would not have been entitled to receive a voter identification  
 10.18 card under section 171.07, subdivision 3b.

10.19 (b) The commissioner must cancel the voter identification card issued pursuant to section  
 10.20 171.07, subdivision 3b, of a person described in paragraph (a) until the person completes  
 10.21 the application process under section 171.07, subdivision 3b, and complies in all respects  
 10.22 with the requirements of the commissioner.

10.23 (c) The commissioner must immediately notify the holder of a voter identification card  
 10.24 issued pursuant to section 171.07, subdivision 3b, of a cancellation of the card. Notification  
 10.25 must be by mail and addressed to the cardholder's last known address.

10.26 **EFFECTIVE DATE.** This section is effective June 1, 2021.

10.27 Sec. 13. **[200.035] DOCUMENTATION OF IDENTITY AND RESIDENCE.**

10.28 (a) The following are sufficient proof of identity and residence for purposes of election  
 10.29 day voter registration under section 201.061, subdivision 3; absentee voting under sections  
 10.30 203B.04, 203B.07, and 203B.08; photo identification requirements under section 204C.10;  
 10.31 and for determining whether to count a provisional ballot under section 204C.135, subdivision  
 10.32 2:

11.1 (1) a current driver's license, state identification card, or voter identification card issued  
11.2 to the voter by the Department of Public Safety that contains the voter's photograph and  
11.3 current address of residence in the precinct;

11.4 (2) a valid United States military identification card issued to the voter by the Department  
11.5 of Defense that contains the voter's photograph and current address of residence in the  
11.6 precinct;

11.7 (3) an identification card issued to the voter by the tribal government of a tribe recognized  
11.8 by the Bureau of Indian Affairs that contains a photograph of the voter, the voter's current  
11.9 address of residence in the precinct, and any other items of data required to be contained  
11.10 on a Minnesota identification card, as provided in section 171.07, subdivision 3, paragraphs  
11.11 (a) and (b);

11.12 (4) an original receipt for a new, renewed, or updated driver's license, state identification  
11.13 card, or voter identification card issued to the voter under section 171.07 that contains the

**201.061 REGISTRATION ON OR BEFORE ELECTION DAY.**

Subd. 7. **Record of attempted registrations.** The election judge responsible for election day registration shall attempt to keep a record of the number of individuals who attempt to register on election day but who cannot provide proof of residence as required by this section. The record shall be forwarded to the county auditor with the election returns for that precinct.
