1.2 relating to state government; abolishing the Public Employment Relations Board;
1.3 amending Minnesota Statutes 2018, sections 179A.04, subdivision 3; 179A.051;
1.4 179A.10, subdivision 1; 179A.13; 179A.135; repealing Minnesota Statutes 2018,
1.5 sections 179A.03, subdivision 2a; 179A.041; 179A.052.

1.6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.7 Section 1. Minnesota Statutes 2018, section 179A.04, subdivision 3, is amended to read:

1.8 Subd. 3. **Other duties.** (a) The commissioner shall:

1.9 (1) provide mediation services as requested by the parties until the parties reach
1.10 agreement, and may continue to assist parties after they have submitted their final positions
1.11 for interest arbitration;

1.12 (2) issue notices, subpoenas, and orders required by law to carry out duties under sections
1.13 179A.01 to 179A.25;

1.14 (3) assist the parties in formulating petitions, notices, and other papers required to be
1.15 filed with the commissioner ~~or the board~~;

1.16 (4) conduct elections;

1.17 (5) certify the final results of any election or other voting procedure conducted under
1.18 sections 179A.01 to 179A.25;

1.19 (6) adopt rules relating to the administration of this chapter and the conduct of hearings
1.20 and elections;

1.21 (7) receive, catalogue, file, and make available to the public all decisions of arbitrators
1.22 and panels authorized by sections 179A.01 to 179A.25, all grievance arbitration decisions

2.1 to the extent the decision is public under section 13.43, subdivision 2, paragraph (b), and
2.2 the commissioner's orders and decisions;

2.3 (8) adopt, subject to chapter 14, a grievance procedure that fulfills the purposes of section
2.4 179A.20, subdivision 4, that is available to any employee in a unit not covered by a
2.5 contractual grievance procedure;

2.6 (9) maintain a schedule of state employee classifications or positions assigned to each
2.7 unit established in section 179A.10, subdivision 2;

2.8 (10) collect fees established by rule for empanelment of persons on the labor arbitrator
2.9 roster maintained by the commissioner or in conjunction with fair share fee challenges.
2.10 Arbitrator application fees will be \$100 per year for initial applications and renewals effective
2.11 July 1, 2007;

2.12 (11) provide technical support and assistance to voluntary joint labor-management
2.13 committees established for the purpose of improving relationships between exclusive
2.14 representatives and employers, at the discretion of the commissioner;

2.15 (12) provide to the parties a list of arbitrators as required by section 179A.16, subdivision
2.16 4; and

2.17 (13) maintain a list of up to 60 arbitrators for referral to employers and exclusive
2.18 representatives for the resolution of grievance or interest disputes. Each person on the list
2.19 must be knowledgeable about collective bargaining and labor relations in the public sector,
2.20 well versed in state and federal labor law, and experienced in and knowledgeable about
2.21 labor arbitration. To the extent practicable, the commissioner shall appoint members to the
2.22 list so that the list is gender and racially diverse; ~~and.~~

2.23 ~~(14) upon request of the board, provide administrative support and other assistance to~~
2.24 ~~the board, including assistance in development and adoption of board rules.~~

2.25 (b) From the names provided by representative organizations, the commissioner shall
2.26 maintain a list of arbitrators to conduct teacher discharge or termination hearings according
2.27 to section 122A.40 or 122A.41. The persons on the list must meet at least one of the following
2.28 requirements:

2.29 (1) be a former or retired judge;

2.30 (2) be a qualified arbitrator on the list maintained by the bureau;

2.31 (3) be a present, former, or retired administrative law judge; or

3.1 (4) be a neutral individual who is learned in the law and admitted to practice in Minnesota,
 3.2 who is qualified by experience to conduct these hearings, and who is without bias to either
 3.3 party.

3.4 Each year, education Minnesota shall provide a list of up to 14 names and the Minnesota
 3.5 School Boards Association a list of up to 14 names of persons to be on the list. The
 3.6 commissioner may adopt rules about maintaining and updating the list.

3.9 **179A.051 APPEALS OF COMMISSIONER'S DECISIONS.**

3.10 (a) Decisions of the commissioner relating to supervisory, confidential, essential, and
 3.11 professional employees, appropriateness of a unit, or fair share fee challenges may be
 3.12 reviewed on certiorari by the court of appeals. A petition for a writ of certiorari must be
 3.13 filed and served on the other party or parties and the commissioner within 30 days from the
 3.14 date of the mailing of the commissioner's decision. The petition must be served on the other
 3.15 party or parties at the party's or parties' last known address.

3.16 ~~(b) Decisions of the commissioner relating to unfair labor practices under section~~
 3.17 ~~179A.12, subdivision 11, may be appealed to the board if the appeal is filed with the board~~
 3.18 ~~and served on all other parties no later than 30 days after service of the commissioner's~~
 3.19 ~~decision.~~

3.20 **EFFECTIVE DATE.** This section is effective the day following final enactment.

3.21 Sec. 3. Minnesota Statutes 2018, section 179A.10, subdivision 1, is amended to read:

3.22 Subdivision 1. **Exclusions.** The commissioner of management and budget shall meet
 3.23 and negotiate with the exclusive representative of each of the units specified in this section,
 3.24 except as provided in section 43A.06, subdivision 1, paragraph (c). The units provided in
 3.25 this section are the only appropriate units for executive branch state employees. The following
 3.26 employees shall be excluded from any appropriate unit:

3.27 (1) the positions and classes of positions in the classified and unclassified services defined
 3.28 as managerial by the commissioner of management and budget in accordance with section
 3.29 43A.18, subdivision 3, and so designated in the official state compensation schedules;

3.30 (2) unclassified positions in the Minnesota State Colleges and Universities defined as
 3.31 managerial by the Board of Trustees;

4.1 (3) positions of all unclassified employees appointed by a constitutional officer;

4.2 (4) positions in the Bureau of Mediation Services ~~and the Public Employment Relations~~
4.3 ~~Board;~~

4.4 (5) positions of employees whose classification is pilot or chief pilot;

4.15 Subdivision 1. **Actions.** ~~(a)~~ The practices specified in this section are unfair labor
4.16 practices. Any employee, employer, employee or employer organization, exclusive
4.17 representative, or any other person or organization aggrieved by an unfair labor practice as
4.18 defined in this section may ~~file an unfair labor practice charge with the board~~ bring an action
4.19 for injunctive relief and for damages caused by the unfair labor practice in the district court
4.20 of the county in which the practice is alleged to have occurred. A copy of any complaint
4.21 alleging an unfair labor practice must be filed with the commissioner at the time it is brought
4.22 in district court. The party bringing an unfair labor practice action in district court shall also
4.23 transmit to the commissioner any orders or judgments of the court within ten days of the
4.24 order or judgment.

4.25 ~~(b) Whenever it is charged that any party has engaged in or is engaging in any unfair~~

6.3 ~~recommended decision and order stating findings of fact and dismissing the complaint.~~

6.4 ~~(k) Parties may file exceptions to the hearing officer's recommended decision and order~~
6.5 ~~with the board no later than 30 days after service of the recommended decision and order.~~
6.6 ~~The board shall review the recommended decision and order upon timely filing of exceptions~~
6.7 ~~or upon its own motion. If no timely exceptions have been filed, the parties must be deemed~~
6.8 ~~to have waived their exceptions. Unless the board reviews the recommended decision and~~
6.9 ~~order upon its own motion, it must not be legal precedent and must be final and binding~~
6.10 ~~only on the parties to the proceeding as issued in an order issued by the board. If the board~~
6.11 ~~does review the recommended decision and order, the board may adopt all, part, or none of~~

6.24 ~~(n) Whenever it appears that any party has violated a final order of the board issued~~
6.25 ~~pursuant to this section, the board must petition the district court for an order directing the~~
6.26 ~~party and its officers, agents, servants, successors, and assigns to comply with the order of~~
6.27 ~~the board. The board shall be represented in this action by its general counsel, who has been~~
6.28 ~~appointed by the board. The court may grant or refuse, in whole or in part, the relief sought,~~

7.9 Subd. 2. **Employers.** Public employers, their agents and representatives are prohibited
 7.10 from:

7.11 (1) interfering, restraining, or coercing employees in the exercise of the rights guaranteed
 7.12 in sections 179A.01 to 179A.25;

7.13 (2) dominating or interfering with the formation, existence, or administration of any
 7.14 employee organization or contributing other support to it;

7.15 (3) discriminating in regard to hire or tenure to encourage or discourage membership in
 7.16 an employee organization;

7.17 (4) discharging or otherwise discriminating against an employee because the employee
 7.18 has signed or filed an affidavit, petition, or complaint or given information or testimony
 7.19 under sections 179A.01 to 179A.25;

7.20 (5) refusing to meet and negotiate in good faith with the exclusive representative of its
 7.21 employees in an appropriate unit;

7.22 (6) refusing to comply with grievance procedures contained in an agreement;

7.23 (7) distributing or circulating a blacklist of individuals exercising a legal right or of
 7.24 members of a labor organization for the purpose of preventing blacklisted individuals from
 7.25 obtaining or retaining employment;

7.26 (8) violating rules established by the commissioner regulating the conduct of
 7.27 representation elections;

7.28 (9) refusing to comply with a valid decision of a binding arbitration panel or arbitrator;

7.29 (10) violating or refusing to comply with any lawful order or decision issued by the
 7.30 commissioner ~~or the board~~;

7.31 (11) refusing to provide, upon the request of the exclusive representative, all information
 7.32 pertaining to the public employer's budget both present and proposed, revenues, and other

8.1 financing information provided that in the executive branch of state government this clause
8.2 may not be considered contrary to the budgetary requirements of sections 16A.10 and
8.3 16A.11; or

8.4 (12) granting or offering to grant the status of permanent replacement employee to a
8.5 person for performing bargaining unit work for the employer during a lockout of employees
8.6 in an employee organization or during a strike authorized by an employee organization that
8.7 is an exclusive representative.

8.8 Subd. 3. **Employees.** Employee organizations, their agents or representatives, and public
8.9 employees are prohibited from:

8.10 (1) restraining or coercing employees in the exercise of rights provided in sections
8.11 179A.01 to 179A.25;

8.12 (2) restraining or coercing a public employer in the election of representatives to be
8.13 employed to meet and negotiate or to adjust grievances;

8.14 (3) refusing to meet and negotiate in good faith with a public employer, if the employee
8.15 organization is the exclusive representative of employees in an appropriate unit;

8.16 (4) violating rules established by the commissioner regulating the conduct of
8.17 representation elections;

8.18 (5) refusing to comply with a valid decision of an arbitration panel or arbitrator;

8.19 (6) calling, instituting, maintaining, or conducting a strike or boycott against any public
8.20 employer on account of any jurisdictional controversy;

8.21 (7) coercing or restraining any person with the effect to:

8.22 (i) force or require any public employer to cease dealing or doing business with any
8.23 other person;

8.24 (ii) force or require a public employer to recognize for representation purposes an
8.25 employee organization not certified by the commissioner;

8.26 (iii) refuse to handle goods or perform services; or

8.27 (iv) prevent an employee from providing services to the employer;

8.28 (8) committing any act designed to damage or actually damaging physical property or
8.29 endangering the safety of persons while engaging in a strike;

9.1 (9) forcing or requiring any employer to assign particular work to employees in a
 9.2 particular employee organization or in a particular trade, craft, or class rather than to
 9.3 employees in another employee organization or in another trade, craft, or class;

9.4 (10) causing or attempting to cause a public employer to pay or deliver or agree to pay
 9.5 or deliver any money or other thing of value, in the nature of an exaction, for services which
 9.6 are not performed or not to be performed;

9.7 (11) engaging in an unlawful strike;

9.8 (12) picketing which has an unlawful purpose such as secondary boycott;

9.9 (13) picketing which unreasonably interferes with the ingress and egress to facilities of
 9.10 the public employer;

9.11 (14) seizing or occupying or destroying property of the employer;

9.12 (15) violating or refusing to comply with any lawful order or decision issued by the
 9.13 commissioner ~~or the board~~.

9.14 **EFFECTIVE DATE.** This section is effective the day following final enactment.

9.15 Sec. 5. Minnesota Statutes 2018, section 179A.135, is amended to read:

9.16 **179A.135 UNFAIR LABOR PRACTICES INVOLVING CHARITABLE**
 9.17 **HOSPITALS.**

9.18 Any charitable hospital as defined in section 179.35, subdivision 2, any hospital employee
 9.19 as defined in section 179.35, subdivision 3, any labor organization as defined in section
 9.20 179.01, subdivision 6, or any other person or organization connected with a charitable
 9.21 hospital, who is aggrieved by an unfair labor practice as defined in sections 179.11 and
 9.22 179.12, may file an unfair labor practice charge ~~with the Public Employment Relations~~
 9.23 ~~Board that will be processed in accordance with the provisions of sections 179A.051,~~
 9.24 ~~179A.052, and 179A.13~~ as provided in section 179A.13.

9.25 **EFFECTIVE DATE.** This section is effective the day following final enactment.

9.26 Sec. 6. **APPEALS PENDING BEFORE THE PUBLIC EMPLOYMENT RELATIONS**
 9.27 **BOARD.**

9.28 (a) Appeals pending before the Public Employment Relations Board are dismissed
 9.29 without prejudice. An appellant whose appeal is dismissed under this section may file a
 9.30 petition for writ of certiorari, and serve the other party or parties and the commissioner of
 9.31 the Bureau of Mediation Services, within 60 days of the effective date of this section.

10.1 (b) Within 15 days of the effective date of this section, the commissioner of the Bureau
10.2 of Mediation Services must notify the appellants whose appeals are dismissed by this section
10.3 in writing that their appeal to the Public Employment Relations Board has been dismissed.
10.4 The notice must describe the option of filing a petition for writ of certiorari and provide the
10.5 deadline for that filing.

10.6 **EFFECTIVE DATE.** This section is effective the day following final enactment.

10.8 Minnesota Statutes 2018, sections 179A.03, subdivision 2a; 179A.041; and 179A.052,

10.10 **EFFECTIVE DATE.** This section is effective the day following final enactment.

179A.03 DEFINITIONS.

Subd. 2a. **Board.** "Board" means the Public Employment Relations Board under section 179A.041.

179A.041 PUBLIC EMPLOYMENT RELATIONS BOARD; POWER, AUTHORITY, AND DUTIES.

Subdivision 1. **Membership.** The Public Employment Relations Board is established with three members. One member shall be an officer or employee of an exclusive representative of public employees and shall be appointed by the governor; one shall be representative of public employers and shall be appointed by the governor; and one shall be representative of the public at large and shall be appointed by the other two members. Public employers and employee organizations representing public employees may submit for consideration names of persons representing their interests. The board shall select one of its members to serve as chair for a term beginning July 1 of each year.

Subd. 2. **Alternate members.** (a) The appointing authorities shall appoint alternate members to serve only in the case of a member having a conflict of interest under subdivision 9, as follows:

(1) one alternate, appointed by the governor, who is an officer or employee of an exclusive representative of public employees, to serve as an alternate to the member appointed by the governor who is an officer or employee of an exclusive representative of public employees. This alternate must not be an officer or employee of the same exclusive representative of public employees as the member for whom the alternate serves;

(2) one alternate, appointed by the governor, who is a representative of public employers, to serve as an alternate to the member appointed by the governor who is a representative of public employers. This alternate must not represent the same public employer as the member for whom the alternate serves; and

(3) one alternate, appointed by the member who is an officer or employee of an exclusive representative of public employees and the member who is a representative of public employers, who is not an officer or employee of an exclusive representative of public employees, or a representative of a public employer, to serve as an alternate for the member that represents the public at large.

(b) Each alternate member shall serve a term that is coterminous with the term of the member for whom the alternate member serves as an alternate.

Subd. 3. **Terms; compensation.** The membership terms, compensation, removal of members, and filling of vacancies for members and alternate members shall be as provided in section 15.0575.

Subd. 4. **Rules; meetings.** The board shall adopt rules governing its procedure and shall hold meetings as prescribed in those rules. The chair shall convene and preside at meetings of the board.

Subd. 5. **Powers.** The board shall have the powers and authority required for the board to take the actions assigned to the board under section 179A.13.

Subd. 6. **Appeals.** In addition to the other powers and duties given it by law, the board shall hear and decide appeals from:

(1) recommended decisions and orders relating to an unfair labor practice under section 179A.13; and

(2) determinations of the commissioner under section 179A.12, subdivision 11.

Subd. 7. **Rulemaking.** The board shall adopt rules under chapter 14 governing the presentation of issues and the taking of appeals under subdivision 6. All issues and appeals presented to the board shall be determined upon the record of hearing, except that the board may request additional evidence when necessary or helpful.

Subd. 8. **Employees and contracts.** The board may hire investigators, hearing officers, and other employees as necessary to perform its duties, or may enter into contracts to perform any of the board's duties.

Subd. 9. **Conflict of interest.** A member must disclose any conflict of interest in a case before the board and shall not take any action or vote in the case. The person designated as the recused member's alternate shall serve in place of the member who has a conflict for all actions and votes on the case, unless the alternate has a conflict of interest. If both a member and the member's

alternate have a conflict of interest in a case, the appointing authority will appoint a second alternate member, who meets the same requirements as the alternate member and who has no conflict of interest, to take action and vote in the case. A board member or alternate member has a conflict of interest in a case if the member is employed by, an officer of, a member of the governing body of, or a member of, a party in the case.

179A.052 APPEALS OF BOARD'S DECISIONS.

Decisions of the board relating to unfair labor practices under section 179.11, 179.12, 179A.12, subdivision 11, or 179A.13 including dismissal of unfair labor practice charges, may be reviewed on certiorari by the court of appeals. A petition for a writ of certiorari must be filed and served on the other party or parties and the board within 30 days from the date of the mailing of the board's decision. The petition must be served on the other party or parties at the party's or parties' last known address.
