1.2 relating to forfeiture; limiting vehicles and other property subject to forfeiture;
1.3 providing for recovery of property by innocent owners; modifying participation
1.4 in the federal equitable sharing program; requiring reports; appropriating money;
1.5 amending Minnesota Statutes 2018, sections 169A.63, subdivisions 1, 7, 8, 10, by
1.6 adding subdivisions; 609.531, subdivision 1, by adding a subdivision; 609.5311,
1.7 subdivisions 2, 3, 4; 609.5314, subdivisions 1, 2, by adding a subdivision; 609.5315,
1.8 subdivisions 5, 5b, 6; Minnesota Statutes 2019 Supplement, section 169A.63,
1.9 subdivision 13; repealing Minnesota Statutes 2018, section 609.5317.

1.10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.11 Section 1. Minnesota Statutes 2018, section 169A.63, subdivision 1, is amended to read:

1.12 Subdivision 1. Definitions. (a) As used in this section, the following terms have the
1.13 meanings given them.

1.14 (b) "Appropriate agency" means a law enforcement agency that has the authority to
1.15 make an arrest for a violation of a designated offense or to require a test under section
1.16 169A.51 (chemical tests for intoxication).

1.17 (c) "Asserting person" means a person, other than the driver alleged to have committed
1.18 a designated offense, claiming an ownership interest in a vehicle that has been seized or
1.19 restrained under this section.

1.20 (e) (d) "Claimant" means an owner of a motor vehicle or a person claiming a leasehold
1.21 or security interest in a motor vehicle.

1.22 (d) (e) "Designated license revocation" includes a license revocation under section
1.23 169A.52 (license revocation for test failure or refusal) or 171.177 (revocation; search warrant)
1.24 or a license disqualification under section 171.165 (commercial driver's license

2.1 disqualification) resulting from a violation of section 169A.52 or 171.177; within ten years  
 2.2 of the first of two or more qualified prior impaired driving incidents.

2.3 ~~(e)~~ (f) "Designated offense" includes:

2.4 (1) a violation of section 169A.20 (driving while impaired) under the circumstances  
 2.5 described in section 169A.24 (first-degree driving while impaired), ~~or 169A.25~~  
 2.6 ~~(second-degree driving while impaired); or~~

2.7 (2) a violation of section 169A.20 or an ordinance in conformity with it: within ten years  
 2.8 of the first of two qualified prior impaired driving incidents.

2.9 ~~(i) by a person whose driver's license or driving privileges have been canceled as inimical~~  
 2.10 ~~to public safety under section 171.04, subdivision 1, clause (10), and not reinstated; or~~

2.11 ~~(ii) by a person who is subject to a restriction on the person's driver's license under~~  
 2.12 ~~section 171.09 (commissioner's license restrictions), which provides that the person may~~  
 2.13 ~~not use or consume any amount of alcohol or a controlled substance.~~

2.14 ~~(f)~~ (g) "Family or household member" means:

2.15 (1) a parent, stepparent, or guardian;

2.16 (2) any of the following persons related by blood, marriage, or adoption: brother, sister,  
 2.17 stepbrother, stepsister, first cousin, aunt, uncle, nephew, niece, grandparent,  
 2.18 great-grandparent, great-uncle, great-aunt; or

2.19 (3) persons residing together or persons who regularly associate and communicate with  
 2.20 one another outside of a workplace setting.

2.21 ~~(g)~~ (h) "Motor vehicle" and "vehicle" do not include a vehicle which is stolen or taken  
 2.22 in violation of the law.

2.23 ~~(h)~~ (i) "Owner" means a person legally entitled to possession, use, and control of a motor  
 2.24 vehicle, including a lessee of a motor vehicle if the lease agreement has a term of 180 days  
 2.25 or more. There is a rebuttable presumption that a person registered as the owner of a motor  
 2.26 vehicle according to the records of the Department of Public Safety is the legal owner. For  
 2.27 purposes of this section, if a motor vehicle is owned jointly by two or more people, each  
 2.28 owner's interest extends to the whole of the vehicle and is not subject to apportionment.

2.29 ~~(i)~~ (j) "Prosecuting authority" means the attorney in the jurisdiction in which the  
 2.30 designated offense occurred who is responsible for prosecuting violations of a designated  
 2.31 offense or a designee. If a state agency initiated the forfeiture, and the attorney responsible

3.1 for prosecuting the designated offense declines to pursue forfeiture, the Attorney General's  
3.2 Office or its designee may initiate forfeiture under this section.

3.3 ~~(j)~~ (k) "Security interest" means a bona fide security interest perfected according to  
3.4 section 168A.17, subdivision 2, based on a loan or other financing that, if a vehicle is  
3.5 required to be registered under chapter 168, is listed on the vehicle's title.

3.6 **EFFECTIVE DATE.** This section is effective January 1, 2021, and applies to seizures  
3.7 that take place on or after that date.

3.8 Sec. 2. Minnesota Statutes 2018, section 169A.63, subdivision 7, is amended to read:

3.9 **Subd. 7. Limitations on vehicle forfeiture.** (a) A vehicle is presumed subject to forfeiture  
3.10 under this section if:

3.11 (1) the driver is convicted of the designated offense upon which the forfeiture is based;

3.12 or

3.13 ~~(2) the driver fails to appear for a scheduled court appearance with respect to the~~  
3.14 ~~designated offense charged and fails to voluntarily surrender within 48 hours after the time~~  
3.15 ~~required for appearance; or~~

3.16 ~~(3)~~ (2) the driver's conduct results in a designated license revocation and the driver fails  
3.17 to seek judicial review of the revocation in a timely manner as required by section 169A.53,  
3.18 subdivision 2, (petition for judicial review), or the license revocation is judicially reviewed  
3.19 and sustained under section 169A.53, subdivision 2.

3.20 (b) A vehicle encumbered by a security interest perfected according to section 168A.17,  
3.21 subdivision 2, or subject to a lease that has a term of 180 days or more, is subject to the  
3.22 interest of the secured party or lessor unless the party or lessor had knowledge of or consented  
3.23 to the act upon which the forfeiture is based. However, when the proceeds of the sale of a  
3.24 seized vehicle do not equal or exceed the outstanding loan balance, the appropriate agency  
3.25 shall remit all proceeds of the sale to the secured party after deducting the agency's costs  
3.26 for the seizure, tow, storage, forfeiture, and sale of the vehicle. If the sale of the vehicle is  
3.27 conducted in a commercially reasonable manner consistent with the provisions of section  
3.28 336.9-610, the agency is not liable to the secured party for any amount owed on the loan in  
3.29 excess of the sale proceeds. The validity and amount of a nonperfected security interest  
3.30 must be established by its holder by clear and convincing evidence.

3.31 (c) Notwithstanding paragraph (b), the secured party's or lessor's interest in a vehicle is  
3.32 not subject to forfeiture based solely on the secured party's or lessor's knowledge of the act  
3.33 or omission upon which the forfeiture is based if the secured party or lessor demonstrates

4.1 by clear and convincing evidence that the party or lessor took reasonable steps to terminate  
4.2 use of the vehicle by the offender.

4.3 ~~(d) A motor vehicle is not subject to forfeiture under this section if any of its owners  
4.4 who petition the court can demonstrate by clear and convincing evidence that the petitioning  
4.5 owner did not have actual or constructive knowledge that the vehicle would be used or  
4.6 operated in any manner contrary to law or that the petitioning owner took reasonable steps  
4.7 to prevent use of the vehicle by the offender. If the offender is a family or household member  
4.8 of any of the owners who petition the court and has three or more prior impaired driving  
4.9 convictions, the petitioning owner is presumed to know of any vehicle use by the offender  
4.10 that is contrary to law. "Vehicle use contrary to law" includes, but is not limited to, violations  
4.11 of the following statutes:~~

4.12 ~~(1) section 171.24 (violations; driving without valid license);~~

4.13 ~~(2) section 169.791 (criminal penalty for failure to produce proof of insurance);~~

4.14 ~~(3) section 171.09 (driving restrictions; authority, violations);~~

4.15 ~~(4) section 169A.20 (driving while impaired);~~

4.16 ~~(5) section 169A.33 (underage drinking and driving); and~~

4.17 ~~(6) section 169A.35 (open bottle law).~~

4.18 **EFFECTIVE DATE.** This section is effective January 1, 2021, and applies to seizures  
4.19 that take place on or after that date.

4.20 Sec. 3. Minnesota Statutes 2018, section 169A.63, is amended by adding a subdivision to  
4.21 read:

4.22 Subd. 7a. **Innocent owner.** (a) An asserting person may bring an innocent owner claim  
4.23 by notifying the prosecuting authority in writing and within 60 days of the service of the  
4.24 notice of seizure.

4.25 (b) Upon receipt of notice pursuant to paragraph (a), the prosecuting authority may  
4.26 release the vehicle to the asserting person. If the prosecuting authority proceeds with the  
4.27 forfeiture, the prosecuting authority must, within 30 days, file a separate complaint in the  
4.28 name of the jurisdiction pursuing the forfeiture against the vehicle, describing the vehicle,  
4.29 specifying that the vehicle was used in the commission of a designated offense or was used  
4.30 in conduct resulting in a designated license revocation, and specifying the time and place  
4.31 of the vehicle's unlawful use. The complaint may be filed in district court or conciliation  
4.32 court and the filing fee is waived.

5.1 (c) A complaint filed by the prosecuting authority must be served on the asserting person  
5.2 and on any other registered owners. Service may be made by certified mail at the address  
5.3 listed in the Department of Public Safety's computerized motor vehicle registration records  
5.4 or by any means permitted by court rules.

5.5 (d) The hearing on the complaint shall, to the extent practicable, be held within 30 days  
5.6 of the filing of the petition. The court may consolidate the hearing on the complaint with a  
5.7 hearing on any other complaint involving a claim of an ownership interest in the same  
5.8 vehicle.

5.9 (e) At a hearing held pursuant to this subdivision, the prosecuting authority must:

5.10 (1) prove by a preponderance of the evidence that the seizure was incident to a lawful  
5.11 arrest or a lawful search; and

5.12 (2) certify that the prosecuting authority has filed, or intends to file, charges against the  
5.13 driver for a designated offense or that the driver has a designated license revocation.

5.14 (f) At a hearing held pursuant to this subdivision, the asserting person must prove by a  
5.15 preponderance of the evidence that the asserting person:

5.16 (1) has an actual ownership interest in the vehicle; and

5.17 (2) did not have actual or constructive knowledge that the vehicle would be used or  
5.18 operated in any manner contrary to law or that the asserting person took reasonable steps  
5.19 to prevent use of the vehicle by the alleged offender.

5.20 (g) If the court determines that the state met both burdens under paragraph (e) and the  
5.21 asserting person failed to meet any burden under paragraph (f), the court shall order that  
5.22 the vehicle remains subject to forfeiture under this section.

5.23 (h) The court shall order that the vehicle is not subject to forfeiture under this section  
5.24 and shall order the vehicle returned to the asserting person if it determines that:

5.25 (1) the state failed to meet any burden under paragraph (e);

5.26 (2) the asserting person proved both elements under paragraph (f); or

5.27 (3) clauses (1) and (2) apply.

5.28 (i) If the court determines that the asserting person is an innocent owner and orders the  
5.29 vehicle returned to the innocent owner, an entity in possession of the vehicle is not required  
5.30 to release it until the innocent owner pays:

6.1 (1) the reasonable costs of the towing, seizure, and storage of the vehicle incurred before  
6.2 the innocent owner provided the notice required under paragraph (a); and

6.3 (2) any reasonable costs of storage of the vehicle incurred more than two weeks after  
6.4 an order issued under paragraph (h).

6.5 **EFFECTIVE DATE.** This section is effective January 1, 2021, and applies to seizures  
6.6 that take place on or after that date.

6.7 Sec. 4. Minnesota Statutes 2018, section 169A.63, subdivision 8, is amended to read:

6.8 Subd. 8. **Administrative forfeiture procedure.** (a) A motor vehicle used to commit a  
6.9 designated offense or used in conduct resulting in a designated license revocation is subject  
6.10 to administrative forfeiture under this subdivision.

6.11 (b) Within 60 days from when a motor vehicle is seized under subdivision 2, or within  
6.12 a reasonable time after seizure, the appropriate agency shall serve the driver or operator of  
6.13 the vehicle with a notice of the seizure and intent to forfeit the vehicle. Additionally, when  
6.14 a motor vehicle is seized under subdivision 2, or within a reasonable time after that, all  
6.15 persons known to have an ownership, possessory, or security interest in the vehicle must  
6.16 be notified of the seizure and the intent to forfeit the vehicle. For those vehicles required to  
6.17 be registered under chapter 168, the notification to a person known to have a security interest  
6.18 in the vehicle is required only if the vehicle is registered under chapter 168 and the interest  
6.19 is listed on the vehicle's title. Upon motion by the appropriate agency or prosecuting  
6.20 authority, a court may extend the time period for sending notice for a period not to exceed  
6.21 90 days for good cause shown. Notice mailed by certified mail to the address shown in  
6.22 Department of Public Safety records is sufficient notice to the registered owner of the  
6.23 vehicle. For motor vehicles not required to be registered under chapter 168, notice mailed  
6.24 by certified mail to the address shown in the applicable filing or registration for the vehicle  
6.25 is sufficient notice to a person known to have an ownership, possessory, or security interest  
6.26 in the vehicle. Otherwise, notice may be given in the manner provided by law for service  
6.27 of a summons in a civil action.

6.28 (c) The notice must be in writing and contain:

6.29 (1) a description of the vehicle seized;

6.30 (2) the date of seizure; and

6.31 (3) notice of the right to obtain judicial review of the forfeiture and of the procedure for  
6.32 obtaining that judicial review, printed in English. This requirement does not preclude the  
6.33 appropriate agency from printing the notice in other languages in addition to English.

7.1 Substantially the following language must appear conspicuously in the notice:

7.2 "WARNING: If you were the driver, you will automatically lose the above-described  
7.3 property and the right to be heard in court if you do not file a lawsuit and serve the  
7.4 prosecuting authority within 60 days. You may file your lawsuit in conciliation court if the  
7.5 property is worth \$15,000 or less; otherwise, you must file in district court. You ~~may do~~  
7.6 not have to pay a filing fee for your lawsuit ~~if you are unable to afford the fee. You do not~~  
7.7 have to pay a conciliation court fee if your property is worth less than \$500.

7.8 WARNING: If you have an ownership interest in the vehicle and were not the driver,  
7.9 you will automatically lose the above-described property and the right to be heard in court  
7.10 if you do not notify the prosecuting authority of your interest in writing within 60 days."

7.11 (d) If notice is not sent in accordance with paragraph (b), and no time extension is granted  
7.12 or the extension period has expired, the appropriate agency shall return the property vehicle  
7.13 to the person from whom the property was seized, if known owner. An agency's return of  
7.14 property due to lack of proper notice does not restrict the agency's authority to commence  
7.15 a forfeiture proceeding at a later time. ~~The agency shall not be required to return contraband~~  
7.16 ~~or other property that the person from whom the property was seized may not legally possess.~~

7.17 (e) Within 60 days following service of a notice of seizure and forfeiture under this  
7.18 subdivision, a claimant may file a demand for a judicial determination of the forfeiture. The  
7.19 demand must be in the form of a civil complaint and must be filed with the court  
7.20 administrator in the county in which the seizure occurred, together with proof of service of  
7.21 a copy of the complaint on the prosecuting authority having jurisdiction over the forfeiture,  
7.22 ~~including the standard filing fee for civil actions unless the petitioner has the right to sue~~  
7.23 ~~in forma pauperis under section 563.01.~~ The claimant may serve the complaint by certified  
7.24 mail or any means permitted by court rules. If the value of the seized property is \$15,000  
7.25 or less, the claimant may file an action in conciliation court for recovery of the seized vehicle.  
7.26 A copy of the conciliation court statement of claim must be served personally or by mail  
7.27 on the prosecuting authority having jurisdiction over the forfeiture, ~~as well as on the~~  
7.28 ~~appropriate agency that initiated the forfeiture,~~ within 60 days following service of the  
7.29 notice of seizure and forfeiture under this subdivision. ~~If the value of the seized property is~~  
7.30 ~~less than \$500,~~ The claimant does not have to pay the ~~conciliation~~ court filing fee.

7.31 No responsive pleading is required of the prosecuting authority and no court fees may  
7.32 be charged for the prosecuting authority's appearance in the matter. The prosecuting authority  
7.33 may appear for the appropriate agency. Pleadings, filings, and methods of service are  
7.34 governed by the Rules of Civil Procedure.

8.1 (f) The complaint must be captioned in the name of the claimant as plaintiff and the  
8.2 seized vehicle as defendant, and must state with specificity the grounds on which the claimant  
8.3 alleges the vehicle was improperly seized, the claimant's interest in the vehicle seized, and  
8.4 any affirmative defenses the claimant may have. Notwithstanding any law to the contrary,  
8.5 an action for the return of a vehicle seized under this section may not be maintained by or  
8.6 on behalf of any person who has been served with a notice of seizure and forfeiture unless  
8.7 the person has complied with this subdivision.

8.8 (g) If the claimant makes a timely demand for a judicial determination under this  
8.9 subdivision, the forfeiture proceedings must be conducted as provided under subdivision  
8.10 9.

8.11 **EFFECTIVE DATE.** This section is effective January 1, 2021, and applies to seizures  
8.12 that take place on or after that date.

8.13 Sec. 5. Minnesota Statutes 2018, section 169A.63, subdivision 10, is amended to read:

8.14 Subd. 10. **Disposition of forfeited vehicle.** (a) If the vehicle is administratively forfeited  
8.15 under subdivision 8, or if the court finds under subdivision 9 that the vehicle is subject to  
8.16 forfeiture under subdivisions 6 and 7, the appropriate agency shall:

8.17 (1) sell the vehicle and distribute the proceeds under paragraph (b); or

8.18 (2) keep the vehicle for official use. If the agency keeps a forfeited motor vehicle for  
8.19 official use, it shall make reasonable efforts to ensure that the motor vehicle is available for  
8.20 use by the agency's officers who participate in the drug abuse resistance education program.

8.21 (b) The proceeds from the sale of forfeited vehicles, after payment of seizure, towing,  
8.22 storage, forfeiture, and sale expenses, and satisfaction of valid liens against the property,  
8.23 must be distributed as follows:

8.24 (1) 70 percent of the proceeds must be forwarded to the appropriate agency for deposit  
8.25 as a supplement to the state or local agency's operating fund or similar fund for use in  
8.26 DWI-related enforcement, training, ~~and~~ education, crime prevention, equipment, or capital  
8.27 expenses; and

8.28 (2) 30 percent of the money or proceeds must be forwarded to the prosecuting authority  
8.29 that handled the forfeiture for deposit as a supplement to its operating fund or similar fund  
8.30 for prosecutorial purposes, training, education, crime prevention, equipment, or capital  
8.31 expenses. For purposes of this subdivision, the prosecuting authority shall not include  
8.32 privately contracted prosecutors of a local political subdivision and, in those events, the



9.1 forfeiture proceeds shall be forwarded to the political subdivision where the forfeiture was  
 9.2 handled for the purposes identified in clause (1).

9.3 (c) If a vehicle is sold under paragraph (a), the appropriate agency shall not sell the  
 9.4 vehicle to: (1) an officer or employee of the agency that seized the property or to a person  
 9.5 related to the officer or employee by blood or marriage; or (2) the prosecuting authority or  
 9.6 any individual working in the same office or a person related to the authority or individual  
 9.7 by blood or marriage.

9.8 (d) Sales of forfeited vehicles under this section must be conducted in a commercially  
 9.9 reasonable manner.

9.10 (e) If a vehicle is forfeited administratively under this section and no demand for judicial  
 9.11 determination is made, the appropriate agency shall provide the prosecuting authority with  
 9.12 a copy of the forfeiture or evidence receipt, the notice of seizure and intent to forfeit, a  
 9.13 statement of probable cause for forfeiture of the property, and a description of the property  
 9.14 and its estimated value. Upon review and certification by the prosecuting authority that (1)  
 9.15 the appropriate agency provided a receipt in accordance with subdivision 2, paragraph (c),  
 9.16 (2) the appropriate agency served notice in accordance with subdivision 8, and (3) probable  
 9.17 cause for forfeiture exists based on the officer's statement, the appropriate agency may  
 9.18 dispose of the property in any of the ways listed in this subdivision.

9.19 **EFFECTIVE DATE.** This section is effective January 1, 2021, and applies to seizures  
 9.20 that take place on or after that date.

9.21 Sec. 6. Minnesota Statutes 2019 Supplement, section 169A.63, subdivision 13, is amended  
 9.22 to read:

9.23 Subd. 13. **Exception.** (a) A forfeiture proceeding is stayed and the vehicle must be  
 9.24 returned if the driver who committed a designated offense or whose conduct resulted in a  
 9.25 designated license revocation becomes a program participant in the ignition interlock program  
 9.26 under section 171.306 at any time before the motor vehicle is forfeited, the forfeiture  
 9.27 proceeding is stayed and the vehicle must be returned and any of the following apply:

9.28 (1) the driver committed a designated offense other than a violation of section 169A.20  
 9.29 under the circumstances described in section 169A.24; or

9.30 (2) the driver is accepted into a treatment court dedicated to changing the behavior of  
 9.31 alcohol- and other drug-dependent offenders arrested for driving while impaired.

10.1 (b) Notwithstanding paragraph (a), the vehicle whose forfeiture was stayed in paragraph  
10.2 (a) may be seized and the forfeiture action may proceed under this section if the program  
10.3 participant described in paragraph (a):

10.4 (1) subsequently operates a motor vehicle:

10.5 (i) to commit a violation of section 169A.20 (driving while impaired);

10.6 (ii) in a manner that results in a license revocation under section 169A.52 (license  
10.7 revocation for test failure or refusal) or 171.177 (revocation; search warrant) or a license  
10.8 disqualification under section 171.165 (commercial driver's license disqualification) resulting  
10.9 from a violation of section 169A.52 or 171.177;

10.10 (iii) after tampering with, circumventing, or bypassing an ignition interlock device; or

10.11 (iv) without an ignition interlock device at any time when the driver's license requires  
10.12 such device; ~~or~~

10.13 (2) either voluntarily or involuntarily ceases to participate in the program for more than  
10.14 30 days, or fails to successfully complete it as required by the Department of Public Safety  
10.15 due to:

10.16 (i) two or more occasions of the participant's driving privileges being withdrawn for  
10.17 violating the terms of the program, unless the withdrawal is determined to be caused by an  
10.18 error of the department or the interlock provider; or

10.19 (ii) violating the terms of the contract with the provider as determined by the provider;

10.21 (3) if forfeiture was stayed after the driver entered a treatment court, the driver ceases  
10.22 to be a participant in the treatment court for any reason.

10.23 (c) Paragraph (b) applies only if the described conduct occurs before the participant has  
10.24 been restored to full driving privileges or within three years of the original designated offense  
10.25 or designated license revocation, whichever occurs latest.

10.26 (d) The requirement in subdivision 2, paragraph (b), that device manufacturers provide  
10.27 a discounted rate to indigent program participants applies also to device installation under  
10.28 this subdivision.

10.29 (e) An impound or law enforcement storage lot operator must allow an ignition interlock  
10.30 manufacturer sufficient access to the lot to install an ignition interlock device under this  
10.31 subdivision.

11.1 (f) Notwithstanding paragraph (a), an entity in possession of the vehicle is not required  
 11.2 to release it until the reasonable costs of the towing, seizure, and storage of the vehicle have  
 11.3 been paid by the vehicle owner.

11.4 (g) At any time prior to the vehicle being forfeited, the appropriate agency may require  
 11.5 that the owner or driver of the vehicle ~~give security or post bond payable to the appropriate~~  
 11.6 ~~agency in an amount equal to the retail value~~ surrender the title of the seized vehicle. ~~If this~~  
 11.7 ~~occurs, any future forfeiture action against the vehicle must instead proceed against the~~

11.9 ~~(h) The appropriate agency may require an owner or driver to give security or post bond~~  
 11.10 ~~payable to the agency in an amount equal to the retail value of the vehicle, prior to releasing~~

11.12 ~~(+)~~ (h) If an event described in paragraph (b) occurs in a jurisdiction other than the one  
 11.13 in which the original forfeitable event occurred, and the vehicle is subsequently forfeited,

**609.5317 REAL PROPERTY; SEIZURES.**

Subdivision 1. **Rental property.** (a) When contraband or a controlled substance manufactured, distributed, or acquired in violation of chapter 152 is seized on residential rental property incident to a lawful search or arrest, the prosecuting authority shall give the notice required by this subdivision to (1) the landlord of the property or the fee owner identified in the records of the county assessor, and (2) the agent authorized by the owner to accept service pursuant to section 504B.181. The notice is not required during an ongoing investigation. The notice shall state what has been seized and specify the applicable duties and penalties under this subdivision. The notice shall state that the landlord who chooses to assign the right to bring an eviction action retains all rights and duties, including removal of a tenant's personal property following issuance of the writ of recovery and delivery of the writ to the sheriff for execution. The notice shall also state that the landlord may contact the prosecuting authority if threatened by the tenant. Notice shall be sent by certified letter, return receipt requested, within 30 days of the seizure. If receipt is not returned, notice shall be given in the manner provided by law for service of summons in a civil action.

(b) Within 15 days after notice of the first occurrence, the landlord shall bring, or assign to the prosecuting authority of the county in which the real property is located, the right to bring an eviction action against the tenant. The assignment must be in writing on a form prepared by the prosecuting authority. Should the landlord choose to assign the right to bring an eviction action, the assignment shall be limited to those rights and duties up to and including delivery of the writ of recovery to the sheriff for execution.

(c) Upon notice of a second occurrence on any residential rental property owned by the same landlord in the same county and involving the same tenant, and within one year after notice of the first occurrence, the property is subject to forfeiture under sections 609.531, 609.5311, 609.5313, and 609.5315, unless an eviction action has been commenced as provided in paragraph (b) or the right to bring an eviction action was assigned to the prosecuting authority as provided in paragraph (b). If the right has been assigned and not previously exercised, or if the prosecuting authority requests an assignment and the landlord makes an assignment, the prosecuting authority may bring an eviction action rather than an action for forfeiture.

(d) The Department of Corrections Fugitive Apprehension Unit shall not seize real property for the purposes of forfeiture as described in paragraphs (a) to (c).

Subd. 2. **Additional remedies.** Nothing in subdivision 1 prevents the prosecuting authority from proceeding under section 609.5311 whenever that section applies.

Subd. 3. **Defenses.** It is a defense against a proceeding under subdivision 1, paragraph (b), that the tenant had no knowledge or reason to know of the presence of the contraband or controlled substance or could not prevent its being brought onto the property.

It is a defense against a proceeding under subdivision 1, paragraph (c), that the landlord made every reasonable attempt to evict a tenant or to assign the prosecuting authority the right to bring an eviction action against the tenant, or that the landlord did not receive notice of the seizure.

Subd. 4. **Limitations.** This section shall not apply if the retail value of the controlled substance is less than \$100, but this section does not subject real property to forfeiture under section 609.5311 unless the retail value of the controlled substance is: (1) \$1,000 or more; or (2) there have been two previous controlled substance seizures involving the same tenant.
