1.8	Subd. 3. Motorized bicycle. (a) A motorized bicycle may not be operated on any public
1.9	roadway by any person who does not possess a valid driver's license, unless the person has
1.10	obtained a motorized bicycle operator's permit or motorized bicycle instruction permit from
1.11	the commissioner of public safety. The operator's permit may be issued to any person who
1.12	has attained the age of 15 years and who has passed the examination prescribed by the
1.13	commissioner. The instruction permit may be issued to any person who has attained the age
1.14	of 15 years and who has successfully completed an approved safety course and passed the
1.15	written portion of the examination prescribed by the commissioner.

- 3.27 (b) In addition to each fee required in paragraph (a), the commissioner must collect a surcharge of \$2.25 \$4.50. Surcharges collected under this paragraph must be credited to the driver and vehicle services technology account under section 299A.705.
- (c) Notwithstanding paragraph (a), an individual who holds a provisional license and has a driving record free of (1) convictions for a violation of section 169A.20, 169A.33, 169A.35, sections 169A.50 to 169A.53, or section 171.177, (2) convictions for crash-related moving violations, and (3) convictions for moving violations that are not crash related, has a \$3.50 credit toward the fee for any classified under-21 driver's license. "Moving violation" has the meaning given it in section 171.04, subdivision 1.
 - (d) In addition to the driver's license fee required under paragraph (a), the commissioner must collect an additional \$4 \subseteq 8 processing fee from each new applicant or individual renewing a license with a school bus endorsement to cover the costs for processing an applicant's initial and biennial physical examination certificate. - (d) A filing fee retained by the agent employed by a county board must be paid into the county treasury and credited to the general revenue fund of the county.  - (2) a noncompliant identification card is valid for the lifetime of the applicant.
- (c) For the purposes of paragraph (b), "Minnesota identification card" does not include an enhanced identification card issued to an applicant age 65 or older.
 - (d) (b) The expiration date for an Under-21 identification card is the cardholder's 21st birthday. The commissioner shall must issue an identification card to a holder of an Under-21 identification card who applies for the card, pays the required fee, and presents proof of identity and age, unless the commissioner determines that the applicant is not qualified for the identification card.
 - (e) (c) Notwithstanding paragraphs (a) to (d) and (b), the expiration date for an identification card issued to a person with temporary lawful status is the last day of the person's legal stay in the United States, or one year after issuance if the last day of the person's legal stay is not identified.

 - Subd. 4. **Variance for homebound individuals.** (a) Notwithstanding section 171.07 or Minnesota Rules, part 7410.1810, the commissioner may grant a variance from the photograph requirements for a noncompliant identification card if: (1) the individual is homebound as defined in paragraph (b); (2) the individual has submitted proof of homebound status; and (3) the department has a photograph of the applicant on file that was taken within the last <u>four eight</u> years or during the most recent renewal cycle or the applicant has submitted a photograph to the department that meets the requirements of section 171.07, Minnesota Rules, part 7410.1810, subpart 1, and other technical requirements established by the commissioner, such as background color and electronic file size, to ensure the image can be used on a credential and conforms with images taken by the department. Applicants granted a photograph variance under this subdivision are not required to appear in person to have a new photograph taken.

171.27 LICENSE EXPIRATION AND RENEWAL; EXCEPTIONS.

- Subdivision 1. **Expiration.** (a) Except as otherwise provided in this section, the expiration date for each driver's license is the birthday of the driver in the <u>fourth eighth</u> year following the date of issuance of the license. The birthday of the driver <u>shall must</u> be as indicated on the application for a driver's license. A license may be renewed on or before expiration or within one year after expiration upon application, payment of the required fee, and passing the examination required of all drivers for renewal. Driving privileges <u>shall must</u> be extended or renewed on or preceding the expiration date of an existing driver's license unless the commissioner believes that the licensee is no longer qualified as a driver.
- (b) The expiration date for each under-21 license shall <u>must</u> be the 21st birthday of the licensee. Upon the licensee attaining the age of 21 and upon the application, payment of the required fee, and passing the examination required of all drivers for renewal, a driver's license shall <u>must</u> be issued unless the commissioner determines that the licensee is no longer qualified as a driver.
- (c) The expiration date for each provisional license is two years after the date of application for the provisional license.
- (d) Notwithstanding paragraphs (a) to (c), the expiration date for a license issued to a person with temporary lawful status is the last day of the person's legal stay in the United States, or one year after issuance if the last day of the person's legal stay is not identified.
- 7.27 Subd. 2. **Extension of expiration.** (a) For purposes of this subdivision, "eligible individual" means:
- (1) a person then or subsequently serving outside Minnesota in active military service,
 as defined in section 190.05, subdivision 5, in any branch or unit of the armed forces of the
