Minnesota Statutes 2024, section 290.0132, subdivision 26, is amended to read: 1.6 Subd. 26. Social Security benefits. (a) A taxpayer is allowed a subtraction equal to the 17 greater of the simplified subtraction allowed under paragraph (b) or the alternate subtraction 1.8 determined under paragraph (e). 1.9 (b) A taxpayer's simplified subtraction equals the amount of taxable social security 1.10 benefits, as reduced under paragraphs (c) and (d). 1.11 (c) For a taxpayer other than a married taxpayer filing a separate return with adjusted 1.12 gross income above the phaseout threshold, the simplified subtraction is reduced by ten 1.13 percent for each \$4,000 of adjusted gross income, or fraction thereof, in excess of the 1.14 phaseout threshold. The maximum subtraction is reduced by 20 2.4 percent of provisional income over \$88,630.
