1.24 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.25 **ARTICLE 1**

1.26 **MINNESOTA ELECTIONS INTEGRITY ACT**

1.27 Section 1. **TITLE.**

1.28 This act shall be known as the "Minnesota Elections Integrity Act."

2.1 **ARTICLE 2**

2.2 **VOTER ID**

2.3 Section 1. Minnesota Statutes 2024, section 5B.06, is amended to read:

2.4 **5B.06 VOTING BY PROGRAM PARTICIPANT; ABSENTEE BALLOT.**

2.5 Notwithstanding any law to the contrary, a program participant who is otherwise eligible
 2.6 to vote may vote pursuant to this section and may register with the secretary of state as a
 2.7 permanent absentee voter. Notwithstanding section 203B.04, subdivision 5, the secretary
 2.8 of state is not required to send an absentee ballot application prior to each election to a
 2.9 program participant registered as a permanent absentee voter under this section. As soon
 2.10 as practicable before each election, the secretary of state shall determine the precinct in
 2.11 which the residential address of a program participant is located. Upon making a precinct
 2.12 determination, the secretary of state shall either (1) request from and receive from the county
 2.13 auditor or other election official the ballot for that precinct and mail the absentee ballot to
 2.14 the program participant, or (2) using the Minnesota statewide voter registration system,
 2.15 prepare the program participant's ballot for that precinct and mail the absentee ballot to the
 2.16 program participant. The secretary of state shall include with each mailed absentee ballot
 2.17 all corresponding materials for absentee balloting as required by Minnesota law. The program
 2.18 participant shall complete the ballot and return it to the secretary of state, who shall review
 2.19 the ballot in the manner provided by section 203B.121, subdivision 2. If the ballot and ballot
 2.20 materials comply with the requirements of that section, the ballot must be certified by the
 2.21 secretary of state as the ballot of a program participant, and must be forwarded to the
 2.22 appropriate electoral jurisdiction for tabulation along with all other ballots. The name and
 2.23 address of a program participant must not be listed in the statewide voter registration system.

2.24 Sec. 2. Minnesota Statutes 2024, section 13.6905, is amended by adding a subdivision to
 2.25 read:

2.26 Subd. 39. **Voter identification card.** Applicant data related to a voter identification
 2.27 card is governed by section 171.06, subdivision 3c.

2.28 **EFFECTIVE DATE.** This section is effective June 1, 2026.

2.29 Sec. 3. Minnesota Statutes 2024, section 142A.412, subdivision 1, is amended to read:

2.30 Subdivision 1. **Creation of trust fund.** A children's trust fund for the prevention of child
 2.31 abuse is established as an account in the state treasury. The commissioner of management
 2.32 and budget shall credit to the trust fund all amounts received under sections 142A.415 and

3.1 144.226, ~~subdivision~~ subdivisions 3 and 10, paragraph (c), and shall ensure that trust fund
 3.2 money is invested under section 11A.25. All money earned by the trust fund must be credited
 3.3 to the trust fund. The trust fund earns its proportionate share of the total annual state
 3.4 investment income.

3.5 **EFFECTIVE DATE.** This section is effective June 1, 2026.

3.6 Sec. 4. Minnesota Statutes 2024, section 144.226, is amended by adding a subdivision to
 3.7 read:

3.8 Subd. 9. **Documents required for voter identification card.** (a) Notwithstanding
 3.9 provisions to the contrary in this section, no fee or surcharge shall be charged by the state
 3.10 registrar or local issuance office for a certified vital record if the applicant attests that the
 3.11 record is needed to obtain a voter identification card issued pursuant to section 171.07,
 3.12 subdivision 3c.

3.13 (b) The state registrar and local issuance offices shall report annually to the commissioner
 3.14 of management and budget the number of records requested and the number of records
 3.15 issued under this subdivision for which no fee or surcharge was charged.

3.16 **EFFECTIVE DATE.** This section is effective June 1, 2026.

3.17 Sec. 5. Minnesota Statutes 2024, section 144.226, is amended by adding a subdivision to
 3.18 read:

3.19 Subd. 10. **Appropriations and transfers.** (a) An amount equal to the total number of
 3.20 records requested and reported to the commissioner of management and budget under
 3.21 subdivision 9, paragraph (b), for the previous fiscal year times the amount of the surcharge
 3.22 under subdivision 3, paragraph (b), is appropriated from the general fund to the commissioner
 3.23 of health for the administration of this section.

3.24 (b) An amount equal to the total number of records requested and reported to the
 3.25 commissioner of management and budget under subdivision 9, paragraph (b), for the previous
 3.26 fiscal year times the amount of the surcharge under subdivision 4, is transferred from the
 3.27 general fund to the state government special revenue fund. This amount is appropriated
 3.28 from the state government special revenue fund to the commissioner of health for the
 3.29 administration of this section.

3.30 (c) An amount equal to the total number of records issued and reported to the
 3.31 commissioner of management and budget under subdivision 9, paragraph (b), for the previous
 3.32 fiscal year times the amount of the surcharge under subdivision 3, paragraph (a), is transferred

4.1 from the general fund to the account for the children's trust fund for the prevention of child
4.2 abuse established under section 142A.412.

4.3 (d) An amount equal to the number of records requested and reported to the commissioner
4.4 of management and budget by the state registrar under subdivision 9, paragraph (b), for the
4.5 previous fiscal year times the amount of the fee under subdivision 1, paragraph (b), is
4.6 transferred from the general fund to the state government special revenue fund. This amount
4.7 is appropriated from the state government special revenue fund to the commissioner of
4.8 health for the administration of this section.

4.9 (e) The commissioner of health must transmit payment of \$9 to a local issuance office
4.10 for each certified vital record requested for no charge under subdivision 9, paragraph (a).
4.11 An amount equal to the number of records requested and reported to the commissioner of
4.12 management and budget by local issuance offices under subdivision 9, paragraph (b), for
4.13 the previous fiscal year times the amount of the fee under subdivision 1, paragraph (b), is
4.14 appropriated from the general fund to the commissioner of health to make payments under
4.15 this paragraph.

4.16 **EFFECTIVE DATE.** This section is effective June 1, 2026.

4.17 Sec. 6. Minnesota Statutes 2024, section 171.06, subdivision 1, is amended to read:

4.18 Subdivision 1. **Application format and requirements.** Every application for a Minnesota
4.19 identification card, including an enhanced identification card, ~~or~~ for a driver's license,
4.20 including an instruction permit, a provisional license, a noncompliant driver's license, a
4.21 REAL ID driver's license, and an enhanced driver's license; or for a voter identification
4.22 card, must be made in a format approved by the department. Every application must be
4.23 accompanied by payment of the proper fee except for an application for a voter identification
4.24 card issued pursuant to section 171.07, subdivision 3c. All applicants must sign the
4.25 application and declare, under penalty of perjury, that the information and documentation
4.26 presented in the application is true and correct. All applications requiring evidence of legal
4.27 presence in the United States or United States citizenship must be signed in the presence
4.28 of the person authorized to accept the application, or the signature on the application may
4.29 be verified by a notary public.

4.30 **EFFECTIVE DATE.** This section is effective June 1, 2026.

5.41 (b) In addition to each fee required in paragraph (a), the commissioner must collect a
5.42 surcharge of \$2.25. Surcharges collected under this paragraph must be credited to the driver
5.43 and vehicle services technology account under section 299A.705.

5.44 (c) Notwithstanding paragraph (a), an individual who holds a provisional license and
5.45 has a driving record free of (1) convictions for a violation of section 169A.20, 169A.33,
5.46 169A.35, sections 169A.50 to 169A.53, or section 171.177, (2) convictions for crash-related
5.47 moving violations, and (3) convictions for moving violations that are not crash related, has

6.1 a \$3.50 credit toward the fee for any classified under-21 driver's license. "Moving violation"
6.2 has the meaning given it in section 171.04, subdivision 1.

6.3 (d) In addition to the driver's license fee required under paragraph (a), the commissioner
6.4 must collect an additional \$4 processing fee from each new applicant or individual renewing
6.5 a license with a school bus endorsement to cover the costs for processing an applicant's
6.6 initial and biennial physical examination certificate. The department must not charge these
6.7 applicants any other fee to receive or renew the endorsement.

6.8 (e) In addition to the fee required under paragraph (a), a driver's license agent may charge
6.9 and retain a filing fee as provided under section 171.061, subdivision 4.

6.10 (f) In addition to the fee required under paragraph (a), the commissioner must charge a
6.11 filing fee at the same amount as a driver's license agent under section 171.061, subdivision
6.12 4. Revenue collected under this paragraph must be deposited in the driver and vehicle
6.13 services operating account under section 299A.705.

6.14 (g) An application for a Minnesota identification card, instruction permit, provisional
6.15 license, or driver's license, including an application for renewal, must contain a provision
6.16 that allows the applicant to add to the fee under paragraph (a), a \$2 donation for the purposes
6.17 of public information and education on anatomical gifts under section 171.075.

6.18 (h) The commissioner or driver's license agent must not collect any fee or surcharge for
6.19 a voter identification card issued pursuant to section 171.07, subdivision 3c, or for a duplicate
6.20 voter identification card under section 171.11, subdivision 2.

6.21 **EFFECTIVE DATE.** This section is effective June 1, 2026.

6.22 Sec. 8. Minnesota Statutes 2024, section 171.06, is amended by adding a subdivision to
6.23 read:

6.24 Subd. 3c. **Application for voter identification card.** (a) An application for a voter
6.25 identification card, including a renewal or duplicate card, must:

6.26 (1) state the applicant's full legal name, date of birth, sex, residence address, and (i) last
6.27 four digits of the applicant's Social Security number, or (ii) certification that the applicant
6.28 has not been assigned a Social Security number;

6.29 (2) provide a description of the applicant in the same manner as required on an application
6.30 for a Minnesota driver's license;

6.31 (3) state the length of residence at the applicant's current address;

7.1 (4) include a space where the applicant must attest that the applicant does not have any
 7.2 document sufficient to prove identity and residence as provided in section 200.035; and

7.3 (5) be accompanied by the following documents:

7.4 (i) proof of the applicant's United States citizenship by presenting a document included
 7.5 in Minnesota Rules, part 7410.0400, subpart 1, item D;

7.6 (ii) proof of name, date of birth, and identity as provided in Minnesota Rules, part
 7.7 7410.0400; and

7.8 (iii) proof of a residence address in Minnesota as provided in Minnesota Rules, part
 7.9 7410.0410, subpart 4a.

7.10 (b) Applicant data, submitted pursuant to this subdivision, is private data on individuals,
 7.11 as defined in section 13.02, subdivision 12.

7.12 **EFFECTIVE DATE.** This section is effective June 1, 2026.

7.13 Sec. 9. Minnesota Statutes 2024, section 171.061, subdivision 4, is amended to read:

7.14 Subd. 4. **Fee; equipment.** (a) The agent may charge and retain a filing fee for each
 7.15 application as follows:

7.16 (1) New application for a noncompliant, REAL ID-compliant, or \$ 16.00
 7.17 enhanced driver's license or identification card

7.18 (2) Renewal application for a noncompliant, REAL ID-compliant, or \$ 11.00
 7.19 enhanced driver's license or identification card

7.20 (3) Voter identification card issued pursuant to section 171.07, \$ 0.00
 7.21 subdivision 3c

7.22 Except as provided in paragraph (c), the fee must cover all expenses involved in receiving,
 7.23 accepting, or forwarding to the department the applications and fees required under sections
 7.24 171.02, subdivision 3; 171.06, subdivisions 2 and 2a; and 171.07, subdivisions 3 and 3a.

7.25 (b) The statutory fees and the filing fees imposed under paragraph (a) may be paid by
 7.26 credit card or debit card. The driver's license agent may collect a convenience fee on the
 7.27 statutory fees and filing fees not greater than the cost of processing a credit card or debit
 7.28 card transaction. The convenience fee must be used to pay the cost of processing credit card
 7.29 and debit card transactions. The commissioner must adopt rules to administer this paragraph
 7.30 using the exempt procedures of section 14.386, except that section 14.386, paragraph (b),
 7.31 does not apply.

8.1 (c) The department must maintain the photo identification and vision examination
8.2 equipment for all agents. All photo identification and vision examination equipment must
8.3 be compatible with standards established by the department.

8.4 (d) A filing fee retained by the agent employed by a county board must be paid into the
8.5 county treasury and credited to the general revenue fund of the county. An agent who is not
8.6 an employee of the county must retain the filing fee in lieu of county employment or salary
8.7 and is considered an independent contractor for pension purposes, coverage under the
8.8 Minnesota State Retirement System, or membership in the Public Employees Retirement
8.9 Association.

8.10 (e) Before the end of the first working day following the final day of the reporting period
8.11 established by the department, the agent must forward to the department all applications
8.12 and fees collected during the reporting period except as provided in paragraph (d).

8.13 (f) The commissioner must transmit payment to the agent of \$8 for each application for
8.14 a voter identification card issued pursuant to section 171.07, subdivision 3c. An agent
8.15 employed by a county board must remit the payments to the county under paragraph (d).
8.16 All other agents may retain the payments.

8.17 **EFFECTIVE DATE.** This section is effective June 1, 2026.

8.18 Sec. 10. Minnesota Statutes 2024, section 171.07, is amended by adding a subdivision to
8.19 read:

8.20 Subd. 3c. **Voter identification cards.** (a) A voter identification card must be issued to
8.21 a qualifying applicant who, on the election day next occurring after the date of issuance,
8.22 will meet the voter eligibility requirements of the Minnesota Constitution and Minnesota
8.23 Statutes, and who does not possess any of the documents sufficient to prove identity and
8.24 residence as provided in section 200.035.

8.25 (b) A voter identification card must bear a distinguishing number assigned to the
8.26 applicant, the applicant's full name and date of birth, the applicant's address of residence or
8.27 designated address under section 5B.05, a description of the applicant in the same manner
8.28 as provided on a Minnesota driver's license, the date of the card's expiration, and the usual
8.29 signature of the applicant. The card must bear a colored photograph or an electronically
8.30 produced image of the applicant, or, for an applicant who has affirmed a religious objection
8.31 under section 171.071, subdivision 1, the card must bear the words "Valid without
8.32 photograph."

9.1 (c) A voter identification card is not valid identification for any purpose other than
 9.2 proving identity and residence for voting purposes.

9.3 (d) A voter identification card must be of a different color scheme than a Minnesota
 9.4 driver's license or state identification card, but must incorporate the same information and
 9.5 security features as provided in subdivision 9.

9.6 (e) Each voter identification card must be plainly marked: "Voter Identification Card.
 9.7 Valid Identification Only for Voting."

9.8 **EFFECTIVE DATE.** This section is effective June 1, 2026.

9.9 Sec. 11. Minnesota Statutes 2024, section 171.07, subdivision 4, is amended to read:

9.10 Subd. 4. **Identification card expiration.** (a) Except as otherwise provided in this
 9.11 subdivision, the expiration date of a Minnesota identification card or voter identification
 9.12 card is the birthday of the applicant in the fourth year following the date of issuance of the
 9.13 card.

9.14 (b) For an applicant age 65 or older:

9.15 (1) the expiration date of a Minnesota identification card or voter identification card is
 9.16 the birthday of the applicant in the eighth year following the date of issuance of the card;
 9.17 or

9.18 (2) a noncompliant identification card is valid for the lifetime of the applicant.

9.19 (c) For the purposes of paragraph (b), "Minnesota identification card" does not include
 9.20 an enhanced identification card issued to an applicant age 65 or older.

9.21 (d) The expiration date for an Under-21 identification card is the cardholder's 21st
 9.22 birthday. The commissioner shall issue an identification card to a holder of an Under-21
 9.23 identification card who applies for the card, pays the required fee, and presents proof of
 9.24 identity and age, unless the commissioner determines that the applicant is not qualified for
 9.25 the identification card.

9.26 (e) Notwithstanding paragraphs (a) to (d), the expiration date for an identification card
 9.27 issued to a person with temporary lawful status is the last day of the person's legal stay in
 9.28 the United States, or one year after issuance if the last day of the person's legal stay is not
 9.29 identified.

9.30 (f) Notwithstanding paragraphs (a) to (d), a voter identification card issued pursuant to
 9.31 section 171.07, subdivision 3c, to a person then or subsequently serving outside Minnesota
 9.32 in active military service, as defined in section 190.05, subdivision 5, in any branch or unit

10.1 of the armed forces of the United States, or the person's spouse, continues in full force and
10.2 effect without requirement for renewal until the later of the date one year following the
10.3 service member's separation or discharge from active military service, or until the cardholder's
10.4 birthday in the fourth full year following the person's most recent card renewal.

10.5 **EFFECTIVE DATE.** This section is effective June 1, 2026.

10.6 Sec. 12. Minnesota Statutes 2024, section 171.11, is amended to read:

10.7 **171.11 DUPLICATE LICENSE; CHANGE OF DOMICILE OR NAME.**

10.8 Subdivision 1. **Duplicate driver's license.** When any person, after applying for or
10.9 receiving a driver's license, shall change permanent domicile from the address named in
10.10 such application or in the license issued to the person, or shall change a name by marriage
10.11 or otherwise, such person shall, within 30 days thereafter, apply for a duplicate driver's
10.12 license upon a form furnished by the department and pay the required fee. The application
10.13 or duplicate license shall show both the licensee's old address and new address or the former
10.14 name and new name as the case may be.

10.15 Subd. 2. **Duplicate voter identification card.** A voter identification cardholder who
10.16 changes a residence address or name from the address or name stated on the card must not
10.17 present the card for voting purposes but must apply for a duplicate voter identification card
10.18 upon a form furnished by the department. The application for a duplicate voter identification
10.19 card must show the cardholder's former address and current address, along with length of
10.20 residence at the current address, and the cardholder's former name and current name, as
10.21 applicable.

10.22 **EFFECTIVE DATE.** This section is effective June 1, 2026.

10.23 Sec. 13. Minnesota Statutes 2024, section 171.14, is amended to read:

10.24 **171.14 CANCELLATION.**

10.25 Subdivision 1. **Cancellation of driver's license.** (a) The commissioner may cancel any
10.26 driver's license upon determination that (1) the licensee was not entitled to the issuance of
10.27 the license, (2) the licensee failed to give the required or correct information in the
10.28 application, (3) the licensee committed any fraud or deceit in making the application, or (4)
10.29 the person, at the time of the cancellation, would not have been entitled to receive a license
10.30 under section 171.04.

11.1 (b) The commissioner shall cancel the driver's license of a person described in paragraph
 11.2 (a), clause (3), for 60 days or until the required or correct information has been provided,
 11.3 whichever is longer.

11.4 Subd. 2. Cancellation of voter identification card. (a) The commissioner must cancel
 11.5 any voter identification card issued pursuant to section 171.07, subdivision 3c, upon
 11.6 determination that the cardholder:

11.7 (1) was not entitled to the issuance of the card;

11.8 (2) failed to give the required or correct information in the application;

11.9 (3) committed any fraud or deceit in making the application; or

11.10 (4) at the time of the cancellation, would not have been entitled to receive a voter
 11.11 identification card under section 171.07, subdivision 3c.

11.12 (b) The commissioner must cancel the voter identification card issued pursuant to section
 11.13 171.07, subdivision 3c, of a person described in paragraph (a) until the person completes
 11.14 the application process under section 171.07, subdivision 3c, and complies in all respects
 11.15 with the requirements of the commissioner.

11.16 (c) The commissioner must immediately notify the holder of a voter identification card
 11.17 issued pursuant to section 171.07, subdivision 3c, of a cancellation of the card. Notification
 11.18 must be by mail and addressed to the cardholder's last known address.

11.19 **EFFECTIVE DATE.** This section is effective June 1, 2026.

11.20 Sec. 14. [200.035] DOCUMENTATION OF IDENTITY AND RESIDENCE.

11.21 (a) The following are sufficient proof of identity and residence for purposes of election
 11.22 day voter registration under section 201.061, subdivision 3; absentee voting under sections
 11.23 203B.04, 203B.07, and 203B.08; early voting under section 203B.30; photo identification
 11.24 requirements under section 204C.10; and for determining whether to count a provisional
 11.25 ballot under section 204C.135, subdivision 2:

11.26 (1) an unexpired driver's license, state identification card, or voter identification card
 11.27 issued to the voter by the Department of Public Safety that contains the voter's photograph
 11.28 and current address of residence in the precinct;

Subd. 7. **Record of attempted registrations.** The election judge responsible for election day registration shall attempt to keep a record of the number of individuals who attempt to register on election day but who cannot provide proof of residence as required by this section. The record shall be forwarded to the county auditor with the election returns for that precinct.
