- 1 may bring a civil action pursuant to section 8.31 to recover damages, together with costs of investigation and reasonable attorney fees, and receive other equitable relief as determined by the court. An action brought by an injured party under section 8.31, subdivision 3a, benefits the public. In addition to all other damages, the court may impose a civil penalty of up to \$1,000 for each violation.
- (c) Civil remedies allowable under this section are cumulative and do not restrict any other right or remedy otherwise available. The complaint process provided in sections 2.10 211B.31 to 211B.36 does not apply to violations of this section. 2.11
- **EFFECTIVE DATE.** This section is effective August 1, 2025, and applies to crimes 2.12 committed on or after that date and causes of action accruing on or after that date. 2.13

- Subdivision 1. Administrative remedy; exhaustion. (a) Except as provided in paragraphs 2.15 (b) and (c), a complaint alleging a violation of chapter 211A or 211B must be filed with the 2.16 office. The complaint must be finally disposed of by the office before the alleged violation 2.17 may be prosecuted by a county attorney. 2.18
 - (b) Complaints arising under those sections and related to those individuals and associations specified in section 10A.022, subdivision 3, must be filed with the Campaign Finance and Public Disclosure Board.
