3.15 for the costs of administering the Minnesota
3.16 GI Bill postsecondary educational benefits,
3.17 on-the-job training, and apprenticeship
3.18 program under Minnesota Statutes, section
3.19 197.791.

3.20 (e) **Gold Star Program.** \$100,000 each year
3.21 is for administering the Gold Star Program for
3.22 surviving family members of deceased
3.23 veterans.

3.24 (f) **County Veterans Service Office.**
3.25 \$1,610,000 each year is for the County
3.26 Veterans Service Office grant program under
3.27 Minnesota Statutes, section 197.608. Of this
3.28 amount, \$20,000 is for a women veterans
3.29 technical assistance coordinator, \$20,000 is
3.30 for a veteran suicide prevention technical
3.31 assistance coordinator, and \$20,000 is for a
3.32 justice-involved veteran technical assistance
3.33 coordinator. Any unencumbered balance in
3.34 the first year does not cancel and is available
3.35 in the second year.

4.1 (g) **Camp Bliss.** \$150,000 each year is for a
4.2 grant to Independent Lifestyles, Inc., to
4.3 provide therapy, transportation, and activities
4.4 customized for veterans who are Minnesota
4.5 residents and their spouses, domestic partners,
4.6 and children, at Camp Bliss in the city of
4.7 Walker. The commissioner of veterans affairs
4.8 must report to the chairs and ranking minority
4.9 members of the legislative committees with
4.10 jurisdiction over veterans affairs on:
4.11 (1) the number of veterans and veterans'
4.12 family members served; and
4.13 (2) a detailed explanation of expenditures of
4.14 the grant money.

4.15 (h) **Veteran Resilience Project.** \$140,000
4.16 each year is for a grant to the veteran resilience
4.17 project. Grant funds must be used to make eye
4.18 movement desensitization and reprocessing
4.19 therapy available to veterans, veterans'
4.20 spouses, current military service members,
4.21 and current military service members' spouses
4.22 who are suffering from posttraumatic stress
4.23 disorder and trauma.

4.24 The veteran resilience project must report to
4.25 the commissioner of veterans affairs and the
4.26 chairs and ranking minority members of the
4.27 legislative committees with jurisdiction over
4.28 veterans affairs policy and finance by January
4.29 15 of each year on the program. The report
4.30 must include an overview of the program's
4.31 budget, a detailed explanation of program
4.32 expenditures, the number of veterans and
4.33 service members served by the program, and
4.34 a list and explanation of the services provided
4.35 to program participants.

5.1 (i) **CORE Program.** \$1,225,000 each year is
5.2 for the Counseling and Case Management
5.3 Outreach Referral and Education (CORE)
5.4 program.

5.5 (j) **LinkVet Call Center.** \$369,000 each year
5.6 is for the operation of the state's LinkVet Call
5.7 Center.

5.8 (k) **Recently Separated Veterans Program.**
5.9 \$300,000 each year is for operation of the
5.10 recently separated veterans program. The
5.11 commissioner of veterans affairs may use
5.12 Department of Defense and other veteran data
5.13 that was provided with an appropriate
5.14 disclosure to assist with connecting veterans
5.15 to resources and new programming. The
5.16 commissioner may use money for personnel,
5.17 research, marketing, technology solutions, and
5.18 professional or technical contracts.

5.19 (l) **Homeless Veterans and SOAR Program.**
5.20 \$1,344,000 each year is to operate the
5.21 homeless veteran registry and homeless
5.22 programs and to assist veterans, former service
5.23 members, and veterans' and former service
5.24 members' dependents with obtaining federal
5.25 benefits through the Social Security
5.26 Administration. The commissioner of veterans
5.27 affairs may use money for personnel, training,
5.28 research, marketing, and professional or
5.29 technical contracts.

5.30 (m) **Minnesota Assistance Council for**
5.31 **Veterans.** \$1,075,000 each year is for grants
5.32 to the Minnesota Assistance Council for
5.33 Veterans to provide assistance throughout
5.34 Minnesota to veterans and veterans' families

6.1 who are homeless or in danger of
 6.2 homelessness, including assistance with:
 6.3 (1) supportive services to maintain housing;
 6.4 (2) employment;
 6.5 (3) legal issues;
 6.6 (4) housing and housing-related costs;
 6.7 (5) transportation;
 6.8 (6) the acquisition and creation of permanent
 6.9 supportive housing; and
 6.10 (7) property management of permanent
 6.11 supportive housing.

6.12 Any unencumbered balance remaining in this
 6.13 paragraph in the first year does not cancel and
 6.14 is available for the second year. Assistance
 6.15 authorized under this paragraph must be
 6.16 provided only to a veteran who has resided in
 6.17 Minnesota for 30 days prior to the veteran's
 6.18 application for assistance and according to
 6.19 other guidelines established by the
 6.20 commissioner. To avoid duplication of
 6.21 services, the commissioner must ensure that
 6.22 this assistance is coordinated with all other
 6.23 available programs for veterans.

6.24 (n) **Minnesota Military and Veterans**
 6.25 **Museum.** \$300,000 each year is for a grant to
 6.26 the Minnesota Military and Veterans Museum
 6.27 for museum staff to provide direct services to
 6.28 veterans and their families.

6.29 (o) **Veteran Homelessness Initiative.**
 6.30 \$1,311,000 each year is for an initiative to
 6.31 prevent and end veteran homelessness.

- 7.1 (a) \$110,302,000 the first year and
7.2 \$114,670,000 the second year may be
7.3 transferred to a veterans homes special
7.4 revenue account in the special revenue fund

7.7 section 198.34, and are appropriated to the
7.8 commissioner of veterans affairs for the

- 7.30 Section 1. Minnesota Statutes 2024, section 13.461, subdivision 27, is amended to read:
- 7.31 Subd. 27. ~~State soldiers assistance program~~ Veterans affairs programs. Access to
7.32 information for purposes of verifying eligibility for the State Soldiers Assistance Program,

8.1 the Veterans Stable Housing Initiative, and the Veterans Programs Division is governed by
8.2 section 197.065.

8.3 Sec. 2. Minnesota Statutes 2024, section 193.143, is amended to read:

8.4 **193.143 STATE ARMORY BUILDING COMMISSION, POWERS.**

8.5 Such corporation, subject to the conditions and limitations prescribed in sections 193.141
8.6 to 193.149, shall possess all the powers of a body corporate necessary and convenient to
8.7 accomplish the objectives and perform the duties prescribed by sections 193.141 to 193.149,
8.8 including the following, which shall not be construed as a limitation upon the general powers
8.9 hereby conferred:

8.10 (1) To acquire by lease, purchase, gift, or condemnation proceedings all necessary right,
8.11 title, and interest in and to the lands required for a site for a new armory and all other real
8.12 or personal property required for the purposes contemplated by the Military Code and to
8.13 hold and dispose of the same, subject to the conditions and limitations herein prescribed;
8.14 provided that any such real or personal property or interest therein may be so acquired or
8.15 accepted subject to any condition which may be imposed thereon by the grantor or donor
8.16 and agreed to by such corporation not inconsistent with the proper use of such property by
8.17 the state for armory or military purposes as herein provided.

8.18 (2) To exercise the power of eminent domain in the manner provided by chapter 117,
8.19 for the purpose of acquiring any property which such corporation is herein authorized to
8.20 acquire by condemnation; provided, that the corporation may take possession of any such
8.21 property so to be acquired at any time after the filing of the petition describing the same in
8.22 condemnation proceedings; provided further, that this shall not preclude the corporation
8.23 from abandoning the condemnation of any such property in any case where possession
8.24 thereof has not been taken.

8.25 (3) To construct and equip new armories as authorized herein; to pay therefor out of the
8.26 funds obtained as hereinafter provided and to hold, manage, and dispose of such armory,
8.27 equipment, and site as hereinafter provided. The total amount of bonds issued on account
8.28 of such armories shall not exceed the amount of the cost thereof; provided also, that the
8.29 total bonded indebtedness of the commission shall not at any time exceed the aggregate
8.30 sum of ~~\$15,000,000~~ \$45,000,000.

8.31 (4) To provide partnerships with federal and state governments and to match federal and
8.32 local funds, when available.

8.33 (5) To sue and be sued.

(6) To contract and be contracted with in any matter connected with any purpose or activity within the powers of such corporations as herein specified; provided, that no officer or member of such corporation shall be personally interested, directly or indirectly, in any contract in which such corporation is interested.

(7) To employ any and all professional and nonprofessional services and all agents, employees, workers, and servants necessary and proper for the purposes and activities of such corporation as authorized or contemplated herein and to pay for the same out of any portion of the income of the corporation available for such purposes or activities. The officers and members of such corporation shall not receive any compensation therefrom, but may receive their reasonable and necessary expenses incurred in connection with the performance of their duties; provided however, that whenever the duties of any member of the commission require full time and attention the commission may compensate the member therefor at such rates as it may determine.

(8) To borrow money and issue bonds for the purposes and in the manner and within the limitations herein specified, and to pledge any and all property and income of such corporation acquired or received as herein provided to secure the payment of such bonds, subject to the provisions and limitations herein prescribed, and to redeem any such bonds if so provided therein or in the mortgage or trust deed accompanying the same.

(9) To use for the following purposes any available money received by such corporation from any source as herein provided in excess of those required for the payment of the cost of such armory and for the payment of any bonds issued by the corporation and interest thereon according to the terms of such bonds or of any mortgage or trust deed accompanying the same:

(a) to pay the necessary incidental expenses of carrying on the business and activities of the corporation as herein authorized;

(b) to pay the cost of operating, maintaining, repairing, and improving such new armories;

(c) if any further excess money remains, to purchase upon the open market at or above or below the face or par value thereof any bonds issued by the corporation as herein authorized, provided that any bonds so purchased shall thereupon be canceled.

(10) To adopt and use a corporate seal.

(11) To adopt all needful bylaws and rules for the conduct of business and affairs of such corporation and for the management and use of all armories while under the ownership

10.1 and control of such corporation as herein provided, not inconsistent with the use of such
10.2 armory for armory or military purposes.

10.3 (12) Such corporation shall issue no stock.

10.4 (13) No officer or member of such corporation shall have any personal share or interest
10.5 in any funds or property of the corporation or be subject to any personal liability by reason
10.6 of any liability of the corporation.

10.7 (14) The Minnesota State Armory Building Commission created under section 193.142
10.8 shall keep all money and credits received by it as a single fund, to be designated as the
10.9 "Minnesota State Armory Building Commission fund," with separate accounts for each
10.10 armory; and the commission may make transfers of money from funds appertaining to any
10.11 armory under its control for use for any other such armory; provided such transfers shall
10.12 be made only from money on hand, from time to time, in excess of the amounts required
10.13 to meet payments of interest or principal on bonds or other obligations appertaining to the
10.14 armory to which such funds pertain and only when necessary to pay expenses of construction,
10.15 operation, maintenance, debt service, and other obligations reasonable and necessary, of
10.16 such other armory; provided further, no such transfer of any money paid for the support of
10.17 any armory by the municipality in which such armory is situated shall be made by the
10.18 commission.

10.19 (15) The corporation created under section 193.142 may designate one or more state or
10.20 national banks as depositories of its funds, and may provide, upon such conditions as the
10.21 corporation may determine, that the treasurer of the corporation shall be exempt from
10.22 personal liability for loss of funds deposited in any such depository due to the insolvency
10.23 or other acts or omissions of such depository.

10.24 (16) The governor is empowered to apply for grants of money, equipment, and materials
10.25 which may be made available to the states by the federal government for leasing, building,
10.26 and equipping armories for the use of the military forces of the state which are reserve
10.27 components of the armed forces of the United States, whenever the governor is satisfied
10.28 that the conditions under which such grants are offered by the federal government, are for
10.29 the best interests of the state and are not inconsistent with the laws of the state relating to
10.30 armories, and to accept such grants in the name of the state. The Minnesota State Armory
10.31 Building Commission is designated as the agency of the state to receive such grants and to
10.32 use them for armory purposes as prescribed in this chapter, and by federal laws, and
10.33 regulations not inconsistent therewith.

11.2 **197.065 ACCESS TO DATABASE.**

11.3 (a) Notwithstanding section 13.46, subdivision 2, the commissioner of veterans affairs
11.4 may electronically access the MAXIS database maintained by the Department of ~~Human~~
11.5 ~~Services~~ Children, Youth, and Families for the purpose of verifying eligibility status of
11.6 applicants for benefits under the State Soldiers Assistance Program, the Veterans Stable
11.7 Housing Initiative, and the Veterans Programs Division. The commissioner may electronically
11.8 access the MAXIS database to ensure that veterans are connected to all available state and
11.9 federal resources for which the veterans are eligible.

11.10 (b) In order to access any private data on individuals, as defined by section 13.02,

11.14 Subd. 8. **Eligibility.** Cemeteries must be operated solely for the burial of service members
11.15 who die on active duty, eligible veterans, and their spouses and dependent children, as
11.16 defined in United States Code, title 38, section ~~401~~ 2402, paragraph ~~(2)~~ (a), subparagraphs
11.17 1 to 5 and 7.

11.18 Sec. 5. Minnesota Statutes 2024, section 197.236, subdivision 9, is amended to read:

11.19 Subd. 9. **Burial fees.** (a) The commissioner of veterans affairs shall establish a fee
11.20 schedule, which may be adjusted from time to time, for the interment of eligible spouses
11.21 and dependent children. The fees shall cover as nearly as practicable the actual costs of
11.22 interment, excluding the value of the plot.

11.23 (b) Upon application, the commissioner may waive or reduce the burial fee for an indigent
11.24 eligible person. The commissioner shall ~~develop~~ maintain a policy, eligibility standards,
11.25 and application form for requests to waive or reduce the burial fee to indigent eligible
11.26 applicants.

12.2 Subd. 6. **Grant amount.** (a) Each county is eligible to receive an annual grant of \$7,500
12.3 for the following purposes:

12.4 (1) to provide outreach to the county's veterans;

12.5 (2) to assist in the reintegration of combat veterans into society;

12.6 (3) to collaborate with other social service agencies, educational institutions, and other
12.7 community organizations for the purposes of enhancing services offered to veterans;

12.8 (4) to reduce homelessness among veterans; and

12.9 (5) to enhance the operations of the county veterans service office.

12.10 (b) In addition to the grant amount in paragraph (a), each county is eligible to receive
12.11 an additional annual grant under this paragraph. The amount of each additional annual grant

12.24 accreditation, and costs associated with reintegration services. Up to \$60,000 of this amount
12.25 may be used to train technical assistance coordinators and for technical assistance

13.4 Subdivision 1. **Definitions.** (a) For purposes of this section, the following terms have
13.5 the meanings given.

13.6 (b)(1) "Advertising" or "advertisement" means any of the following:

13.7 (i) any written or printed communication made for the purpose of soliciting business for
13.8 veterans benefits services, or veterans benefits appeal services, including but not limited to
13.9 a brochure, letter, pamphlet, newspaper, telephone listing, periodical, or other writing;

13.10 (ii) any directory listing caused or permitted by a person and made available by that
13.11 person indicating that veterans benefits services, or veterans benefits appeal services, are
13.12 being offered; or

13.13 (iii) any radio, television, computer network, or similar airwave or electronic transmission
13.14 that solicits business for or promotes a person offering veterans benefits services, or veterans
13.15 benefits appeal services.

13.16 (2) "Advertising" or "advertisement" does not include any of the following:

13.17 (i) any printing or writing used on buildings, uniforms, or badges, where the purpose of
13.18 the writing is for identification; or

13.19 (ii) any printing or writing in a memorandum or other communication used in the ordinary
13.20 course of business where the sole purpose of the writing is other than soliciting business
13.21 for veterans benefits services, or veterans benefits appeal services.

13.22 (c) "Benefit" means any payment, service, commodity, function, status, or entitlement
13.23 to which is determined under laws administered by the United States Department of Veterans
13.24 Affairs pertaining to veterans, dependents, and survivors.

13.25 (d) "Claim" means an application made under United States Code, title 38, and
13.26 implementing directives, for entitlement to United States Department of Veterans Affairs
13.27 benefits, reinstatement, continuation, or increase of benefits, or the defense of a proposed
13.28 agency adverse action concerning benefits.

Before a person enters into an agreement to provide veterans benefits services or accepts ~~money or any other thing of value~~ compensation for the provision of veterans benefits services, the person must obtain the signature of the client on a written disclosure statement containing an attestation by the client that the client has read and understands the written disclosure statement. This subdivision does not apply to an attorney accredited by the United States Department of Veterans Affairs under Code of Federal Regulations, title 38, section 14.629.

Subd. 3a. **Federal accreditation; other requirements.** (a) A person who provides veterans benefits services, or veterans benefits appeals services, in exchange for compensation must be accredited by the secretary of the United States Department of Veterans Affairs under United States Code, title 38, chapter 59.

(b) A person may not make a referral for compensation of claimant to a provider of veterans benefits services, or veterans benefits appeals services, unless they are accredited by the secretary of the United States Department of Veterans Affairs except as permitted under United States Code, title 38, chapter 59.

(c) A person subject to an accreditation requirement under paragraph (a), and who provides veterans benefits services, or veterans benefits appeals services, may charge a veteran or a family member of a veteran a fee or other form of compensation only as provided in Code of Federal Regulations, title 38, section 14.636.

(d) Before providing veterans benefits services, or veterans benefits appeals services, a person must provide a veteran or a family member of a veteran a written fee agreement that complies with Code of Federal Regulations, title 38, section 14.636, memorializing all terms regarding payment of fees, and signed by both parties.

(e) A person shall not engage in the practice of law where it concerns veterans, in the preparation, presentation, or prosecution for veterans benefits before the United States Department of Veterans Affairs, except if the person is a VA-accredited representative.

(f) A person seeking compensation in connection with a veterans benefit service or veterans benefit appeal service must:

(1) not use a veteran's personal login, username, or password information to access the veteran's medical, financial, or government benefits information; and

(2) ensure that any individual who has access to a veteran's medical or financial information undergoes a background check prior to having access to that information. The background check must be conducted by a reputable source and include identity verification and a criminal records check.

Subd. 3b. Guarantee of benefits prohibited. A person providing veterans benefits services, or veterans benefits appeals services, in exchange for compensation, must not guarantee, either directly or by implication, that a veteran or a family member of a veteran is certain to receive specific federal, state, or county veterans benefits or any specific level, percentage, or amount of federal, state, or county veterans benefits.

Subd. 4. Violations; penalties. ~~A person who fails to comply with this section is subject to a civil penalty not to exceed \$1,000 for each violation. Civil penalties shall be assessed by the district court in an action initiated by the attorney general. For the purposes of computing the amount of each civil penalty, each day of a continuing violation constitutes a separate violation. Additionally, the attorney general may accept a civil penalty as determined by the attorney general in settlement of an investigation of a violation of this section regardless of whether an action has been filed under this section.~~ A violation of this section is an unlawful practice under section 325F.69. Any civil penalty recovered shall be deposited in the Support Our Troops account established under section 190.19.

(iii) is enrolled in an education program leading to a certificate, diploma, or degree at an eligible institution;

(iv) has applied for educational assistance under this section prior to the end of the academic term for which the assistance is being requested;

(v) is in compliance with child support payment requirements under section 136A.121, subdivision 2, clause (5); and

(vi) has completed the Free Application for Federal Student Aid (FAFSA).

(b) A person's eligibility terminates when the person becomes eligible for benefits under section 135A.52.

(c) To determine eligibility, the commissioner may require official documentation, including the person's federal form DD-214 or other official military discharge papers; correspondence from the United States Veterans Administration; birth certificate; marriage certificate; proof of enrollment at an eligible institution; signed affidavits; proof of residency; proof of identity; or any other official documentation the commissioner considers necessary to determine eligibility.

(d) The commissioner may deny eligibility or terminate benefits under this section to any person who has not provided sufficient documentation to determine eligibility for the program. An applicant may appeal the commissioner's eligibility determination or termination of benefits in writing to the commissioner at any time. The commissioner must rule on any application or appeal within 30 days of receipt of all documentation that the commissioner requires. The decision of the commissioner regarding an appeal is final. However, an applicant whose appeal of an eligibility determination has been rejected by the commissioner may submit an additional appeal of that determination in writing to the commissioner at any time that the applicant is able to provide substantively significant additional information regarding the applicant's eligibility for the program. An approval of an applicant's eligibility by the commissioner following an appeal by the applicant is not retroactively effective for more than one year or the semester of the person's original application, whichever is later.

(e) Upon receiving an application with insufficient documentation to determine eligibility, the commissioner must notify the applicant within 30 days of receipt of the application that the application is being suspended pending receipt by the commissioner of sufficient documentation from the applicant to determine eligibility.

Sec. 10. **GOLD STAR AND BLUE STAR FAMILIES; MEMORIAL PLAQUE.**

The commissioner of administration shall place a memorial plaque in the court of honor on State Capitol grounds to recognize the service and sacrifices of Minnesota's Gold Star and Blue Star families. The Capitol Area Architectural and Planning Board must solicit design submissions from the public. The Capitol Area Architectural and Planning Board shall select a design from the submitted designs to use as a basis for final production. The selected design must be approved by the commissioner of veterans affairs and must be furnished by the person or group who submitted the design at no cost to the state.
