This is a onetime 2.8 appropriation and is available until June 30, 29 2027. The commissioner of employment and 2.10 economic development may enter into an 2.11 interagency agreement with the Office of 2.12 Higher Education, including agreements to 2.13 transfer funds and to administer the program. 2.14 (c) \$100,000 the second year is from the 2.15 workforce development fund for a grant to 2.16 Inspire Change Clinic for their health care 2.17 fellowship program designed to create 2.18 pathways to medicine for high school and 2.19 college students interested in pursuing a career 2.20 in the health care workforce. This is a 6.28 6.29 onetime appropriation. (q) \$100,000 the second year is from the 6.30 workforce development fund and is for a grant 6.31 to Ramsey County for a subgrant with People 6.32 in Action to provide workforce development 6.33 programming. must be expended within the city of St. Paul. 7.1 Grants provided by People in Action must be 7.2 awarded through at least two requests for 7.3 proposals. 10.24	workforce development fund for a grant to the
10.25	Twin Cities Urban League for support,
10.26	capacity building, and expansion of the Work
10.27	Readiness Program. This is a onetime
10.28	appropriation.

10.30	workforce development fund for a grant to
10.31	Arrowhead Opportunity Agency for the
10.32	purposes of expanding workforce development
10.33	opportunities in the region through the creation
10.34	of a regional hub building where services can
10.35	be provided. Money may be used for the costs

11.16	Minnesota, including agreements to transfer
11.17	funds and administer the grant.
11.18	(jj) \$50,000 the second year is from the
11.19	general fund for a grant to Block Builders
11.20	Foundation. This appropriation must be used
11.21	for programming targeted toward at-risk youth
11.22	coaching, financial literacy education, juvenile
11.23	offender diversion programming, and
11.24	community outreach. This is a onetime
11.25	appropriation.
