1.21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.22 Section 1. Minnesota Statutes 2024, section 10A.01, is amended by adding a subdivision

1.23 to read:

1.24 Subd. 1a. **Address.** "Address" means the complete mailing address, including the zip

1.25 code. An individual may use either the individual's business address or home address. An

1.26 association's address is the address from which the association conducts its business.

2.1 Sec. 2. Minnesota Statutes 2025 Supplement, section 10A.01, subdivision 26, is amended
2.2 to read:

2.3 Subd. 26. **Noncampaign disbursement.** (a) "Noncampaign disbursement" means a
2.4 purchase or payment of money or anything of value made, or an advance of credit incurred,
2.5 or a donation in kind received, by a principal campaign committee for any of the following
2.6 purposes:

2.7 (1) payment for accounting and legal services related to operating the candidate's
2.8 campaign committee, serving in office, or security for the candidate or the candidate's
2.9 immediate family, including but not limited to seeking and obtaining a harassment restraining
2.10 order;

2.11 (2) return of a contribution to the source;

2.12 (3) repayment of a loan made to the principal campaign committee by that committee;

2.13 (4) return of a public subsidy;

2.14 (5) payment for food, beverages, and necessary utensils and supplies, entertainment,
2.15 and facility rental for a fundraising event;

2.16 (6) services for a constituent by a member of the legislature or a constitutional officer
2.17 in the executive branch as provided in section 10A.173, subdivision 1;

2.18 (7) payment for food and beverages consumed by a candidate or volunteers while they
2.19 are engaged in campaign activities;

2.20 (8) payment for food or a beverage consumed while attending a reception or meeting
2.21 directly related to legislative duties;

2.22 (9) payment of expenses incurred by elected or appointed leaders of a legislative caucus
2.23 in carrying out their leadership responsibilities;

2.24 (10) payment by a principal campaign committee of the candidate's expenses for serving
2.25 in public office, other than for personal uses;

2.26 (11) costs of child care for the candidate's children when campaigning;

2.27 (12) fees paid to attend a campaign school;

2.28 (13) costs of a postelection party during the election year when a candidate's name will
2.29 no longer appear on a ballot or the general election is concluded, whichever occurs first;

2.30 (14) interest on loans paid by a principal campaign committee on outstanding loans;

2.31 (15) filing fees;

3.1 (16) post-general election holiday or seasonal cards, thank-you notes, or advertisements
3.2 in the news media mailed or published prior to the end of the election cycle;

3.3 (17) the cost of campaign material purchased to replace defective campaign material, if
3.4 the defective material is destroyed without being used;

3.5 (18) contributions to a party unit;

3.6 (19) payments for funeral gifts or memorials;

3.7 (20) the cost of a magnet less than six inches in diameter containing legislator contact
3.8 information and distributed to constituents;

3.9 (21) costs associated with a candidate attending a political party state or national
3.10 convention in this state;

3.11 (22) other purchases or payments specified in board rules or advisory opinions as being
3.12 for any purpose other than to influence the nomination or election of a candidate or to
3.13 promote or defeat a ballot question;

3.14 (23) costs paid to a third party for processing contributions made by a credit card, debit
3.15 card, or electronic check;

3.16 (24) costs paid by a candidate's principal campaign committee to support the candidate's
3.17 participation in a recount of ballots affecting the candidate's election;

3.18 (25) a contribution to a fund established to support a candidate's participation in a recount
3.19 of ballots affecting that candidate's election;

3.20 (26) costs paid by a candidate's principal campaign committee for a single reception
3.21 given in honor of the candidate's retirement from public office after the filing period for
3.22 affidavits of candidacy for that office has closed;

3.23 (27) a donation from a terminating principal campaign committee to the state general
3.24 fund;

3.25 (28) a donation from a terminating principal campaign committee to a county obligated
3.26 to incur special election expenses due to that candidate's resignation from state office;

3.27 (29) during a period starting January 1 in the year following a general election and ending
3.28 on December 31 of the year of general election, total payments of up to ~~\$3,000~~ \$5,000 for:

3.29 (i) detection-related security monitoring expenses for a candidate, including home
3.30 security hardware, maintenance of home security monitoring hardware, identity theft
3.31 monitoring services, and credit monitoring services; and

4.1 (ii) purchase, installation, and maintenance of structural security devices such as locks,
4.2 wiring, lighting, gates, doors, and fencing so long as such devices are intended solely to
4.3 provide security;

4.10 For purposes of this clause, campaign property includes but is not limited to campaign lawn
4.11 signs. The candidate must document the need for these costs in writing or with photographs;

4.13 (31)(32) transition expenses and inaugural event expenses as defined in section 10A.174.

4.14 (b) The board must determine whether an activity involves a noncampaign disbursement
4.15 within the meaning of this subdivision.

4.16 (c) A noncampaign disbursement is considered to be made in the year in which the
4.17 candidate made the purchase of goods or services or incurred an obligation to pay for goods
4.18 or services.

4.19 Sec. 3. Minnesota Statutes 2024, section 10A.01, is amended by adding a subdivision to
4.20 read:

4.21 Subd. 35d. **Security services.** (a) "Security services" means threat assessments, security
4.22 guards, or guest screening services needed to address specific security concerns that result
4.23 from the individual's position as a public official or state or local candidate that are provided
4.24 by:

4.25 (1) a state or local law enforcement agency; or

4.26 (2) an insured vendor licensed by the Board of Private Detective and Protective Agent
4.27 Services under sections 326.32 to 326.339.

4.28 (b) Security services do not include:

4.29 (1) services obtained from a relative or a business owned by a relative, within the third
4.30 degree of consanguinity, of an official or candidate; or

4.31 (2) services obtained above fair market value.

5.3 Subd. 36a. **Street address.** "Street address" means the name or number of the building,
5.4 the name of the street on which the building is located, and any unit number.

5.5 Sec. 5. Minnesota Statutes 2025 Supplement, section 10A.02, subdivision 11b, is amended
5.6 to read:

5.7 Subd. 11b. **Data privacy related to electronic reporting system.** (a) The board may
5.8 develop and maintain systems to enable ~~treasurers~~ individuals to enter and store electronic
5.9 records online for the purpose of complying with this chapter. Data entered into such systems
5.10 ~~by treasurers or their authorized agents~~ is not government data under chapter 13 and may
5.11 not be accessed or used by the board for any purpose without the ~~treasurer's~~ written consent
5.12 of the filer to whom the data pertains. Except for street addresses for individuals, data from
5.13 such systems that has been submitted to the board as a filed report or statement is government
5.14 data under chapter 13. The street address of individuals contained on reports and statements
5.15 filed with the board are classified as nonpublic data, as defined in section 13.02, subdivision
5.16 9, or as private data on individuals, as defined in section 13.02, subdivision 12, and in
5.17 addition to the subject of the data, are accessible to the filer of the report or statement
5.18 containing that data. The board, a county attorney, or a county, municipality, school district,
5.19 or other political subdivision may use street addresses disclosed on reports and statements
5.20 to ensure compliance with this chapter. In addition, the street address of a candidate contained
5.21 on a report filed with the board by the candidate's principal campaign committee is accessible
5.22 to the leader of each major political party caucus within the house of representatives and
5.23 the senate. As a condition of receiving this access, a major political party caucus leader
5.24 must agree to use the data only for official business and must not further distribute or publish
5.25 the street address for any purpose.

5.26 (b) For purposes of administering the refund under section 290.06, subdivision 23, the
5.27 board may access or use the following data entered and stored in an electronic reporting
5.28 system and share the data with the commissioner of revenue: (1) the amount of the
5.29 contribution; (2) the name and address of the contributor; (3) any unique identifier for the
5.30 contribution; (4) the name and campaign identification number of the party or candidate
5.31 that received the contribution; and (5) the date on which the contribution was received. Data
5.32 accessed, used, or maintained by the board under this paragraph are classified as nonpublic
5.33 data, as defined in section 13.02, subdivision 9, and private data on individuals, as defined
5.34 in section 13.02, subdivision 12.

6.2 **10A.027 INFORMATION ON WEBSITE.**

6.3 Subdivision 1. **Financial information.** The board must not post on its website any
6.4 canceled checks, bank account numbers, credit card account numbers, or Social Security
6.5 numbers that may be in the board's possession as a result of report or statement filings,
6.6 complaints, or other proceedings under this chapter.

6.7 Subd. 2. **Addresses.** The board must not post on its website the street address of an
6.8 individual disclosed on a report or statement filed with the board. Reports and statements
6.9 filed and available on the board's website prior to the effective date of this subdivision may
6.10 be modified or republished by the board to exclude or redact street addresses of individuals.

6.11 Sec. 7. Minnesota Statutes 2025 Supplement, section 10A.04, subdivision 4, is amended
6.12 to read:

6.13 Subd. 4. **Content.** (a) A report under this section must include information the board
6.14 requires from the registration form and the information required by this subdivision for the
6.15 reporting period.

6.16 (b) A lobbyist must report the specific subjects of interest for an entity represented by
6.17 the lobbyist on each report submitted under this section. A lobbyist must describe a specific
6.18 subject of interest in the report with enough information to show the particular issue of
6.19 importance to the entity represented.

6.20 (c) A lobbyist must report every state agency that had administrative action that the
6.21 represented entity sought to influence during the reporting period. The lobbyist must report
6.22 the specific subjects of interest for each administrative action and the revisor of statutes
6.23 rule draft number assigned to the administrative rulemaking.

6.24 (d) A lobbyist must report every political subdivision that considered official action that
6.25 the represented entity sought to influence during the reporting period. The lobbyist must
6.26 report the specific subjects of interest for each action.

6.27 (e) A lobbyist must report general lobbying categories and up to four specific subjects
6.28 of interest related to each general lobbying category on which the lobbyist attempted to
6.29 influence legislative action during the reporting period. If the lobbyist attempted to influence
6.30 legislative action on more than four specific subjects of interest for a general lobbying
6.31 category, the lobbyist, in consultation with the represented entity, must determine which
6.32 four specific subjects of interest were the entity's highest priorities during the reporting
6.33 period and report only those four subjects.

7.1 (f) A lobbyist must report the Public Utilities Commission project name for each rate
7.2 setting, power plant and powerline siting, or granting of certification of need before the
7.3 Public Utilities Commission that the represented entity sought to influence during the
7.4 reporting period.

7.5 (g) A lobbyist must report the amount and nature of each gift, item, or benefit, excluding
7.6 contributions to a candidate, equal in value to \$5 or more, given or paid to any official, as
7.7 defined in section 10A.071, subdivision 1, by the lobbyist or an employer or employee of
7.8 the lobbyist. The list must include the official's name and address of, title, and the government
7.9 jurisdiction for which the official serves for each official to whom the gift, item, or benefit
7.10 was given or paid and the date it was given or paid.

7.11 (h) A lobbyist must report each original source of money in excess of \$500 in any year
7.12 used for the purpose of lobbying to influence legislative action, administrative action, or
7.13 the official action of a political subdivision. The list must include the name, address, and
7.14 employer, or, if self-employed, the occupation and principal place of business, of each payer
7.15 of money in excess of \$500.

7.16 (i) On each report, a lobbyist must disclose the general lobbying categories that were
7.17 lobbied on in the reporting period.

7.18 (j) A lobbyist must report each expert witness that the lobbyist requested to communicate
7.19 with public or local officials as described in section 10A.01, subdivision 21, paragraph (b),
7.20 clause (9), and each finance professional who participated in conduit financing as described
7.21 in section 10A.01, subdivision 21, paragraph (b), clause (7). The lobbyist must report the
7.22 name of the expert witness or finance professional; the employer, if any, of the expert witness
7.23 or finance professional; the government entity that received the communication from the
7.24 expert witness or finance professional; and the specific subject on which the expert witness
7.25 or finance professional communicated. The designated lobbyist must also report this
7.26 information if the expert witness or finance professional is requested to communicate by
7.27 the principal or association that the lobbyist represents.

7.28 Sec. 8. Minnesota Statutes 2024, section 10A.09, subdivision 5, is amended to read:

7.29 Subd. 5. **Form; general requirements.** (a) A statement of economic interest required
7.30 by this section must be on a form prescribed by the board. Except as provided in subdivision
7.31 5b, the individual filing must provide the following information:

7.32 (1) the individual's name, address, occupation, and principal place of business;

7.33 (2) a listing of the name of each associated business and the nature of that association;

8.1 (3) a listing of all real property within the state, excluding homestead property, in which
8.2 the individual or the individual's spouse holds: (i) a fee simple interest, a mortgage, a contract
8.3 for deed as buyer or seller, or an option to buy, whether direct or indirect, if the interest is
8.4 valued in excess of \$2,500; or (ii) an option to buy, if the property has a fair market value
8.5 of more than \$50,000;

8.6 (4) a listing of all real property within the state in which a partnership of which the
8.7 individual or the individual's spouse is a member holds: (i) a fee simple interest, a mortgage,
8.8 a contract for deed as buyer or seller, or an option to buy, whether direct or indirect, if the
8.9 individual's share of the partnership interest is valued in excess of \$2,500; or (ii) an option
8.10 to buy, if the property has a fair market value of more than \$50,000. A listing under this
8.11 clause or clause (3) must indicate ~~the street address and~~ the municipality or the section,
8.12 township, range and approximate acreage, whichever applies, and the county in which the
8.13 property is located;

8.14 (5) a listing of any investments, ownership, or interests in property connected with
8.15 pari-mutuel horse racing in the United States and Canada, including a racehorse, in which
8.16 the individual directly or indirectly holds a partial or full interest or an immediate family
8.17 member holds a partial or full interest;

8.18 (6) a listing of the principal business or professional activity category of each business
8.19 from which the individual or the individual's spouse receives more than \$250 in any month
8.20 during the reporting period as an employee, if the individual or the individual's spouse has
8.21 an ownership interest of 25 percent or more in the business;

8.22 (7) a listing of each principal business or professional activity category from which the
8.23 individual or the individual's spouse received compensation of more than \$2,500 in the past
8.24 12 months as an independent contractor;

8.25 (8) a listing of the full name of each security with a value of more than \$10,000 owned
8.26 in part or in full by the individual or the individual's spouse, at any time during the reporting
8.27 period; and

8.28 (9) a listing of any contract, professional license, lease, or franchise that:

8.29 (i) is held by the individual or the individual's spouse or any business in which the
8.30 individual has an ownership interest of 25 percent or more; and

8.31 (ii) is entered into with, or issued by, the government agency on which the individual
8.32 serves as a public or local official.

9.1 (b) The business or professional categories for purposes of paragraph (a), clauses (6)
9.2 and (7), must be the general topic headings used by the federal Internal Revenue Service
9.3 for purposes of reporting self-employment income on Schedule C. This paragraph does not
9.4 require an individual to report any specific code number from that schedule. Any additional
9.5 principal business or professional activity category may only be adopted if the category is
9.6 enacted by law.

9.7 (c) For the purpose of calculating the amount of compensation received from any single
9.8 source in a single month, the amount shall include the total amount received from the source
9.9 during the month, whether or not the amount covers compensation for more than one month.

9.10 (d) For the purpose of determining the value of an individual's interest in real property,
9.11 the value of the property is the market value shown on the property tax statement.

9.12 (e) For the purpose of this section, "date of appointment" means the effective date of
9.13 appointment to a position.

9.14 (f) For the purpose of this section, "accepting employment as a public official" means
9.15 the effective date of the appointment to the position, as stated in the appointing authority's
9.16 notice to the board.

9.17 (g) The listings required in paragraph (a), clauses (3) to (9), must not identify whether
9.18 the individual or the individual's spouse is associated with or owns the listed item.

9.19 Sec. 9. Minnesota Statutes 2024, section 10A.09, subdivision 5b, is amended to read:

9.20 Subd. 5b. **Form; exceptions for certain officials.** (a) This subdivision applies to the
9.21 following individuals:

9.22 (1) a supervisor of a soil and water conservation district;

9.23 (2) a manager of a watershed district; and

9.24 (3) a member of a watershed management organization as defined under section
9.25 103B.205, subdivision 13.

9.26 (b) Notwithstanding subdivision 5, paragraph (a), an individual listed in paragraph (a),
9.27 must provide only the information listed below on a statement of economic interest:

9.28 (1) the individual's name, address, occupation, and principal place of business;

9.29 (2) a listing of any association, corporation, partnership, limited liability company,
9.30 limited liability partnership, or other organized legal entity from which the individual
9.31 receives compensation in excess of \$250, except for actual and reasonable expenses, in any

10.6 to buy, whether direct or indirect, if the interest is valued in excess of \$2,500; or

10.7 (ii) an option to buy, if the property has a fair market value of more than \$50,000;

10.8 (4) a listing of all real property within the state in which a partnership of which the
10.9 individual or the individual's spouse is a member holds:

10.10 (i) a fee simple interest, a mortgage, a contract for deed as buyer or seller, or an option
10.11 to buy, whether direct or indirect, if the individual's share of the partnership interest is valued
10.12 in excess of \$2,500; or

10.13 (ii) an option to buy, if the property has a fair market value of more than \$50,000. A
10.14 listing under this clause or clause (3) must indicate the street address and the municipality
10.15 or the section, township, range and approximate acreage, whichever applies, and the county

10.17 (5) a listing of any contract, professional license, lease, or franchise that meets the
10.18 following criteria:

10.19 (i) it is held by the individual or the individual's spouse or any business in which the
10.20 individual has an ownership interest of 25 percent or more; and

10.21 (ii) it is entered into with, or issued by, the government agency on which the individual
10.22 serves as a public or local official.

10.23 (c) The listings required in paragraph (b), clauses (3) to (5), must not identify whether
10.24 the individual or the individual's spouse is associated with or owns the listed item.

10.25 (d) For the purposes of paragraph (b), clauses (3) and (4), the street address of real
10.26 property at which an individual or the individual's immediate family lives on a permanent
10.27 or temporary basis is private data, if the individual certifies for each address that the
10.28 individual would have a reasonable fear for the individual's or individual's immediate family's
10.29 safety if the address were public data.

10.30 (e) If an individual listed in paragraph (a) also holds a public official position that is not
10.31 listed in paragraph (a), the individual must file a statement of economic interest that includes
10.32 the information specified in subdivision 5, paragraph (a).

11.1 Sec. 10. Minnesota Statutes 2024, section 10A.20, subdivision 3, is amended to read:

11.2 Subd. 3. **Contents of report.** (a) The report required by this section must include each
11.3 of the items listed in paragraphs (b) to (q) that are applicable to the filer. The board shall
11.4 prescribe forms based on filer type indicating which of those items must be included on the
11.5 filer's report.

11.6 (b) The report must disclose the amount of liquid assets on hand at the beginning of the
11.7 reporting period.

11.8 (c) The report must disclose the name, address, employer, or occupation if self-employed,
11.9 and registration number if registered with the board, of each individual or association that
11.10 has made one or more contributions to the reporting entity, including the purchase of tickets
11.11 for a fundraising effort, that in aggregate within the year exceed \$200 for legislative or
11.12 statewide candidates or more than \$500 for ballot questions, together with the amount and
11.13 date of each contribution, and the aggregate amount of contributions within the year from
11.14 each source so disclosed. A donation in kind must be disclosed at its fair market value. An
11.15 approved expenditure must be listed as a donation in kind. A donation in kind is considered
11.16 consumed in the reporting period in which it is received. The names of contributors must
11.17 be listed in alphabetical order. Contributions from the same contributor must be listed under
11.18 the same name. When a contribution received from a contributor in a reporting period is
11.19 added to previously reported unitemized contributions from the same contributor and the
11.20 aggregate exceeds the disclosure threshold of this paragraph, the name, address, and
11.21 employer, or occupation if self-employed, of the contributor must then be listed on the
11.22 report.

11.23 (d) The report must disclose the sum of contributions to the reporting entity during the
11.24 reporting period.

11.25 (e) The report must disclose each loan made or received by the reporting entity within
11.26 the year in aggregate in excess of \$200, continuously reported until repaid or forgiven,
11.27 together with the name, address, occupation, principal place of business, if any, and
11.28 registration number if registered with the board of the lender and any endorser and the date
11.29 and amount of the loan. If a loan made to the principal campaign committee of a candidate
11.30 is forgiven or is repaid by an entity other than that principal campaign committee, it must
11.31 be reported as a contribution for the year in which the loan was made.

11.32 (f) The report must disclose each receipt over \$200 during the reporting period not
11.33 otherwise listed under paragraphs (c) to (e).

12.1 (g) The report must disclose the sum of all receipts of the reporting entity during the
12.2 reporting period.

12.3 (h) The report must disclose the name, address, and registration number if registered
12.4 with the board of each individual or association to whom aggregate expenditures, approved
12.5 expenditures, independent expenditures, and ballot question expenditures have been made
12.6 by or on behalf of the reporting entity within the year in excess of \$200, together with the
12.7 amount, date, and purpose of each expenditure, including an explanation of how the
12.8 expenditure was used, and the name and ~~address~~ the city, state, and zip code of, and office
12.9 sought by, each candidate or local candidate on whose behalf the expenditure was made,
12.10 identification of the ballot question that the expenditure was intended to promote or defeat
12.11 and an indication of whether the expenditure was to promote or to defeat the ballot question,
12.12 and in the case of independent expenditures made in opposition to a candidate or local
12.13 candidate, the candidate's or local candidate's name, ~~address;~~ the city, state, and zip code;
12.14 and office sought. A reporting entity making an expenditure on behalf of more than one
12.15 candidate or local candidate must allocate the expenditure among the candidates and local
12.16 candidates on a reasonable cost basis and report the allocation for each candidate or local
12.17 candidate. The report must list on separate schedules any independent expenditures made
