The bill was read for the first time and referred to the Committee on Capital Investment

1.1 A bill for an act
1.2 relating to capital investment; appropriating money for a well and well pump house
1.3 in the city of Middle River; authorizing the sale and issuance of state bonds.

1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. MIDDLE RIVER; WELL AND PUMP HOUSE.

1.6 Subdivision 1. Appropriation. \$988,000 is appropriated from the bond proceeds fund
1.7 to the Public Facilities Authority for a grant to the city of Middle River to design, construct,
1.8 and equip a new well, well pump house facility, and related infrastructure, to provide safe,
1.9 clean drinking water to residents.

1.10 Subd. 2. Bond sale. To provide the money appropriated in this section from the bond
1.11 proceeds fund, the commissioner of management and budget shall sell and issue bonds of
1.12 the state in an amount up to \$988,000 in the manner, upon the terms, and with the effect
1.13 prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota
1.14 Constitution, article XI, sections 4 to 7.

1.15 EFFECTIVE DATE. This section is effective the day following final enactment.
