1.2 relating to natural resources; appropriating money from environment and natural

1.3 resources trust fund; extending certain prior appropriations; modifying conflict of

1.4 interest provisions for members of Legislative-Citizen Commission on Minnesota

1.5 Resources; repealing requirement for commissioner approval of certain land

1.6 acquisitions; amending Minnesota Statutes 2024, sections 116P.09, subdivision

1.7 6; 116P.18; repealing Minnesota Statutes 2024, section 116P.17.

1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.9 Section 1. APPROPRIATIONS.

1.10 The sums shown in the columns marked "Appropriations" are appropriated to the agencies

1.11 and for the purposes specified in this act. The appropriations are from the environment and

1.12 natural resources trust fund, or another named fund, and are available for the fiscal years

1.13 indicated for each purpose. The figures "2026" and "2027" used in this act mean that the

1.14 appropriations listed under them are available for the fiscal year ending June 30, 2026, or

1.15 June 30, 2027, respectively. "The first year" is fiscal year 2026. "The second year" is fiscal

1.16 year 2027. "The biennium" is fiscal years 2026 and 2027.

 5.34 **Contaminants of Emerging Concern**

6.1 \$175,000 the second year is from the trust  
6.2 fund to the commissioner of natural resources  
6.3 for an agreement with the University of St.  
6.4 Thomas to compile and analyze Minnesota's  
6.5 contaminant of emerging concern occurrence  
6.6 data for lakes and rivers to generate ecological  
6.7 risk estimates and publicly accessible and  
6.8 user-friendly dashboards that will support  
6.9 managing and restoring freshwater habitats.

6.10 **(b) Eliminating Phenolic Compounds from**  
6.11 **Water Using Enzyme Filter**

6.12 \$300,000 the second year is from the trust  
6.13 fund to the Board of Regents of the University  
6.14 of Minnesota to evaluate enzymes and design  
6.15 an enzyme membrane filter to capture and  
6.16 eliminate harmful phenolic compounds from  
6.17 Minnesota's rivers and lakes.

6.20 \$2,842,000 the second year is from the trust  
6.21 fund to the commissioner of natural resources  
6.22 for an agreement with the city of Vadnais  
6.23 Heights to install water quality improvement  
6.24 ponds, recreational features, and educational  
6.25 signage near East Vadnais Lake to connect  
6.26 underserved community members with natural  
6.27 resources, protect drinking water, and promote  
6.28 water stewardship. This appropriation is  
6.29 available until June 30, 2030, by which time  
6.30 the project must be completed and final  
6.31 products delivered.

6.33 **Natural Resources Desk**

7.1 \$632,000 the second year is from the trust  
7.2 fund to the commissioner of natural resources  
7.3 for an agreement with Twin Cities Public  
7.4 Television to establish Almanac's environment

7.6 environment and natural resources issues and  
7.7 solutions across the state and hosts community  
7.8 conversations that raise awareness and  
7.9 increase appreciation of Minnesota's air, water,  
7.10 land, and other natural resources.

7.11 **(e) Studying Dam Removal Feasibility for**  
7.12 **the Mississippi Gorge**

7.13 \$923,000 the second year is from the trust  
7.14 fund to the commissioner of natural resources  
7.15 for an agreement with the Friends of the  
7.16 Mississippi River to assess the feasibility,  
7.17 environmental benefits, river restoration  
7.18 potential, and costs of dam removal for the  
7.19 Lower St. Anthony Falls Lock and Dam and  
7.20 Lock and Dam 1 in the Mississippi River  
7.21 gorge.

7.22 **(f) Protecting Minnesota's Waters from**  
7.23 **Plastic- and Rubber-Derived Chemicals**

7.24 \$418,000 the second year is from the trust  
7.25 fund to the Board of Regents of the University  
7.26 of Minnesota to develop stormwater treatment  
7.27 strategies and recommendations to protect  
7.28 surface water and groundwater from pollutants  
7.29 leached from polymers, coatings, plastics, and  
7.30 tire rubbers by assessing pollutant sources,  
7.31 presence, and reactivity.

7.32 **(g) Public Toolbox to Forecast Toxic**  
7.33 **Cyanobacteria Blooms**

8.1 \$509,000 the second year is from the trust  
8.2 fund to the Board of Regents of the University  
8.3 of Minnesota for the Natural Resources  
8.4 Research Institute in Duluth to validate the  
8.5 concept of a field-deployable toolbox to  
8.6 proactively and rapidly detect harmful algal  
8.7 blooms and forecast associated toxin  
8.8 production, evaluate the feasibility of the  
8.9 integrated toolbox, and seek feedback from  
8.10 potential users to inform further refinement.

8.11 **(h) PFAS in Precipitation: Assessing a**  
8.12 **Critical Statewide Threat**

8.13 \$910,000 the second year is from the trust  
8.14 fund to the Board of Regents of the University  
8.15 of Minnesota for the Minnesota Sea Grant  
8.16 college program in Duluth to create a  
8.17 multiyear, multisite, foundational dataset of  
8.18 per- and polyfluoroalkyl substances (PFAS)  
8.19 in rain and snow and to investigate the  
8.20 processes and sources that influence PFAS  
8.21 levels in rain and snow to inform management  
8.22 and remediation efforts. This appropriation is  
8.23 available until June 30, 2030, by which time  
8.24 the project must be completed and final  
8.25 products delivered.

8.26 **(i) Assessment of Microplastic Pollution in**  
8.27 **Minnesota Karst Aquifers**

8.28 \$458,000 the second year is from the trust  
8.29 fund to the Board of Regents of the University  
8.30 of Minnesota to determine the nature and  
8.31 extent of microplastic pollution in shallow  
8.32 karst aquifers, identify potential sources, and  
8.33 assess human and ecosystem health  
8.34 implications to inform mitigation and  
8.35 prevention strategies.

9.3 fund to the commissioner of natural resources  
9.4 for an agreement with Otter Tail County to  
9.5 construct and equip a facility to store and

9.7 alternative to landfilling.

9.16 impact on bioaccumulation in aquatic habitats.

9.20 fund to the commissioner of natural resources  
9.21 for an agreement with the city of Brooklyn  
9.22 Park to stabilize and enhance Shingle Creek  
9.23 through Brookdale Park and a portion of  
9.24 Palmer Lake Environmental Nature Area to  
9.25 improve wildlife passage and habitat,  
9.26 hydrologic function, water quality, and  
9.27 recreational opportunities through streambank  
9.28 and outfall stabilization, native plantings, and  
9.29 stream enhancements.

9.30 **(m) Determining Fracture Characteristics**  
9.31 **for Karst Groundwater Flow Modeling**  
9.32 \$375,000 the second year is from the trust  
9.33 fund to the Board of Regents of the University  
9.34 of Minnesota to develop and validate

10.2 fracture characteristics and improve  
10.3 predictions for groundwater flow and pollutant  
10.4 transport in Minnesota's karst aquifers.

10.5 **(n) Restoring Wild Rice Waters: Sulfate**  
10.6 **and Mercury Treatment**

10.7 \$727,000 the second year is from the trust  
10.8 fund to the commissioner of natural resources  
10.9 for an agreement with the White Iron Chain  
10.10 of Lakes Association to test a biological  
10.11 sulfate reduction system to treat sulfate and  
10.12 sequester mercury to improve the health of  
10.13 wild rice waters and aquatic ecosystems in  
10.14 northern Minnesota. Before costs for this  
10.15 appropriation are incurred, a fiscal agent for  
10.16 White Iron Chain of Lakes Association must  
10.17 be approved in the work plan.

10.18 **(o) Cheap Portable Sensor to Detect PFAS**  
10.19 **in Water**

10.20 \$357,000 the second year is from the trust  
10.21 fund to the Board of Regents of the University  
10.22 of Minnesota to develop a cheap, accurate,  
10.23 and easy-to-use sensor to monitor per- and  
10.24 polyfluoroalkyl substances (PFAS) in  
10.25 waterbodies and detect PFAS in drinking  
10.26 water.

10.27 **(p) Geologic Atlases for Water Resource**  
10.28 **Management**

10.29 \$1,275,000 the second year is from the trust  
10.30 fund to the Board of Regents of the University  
10.31 of Minnesota, Minnesota Geological Survey,  
10.32 to continue producing county geologic atlases  
10.33 to inform management of surface water and  
10.34 groundwater resources. This appropriation is

11.1 to complete Part A, which focuses on the  
11.2 properties and distribution of earth materials  
11.3 to define aquifer boundaries and the  
11.4 connection of aquifers to the land surface and  
11.5 surface water resources.

11.6 **(q) Mitigating Short-Chain Forever**  
11.7 **Chemicals Toward a PFAS-Free Minnesota**

11.8 \$299,000 the second year is from the trust  
11.9 fund to the Board of Regents of the University  
11.10 of Minnesota to demonstrate, optimize, and  
11.11 provide an energy cost analysis of an enhanced  
11.12 plasma reactor to remove resistant short-chain  
11.13 per- and polyfluoroalkyl substances (PFAS)  
11.14 from wastewater and other point sources.

11.15 **(r) Anoka Rum River Dam Reconstruction**  
11.16 **and Modification Project**

11.17 \$3,110,000 the second year is from the trust  
11.18 fund to the commissioner of natural resources  
11.19 for an agreement with the city of Anoka for  
11.20 predesign, engineering, and final design of  
11.21 improvements to the Anoka Rum River Dam  
11.22 to enhance dam safety, restore aquatic habitats,  
11.23 and expand recreational opportunities in the  
11.24 Rum River just upstream of its confluence  
11.25 with the Mississippi River.

11.26 **(s) Lake Superior River Watch**

11.27 \$404,000 the second year is from the trust  
11.28 fund to the commissioner of natural resources  
11.29 for an agreement with the Fond du Lac Tribal  
11.30 and Community College to revitalize the river  
11.31 watch program in the Lake Superior watershed  
11.32 by engaging students in water quality  
11.33 monitoring and analysis to support  
11.34 Minnesota's Lake Superior stewardship efforts.

12.1 **(t) Red Lake Nation Long-Term Continuous**

12.2 **Monitoring Buoys**

12.3 \$993,000 the second year is from the trust  
 12.4 fund to the commissioner of natural resources  
 12.5 for an agreement with the Red Lake Band of  
 12.6 Chippewa Indians to procure, install, and  
 12.7 collect real-time water quality data from  
 12.8 long-term buoys on Upper and Lower Red  
 12.9 Lakes and Lake of the Woods and to improve  
 12.10 hazardous algal bloom forecasts. This  
 12.11 appropriation is available until June 30, 2031,  
 12.12 by which time the project must be completed  
 12.13 and final products delivered.

 12.20 of Southern Minnesota to collaborate with  
 12.21 other greater Minnesota children's museums  
 12.22 to standardize and enhance existing curriculum  
 12.23 and implement nature-based programming  
 12.24 that engages children and fosters  
 12.25 environmental stewardship, awareness of  
 12.26 natural resources, and sustainability. Before  
 12.27 costs for this appropriation are incurred, a  
 12.28 fiscal management plan must be approved in

Subdivision 1. **Commissioner approval.** (a) A recipient of an appropriation from the trust fund who acquires an interest in real property must receive written approval from the commissioner of natural resources prior to the acquisition, if the interest is acquired in whole or in part with the appropriation. A recipient must request the commissioner's approval at least ten business days before the proposed acquisition. When a recipient requests approval under this subdivision, the recipient must simultaneously submit the same information to the commission. Conservation easements to be held by the Board of Water and Soil Resources, acquisitions of land in the metropolitan regional recreation open space systems as defined under section 473.351, subdivision 1, with appropriations to the Metropolitan Council, and acquisitions specifically identified in appropriation laws are not subject to commissioner approval under this section.

(b) The commissioner shall approve acquisitions under this section only when the interest in real property:

(1) is identified as a high priority by the commissioner and meets the objectives and criteria identified in the applicable acquisition plan for the intended management status of the property; or

(2) is otherwise identified by the commissioner as a priority for state financing.

Subd. 2. **Value assessment.** At least ten business days prior to acquiring an interest in real property with an appropriation from the trust fund, a recipient of an appropriation must submit the most recent tax assessed value and most recent tax statement of the real property and the amount the recipient plans to offer for the interest in real property to the commission and the commissioner of natural resources. Conservation easements to be held by the Board of Water and Soil Resources are not subject to the requirements of this section. The board shall keep a record of the tax assessed value of the real property at the time of acquisition and the most recent tax statement.
