1.10 Section 1. Minnesota Statutes 2024, section 13.6905, is amended by adding a subdivision

1.11 to read:

1.12 Subd. 39. **Credential identifier and designation data.** Data related to identifiers and

1.13 designations on driver's licenses and Minnesota identification cards are governed by section

1.14 171.12, subdivision 7d.

1.15 Sec. 2. Minnesota Statutes 2024, section 171.09, subdivision 3, is amended to read:

1.16 Subd. 3. **No-alcohol restriction.** (a) As used in this subdivision, "impaired driving

1.17 incident" has the meaning given in section 169A.03, subdivision 22.

1.18 (b) Upon proper application by a person having a valid driver's license containing the

1.19 restriction that the person must not consume alcohol or controlled substances, who has not

1.20 been documented as having consumed alcohol or having possessed or used a controlled

1.21 substance within the past ~~ten~~ 20 years, and whose driving record contains no impaired

1.22 driving incident within the past ~~ten~~ 20 years, the commissioner must remove the

1.23 no-alcohol/controlled substance restriction on the person's driving record and issue to the

1.24 person a duplicate driver's license that does not show that restriction.

2.3 Subd. 7. **Privacy of data.** (a) Data on individuals provided to obtain a driver's license  
2.4 or Minnesota identification card ~~shall~~ must be treated as provided by United States Code,  
2.5 title 18, section 2721, as in effect on May 23, 2005, ~~and shall~~ must be disclosed as required  
2.6 ~~or by that section, and may be disclosed as permitted by that section.~~ The commissioner  
2.7 ~~shall~~ may disclose the data in bulk form upon request to an authorized recipient under United  
2.8 States Code, title 18, section 2721. For any disclosure of data on individuals related to a  
2.9 noncompliant driver's license or identification card, the commissioner must require a

2.21 card may request that the applicant's residence address be classified as "private data on

2.23 the classification on receipt of a signed statement by the individual that the classification  
2.24 is required for the safety of the applicant or the applicant's family, if the statement also  
2.25 provides a valid, existing address where the applicant consents to receive service of process.  
2.26 The commissioner ~~shall~~ must use the service for process mailing address in place of the  
2.27 residence address in all documents and notices pertaining to the driver's license, instruction  
2.28 permit, or Minnesota identification card. The residence address and any information provided  
2.29 in the classification request, other than the mailing address, are private data on individuals  
2.30 and may be provided to requesting law enforcement agencies, probation and parole agencies,  
2.31 and public authorities, as defined in section 518A.26, subdivision 18.

3.15 under section 169A.54, subdivision 1, or 171.17, subdivision 1, paragraph (a), clause (3)  
3.16 or (10), for conviction of an offense in another state that would be grounds for revocation

 4.15 by a person whose breath alcohol concentration measures 0.02 or higher on the equipment.

4.16 (c) "Location tracking capabilities" means the ability of an electronic or wireless device  
 4.17 to identify and transmit its geographic location through the operation of the device.

4.18 (d) "Program participant" means a person who has qualified to take part in the ignition  
 4.19 interlock program under this section, and whose driver's license has been:

**169A.54 DWI CONVICTIONS, ADJUDICATIONS; ADMINISTRATIVE PENALTIES.**

Subd. 6. **Applicability of implied consent revocation.** (a) Any person whose license has been revoked pursuant to section 169A.52 (license revocation for test failure or refusal) or 171.177 (revocation; pursuant to a search warrant) as the result of the same incident, and who does not have a qualified prior impaired driving incident, is subject to the mandatory revocation provisions of subdivision 1, clause (1) or (2), in lieu of the mandatory revocation provisions of section 169A.52 or 171.177.

(b) Paragraph (a) does not apply to:

(1) a person whose license has been revoked under subdivision 2 (driving while impaired by person under age 21); or

(2) a person whose driver's license has been revoked for, or who is charged with (i) an alcohol concentration of twice the legal limit or more as measured at the time or within two hours of the time of the offense; or (ii) a violation of section 169A.20 (driving while impaired) with an aggravating factor described in section 169A.03, subdivision 3, clause (3).
