1.2	relating to education; clarifying basic skills requirements for teacher candidates
1.3	and licensure; establishing an advisory task force; amending Minnesota Statutes
1.4	2012, sections 122A.18, subdivision 2; 122A.23, subdivision 2.
1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. Minnesota Statutes 2012, section 122A.18, subdivision 2, is amended to read:
1.7	Subd. 2. Teacher and support personnel qualifications. (a) The Board of
1.8	Teaching must issue licenses under its jurisdiction to persons the board finds to be
1.9	qualified and competent for their respective positions.
1.10	(b) The board, until September 1, 2014, must require a person to pass an examination
1.11	of skills in reading, writing, and mathematics before being granted an initial teaching
1.12	license to provide direct instruction to pupils in prekindergarten, elementary, secondary,
1.13	or special education programs, except that the board may issue a temporary, one-year
1.14	teaching license to an otherwise qualified candidate who has not passed the skills
1.15	exam at the time the candidate successfully completes an approved teacher preparation
1.16	program. The board must require colleges and universities offering a board approved
1.17	teacher preparation program to provide remedial assistance that includes a formal
1.18	diagnostic component to persons enrolled in their institution who did not achieve a
1.19	qualifying score on the skills examination, including those for whom English is a
1.20	second language. The colleges and universities must provide assistance in the specific
1.21	academic areas of deficiency in which the person did not achieve a qualifying score.
1.22	School districts must provide similar, appropriate, and timely remedial assistance that
1.23	includes a formal diagnostic component to those persons employed by the district who
1.24	completed their teacher education program, who did not achieve a qualifying score on

the skills examination, including those persons for whom English is a second language 2.1 and persons under section 122A.23, subdivision 2, paragraph (h), who completed their 2.2 teacher's education program outside the state of Minnesota, and who received a temporary, 2.3 one-year license to teach in Minnesota. The Board of Teaching shall report annually to the 2.4 education committees of the legislature on the total number of teacher candidates during 2.5 the most recent school year taking the skills examination, the number who achieve a 2.6 qualifying score on the examination, the number who do not achieve a qualifying score on 2.7 the examination, the distribution of all candidates' scores, the number of candidates who 2.8 have taken the examination at least once before, and the number of candidates who have 2.9 taken the examination at least once before and achieve a qualifying score. 2.10 (c) A person who has completed an approved teacher preparation program and 2.11 obtained a temporary, one-year teaching license, but has not passed the skills exam, may 2.12 have the board renew the temporary one-year license if the licensee: 2.13 (1) provides evidence of participating in an approved remedial assistance program 2.14 through a school district or postsecondary institution that includes a formal diagnostic 2.15 component in the specific subject areas the licensee did not pass; 2.16 (2) attempts to pass the skills exam during the one-year licensure period; and 2.17 (3) the school district employing the licensee requests that the licensee continue to 2.18 teach for that district under a temporary license. 2.19 (d) The Board of Teaching must grant continuing licenses only to those persons who 2.20 have met board criteria for granting a continuing license, which includes passing the skills 2.21 examination in reading, writing, and mathematics. 2.22 2.23 (d) (e) All colleges and universities approved by the board of teaching to prepare persons for teacher licensure must include in their teacher preparation programs a common 2.24 core of teaching knowledge and skills to be acquired by all persons recommended 2.25 for teacher licensure. This common core shall meet the standards developed by the 2.26 interstate new teacher assessment and support consortium in its 1992 "model standards for 2.27 beginning teacher licensing and development." Amendments to standards adopted under 2.28 this paragraph are covered by chapter 14. The board of teaching shall report annually to 2.29 the education committees of the legislature on the performance of teacher candidates 2.30 on common core assessments of knowledge and skills under this paragraph during the 2.31 most recent school year. 2.32 (f) Notwithstanding this subdivision or other law to the contrary, beginning 2.33 September 1, 2014, a teacher is not required to pass an examination of skills in reading, 2.34 writing, and mathematics before the board grants the teacher an initial teaching license to 2.35

4.30 (a) A Teacher Licensure Advisory Task Force is established to make

5.3	(b) Task force recommendations on how teacher candidates demonstrate basic skills

5.7	correspond to a similarly detailed description of relevant public school curriculum;

5.19	(6) reliable evidence showing assessment content is not culturally biased;
5.20	(7) the Board of Teaching and all Minnesota public teacher preparation programs
5.21	and institutions must appropriately accommodate teacher candidates with documented
5.22	learning disabilities; and
5.23	(8) if applicable, give timely, detailed feedback to teacher candidates who do not
5.24	pass the basic skills assessment sufficient for the candidate to target specific areas of
5.25	deficiency for appropriate remediation.
5.26	(c) The Teacher Licensure Advisory Task Force shall be composed of the following
5.27	members:
5.28	(1) two members of the Board of Teaching appointed by the board's executive
5.29	director;
5.30	(2) two representatives from the Department of Education appointed by the
5.31	commissioner of education;
5.32	(3) two house members appointed by the speaker of the house, one from the minority
5.33	party and one from the majority party;
5.34	(4) two state senators appointed by the senate rules committee, one from the
5.35	minority party and one from the majority party;

6.1	(5) one elementary school principal from rural Minnesota appointed by the
6.2	Minnesota Elementary School Principals Association and one secondary school principal
6.3	from the seven-county metropolitan area appointed by the Minnesota Secondary School
6.4	Principals Association;
6.5	(6) one licensed and practicing public elementary school teacher and one licensed
6.6	and practicing secondary school teacher appointed by Education Minnesota;
6.7	(7) one teacher preparation faculty member each from the University of Minnesota
6.8	system appointed by the system president, the Minnesota State Colleges and Universities
6.9	system appointed by the system chancellor, and the Minnesota Private Colleges and
6.10	Universities system appointed by the Minnesota Private Colleges Council;
6.11	(8) one member of the nonpublic education council appointed by the council; and
6.12	(9) one representative of Minnesota charter schools appointed by the Minnesota
6.13	Charter Schools Association.
6.14	(d) The executive director of the Board of Teaching must convene the task force by
6.15	August 1, 2013. Task force members are not eligible for compensation or reimbursement
6.16	for expenses related to task force activities. The executive director of the board and the
6.17	commissioner of education must provide technical assistance to task force members
6.18	upon request.
6.19	(e) By February 1, 2014, task force members must submit to the Board of Teaching,
6.20	the education commissioner, and the education committees of the legislature their written
6.21	recommendations on requirements for teacher applicants to demonstrate mastery of basic
6.22	reading, writing, and mathematics skills and for an alternative licensure pathway for
6.23	nonnative English speakers seeking licensure to teach in a language immersion program.
6.24	EFFECTIVE DATE. This section is effective the day following final enactment.
