BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
Section 1. [3.8844] LEGISLATIVE COMMISSION ON INTELLIGENCE AND
TECHNOLOGY.
Subdivision 1. Established. The Legislative Commission on Intelligence and Technology
is created to study and make recommendations on issues relating to the effect of emerging
technology on privacy. The commission has investigatory and oversight jurisdiction over
government surveillance programs and technology, including subpoena power.
Subd. 2. Membership. The commission consists of three senators appointed by the
senate Subcommittee on Committees of the Committee on Rules and Administration and
three members of the house of representatives appointed by the speaker. One member from
each chamber must be from the minority party in that chamber. Each appointing authority
must make appointments as soon as possible after the beginning of the regular legislative
session in an odd-numbered year. Each member of the commission must take an oath,
swearing to faithfully discharge the duties of members of the commission in compliance
with the laws governing the commission.
Subd. 3. Terms; vacancies. Commission member terms begin upon appointment and
end at the beginning of the regular legislative session in the next odd-numbered year. In the
case of a vacancy, the appropriate appointing authority must fill the vacancy for the remainder
of the unexpired term.

Subd. 4. Officers. The commission must elect a chair and vice-chair and may elect other 2.1 officers as the commission determines is necessary. The chair alternates between a member 2.2 of the senate and a member of the house of representatives in January of each odd-numbered 2.3 2.4 year. Subd. 5. Staff. Legislative staff must provide administrative and research assistance to 2.5 the commission. 2.6 Subd. 6. Meetings; data.
