1.17 and Standards Board.

1.18 Sec. 2. Minnesota Statutes 2018, section 122A.06, subdivision 5, is amended to read:

1.19 Subd. 5. **Field.** A "field," "licensure area," or "subject area" means the content area in  
1.20 which a teacher may become licensed to teach.

1.21 Sec. 3. Minnesota Statutes 2018, section 122A.06, subdivision 7, is amended to read:

1.22 Subd. 7. **Teacher preparation program.** "Teacher preparation program" means a  
1.23 program approved by the Professional Educator Licensing and Standards Board for the  
1.24 purpose of preparing individuals for a specific teacher licensure field in Minnesota. ~~Teacher~~

 3.12 school principal; and

3.13 ~~(6)~~ (7) one member of the public that may be a current or former school board member.

6.13 undergraduate and graduate degrees and the years of experience either as kindergarten  
6.14 through grade 12 classroom teachers or school administrators;

6.15 (2) the average time program graduates in the preceding year needed to complete the  
6.16 program;

6.17 (3) the current number and percentage of students who graduated, received a standard  
6.18 Minnesota administrator license, and were employed as an administrator in a Minnesota  
6.19 school district or school in the preceding year disaggregated by race, except when  
6.20 disaggregation would not yield statistically reliable results or would reveal personally  
6.21 identifiable information about an individual;

6.22 (4) the number of credits by graduate program that students in the preceding school year  
6.23 needed to complete to graduate;

6.24 (5) survey results measuring student, graduate, and employer satisfaction with the  
6.25 program in the preceding school year disaggregated by race, except when disaggregation  
6.26 would not yield statistically reliable results or would reveal personally identifiable  
6.27 information about an individual; and

6.28 (6) information under subdivision 3, paragraphs (c) and (d).

7.2 Subd. 5. **Reading strategies.** (a) All ~~colleges and universities~~ preparation providers  
7.3 approved by the Professional Educator Licensing and Standards Board to prepare persons  
7.4 for classroom teacher licensure must include in their teacher preparation programs  
7.5 research-based best practices in reading, consistent with section 122A.06, subdivision 4,  
7.6 that enables the licensure candidate to teach reading in the candidate's content areas. Teacher
