1.8	Section 1. Minnesota Statutes 2022, section 120B.021, subdivision 1, is amended to read:
1.9	Subdivision 1. Required academic standards. (a) The following subject areas are
1.10	required for statewide accountability:
1.11	(1) language arts;
1.12	(2) mathematics;
1.13	(3) science;
1.14	(4) social studies, including history, geography, economics, ethnic studies, and
1.15	government and citizenship that includes civics consistent with section 120B.02, subdivision

- (b) For purposes of applicable federal law, the academic standards for language arts, mathematics, and science apply to all public school students, except the very few students with extreme cognitive or physical impairments for whom an individualized education program team has determined that the required academic standards are inappropriate. An individualized education program team that makes this determination must establish alternative standards.
- (c) The department must adopt the most recent SHAPE America (Society of Health and Physical Educators) kindergarten through grade 12 standards and benchmarks for physical education as the required physical education academic standards. The department may modify and adapt the national standards to accommodate state interest. The modification and adaptations must maintain the purpose and integrity of the national standards. The department must make available sample assessments, which school districts may use as an alternative to local assessments, to assess students' mastery of the physical education standards beginning in the 2018-2019 school year.
- (d) A school district may include child sexual abuse prevention instruction in a health curriculum, consistent with paragraph (a), clause (6). Child sexual abuse prevention instruction may include age-appropriate instruction on recognizing sexual abuse and assault, boundary violations, and ways offenders groom or desensitize victims, as well as strategies to promote disclosure, reduce self-blame, and mobilize bystanders. A school district may provide instruction under this paragraph in a variety of ways, including at an annual assembly or classroom presentation. A school district may also provide parents information on the warning signs of child sexual abuse and available resources.
- (e) District efforts to develop, implement, or improve instruction or curriculum as a result of the provisions of this section must be consistent with sections 120B.10, 120B.11, and 120B.20.
 - **EFFECTIVE DATE.** This section is effective for the 2027-2028 school year and later.

- (b) A school district is encouraged to offer a course for credit in government and citizenship to 11th or 12th grade students in grade 11 or 12 who begin 9th grade 9 in the 2020-2021 school year and later, that satisfies the government and citizenship requirement in paragraph (a), clause (5).
- 3.21 **EFFECTIVE DATE.** This section is effective for students beginning grade 9 in the 2025-2026 school year and later.
- Sec. 3. Minnesota Statutes 2022, section 120B.024, subdivision 2, is amended to read:

- (c) A career and technical education credit may fulfill a mathematics or arts credit requirement under subdivision 1, clause (2) or (6).
- (d) An agriculture education teacher is not required to meet the requirements of Minnesota Rules, part 3505.1150, subpart 1, item B, to meet the credit equivalency requirements of paragraph (b) above. 4.10
- (e) A computer science credit may fulfill a mathematics credit requirement under 4.11 subdivision 1, clause (2), if the credit meets state academic standards in mathematics. 4.12
 - (f) A Project Lead the Way credit may fulfill a science or mathematics credit requirement under subdivision 1, clause (2) or (4), if the credit meets the state academic standards in science or mathematics.
 - (g) An ethnic studies credit may fulfill a social studies, language arts, or science credit if the credit meets the applicable state academic standards. An ethnic studies credit may fulfill an arts credit if the credit meets the local standards, or state standards for a district that has adopted the state standards.

Subdivision 1. **Definition.** "Ethnic studies" means the critical and interdisciplinary study of race, ethnicity, and indigeneity with a focus on the experiences and perspectives of people of color within and beyond the United States. Ethnic studies analyzes the ways in which race and racism have been and continue to be powerful social, cultural, and political forces, and the connection of race to other groups of stratification, including gender, class, sexuality, religion, and legal status.

Subd. 2. Requirements. (a) A student beginning grade 9 in the 2025-2026 school year and later must successfully complete a semester-long ethnic studies course to graduate from high school. The course must meet the minimum requirements of the model curriculum under subdivision 6. A district or charter school must offer an ethnic studies course that fulfills the requirements of this paragraph without increasing the number of credits required for graduation under section 120B.024. An ethnic studies credit may fulfill a social studies,
