1.8	Subdivision 1. Definitions. (a) For the purposes of this section, the following terms have
1.9	the meanings given.
1.10	(b) "Affordability criteria" means an inflow and infiltration project service area that is
1.11	located, in whole or in part, in a census tract where at least three of the following apply as
1.12	determined using the most recently published data from the United States Census Bureau
1.13	or United States Centers for Disease Control and Prevention:
1.14	(1) 20 percent or more of the residents have income below the federal poverty thresholds:
1.15	(2) the tract has a United States Centers for Disease Control and Prevention Social
1.16	Vulnerability Index greater than 0.80;
1.17	(3) the upper limit of the lowest quintile of household income is less than the state upper
1.18	limit of the lowest quintile;
1.19	(4) the housing vacancy rate is greater than the state average; or
1.20	(5) the percent of the population receiving Supplemental Nutrition Assistance Program
1.21	(SNAP) benefits is greater than the state average.

the gran	at within four years after the award date, the grant must be canceled.
