1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. NORTHSTAR COMMUTER RAIL LINE EXTENSION;
1.6	NEGOTIATIONS.
1.7	The Department of Transportation must contact Burlington Northern Santa Fe Railway
1.8	(BNSF) to negotiate an extension of the Northstar Commuter Rail line between Big Lake
1.9	and St. Cloud. Negotiations under this section are subject to the following conditions:
1.10	(1) the Northstar Commuter Rail line will add at least one morning round trip departure
1.11	between the St. Cloud Amtrak Depot and Big Lake Station with continuing service to Target
1.12	Field Station each weekday, plus one evening round trip between Big Lake Station and St.
1.13	Cloud Amtrak Depot that must begin at Target Field Station, with the departure and arrival
1.14	times set so that approximately ten or more hours elapse between the morning departure
1.15	and evening return each day for both round trips. The Department of Transportation may

2.2	approval by the city of St. Cloud, regarding the sharing of revenues and expenses related
2.3	to the Amtrak station, fare collection, and advertising. The MTC, city of St. Cloud, and
2.4	Stearns, Benton, and Sherburne Counties are prohibited from entering into agreements with
