BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. **CASEY JONES TRAIL.**
- 1.6

Subdivision 1. **Appropriation.** \$846,000 is appropriated from the bond proceeds fund
- 1.7

to the commissioner of natural resources for development of the Casey Jones Trail under
- 1.8

Minnesota Statutes, section 85.015, subdivision 2.
- 1.9

Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond
- 1.10

proceeds fund, the commissioner of management and budget shall sell and issue bonds of
- 1.11

the state in an amount up to \$846,000 in the manner, upon the terms, and with the effect
- 1.12

prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota
- 1.13

Constitution, article XI, sections 4 to 7.
