1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. Minnesota Statutes 2014, section 240A.09, is amended to read:
1.7	240A.09 PLAN DEVELOPMENT; CRITERIA.
1.8	The Minnesota Amateur Sports Commission shall develop a plan to promote the
1.9	development of proposals for new statewide public ice facilities including proposals for
1.10	ice centers and matching grants based on the criteria in this section.
1.11	(a) For ice center proposals, the commission will give priority to proposals that
1.12	come from more than one local government unit. Institutions of higher education are not
1.13	eligible to receive a grant.
1.14	(b) The commission must give priority to grant applications for indoor air quality
1.15	improvements and projects that eliminate R-22. For purposes of this section:
1.16	(1) "indoor air quality improvements" means: (i) renovation or replacement of
1.17	heating, ventilating, and air conditioning systems in existing indoor ice arenas whose
1.18	ice resurfacing and ice edging equipment are not powered by electricity in order to
1.19	reduce concentrations of carbon monoxide and nitrogen dioxide; and (ii) acquisition of
1.20	zero-emission ice resurfacing and ice edging equipment. The new or renovated systems
1.21	may include continuous electronic air monitoring devices to automatically activate the
1.22	ventilation systems when the concentration of carbon monoxide or nitrogen dioxide
1.23	reaches a predetermined level; and

(2) "projects that eliminate R-22," means replacement of ice-making systems in 2.1 existing public facilities that use R-22 as a refrigerant, with systems that use alternative 2.2 non-ozone-depleting refrigerants. 2.3 (c) In the metropolitan area as defined in section 473.121, subdivision 2, the 2.4 commission is encouraged to give priority to the following proposals: 2.5 (1) proposals for construction of two or more ice sheets in a single new facility; 2.6 (2) proposals for construction of an additional sheet of ice at an existing ice center; 2.7 (3) proposals for construction of a new, single sheet of ice as part of a sports complex 28 with multiple sports facilities; and 2.9 (4) proposals for construction of a new, single sheet of ice that will be expanded to a 2.10 two-sheet facility in the future. 2.11 (d) The commission shall administer a site selection process for the ice centers.
