Subd. 3. Informed consent. Before performing a body art procedure, the technician				
shall obtain from the client a signed and dated informed consent form.				
(a) The consent form must disclose:				
(1) that a tattoo is considered permanent and may only be removed with a surgical				
procedure and that any effective removal may leave scarring; or				
(2) that body piercing may leave scarring.				
(b) The consent form must also contain the following warning prominently displayed				
in bold and large type: "Tattoo inks are not regulated by the state or federal government				
and their safety has not been established. Tattoo inks may contain heavy metals and other				
ingredients known to cause allergic reactions and cancer."
