The bill was read for the first time and referred to the Committee on Higher Education Finance and Policy

1.1 A bill for an act
1.2 relating to capital investment; appropriating money for the Lake Superior College
1.3 Allied Health and Science revitalization and renovation project; authorizing
1.4 the sale and issuance of state bonds.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. LAKE SUPERIOR COLLEGE; ALLIED HEALTH
1.7 REVITALIZATION AND RENOVATION.

1.8 Subdivision 1. Appropriation. \$5,266,000 is appropriated from the bond proceeds
1.9 fund to the Board of Trustees of the Minnesota State Colleges and Universities to renovate,
1.10 furnish, and equip existing Allied Health and Science classroom, lab, and clinic space in
1.11 the east building at Lake Superior College.

1.12 Subd. 2. Bond sale. To provide the money appropriated in this section from the
1.13 bond proceeds fund, the commissioner of management and budget shall sell and issue
1.14 bonds of the state in an amount up to \$5,266,000 in the manner, upon the terms, and with
1.15 the effect prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the
1.16 Minnesota Constitution, article XI, sections 4 to 7.

1.17 EFFECTIVE DATE. This section is effective the day following final enactment.
