1.1 A bill for an act
1.2 relating to human services; modifying parental contributions for certain
1.3 disability services; modifying state agency hearings related to the personal care
1.4 assistance program; modifying assessment and support planning; modifying
1.5 certain congregate rate reductions; modifying consultation for housing with
1.6 services; developing the Community First Choice Option; modifying the
1.7 foster care licensing moratorium; modifying residential settings for home
1.8 and community-based services; amending Minnesota Statutes 2010, sections
1.9 252.27, subdivision 2a; 256B.0659, by adding a subdivision; Minnesota Statutes
1.10 2011 Supplement, sections 245A.03, subdivision 7; 256.045, subdivision 3;
1.11 256B.0911, subdivisions 3a, 3c; Laws 2011, First Special Session chapter 9,
1.12 article 10, section 3, subdivision 3; proposing coding for new law in Minnesota
1.13 Statutes, chapter 256B.

1.14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.15 Section 1. Minnesota Statutes 2011 Supplement, section 245A.03, subdivision 7,
1.16 is amended to read:

1.17 Subd. 7. **Licensing moratorium.** (a) The commissioner shall not issue an
1.18 initial license for child foster care licensed under Minnesota Rules, parts 2960.3000 to
1.19 2960.3340, or adult foster care licensed under Minnesota Rules, parts 9555.5105 to
1.20 9555.6265, under this chapter for a physical location that will not be the primary residence
1.21 of the license holder for the entire period of licensure. If a license is issued during this
1.22 moratorium, and the license holder changes the license holder's primary residence away
1.23 from the physical location of the foster care license, the commissioner shall revoke the
1.24 license according to section 245A.07. Exceptions to the moratorium include:

- 1.25 (1) foster care settings that are required to be registered under chapter 144D;
- 1.26 (2) foster care licenses replacing foster care licenses in existence on May 15, 2009,
1.27 and determined to be needed by the commissioner under paragraph (b);

2.1 (3) new foster care licenses determined to be needed by the commissioner under
2.2 paragraph (b) for the closure of a nursing facility, ICF/MR, or regional treatment center, or
2.3 restructuring of state-operated services that limits the capacity of state-operated facilities;

2.4 (4) new foster care licenses determined to be needed by the commissioner under
2.5 paragraph (b) for persons requiring hospital level care; or

2.6 (5) new foster care licenses determined to be needed by the commissioner for the
2.7 transition of people from personal care assistance to the home and community-based
2.8 services.

2.9 (b) The commissioner shall determine the need for newly licensed foster care homes
2.10 as defined under this subdivision. As part of the determination, the commissioner shall
2.11 consider the availability of foster care capacity in the area in which the licensee seeks to
2.12 operate, and the recommendation of the local county board. The determination by the
2.13 commissioner must be final. A determination of need is not required for a change in
2.14 ownership at the same address.

2.15 (c) Residential settings that would otherwise be subject to the moratorium established
2.16 in paragraph (a), that are in the process of receiving an adult or child foster care license as
2.17 of July 1, 2009, shall be allowed to continue to complete the process of receiving an adult
2.18 or child foster care license. For this paragraph, all of the following conditions must be met
2.19 to be considered in the process of receiving an adult or child foster care license:

2.20 (1) participants have made decisions to move into the residential setting, including
2.21 documentation in each participant's care plan;

2.22 (2) the provider has purchased housing or has made a financial investment in the
2.23 property;

2.24 (3) the lead agency has approved the plans, including costs for the residential setting
2.25 for each individual;

2.26 (4) the completion of the licensing process, including all necessary inspections, is
2.27 the only remaining component prior to being able to provide services; and

2.28 (5) the needs of the individuals cannot be met within the existing capacity in that
2.29 county.

2.30 To qualify for the process under this paragraph, the lead agency must submit
2.31 documentation to the commissioner by August 1, 2009, that all of the above criteria are
2.32 met.

2.33 (d) The commissioner shall study the effects of the license moratorium under this
2.34 subdivision and shall report back to the legislature by January 15, 2011. This study shall
2.35 include, but is not limited to the following:

3.1 (1) the overall capacity and utilization of foster care beds where the physical location
 3.2 is not the primary residence of the license holder prior to and after implementation
 3.3 of the moratorium;

3.4 (2) the overall capacity and utilization of foster care beds where the physical
 3.5 location is the primary residence of the license holder prior to and after implementation
 3.6 of the moratorium; and

3.7 (3) the number of licensed and occupied ICF/MR beds prior to and after
 3.8 implementation of the moratorium.

3.9 (e) When a foster care recipient moves out of a foster home that is not the primary
 3.10 residence of the license holder according to section 256B.49, subdivision 15, paragraph
 3.11 (f), the county shall immediately inform the Department of Human Services Licensing
 3.12 Division, and the department shall immediately decrease the licensed capacity for the
 3.13 home if the license holder has a total capacity of 24 or more beds. License holders who
 3.14 have their capacity decreased under this paragraph may consolidate homes as necessary.
 3.15 A decreased licensed capacity according to this paragraph is not subject to appeal under
 3.16 this chapter.

3.17 Sec. 2. Minnesota Statutes 2010, section 252.27, subdivision 2a, is amended to read:

3.18 Subd. 2a. **Contribution amount.** (a) The natural or adoptive parents of a minor
 3.19 child, including a child determined eligible for medical assistance without consideration of
 3.20 parental income, must contribute to the cost of services used by making monthly payments
 3.21 on a sliding scale based on income, unless the child is married or has been married,
 3.22 parental rights have been terminated, or the child's adoption is subsidized according to
 3.23 section 259.67 or through title IV-E of the Social Security Act. The parental contribution
 3.24 is a partial or full payment for medical services provided for diagnostic, therapeutic,
 3.25 curing, treating, mitigating, rehabilitation, maintenance, and personal care services as
 3.26 defined in United States Code, title 26, section 213, needed by the child with a chronic
 3.27 illness or disability.

3.28 (b) For households with adjusted gross income equal to or greater than 100 percent
 3.29 of federal poverty guidelines, the parental contribution shall be computed by applying the
 3.30 following schedule of rates to the adjusted gross income of the natural or adoptive parents:

3.31 (1) if the adjusted gross income is equal to or greater than 100 percent of federal
 3.32 poverty guidelines and less than 175 percent of federal poverty guidelines, the parental
 3.33 contribution is \$4 per month;

3.34 (2) if the adjusted gross income is equal to or greater than 175 percent of federal
 3.35 poverty guidelines and less than or equal to ~~545~~ 525 percent of federal poverty guidelines,

4.1 the parental contribution shall be determined using a sliding fee scale established by the
4.2 commissioner of human services which begins at one percent of adjusted gross income at
4.3 175 percent of federal poverty guidelines and increases to ~~7.5~~ eight percent of adjusted
4.4 gross income for those with adjusted gross income up to ~~545~~ 525 percent of federal
4.5 poverty guidelines;

4.6 (3) if the adjusted gross income is greater than ~~545~~ 525 percent of federal
4.7 poverty guidelines and less than 675 percent of federal poverty guidelines, the parental
4.8 contribution shall be ~~7.5~~ 9.5 percent of adjusted gross income;

4.9 (4) if the adjusted gross income is equal to or greater than 675 percent of federal
4.10 poverty guidelines and less than ~~975~~ 900 percent of federal poverty guidelines, the parental
4.11 contribution shall be determined using a sliding fee scale established by the commissioner
4.12 of human services which begins at ~~7.5~~ 9.5 percent of adjusted gross income at 675 percent
4.13 of federal poverty guidelines and increases to ~~ten~~ 12 percent of adjusted gross income for
4.14 those with adjusted gross income up to ~~975~~ 900 percent of federal poverty guidelines; and

4.15 (5) if the adjusted gross income is equal to or greater than ~~975~~ 900 percent of
4.16 federal poverty guidelines, the parental contribution shall be ~~12.5~~ 13.5 percent of adjusted
4.17 gross income.

4.18 If the child lives with the parent, the annual adjusted gross income is reduced by
4.19 \$2,400 prior to calculating the parental contribution. If the child resides in an institution
4.20 specified in section 256B.35, the parent is responsible for the personal needs allowance
4.21 specified under that section in addition to the parental contribution determined under this
4.22 section. The parental contribution is reduced by any amount required to be paid directly to
4.23 the child pursuant to a court order, but only if actually paid.

4.24 (c) The household size to be used in determining the amount of contribution under
4.25 paragraph (b) includes natural and adoptive parents and their dependents, including the
4.26 child receiving services. Adjustments in the contribution amount due to annual changes
4.27 in the federal poverty guidelines shall be implemented on the first day of July following
4.28 publication of the changes.

4.29 (d) For purposes of paragraph (b), "income" means the adjusted gross income of the
4.30 natural or adoptive parents determined according to the previous year's federal tax form,
4.31 except, effective retroactive to July 1, 2003, taxable capital gains to the extent the funds
4.32 have been used to purchase a home shall not be counted as income.

4.33 (e) The contribution shall be explained in writing to the parents at the time eligibility
4.34 for services is being determined. The contribution shall be made on a monthly basis
4.35 effective with the first month in which the child receives services. Annually upon
4.36 redetermination or at termination of eligibility, if the contribution exceeded the cost of

5.1 services provided, the local agency or the state shall reimburse that excess amount to
5.2 the parents, either by direct reimbursement if the parent is no longer required to pay a
5.3 contribution, or by a reduction in or waiver of parental fees until the excess amount is
5.4 exhausted. All reimbursements must include a notice that the amount reimbursed may be
5.5 taxable income if the parent paid for the parent's fees through an employer's health care
5.6 flexible spending account under the Internal Revenue Code, section 125, and that the
5.7 parent is responsible for paying the taxes owed on the amount reimbursed.

5.8 (f) The monthly contribution amount must be reviewed at least every 12 months;
5.9 when there is a change in household size; and when there is a loss of or gain in income
5.10 from one month to another in excess of ten percent. The local agency shall mail a written
5.11 notice 30 days in advance of the effective date of a change in the contribution amount.
5.12 A decrease in the contribution amount is effective in the month that the parent verifies a
5.13 reduction in income or change in household size.

5.14 (g) Parents of a minor child who do not live with each other shall each pay the
5.15 contribution required under paragraph (a). An amount equal to the annual court-ordered
5.16 child support payment actually paid on behalf of the child receiving services shall be
5.17 deducted from the adjusted gross income of the parent making the payment prior to
5.18 calculating the parental contribution under paragraph (b).

5.19 (h) The contribution under paragraph (b) shall be increased by an additional five
5.20 percent if the local agency determines that insurance coverage is available but not
5.21 obtained for the child. For purposes of this section, "available" means the insurance is a
5.22 benefit of employment for a family member at an annual cost of no more than five percent
5.23 of the family's annual income. For purposes of this section, "insurance" means health
5.24 and accident insurance coverage, enrollment in a nonprofit health service plan, health
5.25 maintenance organization, self-insured plan, or preferred provider organization.

5.26 Parents who have more than one child receiving services shall not be required
5.27 to pay more than the amount for the child with the highest expenditures. There shall
5.28 be no resource contribution from the parents. The parent shall not be required to pay
5.29 a contribution in excess of the cost of the services provided to the child, not counting
5.30 payments made to school districts for education-related services. Notice of an increase in
5.31 fee payment must be given at least 30 days before the increased fee is due.

5.32 (i) The contribution under paragraph (b) shall be reduced by \$300 per fiscal year if,
5.33 in the 12 months prior to July 1:

5.34 (1) the parent applied for insurance for the child;

5.35 (2) the insurer denied insurance;

6.1 (3) the parents submitted a complaint or appeal, in writing to the insurer, submitted
6.2 a complaint or appeal, in writing, to the commissioner of health or the commissioner of
6.3 commerce, or litigated the complaint or appeal; and

6.4 (4) as a result of the dispute, the insurer reversed its decision and granted insurance.

6.5 For purposes of this section, "insurance" has the meaning given in paragraph (h).

6.6 A parent who has requested a reduction in the contribution amount under this
6.7 paragraph shall submit proof in the form and manner prescribed by the commissioner or
6.8 county agency, including, but not limited to, the insurer's denial of insurance, the written
6.9 letter or complaint of the parents, court documents, and the written response of the insurer
6.10 approving insurance. The determinations of the commissioner or county agency under this
6.11 paragraph are not rules subject to chapter 14.

6.12 ~~(j) Notwithstanding paragraph (b), for the period from July 1, 2010, to June 30,~~
6.13 ~~2013, the parental contribution shall be computed by applying the following contribution~~
6.14 ~~schedule to the adjusted gross income of the natural or adoptive parents:~~

6.15 ~~(1) if the adjusted gross income is equal to or greater than 100 percent of federal~~

7.8 Subd. 3. **State agency hearings.** (a) State agency hearings are available for the
7.9 following:

7.10 (1) any person applying for, receiving or having received public assistance, medical
7.11 care, or a program of social services granted by the state agency or a county agency or
7.12 the federal Food Stamp Act whose application for assistance is denied, not acted upon
7.13 with reasonable promptness, or whose assistance is suspended, reduced, terminated, or
7.14 claimed to have been incorrectly paid;

7.15 (2) any patient or relative aggrieved by an order of the commissioner under section
7.16 252.27;

7.17 (3) a party aggrieved by a ruling of a prepaid health plan;

7.18 (4) except as provided under chapter 245C, any individual or facility determined by a
7.19 lead investigative agency to have maltreated a vulnerable adult under section 626.557 after
7.20 they have exercised their right to administrative reconsideration under section 626.557;

7.21 (5) any person whose claim for foster care payment according to a placement of the
7.22 child resulting from a child protection assessment under section 626.556 is denied or not
7.23 acted upon with reasonable promptness, regardless of funding source;

7.24 (6) any person to whom a right of appeal according to this section is given by other
7.25 provision of law;

7.26 (7) an applicant aggrieved by an adverse decision to an application for a hardship

8.21 (b) The hearing for an individual or facility under paragraph (a), clause (4), (9), or
8.22 (10), is the only administrative appeal to the final agency determination specifically,
8.23 including a challenge to the accuracy and completeness of data under section 13.04.
8.24 Hearings requested under paragraph (a), clause (4), apply only to incidents of maltreatment
8.25 that occur on or after October 1, 1995. Hearings requested by nursing assistants in nursing
8.26 homes alleged to have maltreated a resident prior to October 1, 1995, shall be held as a
8.27 contested case proceeding under the provisions of chapter 14. Hearings requested under
8.28 paragraph (a), clause (9), apply only to incidents of maltreatment that occur on or after
8.29 July 1, 1997. A hearing for an individual or facility under paragraph (a), clause (9), is
8.30 only available when there is no juvenile court or adult criminal action pending. If such
8.31 action is filed in either court while an administrative review is pending, the administrative
8.32 review must be suspended until the judicial actions are completed. If the juvenile court
8.33 action or criminal charge is dismissed or the criminal action overturned, the matter may be
8.34 considered in an administrative hearing.

8.35 (c) For purposes of this section, bargaining unit grievance procedures are not an
8.36 administrative appeal.

9.1 (d) The scope of hearings involving claims to foster care payments under paragraph
 9.2 (a), clause (5), shall be limited to the issue of whether the county is legally responsible
 9.3 for a child's placement under court order or voluntary placement agreement and, if so,
 9.4 the correct amount of foster care payment to be made on the child's behalf and shall not
 9.5 include review of the propriety of the county's child protection determination or child
 9.6 placement decision.

9.7 (e) The scope of hearings involving appeals related to the reduction, suspension,
 9.8 denial, or termination of personal care assistance services under section 256B.0659 shall
 9.9 be limited to the specific issues under written appeal.

9.10 (f) A vendor of medical care as defined in section 256B.02, subdivision 7, or a
 9.11 vendor under contract with a county agency to provide social services is not a party and
 9.12 may not request a hearing under this section, except if assisting a recipient as provided in
 9.13 subdivision 4.

9.14 ~~(f)~~ (g) An applicant or recipient is not entitled to receive social services beyond the
 9.15 services prescribed under chapter 256M or other social services the person is eligible
 9.16 for under state law.

9.17 ~~(g)~~ (h) The commissioner may summarily affirm the county or state agency's
 9.18 proposed action without a hearing when the sole issue is an automatic change due to
 9.19 a change in state or federal law.

9.20 **EFFECTIVE DATE.** This section is effective for all notices of action dated on or
 9.21 after July 1, 2012.

 9.23 subdivision to read:

9.24 Subd. 31. Appeals. (a) A recipient who is adversely affected by the reduction,
 9.25 suspension, denial, or termination of services under this section may appeal the decision
 9.26 according to section 256.045. The appeal must be in writing and identify the specific issues
 9.27 the recipient would like to have considered in the appeal hearing and a summary of the
 9.28 basis, with supporting professional documentation if available, for contesting the decision.

9.29 (b) If a recipient has a change in condition or new information after the date of
 9.30 the assessment, temporary services may be authorized according to section 256B.0652,
 9.31 subdivision 9, until a new assessment is completed.

9.32 Sec. 5. Minnesota Statutes 2011 Supplement, section 256B.0911, subdivision 3a,
 9.33 is amended to read:

10.1 Subd. 3a. **Assessment and support planning.** (a) Persons requesting assessment,
10.2 services planning, or other assistance intended to support community-based living,
10.3 including persons who need assessment in order to determine waiver or alternative care
10.4 program eligibility, must be visited by a long-term care consultation team within 15
10.5 calendar days after the date on which an assessment was requested or recommended. After
10.6 January 1, 2011, these requirements also apply to personal care assistance services, private
10.7 duty nursing, and home health agency services, on timelines established in subdivision 5.
10.8 Face-to-face assessments must be conducted according to paragraphs (b) to (i).

10.9 (b) The county may utilize a team of either the social worker or public health nurse,
10.10 or both. After January 1, 2011, lead agencies shall use certified assessors to conduct the
10.11 assessment in a face-to-face interview. The consultation team members must confer
10.12 regarding the most appropriate care for each individual screened or assessed.

10.13 (c) The assessment must be comprehensive and include a person-centered
10.14 assessment of the health, psychological, functional, environmental, and social needs of
10.15 referred individuals and provide information necessary to develop a support plan that
10.16 meets the consumers needs, using an assessment form provided by the commissioner.

10.17 (d) The assessment must be conducted in a face-to-face interview with the person
10.18 being assessed and the person's legal representative, as required by legally executed
10.19 documents, and other individuals as requested by the person, who can provide information
10.20 on the needs, strengths, and preferences of the person necessary to develop a support
10.21 plan that ensures the person's health and safety, but who is not a provider of service or
10.22 has any financial interest in the provision of services. With the permission of the person
10.23 being assessed or the persons' designated or legal representative, the client's provider
10.24 of services may submit a copy of the provider's nursing assessment or written report
10.25 outlining their recommendations regarding the client's care needs. The person conducting
10.26 the assessment will notify the provider of the date by which this information is to be
10.27 submitted. This information shall be provided to the person conducting the assessment
10.28 and must be considered prior to the finalization of the assessment.

10.29 (e) The person, or the person's legal representative, must be provided with written
10.30 recommendations for community-based services, including consumer-directed options,
10.31 or institutional care that include documentation that the most cost-effective alternatives
10.32 available were offered to the individual, and alternatives to residential settings, including,
10.33 but not limited to, foster care settings that are not the primary residence of the license
10.34 holder. For purposes of this requirement, "cost-effective alternatives" means community
10.35 services and living arrangements that cost the same as or less than institutional care.

11.1 (f) If the person chooses to use community-based services, the person or the person's
11.2 legal representative must be provided with a written community support plan, regardless
11.3 of whether the individual is eligible for Minnesota health care programs. A person may
11.4 request assistance in identifying community supports without participating in a complete
11.5 assessment. Upon a request for assistance identifying community support, the person must
11.6 be transferred or referred to the services available under sections 256.975, subdivision 7,
11.7 and 256.01, subdivision 24, for telephone assistance and follow up.

11.8 (g) The person has the right to make the final decision between institutional
11.9 placement and community placement after the recommendations have been provided,
