1.5	Section 1. BENTON COUNTY RECORDER MAY BE APPOINTED.
1.6	Subdivision 1. Authorization to make office appointive. Notwithstanding Minnesota
1.7	Statutes, section 382.01, upon adoption of a resolution by the Benton County Board of
1.8	Commissioners, the office of county recorder is not elective but must be filled by appointment
1.9	by the county board as provided in the resolution.
1.10	Subd. 2. Board controls; may change as long as duties done. Upon adoption of a
1.11	resolution by the county board of commissioners, and subject to subdivisions 3 and 4, the
1.12	duties of an elected official required by statute whose office is made appointive as authorized
1.13	by this section must be discharged by the county board of commissioners acting through a
1.14	department head appointed by the board for that purpose. Reorganization, reallocation,
1.15	delegation, or other administrative change or transfer does not diminish, prohibit, or avoid
1.16	the discharge of duties required by statute.

(a) Before the adoption of a 2.1 resolution to provide for the appointment of the county recorder, the county board must 2.2 2.3 publish a proposed resolution notifying the public of its intent to consider the issue once each week for two consecutive weeks in the official publication of the county. Following 2.4 publication and prior to formally adopting the resolution, the county board shall provide an 2.5 opportunity at its next regular meeting for public comment relating to the issue. After the 2.6 public comment opportunity, at the same meeting or a subsequent meeting, the county board 2.7 2.8 of commissioners may adopt a resolution that provides for the appointment of the county recorder as permitted in this section. The resolution must be approved by at least 80 percent 2.9 of the members of the county board.
