

1.1 A bill for an act  
1.2 relating to state government; appropriating money for environment and natural  
1.3 resources.

1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. **MINNESOTA RESOURCES APPROPRIATION.**

1.6 The sums shown in the columns marked "Appropriations" are appropriated to the  
1.7 agencies and for the purposes specified in this act. The appropriations are from the  
1.8 environment and natural resources trust fund, or another named fund, and are available for  
1.9 the fiscal years indicated for each purpose. The figures "2010" and "2011" used in this  
1.10 act mean that the appropriations listed under them are available for the fiscal year ending  
1.11 June 30, 2010, or June 30, 2011, respectively. "The first year" is fiscal year 2010. "The  
1.12 second year" is fiscal year 2011. "The biennium" is fiscal years 2010 and 2011. The  
1.13 appropriations in this act are onetime. Appropriations for fiscal year 2010 are available the  
1.14 day following final enactment.

2.14 **(a) County Geologic Atlases and Related**  
2.15 **Hydrogeologic Research**

2.16 \$1,130,000 is from the trust fund to the Board  
2.17 of Regents of the University of Minnesota for  
2.18 the Geologic Survey to initiate and continue  
2.19 the production of county geologic atlases,  
2.20 establish hydrologic properties necessary to  
2.21 water management, and investigate the use  
2.22 of geochemical data in water management.  
2.23 This appropriation represents a continuing  
2.24 effort to complete the county geologic atlases  
2.25 throughout the state. This appropriation  
2.26 is available until June 30, 2013, by which  
2.27 time the project must be completed and final  
2.28 products delivered.

2.29 **(b) Updating Minnesota Wetlands Inventory:**  
2.30 **Phase 2**

2.31 \$1,100,000 is from the trust fund to the  
2.32 commissioner of natural resources to  
2.33 continue the update of wetland inventory  
2.34 maps for Minnesota. This appropriation  
2.35 is available until June 30, 2013, by which

3.1 time the project must be completed and final  
3.2 products delivered.

3.3 **(c) Minnesota Breeding Bird Atlas**

3.4 \$372,000 is from the trust fund to continue  
3.5 development of a statewide survey of  
3.6 Minnesota breeding bird distribution and  
3.7 create related publications, including a book  
3.8 and online atlas with distribution maps  
3.9 and breeding status. Of this appropriation,  
3.10 \$211,000 is to the commissioner of natural  
3.11 resources for an agreement with Audubon  
3.12 Minnesota and \$161,000 is to the Board of  
3.13 Regents of the University of Minnesota for  
3.14 the Natural Resources Research Institute.  
3.15 The atlas must be available for downloading  
3.16 on the Internet free of charge.

3.17 **(d) Integrated, Operational Bird Conservation**  
3.18 **Plan for Minnesota**

3.19 \$151,000 is from the trust fund to the  
3.20 commissioner of natural resources for an  
3.21 agreement with Audubon Minnesota to  
3.22 develop an integrated bird conservation plan  
3.23 targeting priority species and providing a  
3.24 framework for implementing coordinated,  
3.25 focused, and effective bird conservation  
3.26 throughout Minnesota.

3.27 **(e) Mitigating Pollinator Decline in Minnesota**

3.28 \$297,000 is from the trust fund to the Board  
3.29 of Regents of the University of Minnesota to  
3.30 assess the role of insecticides in pollinator  
3.31 health in order to help mitigate pollinator  
3.32 decline. This appropriation is available  
3.33 until June 30, 2013, by which time the  
3.34 project must be completed and final products  
3.35 delivered.

4.1 **(f) Science and Innovation from Soudan**  
4.2 **Underground Mine State Park**

4.3 \$545,000 is from the trust fund to the Board  
4.4 of Regents of the University of Minnesota  
4.5 to characterize unique microbes discovered  
4.6 in the Soudan Underground Mine State Park  
4.7 and investigate the potential application  
4.8 in bioenergy and bioremediation. This  
4.9 appropriation is available until June 30,  
4.10 2013, by which time the project must be  
4.11 completed and final products delivered.

4.12 **(g) Quantifying Carbon Burial in Wetlands**

4.13 \$144,000 is from the trust fund to the  
4.14 Board of Regents of the University of  
4.15 Minnesota to determine the potential for  
4.16 carbon sequestration in Minnesota's shallow  
4.17 lakes and wetlands. This appropriation is  
4.18 available until June 30, 2013, by which time  
4.19 the project must be completed and final  
4.20 products delivered.

4.21 **(h) Strategic Planning for Minnesota's Natural**  
4.22 **and Artificial Watersheds**

4.23 \$327,000 is from the trust fund to the Board  
4.24 of Regents of the University of Minnesota  
4.25 to identify the interrelationship between  
4.26 artificial systems of drain tiles and ditches  
4.27 and natural watersheds to guide placement  
4.28 of buffers and stream bed restoration and  
4.29 modification.

4.30 **(i) Ecosystem Services in Agricultural**  
4.31 **Watersheds**

4.32 \$247,000 is from the trust fund to the  
4.33 commissioner of natural resources for  
4.34 an agreement with the Chippewa River  
4.35 Watershed Project to develop local food and

5.1 perennial biofuels markets coupled with  
5.2 conservation incentives to encourage farmers  
5.3 to diversify land cover in the Chippewa  
5.4 River Watershed supporting improvement to  
5.5 water quality and habitat. This appropriation  
5.6 is available until June 30, 2013, by which  
5.7 time the project must be completed and final  
5.8 products delivered.

5.9 **(j) Farmland Conservation in Minnesota**

5.10 \$100,000 is from the trust fund to the  
5.11 commissioner of natural resources for an  
5.12 agreement with the Farmers Legal Action  
5.13 Group, Inc. to assess the implementation of  
5.14 applicable laws for preserving agricultural  
5.15 land and develop a comprehensive and  
5.16 systematic approach and policy tools to  
5.17 preserve agricultural lands.

5.18 **(k) Identifying Critical Habitats for Moose in**  
5.19 **Northeastern Minnesota**

5.20 \$507,000 is from the trust fund to the Board  
5.21 of Regents of the University of Minnesota  
5.22 for the Natural Resources Research Institute  
5.23 to identify critical habitats for moose,  
5.24 develop best management habitat protection  
5.25 practices, and conduct educational outreach  
5.26 in cooperation with the Minnesota Zoo.

5.27 This appropriation is available until June  
5.28 30, 2013, by which time the project must be  
5.29 completed and final products delivered.

5.30 **Subd. 4. Land, Habitat, and Recreation**

5.31 **(a) Ecological Restoration Training**  
5.32 **Cooperative for Habitat Restoration**

5.33 \$550,000 is from the trust fund to the Board  
5.34 of Regents of the University of Minnesota  
5.35 for improving ecological restoration success

6.1 in Minnesota by developing and offering  
6.2 training programs for habitat restoration  
6.3 professionals. This appropriation is available  
6.4 until June 30, 2013, by which time the  
6.5 project must be completed and final products  
6.6 delivered.

6.7 **(b) Scientific and Natural Areas and Native**  
6.8 **Prairie Restoration, Enhancement, and**  
6.9 **Acquisition**

6.10 \$1,750,000 is from the trust fund to the  
6.11 commissioner of natural resources to  
6.12 acquire lands with high quality native  
6.13 plant communities and rare features to be  
6.14 established as scientific and natural areas  
6.15 as provided in Minnesota Statutes, section  
6.16 86A.05, subdivision 5, restore parts of  
6.17 scientific and natural areas, and provide  
6.18 assistance and incentives for native prairie  
6.19 landowners. A list of proposed acquisitions  
6.20 must be provided as part of the required  
6.21 work program. Land acquired with this  
6.22 appropriation must be sufficiently improved  
6.23 to meet at least minimum management  
6.24 standards as determined by the commissioner  
6.25 of natural resources. This appropriation  
6.26 is available until June 30, 2013, by which  
6.27 time the project must be completed and final  
6.28 products delivered.

6.29 **(c) State Park Land Acquisition**

6.30 \$2,200,000 is from the trust fund to the  
6.31 commissioner of natural resources to  
6.32 acquire and preserve critical parcels within  
6.33 the statutory boundaries of state parks.  
6.34 Land acquired with this appropriation  
6.35 must be sufficiently improved to meet at  
6.36 least minimum management standards as

7.1 determined by the commissioner of natural  
7.2 resources. A list of proposed acquisitions  
7.3 must be provided as part of the required work  
7.4 program.

7.5 **(d) Protection of Rare Granite Rock Outcrop**  
7.6 **Ecosystem**

7.7 \$1,800,000 is from the trust fund to the  
7.8 Board of Water and Soil Resources, in  
7.9 cooperation with the Renville Soil and Water  
7.10 Conservation District, to continue to acquire  
7.11 perpetual easements of unique granite rock  
7.12 outcrops, located in the Upper Minnesota  
7.13 River Valley. \$418,000 of this appropriation  
7.14 is for fiscal year 2010 and is available the  
7.15 day following final enactment.

7.16 **(e) Minnesota's Habitat Conservation**  
7.17 **Partnership Supplemental**

7.18 \$1,400,000 is added to Laws 2009, chapter  
7.19 143, section 2, subdivision 4, paragraph  
7.20 (e), from the trust fund for the acceleration  
7.21 of agency programs and cooperative  
7.22 agreements. Of this appropriation, \$318,000  
7.23 is to the commissioner of natural resources  
7.24 for agency programs and \$1,082,000 is for  
7.25 agreements as follows: \$425,000 with Ducks  
7.26 Unlimited, Inc.; \$50,000 with National Wild  
7.27 Turkey Federation; \$210,000 with the Nature  
7.28 Conservancy; \$102,000 with Minnesota  
7.29 Land Trust; \$200,000 with the Trust for  
7.30 Public Land; \$45,000 with Friends of Detroit  
7.31 Lakes Wetland Management District; and  
7.32 \$50,000 to the Leech Lake Band of Ojibwe  
7.33 to plan, restore, and acquire fragmented  
7.34 landscape corridors that connect areas of  
7.35 quality habitat to sustain fish, wildlife, and  
7.36 plants. The United States Department of

8.1 Agriculture Natural Resources Conservation  
8.2 Service is an authorized cooperating partner  
8.3 in the appropriation. Expenditures are limited  
8.4 to the project corridor areas as defined in  
8.5 the work program. Land acquired with this  
8.6 appropriation must be sufficiently improved  
8.7 to meet at least minimum habitat and facility  
8.8 management standards as determined by  
8.9 the commissioner of natural resources.  
8.10 This appropriation may not be used for the  
8.11 purchase of residential structures, unless  
8.12 expressly approved in the work program. All  
8.13 conservation easements must be perpetual  
8.14 and have a natural resource management  
8.15 plan. Any land acquired in fee title by the  
8.16 commissioner of natural resources with  
8.17 money from this appropriation must be  
8.18 designated as an outdoor recreation unit  
8.19 under Minnesota Statutes, section 86A.07.  
8.20 The commissioner may similarly designate  
8.21 any lands acquired in less than fee title. A  
8.22 list of proposed restorations and fee title  
8.23 and easement acquisitions must be provided  
8.24 as part of the required work program. All  
8.25 funding for conservation easements must  
8.26 include a long-term stewardship plan and  
8.27 funding for monitoring and enforcing the  
8.28 agreement.  
8.29 **(f) Metropolitan Conservation Corridors**  
8.30 **Supplemental**  
8.31 \$1,800,000 is added to Laws 2009, chapter  
8.32 143, section 2, subdivision 4, paragraph (f),  
8.33 from the trust fund to the commissioner of  
8.34 natural resources for acceleration of agency  
8.35 programs and cooperative agreements.  
8.36 Of this appropriation, \$1,800,000 is for

9.1 agreements as follows: \$915,000 with  
9.2 the Trust for Public Land; \$485,000 with  
9.3 Minnesota Land Trust; \$350,000 with  
9.4 Minnesota Valley National Wildlife Refuge  
9.5 Trust, Inc.; and \$50,000 with Friends  
9.6 of the Minnesota Valley for planning,  
9.7 restoring, and protecting important natural  
9.8 areas in the metropolitan area, as defined  
9.9 under Minnesota Statutes, section 473.121,  
9.10 subdivision 2, and portions of the surrounding  
9.11 counties, through grants, contracted services,  
9.12 technical assistance, conservation easements,  
9.13 and fee title acquisition. Land acquired  
9.14 with this appropriation must be sufficiently  
9.15 improved to meet at least minimum  
9.16 management standards as determined by  
9.17 the commissioner of natural resources.  
9.18 Expenditures are limited to the identified  
9.19 project corridor areas as defined in the work  
9.20 program. This appropriation may not be used  
9.21 for the purchase of residential structures,  
9.22 unless expressly approved in the work  
9.23 program. All conservation easements must  
9.24 be perpetual and have a natural resource  
9.25 management plan. Any land acquired in fee  
9.26 title by the commissioner of natural resources  
9.27 with money from this appropriation must  
9.28 be designated as an outdoor recreation unit  
9.29 under Minnesota Statutes, section 86A.07.  
9.30 The commissioner may similarly designate  
9.31 any lands acquired in less than fee title. A  
9.32 list of proposed restorations and fee title  
9.33 and easement acquisitions must be provided  
9.34 as part of the required work program. All  
9.35 funding for conservation easements must  
9.36 include a long-term stewardship plan and

10.1 funding for monitoring and enforcing the  
10.2 agreement.

10.3 **(g) Conserving Sensitive and Priority**  
10.4 **Shorelands in Cass County**

10.5 \$300,000 is from the trust fund to the  
10.6 commissioner of natural resources for an  
10.7 agreement with Cass County to provide  
10.8 assistance for the donation of perpetual  
10.9 conservation easements to protect sensitive  
10.10 shoreland parcels for long-term protection  
10.11 of recreation, water quality, and critical  
10.12 habitat in north central Minnesota. This  
10.13 appropriation is available until June 30,  
10.14 2013, by which time the project must be  
10.15 completed and final products delivered.

10.16 **(h) Reconnecting Fragmented Prairie**  
10.17 **Landscapes**

10.18 \$380,000 is from the trust fund to the  
10.19 commissioner of natural resources for an  
10.20 agreement with the Nature Conservancy  
10.21 to develop prairie landscape design plans  
10.22 and monitoring protocol involving local  
10.23 landowners and businesses to guide  
10.24 conservation, restoration, and related  
10.25 economic development. This appropriation  
10.26 is available until June 30, 2013, by which  
10.27 time the project must be completed and final  
10.28 products delivered.

10.29 **Subd. 5. Water Resources** -0- 3,455,000

10.30 **(a) Understanding Sources of Aquatic**  
10.31 **Contaminants of Emerging Concern**

10.32 \$640,000 is from the trust fund to the  
10.33 Board of Regents of the University of  
10.34 Minnesota to identify chemical markers to  
10.35 characterize sources of endocrine disruptors

- 11.1 and pharmaceuticals entering surface waters  
11.2 in the Zumbro River Watershed. This  
11.3 appropriation is available until June 30,  
11.4 2013, by which time the project must be  
11.5 completed and final products delivered.
- 11.6 **(b) Managing Mineland Sulfate Release in St.**  
11.7 **Louis River Basin**
- 11.8 \$270,000 is from the trust fund to the  
11.9 commissioner of natural resources to map  
11.10 current sulfate sources and assess treatment  
11.11 options to minimize potential impacts of  
11.12 mercury on fish and wildlife from sulfate  
11.13 releases in the St. Louis River Basin. This  
11.14 appropriation is available until June 30,  
11.15 2013, by which time the project must be  
11.16 completed and final products delivered.
- 11.17 **(c) Ecological Impacts of Effluent in Surface**  
11.18 **Waters and Fish**
- 11.19 \$340,000 is from the trust fund to the Board  
11.20 of Regents of the University of Minnesota in  
11.21 cooperation with St. Cloud State University  
11.22 to determine the chemical and biological  
11.23 fate of phytoestrogens in surface waters  
11.24 and the impacts on fish. This appropriation  
11.25 is available until June 30, 2013, by which  
11.26 time the project must be completed and final  
11.27 products delivered.
- 11.28 **(d) Agricultural and Urban Runoff Water**  
11.29 **Quality Treatment Analysis**
- 11.30 \$485,000 is from the trust fund to the  
11.31 Board of Water and Soil Resources for  
11.32 an agreement with the Blue Earth County  
11.33 Drainage Authority to reduce soil erosion,  
11.34 peak water flows, and nutrient loading  
11.35 through a demonstration model evaluating  
11.36 storage and treatment options in drainage

12.1 systems in order to improve water quality.

12.2 This appropriation is available until June

12.3 30, 2014, by which time the project must be

12.4 completed and final products delivered.

12.5 **(e) Assessing Septic System Discharge to Lakes**

12.6 \$594,000 is from the trust fund to the

12.7 commissioner of health for department

12.8 activities and for an agreement with the

12.9 United States Geologic Survey in cooperation

12.10 with St. Cloud State University to develop

12.11 quantitative data on septic system discharge

12.12 of estrogenic and pharmaceutical compounds

12.13 and assess septic and watershed influences

12.14 on levels of contamination and biological

12.15 responses in Minnesota lakes. The United

12.16 States Geologic Survey is not subject to the

12.17 requirements in Minnesota Statutes, section

12.18 116P.10. This appropriation is available

12.19 until June 30, 2013, by which time the

12.20 project must be completed and final products

12.21 delivered.

12.22 **(f) Evaluation of Dioxins in Minnesota Lakes**

12.23 \$264,000 is from the trust fund to the Board

12.24 of Regents of the University of Minnesota

12.25 to examine the concentration of dioxins in

12.26 lake sediment and options to improve water

12.27 quality in lakes.

12.28 **(g) Assessment of Shallow Lake Management**

12.29 \$262,000 is from the trust fund to the

12.30 commissioner of natural resources to

12.31 evaluate the major causes of deterioration

12.32 of shallow lakes in Minnesota and evaluate

12.33 results of current management efforts. This

12.34 appropriation is available until June 30,

13.1 2013, by which time the project must be  
13.2 completed and final products delivered.

13.3 **(h) Assessing Cumulative Impacts of Shoreline**  
13.4 **Development**

13.5 \$300,000 is from the trust fund to the Board  
13.6 of Regents of the University of Minnesota to  
13.7 evaluate near-shore, in-water habitat impacts  
13.8 from shoreline development activities to  
13.9 assist in the design and implementation of  
13.10 management practices protecting critical  
13.11 shorelands and aquatic habitat. This  
13.12 appropriation is available until June 30,  
13.13 2013, by which time the project must be  
13.14 completed and final products delivered.

13.15 **(i) Trout Stream Assessments**

13.16 \$300,000 is from the trust fund to the  
13.17 Board of Regents of the University of  
13.18 Minnesota to assess cold water aquatic  
13.19 insect abundance related to warming water  
13.20 temperatures as predictors of trout growth in  
13.21 southeastern Minnesota and assess options  
13.22 to minimize stream temperature changes.  
13.23 This appropriation is available until June  
13.24 30, 2013, by which time the project must be  
13.25 completed and final products delivered.

13.26 **Subd. 6. Aquatic and Terrestrial Invasive**  
13.27 **Species**

13.28 **(a) Biological Control of European Buckthorn**  
13.29 **and Garlic Mustard**

13.30 \$300,000 is from the trust fund to the  
13.31 commissioner of natural resources in  
13.32 cooperation with the commissioner of  
13.33 agriculture to continue the development  
13.34 and implementation of biological control  
14.1 for European buckthorn and garlic mustard.

14.2 This appropriation is available until June  
14.3 30, 2013, by which time the project must be  
14.4 completed and final products delivered.

14.5 **(b) Ecological and Hydrological Impacts of**  
14.6 **Emerald Ash Borer**

14.7 \$636,000 is from the trust fund to the Board  
14.8 of Regents of the University of Minnesota to  
14.9 assess the potential impacts of emerald ash  
14.10 borer on Minnesota's black ash forests and  
14.11 quantify potential impacts on native forest  
14.12 vegetation, invasive species spread, and  
14.13 hydrology. This appropriation is available  
14.14 until June 30, 2015, by which time the  
14.15 project must be completed and final products  
14.16 delivered.

14.17 **(c) Healthy Forests to Resist Invasion**

14.18 \$359,000 is from the trust fund to the Board  
14.19 of Regents of the University of Minnesota to  
14.20 assess the role of forest health management  
14.21 in resisting infestation of invasive species.

14.22 This appropriation is available until June  
14.23 30, 2013, by which time the project must be  
14.24 completed and final products delivered.

14.25 **(d) Bioacoustic Traps for Management of**  
14.26 **Round Goby**

14.27 \$175,000 is from the trust fund to the Board  
14.28 of Regents of the University of Minnesota  
14.29 to evaluate bioacoustic technology specific  
14.30 to invasive round goby in Lake Superior as  
14.31 a method for early detection and population  
14.32 reduction. This appropriation is available  
14.33 until June 30, 2013, by which time the  
14.34 project must be completed and final products  
14.35 delivered.

15.1 **Subd. 7. Renewable Energy** -0- 3,364,000

15.2 **(a) Algae for Fuels Pilot Project**

15.3 \$900,000 is from the trust fund to the Board  
15.4 of Regents of the University of Minnesota  
15.5 to demonstrate an innovative microalgae  
15.6 production system utilizing and treating  
15.7 sanitary wastewater to produce biofuels  
15.8 from algae. This appropriation is available  
15.9 until June 30, 2013, by which time the  
15.10 project must be completed and final products  
15.11 delivered.

15.12 **(b) Sustainable Biofuels**

15.13 \$221,000 is from the trust fund to the Board  
15.14 of Regents of the University of Minnesota  
15.15 to determine how fertilization and irrigation  
15.16 impact yields of grass monoculture and high  
15.17 diversity prairie biofuel crops, their storage  
15.18 of soil carbon, and susceptibility to invasion  
15.19 by exotic species. This appropriation is  
15.20 available until June 30, 2013, by which time  
15.21 the project must be completed and final  
15.22 products delivered.

15.23 **(c) Linking Habitat Restoration to Bioenergy**  
15.24 **and Local Economies**

15.25 \$600,000 is from the trust fund to the  
15.26 commissioner of natural resources to restore  
15.27 high quality native habitats and expand  
15.28 market opportunities for utilizing postharvest  
15.29 restoration as a bioenergy source. This  
15.30 appropriation is available until June 30,  
15.31 2013, by which time the project must be  
15.32 completed and final products delivered.

16.1 **(d) Demonstrating Sustainable Energy**  
16.2 **Practices at Residential Environmental**  
16.3 **Learning Centers (RELCs)**

16.4 \$1,500,000 is from the trust fund to  
16.5 the commissioner of natural resources  
16.6 for agreements as follows: \$206,000  
16.7 with Audubon Center of the North  
16.8 Woods; \$212,000 with Deep Portage  
16.9 Learning Center; \$350,000 with Eagle  
16.10 Bluff Environmental Learning Center;  
16.11 \$258,000 with Laurentian Environmental  
16.12 Learning Center; \$240,000 with Long  
16.13 Lake Conservation Center; and \$234,000  
16.14 with Wolf Ridge Environmental Learning  
16.15 Center to implement renewable energy,  
16.16 energy efficiency, and energy conservation  
16.17 practices at the facilities. Efforts will include  
16.18 dissemination of related energy education.

16.19 **(e) Analysis of Options for Minnesota Energy**  
16.20 **Independence**

16.21 \$143,000 is from the trust fund to the Board  
16.22 of Regents of the University of Minnesota  
16.23 for a life cycle analysis of low carbon energy  
16.24 technologies available to implement in  
16.25 Minnesota.

16.26 **Subd. 8. Environmental Education** -0- 2,640,000

16.28 **Academy**

16.29 \$368,000 is from the trust fund to the Board  
16.30 of Water and Soil Resources in cooperation  
16.31 with the Minnesota Conservation Corps  
16.32 or its successor to train and mentor future  
16.33 conservation professionals by providing  
16.34 apprenticeship service opportunities to  
16.35 soil and water conservation districts. This  
17.1 appropriation is available until June 30,  
17.2 2013, by which time the project must be  
17.3 completed and the final products delivered.

17.4 **(b) Engaging Students in Environmental**  
17.5 **Stewardship through Adventure Learning**

17.6 \$250,000 is from the trust fund to the  
17.7 commissioner of natural resources for an  
17.8 agreement with the Will Steger Foundation  
17.9 to provide curriculum, teacher training,  
17.10 online learning, and grants to schools  
17.11 on investigating the connection between  
17.12 Minnesota's changing climate and the  
17.13 impacts on ecosystems and natural resources.

17.14 This appropriation is available until June  
17.15 30, 2013, by which time the project must be  
17.16 completed and final products delivered.

17.17 **(c) Connecting Youth with Nature**

17.18 \$160,000 is from the trust fund to the  
17.19 commissioner of natural resources to hold  
17.20 teacher training workshops on the use of  
17.21 digital photography as a tool for learning  
17.22 about nature. The equipment must be  
17.23 provided from other funds.

17.24 **(d) Urban Wilderness Youth Outdoor**  
17.25 **Education**

17.26 \$557,000 is from the trust fund to the  
17.27 commissioner of natural resources for  
17.28 an agreement with Wilderness Inquiry to  
17.29 provide an outdoor education and recreation  
17.30 program on the Mississippi River. This  
17.31 appropriation is available until June 30,  
17.32 2013, by which time the project must be  
17.33 completed and final products delivered.

17.34 **(e) Get Outside - Urban Woodland for Kids**

18.1 \$218,000 is from the trust fund to the  
18.2 commissioner of natural resources for  
18.3 an agreement with the city of St. Paul,  
18.4 Department of Parks and Recreation, to

18.5 restore and develop an outdoor classroom  
18.6 for ecological education and historical  
18.7 interpretation at Como Regional Park in  
18.8 St. Paul. This appropriation is available  
18.9 until June 30, 2013, by which time the  
18.10 project must be completed and final products  
18.11 delivered.

18.14 \$300,000 is from the trust fund to the

18.21 \$300,000 is from the trust fund to the  
18.22 commissioner of education in cooperation  
18.23 with the commissioner of natural resources  
18.24 to train and support grade 7-12 teachers  
18.25 to integrate environmental and outdoor  
18.26 education into the instruction of academic  
18.27 standards.

18.28 **(h) Project Get Outdoors**

18.29 \$15,000 is from the trust fund to the  
18.30 commissioner of natural resources for an  
18.31 agreement with Project Get Outdoors, Inc. to  
18.32 develop out of school programs connecting  
18.33 children to local nature experiences.

19.1 **(i) Fishing: Cross Cultural Gateway to**  
19.2 **Environmental Education**

19.3 \$155,000 is from the trust fund to the  
19.4 commissioner of natural resources for  
19.5 an agreement with the Association for  
19.6 the Advancement of Hmong Women

19.7 in Minnesota to provide environmental  
19.8 information and teaching skills to and  
19.9 increase participation of Southeast Asian  
19.10 communities through the gateway of fishing  
19.11 skills. Information on mercury in fish  
19.12 advisories must be included as part of the  
19.13 educational outreach. This appropriation  
19.14 is available until June 30, 2013, by which  
19.15 time the project must be completed and final  
19.16 products delivered.

19.17 **(j) Minnesota WolfLink**

19.18 \$193,000 is from the trust fund to the  
19.19 commissioner of natural resources for an  
19.20 agreement with the International Wolf Center  
19.21 to develop interactive onsite and distance  
19.22 learning about wolves and their habitat.  
19.23 This appropriation is available until June  
19.24 30, 2013, by which time the project must be  
19.25 completed and final products delivered.

19.26 **(k) Online Field Trip of Minnesota River**

19.27 \$124,000 is from the trust fund to the  
19.28 commissioner of natural resources for an  
19.29 agreement with Minnesota State University  
19.30 - Mankato to develop online educational  
19.31 materials on the Minnesota River for schools  
19.32 and outreach centers.

19.33 **Subd. 9. Availability of Appropriations**

20.1 Money appropriated in this section may  
20.2 not be spent on activities unless they are  
20.3 directly related to the specific appropriation  
20.4 and are specified in the approved work  
20.5 program. Money appropriated in this section  
20.6 must not be spent on indirect costs or other  
20.7 institutional overhead charges. Unless

20.8 otherwise provided, the amounts in this  
20.9 section are available until June 30, 2012,  
20.10 when projects must be completed and final  
20.11 products delivered. For acquisition of real  
20.12 property, the amounts in this section are  
20.13 available until June 30, 2013, if a binding  
20.14 contract is entered into by June 30, 2012,  
20.15 and closed not later than June 30, 2013. If

20.25 designed to support data coordination and  
20.26 distribution that have been published by the  
20.27 Minnesota Geospatial Information Office.  
20.28 Descriptions of spatial data must be prepared  
20.29 as specified in the state's geographic metadata  
20.30 guideline and must be submitted to the  
20.31 Minnesota Geospatial Information Office.  
20.32 All data must be accessible and free to the  
20.33 public unless made private under the Data  
20.34 Practices Act, Minnesota Statutes, chapter  
20.35 13.

21.1 To the extent practicable, summary data and  
21.2 results of projects funded under this section  
21.3 should be readily accessible on the Internet  
21.4 and identified as an environment and natural  
21.5 resources trust fund project.

21.6 **Subd. 11. Project Requirements**

- 21.7 (a) As a condition of accepting an  
21.8 appropriation under this section, any agency  
21.9 or entity receiving an appropriation must  
21.10 comply with paragraphs (b) to (h) and  
21.11 Minnesota Statutes, chapter 116P, for any  
21.12 project funded in whole or in part with funds  
21.13 from the appropriation.
- 21.14 (b) To the extent possible, a person  
21.15 conducting restoration with money  
21.16 appropriated under this section must plant  
21.17 vegetation only of ecotypes native to  
21.18 Minnesota and preferably of the local  
21.19 ecotype using a high diversity of species  
21.20 originating as close to the restoration site as  
21.21 possible and, when restoring prairies, protect  
21.22 existing prairies from genetic contamination.  
21.23 Use of seeds and plant materials beyond these  
21.24 requirements must be expressly approved in  
21.25 the work program.
- 21.26 (c) All conservation easements acquired with

24.18 Minnesota Statutes, section 16A.41,  
24.19 expenditures made on or after July 1,  
24.20 2010, or the date the work program is  
24.21 approved, whichever is later, are eligible for  
24.22 reimbursement unless otherwise provided  
24.23 in this section. Periodic payment must  
24.24 be made upon receiving documentation  
24.25 that the deliverable items articulated in  
24.26 the approved work program have been  
24.27 achieved, including partial achievements  
24.28 as evidenced by approved progress reports.

25.3 A political subdivision, public or private  
25.4 corporation, or other entity that receives an  
25.5 appropriation under this section must use the  
25.6 appropriation in compliance with Minnesota  
25.7 Statutes, sections 16B.121, regarding  
25.8 purchase of recycled, repairable, and durable

25.9 materials; and 16B.122, regarding purchase  
25.10 and use of paper stock and printing.

25.11 **Subd. 14. Energy Conservation and**  
25.12 **Sustainable Building Guidelines**

25.13 A recipient to whom an appropriation is made  
25.14 under this section for a capital improvement  
25.15 project must ensure that the project complies  
25.16 with the applicable energy conservation and  
25.17 sustainable building guidelines and standards  
25.18 contained in law, including Minnesota  
25.19 Statutes, sections 16B.325, 216C.19, and  
25.20 216C.20, and rules adopted under those  
25.21 sections. The recipient may use the energy  
25.22 planning, advocacy, and State Energy Office  
25.23 units of the Department of Commerce to  
25.24 obtain information and technical assistance  
25.25 on energy conservation and alternative  
25.26 energy development relating to the planning  
25.27 and construction of the capital improvement  
25.28 project.

25.29 **Subd. 15. Accessibility**

25.30 Structural and nonstructural facilities must  
25.31 meet the design standards in the Americans  
25.32 with Disabilities Act (ADA) accessibility  
25.33 guidelines.

25.34 **Subd. 16. Carryforward**

26.1 The availability of the appropriation for  
26.2 the following projects is extended to  
26.3 June 30, 2011: Laws 2009, chapter 143,  
26.4 section 2, subdivision 4, paragraph (j),  
26.5 Land and Water Conservation Account  
26.6 (LAWCON) Federal Reimbursements;  
26.7 subdivision 5, paragraph (b), Vulnerability  
26.8 of Fish Populations in Lakes to Endocrine  
26.9 Disrupting Contaminants; and subdivision 6,

26.10 paragraph (b), Emergency Delivery System

26.11 Development for Disinfecting Ballast Water.
