1.2 1.3	relating to economic development; authorizing payments for frontline workers whose work put them at risk of contracting COVID-19 during peacetime
1.4	emergency; classifying data; requiring a report; appropriating money.
1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. FRONTLINE WORKER PAYMENTS; PUBLIC PURPOSE.
1.7	This act is intended to provide payments to frontline workers whose work put them at
1.8	risk of contracting COVID-19 during the peacetime emergency declared by the governor
1.9	in Executive Order 20-01. The legislature finds that payments under this section specifically,
1.10	and under the premium pay provisions of the American Rescue Plan Act of 2021 generally,
1.11	have a public purpose and benefit the people of Minnesota by:
1.12	(1) responding to the extraordinary circumstances of the COVID-19 pandemic which
1.13	resulted in the peacetime emergency; and
1.14	(2) compensating workers for working in conditions that, in many cases, exceeded what
1.15	was originally contemplated in their employment agreement to ensure our state was able to
1.16	continue functioning during the pandemic.
1.17	Sec. 2. FRONTLINE WORKER PAYMENTS.
1.18	Subdivision 1. Program established; payments authorized. To the extent feasible, the
1.19	commissioner of revenue, in coordination with the commissioners of labor and industry and
1.20	employment and economic development, must make payments to eligible frontline workers

Subd. 2. Frontline sector defined. "Frontline sector" means the following sectors:

2.1	(1) long-term care and home care;
2.2	(2) health care, excluding physicians;
2.3	(3) emergency responders;
2.4	(4) public health, social service, and regulatory service;
2.5	(5) courts and corrections;
2.6	(6) child care;
2.7	(7) public schools, including charter schools, state schools, and higher education;
2.8	(8) food service, including production, processing, preparation, sale, and delivery;
2.9	(9) retail, including sales, fulfillment, distribution, and delivery;
2.10	(10) temporary shelters and hotels;
2.11	(11) building services, including maintenance, janitorial, and security;
2.12	(12) public transit;
2.13	(13) ground and air transportation services;
2.14	(14) manufacturing; and
2.15	(15) vocational rehabilitation.
2.16	Subd. 3. Eligible frontline workers. (a) An individual is eligible to receive a payment
2.17	under this section if the individual:
2.18	(1) was employed for at least 120 hours in Minnesota in one or more frontline sectors
2.19	during the time period beginning March 15, 2020, and ending June 30, 2021; and
2.20	(2) for the hours worked under clause (1), was not able to telework due to the nature of
2.21	the individual's work and worked in close proximity to individuals outside of the individual's
2.22	household;

2.24	(4) did not collect unemployment insurance benefits for more than 20 weeks on a

2.27	(b) To qualify for a payment, an individual's adjusted gross income, as defined in section
2.28	62 of the Internal Revenue Code, must be less than the following amounts for at least one

3.1	(1) for an individual who was employed in an occupation with direct COVID-19 patient
3.2	care responsibilities, \$250,000 for a married taxpayer filing a joint return and \$150,000 for
3.3	all other filers; or

3.5	\$85,000 for all other filers.
3.6	Subd. 4. Application ; verification of eligibility. (a) To qualify for a payment under
3.7	this section, an individual must apply to the commissioner of labor and industry in the form
3.8	and manner specified by the commissioner. As part of the application, an individual must
3.9	certify to the commissioner of labor and industry that the individual meets the eligibility
3.10	requirements in subdivision 3.
3.11	(b) As soon as practicable after final enactment of this act, the commissioner of labor
3.12	and industry must establish a process for accepting applications for payments under this
3.13	section and begin accepting applications. The commissioner must not accept an application
3.14	submitted more than 45 days after opening the application period.
3.15	(c) The commissioner of labor and industry must assist applicants in submitting an
3.16	application under this section, including but not limited to:
3.17	(1) establishing a multilingual temporary help line for applicants; and
3.18	(2) offering multilingual applications and multilingual instructions.
3.19	(d) To the extent possible, the commissioners of revenue, employment and economic
3.20	development, and labor and industry must verify applicant eligibility for a payment under
3.21	this section. If the commissioners lack the information to verify an applicant's eligibility in
3.22	a timely fashion, the commissioner of labor and industry must accept the applicant's
3.23	self-certification of eligibility in the absence of contrary information.
3.24	(e) An applicant for a payment under this section may appeal a denial of eligibility under
3.25	this subdivision to the commissioner of labor and industry within 15 days of notice of denial.
3.26	The commissioner of labor and industry's decision on an appeal is final.
3.27	(f) The commissioner of labor and industry may contract with a third party to implement
3.28	part or all of the application process and assistance required under this subdivision.
3.29	Subd. 5. Eligibility; payments. (a) After the deadline for applications under subdivision
3.30	4 has elapsed, the commissioner of revenue must determine the payment amount based on
3.31	available appropriations and the number of applications received from eligible frontline
3.32	workers. The payment amount must be the same for each eligible frontline worker, and
3.33	must not exceed \$1,500.

6.1	Subd. 10. Procurement. The commissioners of labor and industry and revenue are
6.2	exempt from the requirements of Minnesota Statutes, chapters 16A, 16B, 16C, and 16E,
6.3	and any other state procurement laws and procedures in administering the program under
6.4	this section.
6.5	Subd. 11. Appropriations. (a) \$1,000,000,000 in fiscal year 2022 is appropriated from
6.6	the general fund to the commissioner of revenue for payments under this section. This is a
6.7	onetime appropriation.
6.8	(b) \$2,480,000 in fiscal year 2022 is appropriated to the commissioner of labor and
6.9	industry for administrative costs to implement the payments under this section.
6.10	(c) \$2,049,000 in fiscal year 2022 is appropriated to the commissioner of revenue for
6.11	administrative costs to implement the payments under this section.
6.12	(d) \$215,000 in fiscal year 2022 is appropriated to the commissioner of employment
6.13	and economic development for administrative costs to implement the payments under this
6.14	section.
6.15	EFFECTIVE DATE. (a) Unless otherwise specified, this section is effective the day
6.16	following final enactment.
6.17	(b) Subdivision 8, paragraphs (a), (b), and (c), are effective for taxable years in which
6.18	a taxpayer received a frontline worker payment. Subdivision 8, paragraph (d), is effective
6.19	the day following final enactment, except for a program for which federal approval is
6.20	required, changes affecting the program are effective upon federal approval.
