BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.5

- Section 1. Minnesota Statutes 2014, section 168.021, subdivision 1, is amended to read: 1.6 Subdivision 1. Disability plates; application. (a) When a motor vehicle registered 1.7 under section 168.017, a motorcycle, a motorized bicycle, a one-ton pickup truck, or 1.8 a self-propelled recreational vehicle is owned or primarily operated by a permanently 1.9 physically disabled person or a custodial parent or guardian of a permanently physically 1.10 disabled minor, the owner may apply for and secure from the commissioner (1) 1.11 immediately, a temporary permit valid for 30 days if the applicant is eligible for the 1.12 disability plates issued under this section and (2) two disability plates with attached 1.13 emblems, one plate to be attached to the front, and one to the rear of the motor vehicle, 1.14 truck, or recreational vehicle, or, in the case of a motorcycle or a motorized bicycle, one 1.15 disability plate the same size as a regular motorcycle plate. 1.16 (b) The commissioner shall not issue more than one plate to the owner of a 1.17 motorcycle or a motorized bicycle and not more than one set of plates to any owner of 1.18 another vehicle described in paragraph (a) at the same time unless the state Council on 1.19 Disability approves the issuance of a second plate or set of plates to an owner. 1.20 (c) When the owner first applies for the disability plate or plates, the owner must 1.21 submit a medical statement in a format approved by the commissioner under section 1 22
- 169.345, or proof of physical disability provided for in that section. 1.23

- 2.1 (d) No medical statement or proof of disability is required when an owner applies for
 2.2 a plate or plates for one or more vehicles listed in paragraph (a) that are specially modified
 2.3 for and used exclusively by permanently physically disabled persons.
- (e) The owner of a vehicle listed in paragraph (a) may apply for and secure (i)
 immediately, a permit valid for 30 days, if the applicant is eligible to receive the disability
 plate or plates issued under this section, and (ii) a disability plate or plates for the vehicle if:
- 2.7 (1) the owner employs a permanently physically disabled person who would qualify2.8 for the disability plate or plates under this section; and
- 2.9 (2) the owner furnishes the motor vehicle to the physically disabled person for the2.10 exclusive use of that person in the course of employment.

Sec. 2. Minnesota Statutes 2014, section 168.021, subdivision 2, is amended to read: 2.11 Subd. 2. Plate design; furnished by commissioner. The commissioner shall design 2.12 and furnish two disability plates, or one disability plate for a motorcycle or a motorized 2.13 bicycle that is the same size as a regular motorcycle plate, with attached emblem or 2.14 emblems to an eligible owner. The emblem must bear the internationally accepted 2.15 wheelchair symbol, as designated in section 326B.106, subdivision 9, approximately three 2.16 inches square. The emblem must be large enough to be visible plainly from a distance of 2.17 50 feet. An applicant eligible for a disability plate or plates shall pay the motor vehicle 2.18 registration fee authorized by sections 168.013 and 168.09. 2.19

- Sec. 3. Minnesota Statutes 2014, section 168.021, subdivision 2a, is amended to read:
 Subd. 2a. Plate transfer. (a) When ownership of a vehicle described in subdivision
 1, is transferred, the owner of the vehicle shall remove the disability plate or plates. The
 buyer of the motor vehicle is entitled to receive a regular plate or plates for the vehicle
 without further cost for the remainder of the registration period.
- (b) Notwithstanding section 168.12, subdivision 1, the disability plate or plates may
 be transferred to a replacement vehicle on notification to the commissioner. However, the
 disability plate or plates may not be transferred unless the replacement vehicle (1) is listed
 under section 168.012, subdivision 1, and, in case of a single plate for a motorcycle or a
 motorized bicycle, the replacement vehicle is a motorcycle or a motorized bicycle, and (2)
 is owned or primarily operated by the permanently physically disabled person.
- 2.31 Sec. 4. Minnesota Statutes 2014, section 169.345, subdivision 1, is amended to read:
 2.32 Subdivision 1. Scope of privilege. (a) A vehicle described in section 168.021,
 2.33 subdivision 1, paragraph (a), that prominently displays the certificate authorized by this

03/02/16 REVISOR RSI/JL 16-6214 section or that bears the disability plate or plates issued under section 168.021 may be 3.1 parked by or solely for the benefit of a physically disabled person: 3.2 (1) in a designated parking space for disabled persons, as provided in section 169.346; 3.3 (2) in a metered parking space without obligation to pay the meter fee and without 3.4 time restrictions unless time restrictions are separately posted on official signs; and 3.5 (3) without time restrictions in a nonmetered space where parking is otherwise 3.6

allowed for passenger vehicles but restricted to a maximum period of time and that does
not specifically prohibit the exercise of disabled parking privileges in that space.

A person may park the vehicle for a physically disabled person in a parking space
described in clause (1) or (2) only when actually transporting the physically disabled
person for the sole benefit of that person and when the parking space is within a reasonable
distance from the drop-off point.

3.13 (b) For purposes of this subdivision, a certificate is prominently displayed if it is 3.14 displayed so that it may be viewed from the front and rear of the motor vehicle by hanging 3.15 it from the rearview mirror attached to the front windshield of the motor vehicle or, in 3.16 the case of a motorcycle or a motorized bicycle, is secured to the vehicle. If there is no 3.17 rearview mirror or if the certificate holder's disability precludes placing the certificate on 3.18 the mirror, the certificate must be displayed on the dashboard of the vehicle. No part of 3.19 the certificate may be obscured.

(c) Notwithstanding paragraph (a), clauses (1), (2), and (3), this section does not
permit parking in areas prohibited by sections 169.32 and 169.34, in designated no
parking spaces, or in parking spaces reserved for specified purposes or vehicles. A local
governmental unit may, by ordinance, prohibit parking on any street or highway to create
a fire lane, or to accommodate heavy traffic during morning and afternoon rush hours and
these ordinances also apply to physically disabled persons.

Sec. 5. Minnesota Statutes 2014, section 169.345, subdivision 3, is amended to read: 3.26 Subd. 3. Identifying certificate. (a) The commissioner shall issue (1) immediately, 3.27 a permit valid for 30 days if the person is eligible for the certificate issued under this 3.28 section and (2) an identifying certificate for a vehicle described in section 168.021, 3.29 subdivision 1, paragraph (a), when a physically disabled applicant submits proof of 3.30 physical disability under subdivision 2a. The commissioner shall design separate 3.31 certificates for persons with permanent and temporary disabilities that can be readily 3.32 distinguished from each other from outside a vehicle at a distance of 25 feet or, in the 3.33 case of a motorcycle or a motorized bicycle, can be readily secured to the motorcycle or 3.34
