1.8	Subdivision 1. Governance. (a) The board of the Perpich Center for Arts Education
1.9	shall consist of <u>15</u> 12 persons, one of whom must have served as a school administrator or
1.10	as an elected school board member, one of whom is a locally or regionally recognized
1.11	professional artist, and one of whom is a secondary or postsecondary arts educator. The
1.12	members of the board shall be appointed by the governor with the advice and consent of
1.13	the senate. At least one member must be appointed from each congressional district.
1.14	(b) A seven-member nominating committee composed of three currently serving
1.15	members of the board of the Perpich Center for Arts Education appointed by the board,
1.16	three members appointed by the Minnesota State Arts Board, and one member appointed
1.17	by the governor shall meet, as required, to prepare and submit a list of recommended
1.18	candidates to the governor for the governor to consider when appointing members of the

1.20	(c) All board members must complete board training requirements consistent with
